1971 Policy and Restrictions.

THE Hon. Minister for Fisheries and Fauna has approved the undermentioned prawning policy conditions and restrictions for 1971. All concerned are hereby notified that the licenses of those vessels involved are hereby endorsed with the appropriate conditions in accordance with the provisions of section 17 of the Fisheries Act:—

- (1) From this date until July 31, 1971 only authorized vessels may take prawns in the Nickol Bay Prawning Area.
- (2) For these purposes, the Nickol Bay Prawning Area is hereby defined as all those Western Australian Waters and all that land lying between latitudes 20 degrees 25 minutes south and 20 degrees 45

- minutes south, from meridian 116 degrees 45 minutes east to meridian 117 degrees 45 minutes east.
- (3) The Nickol Bay Prawning Area is hereby divided into two parts to be known as Part A and Part B, the common boundary of which shall be east meridian 117 degrees 05 minutes. Part A shall comprise all that part of the Nickol Bay Prawning Area to the westward of meridian 117 degrees 05 minutes east and Part B shall comprise all of that part of that Area eastward of meridian 117 degrees 05 minutes.
- (4) During 1971 not more than 13 boats shall be authorized to work in the Nickol Bay Prawning Area.
- (5) Each boat so authorized shall dispose of prawns caught in the Nickol Bay Prawning Area to one or other of the licensed land based processing works and to no other person or establishment.
- (6) Authorizations may be allocated by the Director in the ratio 8 vessels to the Geraldton Fishermen's Co-operative Society's establishment to 5 to that of Markwell Ross Fisheries Pty. Ltd.
- (7) Vessels authorized to trawl for prawns in the Nickol Bay Area shall not operate in either of the restricted prawn trawling areas at Shark Bay or Exmouth Gulf during 1971.
- (8) Vessels authorized to trawl for prawns in the restricted areas of Shark Bay or Exmouth Gulf shall not operate in Nickol Bay during 1971.
- (9) No vessel shall trawl in Area A before April 5, 1971, but as and from that date authorized vessels may operate there.
- (10) No processing establishment shall accept prawns taken in the Nickol Bay Area from any unauthorized vessel.

Regulations.

Principal regulations.

In these regulations the Health Act (Swimming Pools) Regulations, 1964, published in the Government Gazette on the 15th October, 1964, and amended from time to time thereafter by notices published in the Government Gazette, are referred to as the principal regulations.

Regulation 6 of the principal regulations is revoked and the Reg. 6 2. Regulation 6 of the princip substituted. following regulation substituted:-

Lighting of swimming pools.

- 6. (1) Every swimming pool shall be provided with light, whether natural or artificial or both, to such an intensity that at all times when the swimming pool is in use—
 - (a) the average level of illumination on the surface of the water, measured at water level in the horizontal plane at a distance of 3 feet out towards the pool centre from the concourse, is at least 8 lumens per square foot; and
 - (b) at no point on the surface of the water is the illumination less than 4 lumens per square foot.
- (2) The average level of illumination referred to in subregulation (1) of this regulation shall be determined by taking a number of readings at intervals of 10 feet around the perimeter, and calculating the mean of these values.
- (3) The floor of every swimming pool, except for the guide lines, shall be of such colour or colours that it has a light reflecting value of not less than sixty per centum.
- (4) Where underwater lighting is provided in conjunction with overhead lighting the minimum illumination to be provided by underwater floodlights shall be in accordance with requirements set out in Table 1 to these regulations.
- (5) Overhead lighting for diving pools, diving platforms and steps thereto shall be so arranged that direct or reflected glare, either from the fittings or from the water, shall be kept to a minimum acceptable to the Commissioner.
- (6) The minimum requirements shown in lumens per square foot of water surface for the intensity of illumination from underwater fioodlamps in diving pools shall be in accordance with the requirements set out in Table 2 to these regulations.
- (7) Any area of a pool where the depth is greater than 6 feet 6 inches shall be regarded as a diving pool.
- (8) A pool deck shall be provided with sufficient lighting around the pool perimeter so that it may be illuminated to a distance of at least 12 feet out from the pool.
- (9) Any concealed metal, such as conduits, piping or reinforcing steel, within 12 inches of an underwater fitting or exposed metal within 6 feet of such fitting shall be bonded to its forming shell cast into the wall of the pool by brazing or other approved means.
- (10) Junction boxes, installed in conduit installations to underwater pool lights, shall be of the screwed conduit entry type and constructed of corrosion resistant material and shall be located at not less than 8 inches above the maximum pool water level, ground or pool deck, whichever is higher.
- (11) No general purposes outlet shall be installed within 10 feet horizontally of the water's edge.

Reg. 14 amended.

- 3. Regulation 14 of the principal regulations is amended by adding after subregulation (2) the following subregulation:—
 - (3) On or after the 1st day of October, 1972, the qualifications of the person present on the premises when the swimming pool is open to the public as required by subregulation (2) of this regulation shall be-
 - (a) a valid and current "Swimming Pool Manager's Competency Certificate" issued by the National Safety Council of Western Australia Incorporated; or
 - (i) "The St. John's Ambulance First Aid Certificate" or equivalent;
 - (ii) the bronze medallion of the Royal Life-Saving Society or equivalent; and
 - (iii) evidence of knowledge in operating pool equipment to the satisfaction of the Commissioner.

HEALTH ACT, 1911-1970.

Shire of Boulder.

Health By-laws—Stables.

P.H.D. 37/71; Ex. Co. 466.

WHEREAS under the provisions of the Health Act, 1911, as amended, a local authority may make by-laws and may amend, repeal or alter any by-laws so made: Now, therefore, the Council of the Shire of Boulder, being a local authority, doth hereby make the following by-laws:—

- 1. These by-laws may be cited as the "Shire of Boulder Stable By-laws", shall come into operation on publication in the Government Gazette and shall apply and have operation throughout the whose of the Shire of Boulder.
- 2. In these by-laws, unless inconsistent with the text or subject matter—"Act" means the Health Act, 1911, and any amendments thereto;
 - "Council" means the Council of the Shire of Boulder;
 - "Health Surveyor" means any surveyor appointed by the Council under the Health Act;
 - "Horse" means a stallion, mare, gelding, pony, colt or foal and includes an ass, mule, and any beast of whatever description used for burden or draught or for carrying persons;
 - "Person" and words applying to any person or individual includes a corporation;
 - "Stable" means any building in which a horse is stabled or kept and includes any shed, loose-box, stall or shelter used for the keeping, stabling, feeding, watering, grooming, sheltering, shoeing or veterinary treatment of a horse:
 - "Stable Premises" include any paddock or yard used in conjunction with any stable and includes all areas where horses are contained by fences or rails.
- 3. As from and after the date of this by-law coming into operation-
 - (i) no person shall keep or stable any horse within the Shire of Boulder except in a stable registered under this by-law;
 - (ii) no person shall keep or stable in any stable a greater number of horses than the number for which such stable is registered.
- 4. Every person required by these by-laws to register any premises as a stable shall make application therefor in the form prescribed for that purpose in the schedule hereto. With every application for original registration there shall be lodged in respect of the premises for which registration is applied such plans, drawings and particulars as the Council may require.
- 5. Application for the renewal of any registration shall be made annually during the month of December, and the certificate of registration then in force shall be lodged with the said application.

- 6. If any person in whose name a stable is registered desires to have the same transferred to any other person he and the proposed transferee shall make application in the form prescribed for the purpose in the schedule hereto and such appplication shall be lodged with the Council. If the Council approves such appplication it shall register the stable in the name of the transferee. For every transfer of registration there shall be paid to the Council at the time of lodging the application for transfer a fee of fifty cents (50c).
- 7. Upon receipt of such application the Council shall cause such premises to be inspected by the Health Surveyor and reported upon in respect to the sufficiency of such premises, the condition thereof as to repair and cleanliness and such matters as are required by this by-law.
- 8. If upon such application and report being submitted to the Council it shall appear to the Council that such application for registration should be granted, it shall, upon being paid the registration fee hereinafter prescribed, register such premises as a stable subject to such by-laws, orders, regulations and rules respecting stables within the Shire of Boulder as shall be or become of force during the continuance of such registration and to issue to the applicant a certificate of registration in the form set out in the schedule hereto.
- 9. Every registration hereunder shall be of force until the 31st day of December next after the making thereof, and thereafter during the period of every annual renewal and no longer, but may be sooner suspended or cancelled by the Council for breach of any of the by-laws, orders, regulations or rules to which the same is subject or if the stable is used by any person other than the person in whose name it is registered.
- 10. For every such registration and for every renewal thereof, there shall be paid to the Council by the person for whom such registration is made the sum of one dollar (\$1) for every loose-box or stall on the premises and capable of being used for the keeping of a horse, provided that the maximum sum payable in connection with any particular premises shall be ten dollars (\$10).
- 11. Every stable in respect to which application is made for registration must fulfill all the following requirements:—
 - (1) (a) The construction of every building, shed, loose-box, shelter and stall and its situation with respect to adjacent buildings must be in accordance with the Uniform Building By-laws but the Council may if it thinks fit waive strict compliance with this requirement with respect to any stable in existence prior to the date of the by-law coming into force.
 - (b) (i) Every loose-box or stall shall have an area of not less than 120 square feet and walls not less than 10 feet measured both horizontally and vertically.
 - (ii) A shelter provided in a yard for the protection of horses from inclement weather shall have an area of not less than 100 square feet, and a height of not less than 8 feet; it shall not be capable of being closed and shall have at least one side completely open to the outside air.
 - (c) Every stable shall have a properly constructed manure bin in brickwork above the ground level. The floor and internal walls of such manure bin shall be cement rendered and steel trowelled to a smooth surface. Every such bin shall be provided with a close fitting lid or door to render the bin fly-proof as far as practicable.
 - (d) Every stable shall have approved impervious rat-proof receptacles for the storing of chaff, bran, pollard or grain intended for horse feed
 - (2) (a) It shall not be at any less distance than 50 feet from any dwelling house or the milking shed or milk-room of any dairy. Provided that trainers and/or employees engaged in the care of horses stabled on the land may be housed in a building or buildings not less than 20 feet from any stable or building used for the housing of horses if—
 - such building or buildings comply with the minimum requirements of a room used for dwelling or sleeping purposes; and
 - (ii) is or are equipped with proper bathroom and sanitary facilities as required under the Uniform Building By-laws.
 - (b) Any paddock or yard used for the keeping of any horse shall have a fence or railing at a distance of not less than 4 feet from the boundary of any land not in the same occupation and/or possession, and not less than 20 feet from any dwelling house or building or buildings housing trainers and/or employees engaged in the care of horses.
- 12. The occupier of such premises whereon a stable is registered shall with respect to such stables—
 - (a) cause all manure and offensive litter therein to be carefully swept up once at least in each day and forthwith placed in the manure bin;
 - (b) remove and carry away or cause to be removed and carried away from such stable the contents of the manure bin once at least in each week and more often if required by notice in writing from the Health Surveyor so to do;

- (c) spray or cause to be sprayed with an approved pesticide every manure bin immediately after it is emptied and before it is again used;
- (d) spray or cause to be sprayed with an approved residual pesticide any surface of any building, shed, loose-box, stall and shelter if required by notice in writing from the Health Surveyor so to do;
- (e) employ all means and adopt such precautions as may be necessary to keep the stable in a clean and sanitary condition, in good repair, and as far as possible free from flies, rats, vermin and offensive odours.
- 13. Any person who makes a false statement in connection with any application under these by-laws shall be guilty of an offence.
- 14. Any person doing any act forbidden to be done, or failing to do so any act directed to be done by these by-laws, shall be liable to a penalty of not more than one hundred dollars and in the case of a continuing offence, a further daily penalty of not more than ten dollars.
