WHEREAS it is enacted by subsection (1) of section 3 of the Royal Style and Titles Act, 1947-1953, that where the Style and Titles appertaining to the Crown appear in an Act, schedule, form, regulation, rule, rule of court, or by-law, enacted, prescribed or made in, pursuant to, or under the authority of an Act, they are amended by substituting for them the Style and Titles set forth in the schedule to that Act; and whereas it is enacted by subsection (2) of that section that when and as often as the Style and Titles appertaining to the Crown are altered, the Governor may by proclamation declare that the Style and Titles as so altered shall be substituted for the Style and Titles appearing in any Act, schedule, form, regulation, rule, rule of court, or by-law, enacted, prescribed or made in, pursuant to or under the authority of an Act; and whereas, pursuant to an Act of the Parliament of Australia entitled the Royal Style and Titles Act 1973, Her Majesty the Queen has, by proclamation published in the *Australian Government Gazette* on the 19th day of October, 1973, appointed and declared that from that day, so far and as conveniently may be, on all occasions and in all instruments wherein Her Style and Titles are used in relation to Australia and its Territories, the Style and Titles set forth in that proclamation shall be used: Now, therefore, I, the Lieutenant Governor and Administrator, acting with the advice and consent of the Executive Council, declare that the Style and Titles pertaining to the Crown shall be altered by substituting for the Style and Titles appearing in any Act, schedule, form, regulation, rule, rule of court, or by-law, enacted, prescribed or made in, pursuant to, or under the authority of an Act, the following Style and Titles, that is to say:

Elizabeth the Second, by the Grace of God Queen of Australia and Her other Realms and Territories, Head of the Commonwealth.

WHEREAS it is enacted by paragraph (b) of subsection (1) of section 12 of the Medical Act, 1894-1968, that where the Governor is satisfied that any hospital within the meaning of the Hospitals Act, 1927, requires for the proper administration thereof one or more resident medical officers to be employed or engaged on the staff of such hospital and a duly qualified medical practitioner or a sufficient number of such duly qualified medical practitioners is or are not available for such appointment or engagement he may by proclamation published in the *Gazette* declare such area to be a region within the meaning of that section: Now, therefore, I, the Lieutenant Governor and Administrator being satisfied that the Kalgoorlie Regional Hospital and the St. John of God Hospital, Kalgoorlie are hospitals whose proper administration require one or more resident medical officers to be employed or engaged on the staff of such hospitals and a duly qualified medical practitioner or a sufficient number of such duly qualified medical practitioners is or are not available for such appointment or engagement and acting with the advice and consent of the Executive Council do hereby declare the Kalgoorlie Regional Hospital and the St. John of God Hospital, Kalgoorlie, to be regions within the meaning of section 12 of the Medical Act, 1894-1968.

ADMINISTRATION ACT, 1903-1972.

PURSUANT to the powers conferred by the Administration Act, 1903-1972, the Supreme Court Act, 1935-1971, the Public Trustee Act, 1941-1972 and all other powers hereunto enabling, the Judges of the Supreme Court of Western Australia hereby make the following rules.

WHEREAS under the provisions of the Health Act, 1911, as amended, a local authority may make or adopt by-laws, and may alter, amend or repeal any by-laws so made or adopted: Now, therefore, the Shire of Victoria Plains, being a local authority within the meaning of the Act, and having adopted the Model By-laws described as Series "A" as reprinted, pursuant to the Reprinting of Regulations Act, 1954, in the *Government Gazette* of 9th August, 1956, doth hereby resolve and determine that the said adopted by-laws shall be amended as follows:—

Substitute for By-law 19 a new by-law to read as follows:—

Method of Disposal of Rubbish.

19. (1) No person other than an authorised employee of the Council or a person authorised in writing by the Council shall enter or be on any land or premises used by the Council for the depositing of refuse, garbage or rubbish except for the purposes of depositing of refuse, garbage or rubbish thereon.

(2) The Council may by means of signs indicate the place at which refuse garbage or rubbish may be deposited or the place at which refuse garbage or rubbish of a particular nature may be deposited.

(3) No person shall deposit any refuse, garbage or rubbish other than at a position on the land designated by an employee of the Council or as indicated by signs or any refuse garbage or rubbish of a particular nature other than in accordance with the signs or the directions of the Council's employee.

(4) No person other than an authorised employee of the Council or a person authorised in writing by the Council shall interfere with or remove any material or thing whatsoever from any land used by the Council for the deposit of refuse, garbage or rubbish.

(5) No person shall light or cause to be burnt any refuse, garbage or rubbish on any land used by the Council for the deposit of refuse, garbage and rubbish except on a site specified by the Council and under such conditions as the Council may impose.

(6) No person shall deposit any car body or other matter not easily compressible on any land under the control of the Council except at a place which is set aside for the purpose and in accordance with such conditions as the Council may from time to time impose.

(7) A person using a vehicle for disposing of material on land set aside by the Council for the depositing of refuse, garbage or rubbish shall cause the vehicle to be removed from the land immediately such vehicle has been emptied of material.

(8) No person shall park a vehicle except for the purpose of unloading the vehicle on land set aside by the Council for the depositing of refuse, garbage or rubbish unless authorised in writing by the Council to do so.

(9) At all times the Council may refuse acceptance of all refuse, garbage or rubbish arising from premises outside the Shire of Victoria Plains.

(10) Every person entering on land used by the Council for the depositing of refuse garbage or rubbish shall obey all reasonable directions and instructions issued by the authorised employees of the Council.

(11) A person who deposits or disposes of any refuse, garbage or rubbish other than at a place set aside by the Council for the purpose, or otherwise than in accordance with these By-laws, commits an offence.

2/1.1 The portion of the Scheme area (known as and hereafter called "Karawara") comprising approximately 178 acres of land bounded by Jackson Road, Kent Street, Manning Road, the extension of Gillon Street, Abjornson Street, Henley Street and Murray Street, being part of Lots 23 and 24 and the whole of Lot 25 of Canning Location 37 shown on Land Titles Office Plan Number 3383 and parts of Reserves 5987 and 5988 is hereby excised from the Quadruplex Residential QR5 Zone and the remainder is hereby included in various zones. The areas of the land which are so reserved and the areas of the land which are so included in those zones are delineated distinctly, coloured and identified as such on the Scheme Map which is hereby amended accordingly.

2/2.1 Clause 1.9 is amended by—

- (a) Inserting after the definition "aged persons' flat building" the following definition:—

"balcony" means a platform outside and protruding from the main structure of a building with access from an upper floor.

- (b) Inserting after the definition "building line" the following definition:—

"Building set back line" means the line drawn parallel with the boundary of an open space reserve and intersecting a wall or portion of a wall comprising part of a dwelling house or residential building at the point closest to that boundary on the particular lot.

- (f) Inserting after the definition "street alignment" the following definitions:—

"Student housing" means a residential building or buildings reserved for use solely by students and staff of an educational establishment and their immediate families, and includes—

- (a) self-contained dwelling units;
- (b) dwelling units having shared toilet or cooking facilities or both, provided such facilities are not shared by more than four persons of the same sex; and
- (c) residential colleges and hostels.

"take away foods shop" means a shop where the goods kept exposed or offered for sale by retail are mainly food for consumption off the premises.

2/2.2 Clause 3.1 is amended by—

- (a) deleting the words and figures "thirty-six (36)" and substituting therefor the words and figures "thirty-seven (37)";

- (c) provision to the satisfaction of the Council is made for the efficient removal of rubbish from each building by the Council or its agent;
- (d) the Council is satisfied that the buildings will not adversely affect the amenities of the locality and will not clash in harmony with the exterior designs of other buildings in the locality;
- (e) the buildings to be erected conform with the requirements laid down for such buildings in Part 5 of the Scheme.

2/2.18 Clause 5.36 (b) is amended by adding at the end of the clause the following:—

provided that the provisions of this clause do not apply to a fence, free standing wall or hedge erected, grown or maintained on land fronting cul-de-sac streets in the locality known as Karawara.

2/2.19 A new clause is added after clause 5.36 (b) as follows:—

5.36 (c). Any appliance used for the drying of clothes or article of domestic use in the open air shall be effectively screened by fences, courtyard walls or hedges of sufficient height to prevent the same being seen from a street, open space reserve, public place or private street fronting the premises on which such appliance is being used.

2/2.20 A new clause is added after clause 5.36 as follows:—

5.37. Erection and construction of fences, free standing walls in certain areas to be approved by Council: In Karawara:

- (a) no fence or free standing wall shall be erected unless the Council has first approved of its design, height and materials to be used in its construction. The Council shall not approve the erection of any such fence or wall unless it is satisfied that the same will not adversely affect the amenities of the locality. In giving its approval the Council may impose conditions governing the erection of such fences or walls which
 - (i) specify the height;
 - (ii) stipulate the type of materials to be used in the construction;
 - (iii) require gateways to be provided for vehicular access from streets;
 - (iv) specify portions of lots which shall not be enclosed, and places where no fence or free standing wall shall be erected;

- (b) The Council may require the applicant to submit such plans and details of any proposed fence or free standing wall in order that it may properly consider the application in respect of the provisions of subclause (a) to this clause;
- (c) No person shall alter or add to any fence or free standing wall without obtaining the approval of the Council to do so.


