PERTH MINT.

APPLICATIONS are invited from male persons for the position of Technical Assistant in the Perth Mint.

Applicants for this position must have attained matriculation standard and be prepared to proceed towards an Associateship or Bachelor Degree course in Applied Science, Metallurgy or Engineering at the W.A. Institute of Technology. If a candidate should already have embarked on such a course, so much the better.

The salary range for a Technical Assistant is related to the classification of G-VII-1/3 in the State Public Service, i.e., \$1 860 per annum at age 15 years to \$4 025 per annum at age 20 years. On reaching the age of 21 years, a Technical Assistant is promoted to Technical Officer (\$5 853-\$8 096 per annum) provided he has reached an approved academic level (a completed full-time first year course).

On the attainment of Diploma level, a Technical Officer may be further promoted to a higher salary range (\$8 534-\$9 263 per annum).

On completing a degree or associateship the officer may proceed to Level 1 of the Scientific Officers' Agreement (maximum \$9 263 per annum).

The Perth Mint is administered under the Perth Mint Act, 1970 and conditions for salaried staff are similar to those applying in the State Civil Service.

THE recently established Industrial and Commercial Employees' Housing Authority is seeking a Secretary to head its small office establishment. The Secretary will be the Executive Officer of the Authority and will be responsible for the usual secretarial functions. The Secretary will be required to discuss proposals with participating employers and reach firm arrangements on within policy decisions determined beforehand for confirmation by the Authority.

The Authority is set up to assist in the provision of housing for industrial and commercial ventures either by way of direct provision of housing from its own funds or by guarantees for private borrowing for housing finance. Construction and maintenance will be done for the Authority by the State Housing Commission.

The successful applicant must have a high degree of initiative, a capacity to accept change and innovation, sound knowledge of Government and private sector financing, an ability to assemble and analyse a range of relevant facts, and willingness to travel throughout the State.

The successful applicant will be appointed on a seconded basis and will retain all rights and privileges under the Public Service Act.

LIQUOR ACT, 1970-1973.

THE Licensing Court acting pursuant to the powers conferred by the Liquor Act, 1970-1973, hereby makes the following rules—

LICENSING COURT RULES, 1970.

- Citation. 1. In these rules the Licensing Court Rules, 1970 published in the *Government Gazette* on the 7th July, 1970 and amended from time to time thereafter by notices so published are referred to as the principal rules.
- Rule 13 amended. 2. Rule 13 of the principal rules is amended—
- (a) as to subrule (1), by deleting the first word "The" and substituting the following passage—
"Subject to subrule (3) of this rule the"; and
- (b) by adding after subrule (2) a new subrule as follows—
- (3) The Court may accept plans and specifications drawn to a scale otherwise than that prescribed by the Second Schedule if, in the particular circumstances, the plans and specifications are adequate and reasonable and it appears to the Court that it would be a harsh and onerous burden on the applicant for him to lodge plans and specifications that conform with the scale prescribed.
- Rule 18A substituted. 3. The principal rules are amended by deleting rule 18A and substituting the following new rule:—
- 18A. An application for a packet licence permit shall specify—
- (a) the name of the vessel and the address or name of the place at which it is moored;
- (b) the name and address of the proprietor of the vessel;
- (c) the date and the hours for which the permit is required;
- (d) type of occasion;
- (e) name of club, organisation or association;
- (f) the common interest shared by the passengers; and
- (g) an estimate of the number of passengers expected to be in attendance on the vessel.
- Rule 19 substituted. 4. The principal rules are amended by deleting rule 19 and substituting the following new rule:—
19. An application for a lodger's permit shall specify—
- (a) the name and address of the licensed premises; and
- (b) the details of accommodation provided for the travelling public on the licensed premises.
- Rule 20 substituted. 5. The principal rules are amended by deleting rule 20 and substituting the following new rule:—
20. An application for a late delivery permit shall specify the name and address of the licensed premises and details of the nature of the business conducted thereon requiring the making of late deliveries of liquor sold there.
- Rule 21 substituted. 6. The principal rules are amended by deleting rule 21 and substituting the following new rule:—
21. An application for a reception area permit shall specify the name and address of the licensed premises, the type of licence held, and the part of the premises in which liquor is to be sold and supplied.
- Rule 22 substituted. 7. The principal rules are amended by deleting rule 22 and substituting the following new rule:—
22. An application for an unlicensed club permit—
- (a) shall specify—
- (i) the name and address of the club; and
- (ii) the days of the week and the hours for which the permit is required to operate; and
- (b) shall be accompanied by a copy of the rules of the club governing admission to membership.

Rule 24
added.

8. The principal rules are amended by adding after rule 24 the following new rule:—

25. (1) At the hearing of an application the Court may, in the absence of any contrary evidence, accept any document endorsed, in the form as set out in subrule (2) of this rule, by the principal clerk, as being a document forming part of that application.

BROOME TOWN PLANNING SCHEME No. 1—
SHIRE OF BROOME.

THE Council of the Shire of Broome, under and by virtue of the powers conferred upon it in that behalf by the Town Planning and Development Act, 1928 (as amended), hereby makes the following Town Planning Scheme for the purpose of—

- (a) setting aside land for future public use as reserves;
- (b) controlling land development;
- (c) other matters authorised by the enabling Act.

PART I.—PRELIMINARY.

1.1 Scheme Title: This Town Planning Scheme may be cited as the Broome Town Planning Scheme No. 1, Shire of Broome, hereinafter called "the Scheme" and shall come into operation on the publication of notice of the Minister's final approval thereof in the *Government Gazette*.

1.2 Scheme Area: The Scheme shall apply to the whole of the land set out in the maps forming part of the Scheme.

1.3 Responsible Authority: The responsible authority for carrying out the Scheme is the Council of the Shire of Broome (hereinafter referred to as the Council).

1.4 Scheme Documents: The Scheme consists of the following documents:

- (1) The Scheme Text: The Scheme Text is divided into the following parts:—

Part I.—Preliminary

Part II.—Reserved Land

Part III.—Zones

Part IV.—Non-conforming Uses

Part V.—General Provisions

Part VI.—Finance and Administration

- (2) Land Use Maps, and

- (3) Scheme Map, Sheet 1 and Sheet 2.

1.5 Planning Scheme Interpretations: In the Scheme the terms used will have the respective interpretations set out in Appendix "D" of the Town Planning Regulations 1967, unless otherwise specified by the Scheme.

1.6 Definitions in the Scheme: Unless inconsistent with the context or subject matter or some other meaning is clearly intended—

"hospital—veterinary" means any or part of a building or land, in which animals or household pets are received and lodged for medical treatment or care and the expression includes a kennel for boarding of animals;

"Rural use" means the use of land or building for growing, rearing or producing of primary products (exclusive of extractive industries) and the expression includes farming, market gardens, poultry farms, aviaries, apiaries and nurseries;

"Trade display" means the use of land or building for the display of goods for advertising purposes;

"Warehouse" means any building or enclosed land, or part of a building or enclosed land, used principally for the storage of goods but may include the carrying out of commercial transactions involving the sale of such goods by wholesale or retail.

1.7 Relation of Scheme to Any By-laws: The provisions of the Scheme shall have effect immediately after the Scheme comes into operation and where the provisions of the Scheme are inconsistent with the provisions of any by-laws, the provisions of the Scheme shall prevail.

1.8 Appeal Rights: Any person aggrieved by a decision of the Council exercising the discretionary powers embodied in Part III and V of the Scheme Text, may appeal from such decision to the Minister for Town Planning, who may uphold, reverse or vary the decision of the Council, and the order of the Minister shall be final and binding.

PART II.—RESERVED LAND.

2.1 (a) Reservation of Land: Land set aside under the Scheme for the purposes of a reservation is deemed to be reserved for the purposes indicated on the Scheme Map.

(b) Development of Reserved Land: Except as otherwise provided in this Part a person shall not carry out any development on land reserved under the Scheme, other than the erection of a boundary fence, without first applying for and obtaining the written approval of the Council.

(c) Approval of Development: In giving its approval the Council shall have regard to the ultimate purpose intended for the reserve and shall in the case of land reserved for the purposes of a public authority, confer with that Authority before giving its approval.

(d) Existing Use Rights: No provision of this Part shall prevent the continued use of land for the use for which it was being lawfully used immediately prior to the Scheme having the force of law, or the repair and maintenance, for which the prior consent in writing of the Council has been obtained, or buildings or works lawfully existing on the land.

2.2 (a) Injurious Affection: Where a Council refuses approval for the development of land reserved under the Scheme on the ground that the land is reserved for public purposes, or grants approval subject to conditions that are unacceptable to the applicant the owner of the land may, if the land is injuriously affected thereby, claim compensation for such injurious affection.

(b) Claims for Compensation: Claims for such compensation shall be lodged at the office of the Council not later than six months after the date of the decision of the Council refusing approval or granting it subject to conditions that are unacceptable to the applicant.

(c) Council may Purchase: In lieu of paying compensation the Council may purchase the land affected by such decision of the Council at a price not exceeding the value of the land at the time of refusal of approval or of the grant of approval subject to conditions that are unacceptable to the applicant.

PART III.—ZONES.

3.1 Types of Zones: The Scheme Area is divided into the following zones:—

- (1) Residential Zone.
- (2) Chinatown Zone.
- (3) Commercial Zone.
- (4) Industrial Zone.
- (5) Rural Zone.
- (6) Specific Use Zone.

3.2 Zoning Table Explanation: Table I appended to clause 3.3 of this Part indicates the several uses permitted by the Scheme in the various Zones, such uses being determined by cross reference between the list of "Use Classes" on the left hand side of the Table and the list of "Zones" on the top of the Table.

3.3 Meanings of Symbols: The meanings of the symbols used in Table I appended to this clause are as follows:—

"P"—A use that is permitted under the Scheme;

"AA"—A use that is not permitted unless Council gives its approval in writing after giving consideration to the possible effect that such a use would have on the amenity, public health, convenience and economies of the existing or planned uses nearby;

"IP"—A use that is not permitted unless such use is incidental to the predominant use as decided and approved by the Council; and,

"X"—A use that is not permitted.

Permitted Uses are limited to those specifically shown on the Scheme Map.

3.4 Use Classes: In respect of any use that is not specifically listed in Table I, the Council shall determine in which Zone or Zones the use may be permitted with or without conditions, as the Council deems fit.

3.5 Change of Use Classes: No person may change the use of any building or land, however zoned, from one use class to another use class unless the prior approval in writing of the Council has been obtained.

PART IV.—NON-CONFORMING USE OF LAND.

4.1 Existing Use Rights: No provision of the Scheme shall prevent:—

- (1) the continued use of any land or building for the purposes for which it was being lawfully used at the time of the coming into force of the Scheme; or
- (2) the carrying out of any development thereon for which, immediately prior to that time, a permit or permits required under the Town Planning and Development Act, 1928 (as amended), or any other law authorising the development to be carried out had been duly obtained and was current.

4.2 (a) Non-conforming Use of Reserved Land: Where in respect of land reserved under Part II of the Scheme a non-conforming use exists or was authorised as mentioned in clause 4.1 of this Part on that land all or any erections, alterations or extensions of the buildings thereon or use thereof shall not be carried out unless the approval of the Council has been obtained in writing;

(b) Extension of Buildings: Where in respect of land zoned under Part III of the Scheme a non-conforming use exists or was authorised as

mentioned in clause 4.1 of this part on that land, and provided the prior consent in writing of the Council has been obtained, buildings may be extended to the limits prescribed by the Uniform Building By-laws made under the Local Government Act, 1960 (as amended), or by any other by-laws made under that Act for the purpose of limiting the size, location and distance from boundaries and any other matter required by law for that class of use within the boundary of the lot or lots on which the use was carried on immediately prior to the coming into force of the Scheme.

4.3 Change of Non-conforming Use: The Council may permit the use of any land to be changed from one non-conforming use to another non-conforming use, provided the proposed use is, in the opinion of the Council, less detrimental to the amenity of the neighbourhood than the existing use, or is in the opinion of the Council closer to the intended uses of the zone.

4.4 Discontinuance of Non-conforming Use:

- (1) Notwithstanding the preceding provisions of this Part except where a change of non-conforming use has been permitted by the Council under clause 4.3, when a non-conforming use of any land or building has been discontinued, such land or building shall not thereafter be used other than in conformity with the provisions of the Scheme.
- (2) The Council may effect the discontinuance of a non-conforming use by the purchase of the affected property, or by the payment of compensation to the owner or the occupier or to both the owner and the occupier of that property, and may enter into an agreement with the owner for that purpose.

PART V.—GENERAL PROVISIONS.

5.1 Residential Development: For residential development, unless otherwise specified in the Scheme, the site restriction provisions of General Residential Zone—Class 4 (GR-4) as specified in and for the purpose of the Uniform Building By-laws, 1965 (as amended), shall apply.

5.2 Setbacks from Boundaries: The minimum setbacks from boundaries shall not be less than the setbacks given below:—

5.3 Clearance in Front of Building Line: A person shall not stock and place any fuel or raw materials or waste of manufacture in front of a building line other than the building of a service station or petrol filling station.

5.4 Vehicular Parking Spaces: The Council, at its discretion, may require any owner of land to make provision for vehicular parking or loading spaces to be used in conjunction with the use of the land.

5.5 Traffic Entrances: Where in the opinion of the Council, the siting and or design of any means of vehicular or pedestrian access to and from a street reserve seem likely to create a traffic hazard, the Council may require the owner to redesign and or reposition such means of access as it may direct. Where the Council considers that separate entrances to and exits from any lot for road vehicles are desirable for the avoidance of traffic hazards on public roads adjacent thereto it may require the owner to provide such entrances and exits as it may direct.

5.6 Obstruction in Corner Lots: Any structure, shrubs or plantings in any corner lot that in the opinion of the Council, may obstruct visually, shall not be permitted. The Council may order the re-

moval, repositioning or pruning of such structure, shrubs or plantings that in its opinion, may create or cause a traffic hazard to motorists or pedestrians and the owner or occupier shall comply with such order.

5.7 Appearance of Buildings: All buildings and land shall be maintained to preserve the amenity of the surrounding areas and no building shall be so designed or constructed or finished or left unfinished that its external appearance would disfigure the locality or tend to depreciate the value of the surrounding properties.

5.8 Dwellings Incidental to Industrial Uses: A dwelling on land forming part of or adjoining a factory occupied by a caretaker of or an employee of the factory and set aside for the exclusive use of the occupants may be allowed if the Council is satisfied that such a dwelling is necessary for the proper operation of the industry, but not more than one such dwelling for each establishment or industry or lot may be permitted.

5.9 Special Development Control in Chinatown Zone: The Council may impose any conditions on any development in the Chinatown Zone with the object of preserving and maintaining the existing architectural form and character of the area.

PART VI.—FINANCE AND ADMINISTRATION.

6.1 Acquisition of Land: The Council may acquire land for the purpose for which it is reserved in the Scheme, in accordance with the Act and in conformity with the provisions of the Scheme.

6.2 Disposal of Land: The Council may deal with or dispose of any land which it owns or which it has acquired pursuant to the provisions of the Scheme, in accordance with the Act and in conformity with the provisions of the Scheme, and for such purpose may make such agreements with other owners as it deems fit.

6.3 Compensation: Claims for compensation by reason of the Scheme other than for the purpose of Part II shall be made not later than six months from the coming into operation of the Scheme.

6.4 Entry to Premises: The Council may, by its Shire Clerk or any officer authorised by him, enter at all reasonable times any building or land for the purpose of ascertaining whether the provisions of the Scheme are being observed.

6.5 Penalties: Any person who fails to comply with any of the provisions of the Scheme is guilty of an offence and without prejudice to any other remedy given herein is liable to such penalties as are prescribed by the Act.

6.6 Development Approval: The Council shall not approve any application to commence development unless the proposed development complies with the provisions of the Scheme.

THE Town of East Fremantle under and by virtue of the powers conferred upon it in that behalf by the Town Planning and Development Act, 1928 (as amended) and all other powers enabling it hereby makes the following Town Planning Scheme.

PART I.—PRELIMINARY.

Citation.

1. This Town Planning Scheme may be cited as Town of East Fremantle Town Planning Scheme No. 1—District Scheme (hereinafter called "the Scheme").

Arrangement of Scheme Text.

2. The Scheme Text is divided into parts as follows:—

Part I.—Preliminary: Clauses 1-8.

Part II.—Zones: Clauses 9-23A.

Part III.—Regional Reservations: Clauses 24A.

Part IV.—Miscellaneous: Clauses 25-32.

Part V.—Development: Clauses 33-40.

Part VI.—Non-conforming Uses of Land:
Clauses 41-45.

Part VII.—Preservation and Conservation of
Objects of Natural Beauty and Historical
Buildings and Objects of Historic or
Scientific Interest: Clauses 46-57.

Part VIII.—Administration: Clauses 58-61.

Responsible Authority.

3. The authority responsible for enforcing the observance of the Scheme is the Town of East Fremantle (hereinafter called "the Council").

Scheme Area.

4. The Scheme shall apply to the whole of the District of the Town of East Fremantle and this area is the land contained within the inner edge of a broken black line on the Land Use Map and is herein referred to as the Scheme Area.

Maps.

5. The following Maps are attached to this Text and form part of the Scheme:—

Land Use Map.

Scheme Map.

General Objects.

6. The general objects of the Scheme are to zone the Scheme Area for the purposes in this Scheme described and to make provisions as to the nature and location of buildings and the size of lots when used for certain purposes, the preservation of objects of natural beauty, of historical buildings and objects of historical or scientific interest and to make provision for other matters necessary or incidental to town planning or housing.

Interpretation.

7. In this Scheme unless the context otherwise requires the following terms shall have the meaning set out hereunder respectively:—

"Absolute Majority" means a majority of the total number of the members for the time being of the Council whether present or not.

"Car Park" means a site or building used primarily for parking private cars or taxis whether as a public or private car park, but does not include any part of a public road used for parking or for a taxi rank, or any land or buildings on or in which cars are displayed for sale.

"Caretaker's House" means a building used as a residence by the proprietor or manager of a business recreation area or other organisation carried on or existing upon the same site or by a person having the care of the grounds the building or the plant and equipment thereof.

"Consulting Rooms" means a building or part of a building (other than a hospital) used in the practice of his profession by a legally qualified medical practitioner or dentist, or by a physiotherapist, chiropractor, a masseur or a person ordinarily associated with a medical practitioner in the investigation or treatment of physical or mental injuries or ailments.

"Duplex House" means a building comprising two dwellings each being complete and self-contained.

"Eating House" means any house building or structure or any part thereof in which meals are served to the public for gain or reward.

The term does not include—

(a) Any premises licensed under the Licensing Act, 1911 other than a restaurant within the meaning of Section 44G of that Act in respect of which a Restaurant Licence under that Act is granted, or

(b) Any boarding house, lodging house or hostel, or

(c) Any building or other structure used temporarily for serving meals to the public at any fair, show, military encampment, races or other public sports games or amusements.

"Educational Establishment" means a school, college, university, technical institute, academy or other educational centre or a lecture hall, but does not include a reformatory institution or institutional home.

"Effective Frontage" means the length of the lot boundary which is on the street alignment or the width of the lot at the minimum distance from the street alignment at which buildings may be constructed whichever is the greater. If the lot has two or more boundaries on a street alignment then the least of the measurements shall be considered for ascertaining the effective frontage.

"Flat" means a separate and self-contained dwelling within a building containing two or more dwellings.

"Gazettal Date" means the date on which notice of the approval of the Minister to this Scheme is published in the *Government Gazette*.

"Group Housing" means two or more dwellings that are continuous or closely related and each of which has access to its own private garden and does not have another dwelling or part of a dwelling constructed above it.

"Home Occupation" means a business carried on within a dwelling or the curtilage of a dwelling—

- (a) that does not cause injury to or prejudicially affect the amenity of the neighbourhood including (but without limiting the generality of the foregoing) injury or prejudicial affect due to the emission of light, noise, vibration, electrical interference, smell, fumes, smoke, vapour, steam, soot, ash, dust, grit, oil, liquid wastes or waste products.
- (b) that does not entail the employment on the premises of any person not a member of the occupier's family.
- (c) that does not occupy an area greater than 19 square metres (19 m²).
- (d) that does not require the provision of any essential service main of a greater capacity than normally required in the zone in which it is located, and
- (e) for which there is not more than one advertisement sign and that not exceeding 0.2 m² in area.

"Institutional Building" means a building used or designated for use wholly or principally for the purpose of—

- (a) a hospital or sanatorium for the treatment of infectious or contagious diseases.
- (b) a house or other institution for care of State wards orphans or persons who are physically or mentally handicapped.
- (c) a hospital for treatment or care of the mentally sick.

"Institutional Home" means a residential building for the care and maintenance of children, the aged or the infirm and includes a benevolent institution, but does not include a hospital or mental institution.

"Marine Filling Station" means land and buildings used for the storage and supply of liquid fuels and lubricants for marine craft, but in which no industry is carried on; but does not include a service station.

"Medical Clinic" means a premises in which facilities are provided for more than one medical or dental practitioner, physiotherapist, chiropractor or masseur.

"Objects of Natural Beauty" mean the natural beauties of the area including lakes and other inland waters, banks of rivers, foreshores of harbours and other parts of the sea, hill slopes and summits and valleys.

"Office" means the conduct of administration, the practice of a profession, the carrying on of agencies, banks, typist and secretarial services and services of a similar nature, or where not conducted on the site thereof, the administration of or the accounting in connection with an industry.

"Service Station" means land and buildings used for the supply of petroleum products and automotive accessories and includes greasing, tyre repairs and minor mechanical repairs.

"Shop" means any building wherein goods are kept exposed or offered for sale by retail, and includes a cafe and a restaurant and receiving depot; but does not include a bank, fuel depot, an open market or a wholesale market, service station, petrol filling station, milk depot, marine store, timber yard or land and buildings used for the sale of motor and other vehicles, or for any purpose falling within the definition of industry.

"Uniform Building By-laws" means the Uniform Building By-laws 1965, published in the *Government Gazette* on the 22nd October, 1969 and amended.

"Vehicles" includes tractor.

8. The words and expressions used in this Text shall unless the context otherwise requires or unless otherwise provided herein have the meanings assigned to them in Appendix D to the Town Planning Regulations 1967.

PART II.—ZONES.

Classification.

9. There are hereby created the several Zones set out hereunder:

- (1) Single Residential.
- (2) Single Residential and Group Housing.
- (3) Multiple Housing.
- (4) Licensed Hotel.
- (5) Motel.
- (6) Business.
- (7) Parking.
- (8) Service Station.
- (9) Private Clubs and Institutions.

Zone Notation.

10. The said zones are delineated and coloured on the Scheme Map according to the legend thereon.

Uses.

11. The Zoning Table at the end of this Part indicates, subject to the provisions of this Scheme, the uses permitted in the various zones shown in the Zoning Table. The uses are determined by cross reference between the list of Use Classes on the left hand side of the Zoning Table and the list of Zones at the top of the Zoning Table. The symbols used in the cross reference in the Zoning Table have the following meanings:—

"P"—A use that subject to Clause 34 is permitted by the Scheme.

"PS"—A use that is permitted only if special approval is given by the Council.

"X"—A use that is not permitted.

12. Where in the Zoning Table a particular use is mentioned it is deemed to be excluded from any use class which by its more general terms would otherwise include such particular use.

13. If a particular use or purpose is not mentioned in the list of use classes or is not included in the general terms of any of the use classes such use or purpose shall unless it is permitted by the subsequent provisions of the Scheme be deemed to be prohibited.

13A. In respect of any use that is not expressly provided for in the Zoning Table the Council shall on application determine the Zone or Zones if any in which the use may be permitted with or without conditions as the Council deems necessary.

Special Zones.

14. In addition to the Zones mentioned in Clause 9, there are hereby created Special Zones.

15. Those portions of the Scheme Area which are specified in the Schedule hereto are classified as Special Zones.

16. Notwithstanding that a parcel of land described in the Schedule is within another Zone the land or any building or structure thereon may be used for the purpose set against that parcel of land in the said Schedule in addition to the other uses permitted in the Zone in which the land is situated.

Application for Special Approval of Council.

17. Any person who desires to use land for a purpose which by the provisions of this Scheme is only permitted if special approval is given by the Council shall make application for such approval to the Council in writing.

18. The application shall state the following particulars:—

- (a) The full name and address of the applicant.
- (b) A description of the land and the particulars of the Certificate of Title.
- (c) The names and addresses of the registered proprietors and of all other persons having an interest in the land and the nature of their interest.
- (d) The nature of the applicant's interest in the land.
- (e) The purpose for which the applicant desires to use the land.
- (f) The nature of the building and other improvements now on the land.
- (g) The nature of the buildings and other improvements the applicant desires to construct on or make to the land.

19. (1) The Council shall consider the application and may refuse its approval or may resolve to recommend to a subsequent meeting of the Council that approval be granted. If the Council resolves to recommend that approval be granted it shall refer the matter to a subsequent meeting of the Council to be held not less than three weeks nor more than six months after the passing of the resolution recommending approval.

(2) The Council may resolve that notice be given to ratepayers likely to be affected by the granting of the approval and in that case it shall notify the applicant of the names and addresses of all persons who according to the Rate Book are rateable owners of land within an area to be specified by the Council likely to be affected by the granting of the application.

(3) The Council shall require notice to be given to ratepayers likely to be affected if the proposed use is likely to be carried on at night or is likely to cause noise or to cause an assembly of persons or vehicles.

20. If so directed by the Council the applicant shall—

- (a) cause to be sent by certified post to the owners whose names and addresses have been given to him by the Council and to all persons having an interest in the land the subject of the application a copy of his application to the Council; and
- (b) cause to be published in a newspaper circulating in the Scheme Area notice of the application setting out in an abbreviated form the information contained in his application and stating that objections may be made to the Council within twenty-eight days from the publication of the said notice.

21. At a subsequent meeting of the Council held, if notices have been given, after the expiration of twenty-eight days from the publication of the said notice and after the expiration of twenty-eight days from the posting of the said notices to the owners whichever is the later, the Council shall again consider the application and decide whether to grant or withhold its approval or grant its approval upon conditions.

22. In making its decision on applications for its special approval the Council shall take into consideration the following matters:—

- (a) The provisions of any Town Planning Scheme including this Scheme affecting the land the subject of the application or affecting land in the vicinity.
- (b) The nature of the proposed development in relation to the development of any land within the vicinity of the said land.
- (c) The size, shape and character of the parcel of land to which the application relates and the nature and siting of the proposed building, the view from the building and the interruption of view likely to be caused by the proposed building.
- (d) Any representations which may be made by any statutory authority.
- (e) The existing and likely future amenity of the neighbourhood, including (but without limiting the generality of the foregoing) the question of whether the proposed development is likely to cause injury to such amenity including injury due to the emission of light, noise, vibration, smell, fumes, smoke, vapour, steam, soot, ash, dust, grit, oil, liquid wastes or waste products.
- (f) The nature of the roads giving access to the said land.
- (g) What parking facilities are available or proposed and the likely requirements for parking.
- (h) Such other matters as the Council considers relevant.

23. The Council may enter into agreements with the Applicant whereby the applicant covenants for himself and his transferees to carry out and observe the conditions (if any) imposed by the Council in granting its approval as aforesaid.

23A. (1) It is intended that the lands delineated on the Scheme Map as Redevelopment Areas be progressively redeveloped for residential purposes and for business and other uses associated with residential development.

(2) Owners of land within a Redevelopment Area who wish to redevelop their land shall submit an Outline Development Plan to the Council.

(3) If the Council shall approve the Outline Development Plan in principle it shall submit it to the Town Planning Board.

(4) If the Town Planning Board shall approve the Outline Development Plan in principle and the

proposals do not conform to the Scheme Map the appropriate procedure for an amendment to the Scheme shall be followed.

PART III.—RESERVATIONS.

24. The lands shown on the Scheme Map as Regional Open Space and Highway Reserves are lands reserved by the Metropolitan Region Planning Authority pursuant to the Metropolitan Region Scheme or intended by it so to be and are shown on the Scheme Map in order to comply with the Metropolitan Region Town Planning Scheme Act, 1959 as amended. The said lands are not reserved by this Scheme.

Industry, Panel Beating, Car Wrecking, the storage, manufacture or burning of cray pots.

24A. The lands shown on the Scheme Map as Waterway Reserves, Public Open Space Reserves and Public Purposes Reserves are reserved for those purposes respectively. The said lands are owned by the Crown or by the Council.

PART IV—MISCELLANEOUS.

Residential.

25. Paragraphs A, B, C & D of By-law 213 (4) and Tables 213A (GR 4), 213B (GR 5) and 213C (GR 6) of the Uniform Building By-laws shall be deemed to have been modified by Table SR + GH set out hereunder and as so modified shall apply in the Scheme Area in accordance with the following provisions.

26. Subject to the provisions of this Part and to the Uniform Building By-laws and without affecting the restrictions imposed by the Zoning Table no person shall construct a building for residential purposes—

- (a) Within a Single Residential Zone unless in accordance with the relevant provisions of Table SR + GH.
- (b) Within a Single Residential and Group Housing Zone unless in accordance with the relevant provisions of Table 213A (GR 4) of the Uniform Building By-laws as modified by Table SR + GH.
- (c) Within a Multiple Housing Zone unless in accordance with the relevant provisions of Table 213B (GR 5) of the Uniform Building By-laws as modified by Table SR + GH.

27. The Multiple Housing Zone is to be used for:—

- (a) All the uses permitted in a Single Residential and Group Housing Zone; and
- (b) Flats up to a maximum plot ratio of .5 and otherwise as for GR 5.

Provided that the Council may restrict the height of Flats to three floors if a greater height on the particular lot would in the opinion of the Council seriously prejudice the amenity of or the provisions of sunlight to or the view from a lot adjoining it or in close vicinity to it.

28. The following conditions shall apply to Group Housing:—

- (a) For patio and terrace houses, a minimum of three units to be established.
- (b) Where groups of terrace houses exceed 36.6 m in frontage length provision shall be made for a pathway of at least 1 metre width.
- (c) Adequate access to the rear of any group of patio or terrace houses shall be provided for the removal of rubbish from each of the houses in that group.
- (d) Each patio or terrace house shall have a parking space for at least 2 cars, one of which spaces shall be protected by an open sided carport of at least 5.5 m in length and 2.4 m in width set back a minimum of 5.5 m from the front boundary.

(e) Access to the car parking spaces provided pursuant to this clause may be provided from a street or right-of-way provided that any such right-of-way is not less than 7.6 m in width.

(f) Every patio house shall have an open courtyard of not less than 50 square metres.

(g) The minimum distance at which a patio or terrace house shall be setback from its rear boundary shall be increased by the length of any carport erected between such house and such boundary.

29. No person shall on privately owned land within any of the Zones mentioned in Clause 26:—

(a) Park or allow to remain stationary for more than four hours consecutively—

(i) more than two commercial vehicles and if there are two such vehicles one at least must be housed in a domestic garage or domestic out-building;

(ii) any vehicle which due to size or load is not capable of being completely housed within a domestic garage or domestic out-building having a maximum floor area of 50 square metres and in which no horizontal dimension is more than 15 metres;

(iii) a vehicle which together with the load thereon exceeds 2.70 m in height.

(b) Repair service or clean a commercial vehicle unless such work is carried out whilst the vehicle is housed in a domestic garage or domestic out-building.

Miscellaneous Building Standards.

30. Subject to the provisions of the Scheme no person shall develop any land or use any building for any of the purposes mentioned in Column 1. of the Building Table unless such development is in accordance with the standards set against such purpose in the said Table.

Relaxation of Standards.

31. Subject to the provisions of the Uniform Building By-laws the Council may either generally or in any particular case relax the requirements of this Part if the resolution to do so is passed by an absolute majority of the Council and confirmed within six months by an absolute majority of the Council at a subsequent meeting.

General Appearance of Buildings.

32. No person shall construct—

- (a) a building which has an exterior design that is out of harmony with existing buildings.
- (b) an ugly building that may destroy local amenities.

PART V.—DEVELOPMENT.

Council's Approval Necessary.

33. In addition to a Building Licence, Council's prior approval to commence development is required for all development except a private dwelling house or duplex house.

Application for Approval.

34. Application to the Council for its approval to commence development shall be made on the same or similar form as that used for applications for approval to commence development under the Metropolitan Region Scheme.

Council's Approval.

35. The Council may grant its approval with or without conditions or may refuse to grant its approval to the application to commence development.

36. If the Council shall have granted its approval to commence development subject to conditions and any of the conditions shall not be fulfilled or complied with the Council may revoke its approval.

37. The Council may limit the time for which its approval to commence development remains valid.

38. If the Council shall not within sixty days of the receipt by it of an application to commence development have conveyed its decision to the applicant the application shall be deemed to have been refused.

Appeal.

39. Should an owner be aggrieved by a decision of the Council exercising a discretionary power conferred upon it by the Scheme he may appeal in accordance with Part V of the Act.

Prohibition.

40. In cases where Council's approval is required to commence development no person shall commence development without the approval of the Council or carry out any development otherwise than in accordance with the conditions of the Council's approval.

PART VI.—NON-CONFORMING USES OF LAND.

41. If at the gazettal date any land building or structure is being lawfully used for a purpose or in a manner not permitted by the foregoing provisions of this Scheme (hereinafter called "a non-conforming use") the non-conforming use may continue subject to the following restrictions:—

- (a) the non-conforming use shall not be extended beyond the boundaries of the lot or lots upon which it was carried on at the gazettal date;
- (b) if the buildings in which the non-conforming use is carried on are wholly within one lot only then such buildings shall not be extended beyond the limits of that lot;
- (c) if the building or buildings in which the non-conforming use is carried on are constructed on more than one lot such non-conforming use shall be restricted to the land on which the building stands or the buildings stand and such land which is adjacent to the building or buildings and not being used for any other purpose authorised by the Scheme as is reasonably required for the purpose for which the building or buildings is or are being used;
- (d) no building which is subject to any of the special restrictions contained in this Scheme shall be altered or extended unless it conforms to the relevant provisions of the Scheme or unless with the special approval of the Council.

42. If a non-conforming use shall after the gazettal date be discontinued, or changed, no person shall subject to the following clause thereafter use the land or any building or structure thereon on which the non-conforming use was carried on for any purpose not permitted by this Scheme.

43. The Council may upon such conditions as it thinks fit permit the change of the non-conforming use to another non-conforming use if in the opinion of the Council the latter use is less prejudicial to the amenity of the area.

44. The Council may for the purpose of discontinuing any particular non-conforming use acquire the lot and buildings (if any) on or in which the use is or is permitted to be carried on or make agreements relating to the payment of compensation or moneys to persons willing to discontinue a non-conforming use.

45. Any person carrying on a non-conforming use shall within twelve calendar months of the gazettal date or within such extended time as the Council shall allow give to the Council in writing full information of the nature and extent of the non-conforming use.

PART VII.—PRESERVATION AND CONSERVATION OF OBJECTS OF NATURAL BEAUTY AND HISTORICAL BUILDINGS AND OBJECTS OF HISTORIC OR SCIENTIFIC INTEREST.

46. (1) The Council may resolve that it will consider whether an object of natural beauty specified in the resolution should be conserved.

(2) The Council may resolve that it will consider whether an historical building or an object of historical or scientific interest should be preserved.

47. If the Council shall pass one of the resolutions mentioned in the clause immediately preceding (hereinafter called "the preliminary resolution") it shall forthwith give notice of the resolution to:—

- (a) The owner of the land on which the object of natural beauty or the historical building or the object of historical or scientific interest is situated.
- (b) The occupier of such land if he is not the owner.
- (c) All other persons whose names appear on the Certificate of Title to the said land as having an interest therein.
- (d) The National Trust of Australia (W.A.).
- (e) The Royal Western Australian Historical Society (Inc.).
- (f) The Western Australian Tourist Development Authority.
- (g) Such other persons who in the opinion of the Council could give to it information which would assist the Council in arriving at a decision on the proposal.

48. The said notice shall inform the person to whom it is directed that the matter will be reconsidered by the Council after the expiration of two calendar months from the date of the passing of the said resolution and that any recommendations or objections made in writing to the Council by such person before that time will be considered. The notice shall also contain a copy of this Part of the Scheme.

49. The Council shall cause a copy of the preliminary resolution to be published in a newspaper circulating throughout the State of Western Australia and in a newspaper published in the Council's District if such exists.

50. After the expiration of two calendar months but not later than four calendar months from the passing of the preliminary resolution the matter shall be reconsidered by the Council.

51. The Council shall consider all written recommendations and objections submitted to it and may resolve that the object of natural beauty or the historical building or object of historical or scientific interest should be conserved or preserved as the case may be. If the Council shall pass the said resolution (hereinafter called "the preservation resolution") it shall give written notice thereof to all persons mentioned in Clause 52 hereof.

52. If the Council shall not within a period of six months from the passing of the preliminary resolution pass the preservation resolution the Council shall be deemed to have abandoned the proposal contained in the preliminary resolution and shall not pass a preservation resolution unless and until the procedure mentioned in this Part of the Scheme shall have again been followed.

53. The Council may purchase or subject to the Act resume the parcel of land on which the object of natural beauty or the historical building or object of historical or scientific interest mentioned in the preservation resolution passed by the Council is situated or so much thereof as is in the opinion of the Council necessary for the preservation of the said object or building.

54. The Council may—

- (a) enter into agreements with the owners or occupiers of land on which an object of natural beauty or historic building or object of historical or scientific interest is situated, for the preservation or conservation of such building or object whether a preservation resolution has been passed or not.
- (b) enter into agreements with any of the organisations named in paragraphs (d), (e) or (f) of Clause 47 hereof or with any other person for the preservation or conservation of any building or object mentioned in a preservation resolution passed by the Council; or if the owner thereof so agrees notwithstanding that no preservation resolution has been passed.
- (c) enter into agreements relating to the determination and settling of compensation.

55. Any person who is injuriously affected by the passing of a preservation resolution may within six months from the passing of the said resolution claim compensation from the Council.

56. If the parties cannot agree upon the amount of compensation payable it shall be determined by arbitration in accordance with the Arbitration Act 1895.

57. No person shall without the written consent of the Council—

- (a) within six months from the passing of a preliminary resolution, or
- (b) after the passing of a preservation resolution, make any alteration or addition to, damage, deface, demolish or remove any object of natural beauty, historic building or object of historical or scientific interest referred to in any such resolution.

PART VIII.—ADMINISTRATION.

Prohibition.

58. (1) No person shall use any land or any building or structure thereon contrary to or otherwise than in accordance with the provisions of this Scheme.

(2) If pursuant to the provisions of the Scheme approval has been granted by the Council upon conditions no person shall commit a breach of any of these conditions.

Powers of Council.

59. The Council in the conduct and management of this Scheme shall in addition to all other powers vested in it have the following powers:—

- (a) To enter and inspect any land or building within the Scheme Area.
- (b) To enter into agreements and arrangements with any of the owners of land within the Scheme Area.
- (c) To deal with or dispose of any land for the time being vested in it.

60. Twenty-eight (28) days' written notice is hereby prescribed as the notice to be given pursuant to Section 10 of the Act.

Compensation.

61. Claims for compensation by reason of this Scheme shall be made not later than six months from the date on which notice of approval of this Scheme is published in the *Government Gazette*.

COMMERCIAL HOUSEBOAT (LICENSING) REGULATIONS, 1974.

PART I.—PRELIMINARY.

Citation and arrangement. 1. (1) These regulations may be cited as the Commercial Houseboat (Licensing) Regulations, 1974.

(2) These regulations are divided as follows—

PART I.—PRELIMINARY.

PART II.—LICENSING OF HOUSEBOATS.

PART III.—REQUIREMENTS AS TO HULLS, MACHINERY, AND APPLIANCES OF HOUSEBOATS.

Division 1.—Hull and type of construction.

Division 2.—Propulsion and fuel systems.

Division 3.—Liquefied petroleum gas installations.

Division 4.—Electrical installations.

Division 5.—Other fittings and equipment.

PART IV.—OFFENCES.

SCHEDULE.

Definitions. 2. (1) In these regulations unless the contrary intention appears—
“Department” means the Harbour and Light Department of the State;

“houseboat” means a vessel within the meaning of paragraph (i) of section 183 of the Act that is held or let for hire or reward—

(a) as a place of habitation whether such use be temporary, intermittent or permanent;

(b) as a place for accommodating or receiving persons for purposes of shelter, recreation, entertainment or refreshment; or

(c) as club or business premises,

but does not include a vessel being temporarily used for any of the purposes referred to in paragraph (a), (b) or (c) of this definition if that vessel is normally employed in carrying goods or passengers, or both, for reward or plying for hire either for the carriage of goods or passengers, or both;

“regulation” means one of these regulations;

“surveyor” means a person appointed under the Act to survey ships;

“the Act” means the Western Australian Marine Act, 1948.

(2) These regulations apply to the use and navigation of houseboats in any waters within the jurisdiction.

PART II.—LICENSING OF HOUSEBOATS.

Application for license. 3. (1) Application for the grant of a license for a houseboat or for the renewal of such a license shall be made by the owner to the Department.

(2) The application shall be in writing and shall state—

(a) the name and address of the owner of the houseboat;

(b) the limits of the waters in which the houseboat is to operate;

(c) the address or location of the base from which the houseboat is to operate; and

(d) in the case of an application for the renewal of a license, the registered number allotted to the houseboat.

(3) In the case of an application for the grant of a license the application shall be accompanied by three copies of detailed plans and specifications of the houseboat.

Issue of license.

4. (1) On receipt of—

(a) an application made in accordance with regulation 3; and

(b) the appropriate fee determined in accordance with regulation 9 the Department may, subject to regulation 5,—

(c) where the application is for the grant of a license: allot a registration number for the houseboat in respect of which the application is made; and

(d) in every case: issue a license to the applicant.

Inspection by surveyor.

5. Whenever an application is made under regulation 3 the Department shall—

(a) arrange for the houseboat in respect of which the application is made to be inspected by a surveyor; and

- (b) give the applicant reasonable notice as to the date on which the inspection will take place and no license for that houseboat shall be granted or renewed under these regulations unless the surveyor, after inspecting the vessel is satisfied that—
- (c) the hull of the houseboat;
- (d) the machinery, and the installation thereof, upon the houseboat; and
- (e) the appliances and equipment, including lifesaving equipment, in and upon the houseboat,

are complete, sound and serviceable and comply with the provisions of these regulations.

Number of persons to be carried aboard houseboat. 6. (1) Where the Department wishes to attach to a license granted under these regulations a condition that not more than a specified number of persons shall be carried at any one time on the houseboat the subject of the license, that number shall, subject to subregulation (2) of this regulation be calculated by allowing one person to each square metre of the area of the deck of the houseboat.

(2) Notwithstanding subregulation (1) of this regulation a houseboat shall not be licensed to carry a greater number of persons than the number that can, having regard to the seaworthiness and stability of the houseboat, safely be carried by that houseboat in the waters in which she is to operate.

Duration of license. 7. A license granted under these regulations—

- (a) continues in force for a period, being not less than six months nor more than eighteen months, that is selected by the Department; and
- (b) may thereafter be renewed each year and, when renewed, continues in force for a period expiring on the next anniversary of the date of the termination of the period referred to in paragraph (a) of this regulation.

Renewal of license. 8. (1) Application for the renewal of a license for a houseboat shall be made not later than one month before the date on which that license is due to expire.

(2) Notwithstanding regulation 7 where the Department has received an application for the renewal of a license for a houseboat and it is impracticable or would occasion unreasonable or unnecessary expense or inconvenience to have the houseboat inspected by a surveyor on or before the date on which the license is due to expire, the Department may, by notice in writing to the owner, extend the operation of the license for any period not exceeding one month.

(3) A license that is extended under subregulation (2) of this regulation shall be deemed to continue in force until—

- (a) the expiration of the period of extension; or
 - (b) the license is renewed under these regulations,
- whichever occurs first.

Fees. 9. The fees payable on applications for the grant or renewal of licenses under these regulations shall be those set out in the following table:—

Type of application	Fee
For grant of license	\$26 plus a further \$2 for each whole month of the period for which the license is granted.
For renewal of license	\$50.

License to be exhibited. 10. The current license issued for a houseboat under these regulations shall be kept on board the houseboat and shall at all times be exhibited in a frame in a conspicuous place inside the enclosed structure of the houseboat so that it is available for inspection by any person on board.

Alterations to be notified. 11. The owner of a houseboat that is the subject of a current license under these regulations shall not make any alteration, or cause or permit any alteration to be made to the hull, machinery, appliances or equipment of the houseboat, unless he has first submitted details of the proposed alteration to the Department and received written notification from the Department that the alteration is approved.

Transfer of license. 12. (1) Where the owner of a houseboat sells or otherwise disposes of the houseboat he shall—

- (a) forthwith furnish the current license for the houseboat to the new owner; and
- (b) within seven days of the sale or disposal, notify the Department in writing of the sale or disposal of the houseboat and of the name and address of the new owner.

(2) Application for the transfer of the license for a houseboat that has been sold or disposed of shall be made within fifteen days of the sale or disposal, in the form of Form 1 in the Schedule to these regulations and on receipt of—

- (a) the current license; and
- (b) a fee of two dollars,

the Department may transfer the license and forward it, suitably endorsed, to the new owner of the houseboat.

- Register of use and servicing. 13. (1) The owner of a houseboat shall keep or cause to be kept a register containing the following information in relation to that houseboat, namely—
- (a) in respect of each occasion on which the houseboat is let for hire: the name and address of the person hiring the houseboat and the date on which and period for which the houseboat was hired;
 - (b) in respect of each occasion on which the houseboat is serviced under the provisions of regulations relating to commercial houseboats made under the Health Act, 1911: the place at which and date on which that service was carried out.
- (2) The register referred to in subregulation (1) of this regulation shall be available at all reasonable times for inspection by officers of the Department, or of the Department of Public Health of the State, or of the council of any municipality in whose district the houseboat to which the register relates is licensed to operate.
- Change of address etc. to be notified. 14. The owner of a houseboat shall—
- (a) within fourteen days of any change in his address notify the Department in writing of his new address;
 - (b) within five days of any change in the address or location at or from which the houseboat is operated notify the Department in writing of the new address or location.
- PART III.—REQUIREMENTS AS TO HULLS, MACHINERY,
AND APPLIANCES OF HOUSEBOATS.**
- Division 1.—Hull and type of construction.
- Construction. 15. A houseboat shall be constructed of such materials and be of such dimensions and construction as will render it seaworthy for the purpose for which it is to be used.
- Registration number to be shown. 16. (1) The registration number allotted to a houseboat pursuant to regulation 4 shall be clearly painted on both sides of the houseboat in dark numerals on a white background, or in white numerals on a dark background.
- (2) The numerals required by subregulation (1) of this regulation shall be at least 30 centimetres in height and at least 5 centimetres in width.
- Buoyancy. 17. (1) Subject to subregulation (2) of this regulation, the hull of a houseboat shall be subdivided into watertight compartments so as to provide adequate reserve buoyancy.
- (2) Notwithstanding subregulation (1) of this regulation, buoyancy foam of a type approved by the Department may be fitted instead of watertight compartments in houseboats that are less than 12 metres in length.
- (3) Buoyancy foam fitted in accordance with subregulation (2) of this regulation shall be fitted at the rate of 1 cubic metre per 800 kilograms of flooded weight.
- (4) All bulkhead and deckhead linings to the superstructure shall be of a non-combustible or other fire resistant material.
- Access from enclosed superstructure. 18. The enclosed superstructure of a houseboat shall be constructed so that access may be gained directly to at least two different open decks through exists that are—
- (a) not less than 56 centimetres wide; and
 - (b) capable of being opened from the inside without the use of a key.
- Sundecks. 19. Where an area of open deckspace on a houseboat is intended to be used as a sundeck that area shall be constructed so that—
- (a) it is capable of supporting the maximum number of persons that the houseboat is licensed to carry; and
 - (b) it is surrounded by a safety barrier extending to a height of not less than 80 centimetres above the level of the deck and consisting of a solid bulwark or of staunchions supporting safety rails not less than 25 centimetres apart, or strong netting.
- Division 2.—Propulsion and fuel systems.
- Engines. 20. (1) Houseboats may be propelled by—
- (a) inboard engines that operate on fuel having a flashpoint of not less than 65°C; or
 - (b) outboard engines.
- (2) Engines, engine compartments and fuel systems on houseboats shall comply with the requirements of regulations 21 to 27 both inclusive.
- Ventilation. 21. (1) Where an inboard engine is fitted, the engine compartment shall be ventilated so as to prevent the accumulation of flammable vapours in the compartment.
- (2) All engines shall be fitted with a water-cooled exhaust system and shall be silenced so as to effectively suppress noise.
- Construction of fuel tanks. 22. (1) Fuel tanks—
- (a) shall be soundly constructed from mild steel, stainless steel, salt water resistant aluminium alloy, fibreglass, or copper;
 - (b) shall be designed for a working pressure of not less than 62 kilopascals;

(c) shall be subjected to a test equivalent to 2.5 metres of fresh water above the top of the tank or to a maximum head to which the tank may be subject in service, whichever is the greater. (Where the tank does not form part of the structure of the houseboat the test shall be carried out before the tank is installed.)

(2) Joints and connections in fuel tanks shall be welded or rivetted and shall not depend on soft solder for tightness.

Built-in fuel tanks.

23. (1) Where a built-in fuel tank is installed it shall be installed so as to conform with the following provisions—

- (a) it shall be securely installed as low down in the houseboat as practicable and as distant from the engine and the exhaust lines as practicable;
- (b) contact between the fuel tank and the boat structure shall be limited to the necessary supports so as to provide maximum air circulation around the tank;
- (c) the tank supports and hold downs shall fasten the tank securely and shall be insulated from the tank by non abrasive and non absorbent material;
- (d) where the fuel outlet that supplies fuel to the engine is on the side or at the bottom of the tank, a shut-off valve or cock shall be provided on each outlet from the tank to shut off the supply of fuel to the engine.

(2) Every built-in fuel tank shall be provided with—

- (a) a vent pipe—
 - (i) leading to a position not less than 80 centimetres above deck level;
 - (ii) of sufficient size to prevent the generation of pressure within the tank; and
 - (iii) fitted at the outlet end with a copper or bronze mesh of not less than eleven wires per centimetre; and
- (b) a permanent filling pipe—
 - (i) leading from the deck or from above deck level to the tank;
 - (ii) fitted with a watertight screwed cap; and
 - (iii) located so as to prevent any fuel which may be spilt while fuelling from entering the houseboat or saturating any surrounding material.

(3) A flexible pipe may be used as the section of a permanent filling pipe between a built-in fuel tank and the deck fittings so long as—

- (a) it is constructed of petrol resistant reinforced neoprene of a type approved by the Department;
- (b) it is fastened to the deck and tank fittings with corrosion resistant clips so as not to permit the escape of fuel; and
- (c) the deck fittings are electrically bonded through the tank to the grounding conductor of the houseboat.

(4) Where fuel having a flash point of not less than 65°C is used the permanent filling pipe may terminate at the tank top, but where fuel having a flash point of less than 65°C is used the pipe shall extend into the tank at an angle of not less than 30° to the vertical to within 5 centimetres of the bottom of the fuel tank.

Fuel lines.

24. (1) Fuel lines from a built-in fuel tank shall be of stainless steel, monel metal or copper, with metal to metal joints from the tank to the point of coupling with the engine, but where it is necessary for the proper operation of the engine to provide a flexible length of fuel line, the minimum necessary length of Aeroquip hose No. 2651 or 1509, or of such other hose as the Department may approve, may be incorporated in the line.

(2) Where fuel having a flash point of less than 65°C is used, the method of drawing fuel from the tank shall be by means of a pipe running internally to the bottom of the tank and if the levels of the fuel pump and the carburettor are below the tank level, a valve shall be installed at a suitable position in the line.

Portable fuel tanks.

25. Where fuel is supplied to the engine of a houseboat by means of a portable fuel tank—

- (a) the capacity of the fuel tank shall not exceed 105 litres;
- (b) the fuel tank shall be firmly secured whenever the houseboat is in use or under way;
- (c) the fuel tank shall, where the houseboat is so constructed as to be provided with a flush or sealed deck designed to prevent wash from flowing to the bottom of the houseboat, be situated above that deck and in such a position as to prevent any spillage of fuel from draining below that deck; and
- (d) any fuel line leading from the fuel tank shall be of neoprene tube of a type supplied by or specified by the manufacturer of the engine or of the fuel tank, and shall be fitted with bayonet type fittings.

Shut-off valve. 26. Where any part of the fuel system consists of materials that could be rendered ineffective by heat, a mechanism to operate the shut-off valve or cock attached direct to the tank shall be provided in a position outside the engine compartment to shut off the supply of fuel to the engine.

Reserve fuel tank. 27. (1) An 18 litre reserve fuel tank shall be fitted.
(2) The reserve tank shall be fitted with filling lines, vents and an outlet line independent of the main tank.

Division 3.—Liquefied Petroleum Gas Installations.

Liquefied petroleum gas installations. 28. Where a houseboat carried liquefied petroleum gas cylinders, appliances and installations they shall comply with the requirements of regulations 29, 30 and 31 and where a compartment or a houseboat contains a gas burning appliance that compartment shall comply with the requirements of regulation 32.

Cylinders and storage. 29. Liquefied petroleum gas cylinders shall be—
(a) constructed, tested, marked, maintained and retested in accordance with the Standards Association of Australia L.P. Gas Codes A.S.—C.B. 20 and C.B. 4;
(b) fitted with—
(i) safety relief devices; and
(ii) manually operated stop valves with the operating wheel or handle permanently attached to the valve, which meet the requirements of the Standards Association of Australia L.P. Gas Code A.S.—C.B. 20; and
(c) stored on deck at all times.

Certain Codes to be complied with. 30. All liquefied petroleum gas appliances and installations shall conform with—
(a) the Australian Liquefied Petroleum Gas Association Code for the Installation of Cooking, Heating and other Appliances on Marine Craft; and
(b) the relevant sections of the Australian Gas Association and the Australian Liquefied Petroleum Gas Association Installation Code for Gas Burning Appliances and Equipment.

Pilot lights. 31. Appliances with a continuous burning pilot light or other continuous flame devices, shall not be installed below the main deck and shall be fitted with a device which automatically shuts off the gas in the main supply line to the appliance when the pilot light or continuous flame is extinguished.

Ventilation. 32. A compartment containing a gas burning appliance shall be ventilated by—
(a) at least two natural air ventilator ducts each at least 7.5 centimetres in diameter leading from the atmosphere with one duct extending to the floor level of the compartment and the other to the deckhead; or
(b) mechanical ventilation with the motor situated outside the compartment and the exhaust ventilating duct.

Division 4.—Electrical Installations.

Electrical installations. 33. Electrical installations in a houseboat shall comply with regulations 34 to 41 both inclusive.

Requirements to be observed. 34. (1) Electrical installations shall be carried out by an Electrical Contractor licensed under the Electricity Act Regulations, 1947.

(2) The distribution of current shall be by the two wire insulated system.

(3) Fixed cables may be run in conduit or shall be of one of the following types—

(a) mineral insulated copper sheathed; or

(b) P.V.C. polythene or polychloroprene sheathed.

(4) All cables shall be supported in trays as required and all cables and conduits shall be properly secured and protected from mechanical damage.

(5) Cable clips, saddles, and fixing screws shall be of corrosion resistant materials.

(6) All wiring, other than mineral insulated copper sheathed cable, shall be stranded cable of current carrying capacity in accordance with the requirements of the Australian Standard No. C.C.1, Standards Association of Australia Wiring Rules.

(7) All wiring shall be kept as high as possible above the bilges and all joints in the wires shall be made in a junction box.

(8) Separate circuits shall be provided for essential services.

(9) Navigation lights shall be on a separate circuit with each light individually fused and with all switches for the lights located in or adjacent to the wheelhouse.

(10) All electrical equipment shall be located in dry, accessible and well ventilated positions.

(11) Switch gear and accessories shall be of a type and design sufficient for the maximum current flow, and shall be properly labelled.

(12) Switchboards shall be of insulating material that is mechanically strong, moisture resistant and flame retardant.

(13) Each outgoing circuit from a switchboard or distribution board shall be protected with a circuit breaker, or fuse in each active conductor.

(14) The main switchboard shall have control equipment for the generator and battery which shall include an ammeter to show charge and discharge current, isolating switches, fuses, voltage regulator and cut out.

Electricity Act Regulations and S.A.A. rules to be followed.

35. An electrical installation that is intended to be connected to a pressure exceeding 32 volts shall—

(a) if it is intended to be connected to a public electricity supply system: conform with such requirements of the Electricity Act Regulations, 1947, and current practices of the State Electricity Commission of Western Australia as may be applicable;

(b) in any event conform with the Standards Association of Australia Wiring Rules.

Resistances.

36. Electrical circuits shall have a resistance of not less than one megohm.

Batteries.

37. (1) Batteries shall be of sufficient capacity for their intended service.

(2) The main engine starting batteries shall be used for that purpose only and shall be of sufficient capacity for not less than six consecutive starts of the main engine.

(3) Batteries shall be contained in a tray not less than 10 centimetres deep which shall be lined with lead or fibreglass and, if painted, painted with acid resistant paint.

Starter leads.

38. Engine starter leads shall be as short as is compatible with the safe stowage arrangements for the batteries and shall be taken direct to the starter via the starting relay contacts with the relay mounted directly on or adjacent to the starter.

Fuses.

39. Batteries shall be protected against short circuits in the distribution system by a main fuse in each insulated conductor.

Circuit breakers.

40. Where power is directly supplied by generators, each generator is to be provided with a circuit breaker or a switch and fuse on each insulated pole.

Switchboards etc.

41. (1) The leads between main switchboards, batteries and generators shall be kept as short as possible.

(2) Switchboards shall be placed in accessible, well ventilated positions where they will not be exposed to mechanical damage or damage from water or heat.

(3) Enclosures for switch and fuse boards must be lined with fire resistant materials.

Division 5.—Other fittings and equipment.

Safety equipment.

42. (1) Every houseboat shall carry the following equipment—

(a) navigation lights as required by regulations 7 and 11 of the Regulations for Preventing Collisions at Sea made under the Act;

(b) a hand bilge pump with a capacity not less than 114 litres per minute;

(c) a 75 centimetre lifebuoy fitted with 30 metres of line;

(d) an electrical signalling torch;

(e) a 3 metre oregon barge pole not less than 6 centimetres in diameter;

(f) a 1.5 kilogram B.C.F. fire extinguisher;

(g) a 4 kilogram dry powder, or a 9 litre foam extinguisher which shall be emptied of its contents, examined and tested by hydraulic pressure of 2 350 kilopascals at least once every four years and marked with the date the test is carried out;

(h) a sufficient number of life jackets of a type that—

(i) conforms to standard AS Z27 of the Standards Association of Australia; or

(ii) has been approved by the Marine Board of Victoria or the Department of Shipping and Transport of the Commonwealth, as a life jacket, to provide at least one life jacket for every person that the houseboat is licensed to carry;

(i) a first aid kit approved by the Department of Public Health of the State for use on houseboats;

- (j) where the houseboat is to operate in protected waters, an anchor of a weight in accordance with the appropriate requirement set out in Column 2 of the Table to this subregulation, fitted with—
- (i) a chain pendant at least 2 metres in length and of a diameter in accordance with the appropriate requirement set out in Column 3 of the Table to this subregulation; and
 - (ii) a line of a diameter in accordance with the appropriate requirement set out in Column 4 of the Table to this subregulation and of a length adequate for use in the waters in which the houseboat is to operate
- (k) where the houseboat is to operate outside protected waters, anchors, chains and lines suitable and adequate for use in the waters in which she is to operate.

The equipment numeral of a houseboat shall be determined by the formula—

$$L \times H$$

where—L is the length of the superstructure (in metres);

H is the height of the top of the superstructure above the water line (in metres).

(2) In subregulation (1) of this regulation "protected waters" means the waters contained in any lake, river or estuary, or by any breakwater, but does not include the waters of Cambridge Gulf or Lake Argyle.

PART IV.—OFFENCES.

- Equipment to be carried. 43. The owner of a houseboat shall not let that houseboat for hire or cause or permit that houseboat to be occupied, operated or navigated unless—
- (a) it carries the equipment specified in regulation 42; and
 - (b) that equipment is in a sound and serviceable condition.
- Conditions of license to be observed. 44. A person shall not—
- (a) occupy, operate or navigate a houseboat;
 - (b) cause or permit a houseboat to be occupied, operated or navigated, contrary to any condition of, or attached to, a license issued under these regulations in respect of that houseboat.
- Speeding, dangerous navigation etc. 45. A person shall not navigate a houseboat—
- (a) in a dangerous or negligent manner;
 - (b) at a speed exceeding eight knots; or
 - (c) between the hours of sunset and sunrise, unless the navigation lights referred to in regulation 42 are illuminated.
- Minors not to navigate houseboat. 46. A person shall not—
- (a) navigate a houseboat whilst under the age of seventeen years; or
 - (b) cause or permit a houseboat to be navigated by a person who is under the age of seventeen years.
- Alcohol and drugs. 47. A person shall not navigate or attempt to navigate a houseboat in any waters whilst under the influence of alcohol or drugs to such an extent as to be incapable of having proper control of the houseboat.
- Fuel containers. 48. A person shall not cause or permit petrol or other fuel to be carried on a houseboat in loose drums or other loose containers.
- Causing nuisance. 49. Except in the case of an emergency, a person shall not cause or permit a houseboat to emit smoke, vapour or noise to such an extent as to cause danger, nuisance or annoyance to the public.

- Advertise-ments etc. 50. Except with the permission in writing of the Department, a person shall not cause or permit any advertisement or sign to be carried by, or displayed on a houseboat.
- Wilful damage. 51. A person shall not in any way wilfully damage any part of the hull, machinery, gear, equipment or life saving appliances of a houseboat.
- Climbing on awnings. 52. A person shall not ascend or attempt to ascend a roof or awning on a houseboat unless that roof or awning is constructed as a sundeck and complies with the requirements of regulation 19.
- General. 53. Every person who by act or omission contravenes the provisions of these regulations commits an offence and is liable on conviction, where no other penalty is provided, to a penalty not exceeding Two hundred dollars.
