Forests Act, 1918-1974.

PROCLAMATION

WESTERN AUSTRALIA, } By His Excellency Air Chief Marshal Sir Wallace
To Wit: } Kyle, Knight Grand Cross of the Most Honourable
WALLACE KYLE, } Order of the Bath, Commander of the Most
Governor, } Excellent Order of the British Empire, Companion

Commonwealth of Australia.

WHEREAS the Conservator of Forests has given notice in writing to the Minister of the Crown for the time being administering the Forests Act, 1918-1974, that he considers that earth, soil or trees in the areas of public land specified in the Schedule to this proclamation may be, or may become, infected with the forest disease known as jarrah dieback (*Phytophthora cinnamomi*); and whereas that Minister, after consultation thereon with the Minister of the Crown for the time being administering the Mining Act, 1904-1973, has recommended to me, the Governor, that the areas be constituted forest disease risk areas: Now, therefore, I, the Governor acting pursuant to the powers conferred by section 40D of the Forests Act, 1918-1974, and with the advice and consent of the Executive Council, hereby constitute the areas of public land specified in the Schedule to this proclamation forest disease risk areas to be known as Jarrah Dieback Risk Areas Nos. 1.1, 1.2, 1.3, 1.4, 1.5, 1.6 and 1.7 respectively.

WHEREAS by section 33 of the Land Act, 1933-1972, it is made lawful for the Governor to direct that any Reserve shall vest in and be held by any Municipality, Body Corporate, or other person or persons to be named in the order in trust for the like or other public purposes to be specified in such order; and whereas it is deemed expedient that Class "B" Reserve No. 4872 should vest in and be held by the Claremont Teachers College, in trust for the purpose of "Claremont Teachers College": Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, doth hereby direct that the before-mentioned Reserve shall vest in and be held by the Claremont Teachers College in trust for the purpose aforesaid, subject nevertheless to the powers reserved to him by section 37 of the said Act.

ORDER IN COUNCIL.

L. & S. Corres. 1793/75 (R.4902).

WHEREAS by section 288 of the Local Government Act, 1960-1975, it shall be lawful for the Governor, on request by a Council of a Municipal District, by Order published in the *Government Gazette* to declare any lands reserved or acquired for use by the public or used by the public as a street, way, public place, bridge or thoroughfare, under the care, control, and management of the Council, or lands comprised in a private street, constructed and maintained to the satisfaction of the Council, or lands comprised in a private street of which the public has had uninterrupted use for a period of not less than ten years, as a public street and if the Council thinks fit, that the Governor shall declare the width of the carriageway and footpaths of the public street; and whereas the Shire of Wanneroo has requested that certain lands named and described in the schedule hereunder, which have been reserved for a street within its municipal district be declared a public street: Now, therefore, His Excellency the Governor by and with the advice and consent of the Executive Council, doth hereby declare the said lands to be a public street, and such land shall, from the date of this Order, be absolutely dedicated to the public as a street within the meaning of any law now or hereafter in force.

RADIOACTIVE SUBSTANCES ACT, 1954-1964.

HIS Excellency the Governor in Executive Council acting pursuant to the provisions of the Radioactive Substances Act, 1954-1964 has been pleased to make the regulations set forth in the schedule hereunder.

Schedule.

Regulations.

1. In these regulations the Radioactive Substances Regulations, 1958 published in the *Government Gazette* on the 12th December, 1958 and amended from time to time thereafter by notices so published are referred to as the principal regulations.

2. Subregulation (5) of regulation 5 of the principal regulations is revoked and the following subregulation substituted:—

(5) The Council may exempt—

- (a) any irradiating apparatus or radioactive substance that is known to be without hazard; or
- (b) any irradiating apparatus or radioactive substance that is used in such circumstances as are approved by the Council,

and may require as a condition of the exemption that the irradiating apparatus or radioactive substance so exempted be labelled and used in such manner as is approved by the Council.

3. Regulation 6 of the principal regulations is amended—

- (a) as to subregulation (1), by deleting the passage "V or VA" in line two and substituting the passage "V, VA or VB";




