Constitution Act, 1889-1970.

ORDER IN COUNCIL.

WHEREAS section 74 of the Constitution Act, 1889-1970, provides, *inter alia*, that the Governor in Council may vest in heads of departments, or other officers or persons within the State, power to make minor appointments to public offices under the Government of the State: Now, therefore, His Excellency the Governor acting with the advice and consent of the Executive Council hereby vests in Thomas Francis Meagher, Secretary, Police Department, and in any person temporarily appointed to perform the normal duties of the said Thomas Francis Meagher during his absence or incapacity, the power to make appointments in respect of the department specified in Column 1 of the Schedule hereto, of employees of the categories specified respectively in Column 2 of the Schedule hereto in relation to those departments, on such terms and conditions as are contained from time to time in the awards and agreements specified respectively in Column 3 of the Schedule hereto in relation to those categories of employees.

THE Environmental Protection Authority invites submissions on areas that should be set aside for recreational purposes and as national parks and nature reserves in Western Australia's System 6.


This system extending from Guilderton in the north to Bunbury in the south, is the last of 12 systems within the State to be considered by the Conservation Through Reserves Committee.

THE SHIRE OF WANDERING TOWN PLANNING SCHEME NO. 1.

The Wandering Shire Council, under and by virtue of the powers conferred upon it in that behalf by the Town Planning and Development

Act, 1928 (as amended), hereby makes the following Town Planning Scheme for the purpose of:—

- (a) setting aside lands for future public use as reserves;
- (b) controlling land development by zoning;
- (c) other matters authorised by the enabling Act.

PART I.—PRELIMINARY.

1.1 This Town Planning Scheme may be cited as the Shire of Wandering Town Planning Scheme No. 1 (Townsite area) hereinafter called "the Scheme" and shall come into operation on the publication of notice of the Minister's final approval thereof in the *Government Gazette*.

1.2 The Scheme shall apply to the whole of the Townsite of Wandering.

1.3 The responsible authority for carrying out the Scheme is the Council of the Shire of Wandering.

1.4 In the Scheme the planning area is divided into Zones.

The basic types of zones are:—

1. Residential.
2. General.
3. Rural.
4. Industrial.

1.5 Arrangement of Scheme:

The Scheme is divided into the following Parts and Appendices:—

- Part I.—Preliminary.
- Part II.—Reserves.
- Part III.—Zones.
- Part IV.—Non Conforming Use.
- Part V.—Finance and Administration.

The remaining documents of the Scheme are appended as follows:—

1. Land use Map marked "Map No. 1".
2. Scheme Map marked "Map No. 2".

1.6 Interpretation: In this Scheme the terms used will have the respective interpretations set out in the appendix "D" of the town Planning Regulations, 1963, except that the following words shall be added to the definition of service station:—"a cafe may also form part of such premises".

PART II.—RESERVES.

Reservation of Land and Development Thereof.

2.1. (a) Land set aside under this Scheme for the purposes of a reservation is deemed to be reserved for the purposes indicated on the approved Planning Scheme Map.

(b) Except as otherwise provided in this Part a person shall not carry out any development on land reserves under this Scheme, other than the erection of a boundary fence, without first applying for and obtaining the written approval of the Responsible Authority.

(c) In giving its approval the Responsible Authority shall have regard to the ultimate purpose intended for the reserves, and shall in the case of land reserved for the purposes of a public authority confer with that authority before giving its approval.

(d) No provision of this Part shall prevent the continued use of land for the use for which it was being lawfully used immediately prior to the Scheme having the force of law, or the repair and maintenance of buildings or works lawfully existing on the land.

2.2 (a) Where a Responsible Authority refuses approval for the development of land reserved under the Scheme on the ground that the land is reserved for public purposes, or grants approval subject to conditions the owner of the land may, if the land is injuriously affected thereby, claim compensation for such injurious affection.

(b) Any claim for such compensation shall be lodged at the office of the Responsible Authority not later than six months after the date of the decision of the Responsible Authority refusing approval or granting it subject to conditions that are unacceptable to the applicant.

(c) In lieu of paying compensation the Responsible Authority may purchase the land affected by the decision of the Responsible Authority at a price not exceeding the value of the land at the time of refusal of approval subject to conditions.

PART III.—ZONES.

3.1 Table No. 1 appended to clauses 3.2 of this Part indicates the several uses permitted by this Scheme in the various zones, such uses being determined by cross references between the list of "Use Classes" on the left-hand side of the Table and the list of "Zones" on the top of that table.

3.2 The symbols used in the cross reference in Table No. 1 appended to this clause have the following meanings:—

"P" = A use that is permitted under the provisions of this Scheme.

"AA" = A use that is not permitted unless approval is granted by the Responsible Authority.

"IP" = A use that is not permitted unless such use is incidental to the predominant use as decided and approved by the Responsible Authority.

"X" = A use that is not permitted.

3.4 (a) No development of any land in the Scheme Area shall be commenced without the approval in writing of the Responsible Authority.

(b) Approval under this Part does not exempt the person to whom exemption is granted from the requirements, if any, to obtain promises or approval for development on the land under any other law.

PART IV.—NON-CONFORMING USE OF LAND.

4.1 No provision of the Scheme shall prevent—

(a) the continued use of any land or building for the purpose for which it was being lawfully used at the time of the coming into force of the Scheme; or

(b) the carrying out of any development thereon for which, immediately prior to that time, a permit or permits required under the Town Planning and Development Act, 1928 (as amended), or any other law authorising the development to be carried out had been duly obtained and was current.

4.2 (a) Where in respect of land zoned under Part II of the Scheme a non-conforming use exists or was authorised as mentioned in clause 4.1 of this Part on the land all or any erections, alterations or extensions of the buildings thereon or use thereof shall not be carried out unless the approval of the Responsible Authority has been obtained in writing.

(b) Where in respect of land zoned under Part III of the Scheme a non-conforming use exists or was authorised as mentioned in clause 4.1 of this Part on that land, buildings may be extended to the limits prescribed by the Uniform Building By-Laws made under the Local Government Act, 1960 (as amended), or by any other by-laws made under that Act for the purpose of limiting the size, location and distance from boundaries and any other matter required by law for that class of use within the boundary of the lot or lots on which the use was carried on immediately prior to the coming into force of the Scheme.

4.3 Change of Non-Conforming Use:

The Council may permit the use of any land to be changed from one non-conforming use to another non-conforming use, provided the proposed use is, in the opinion of the Council, less detrimental to the amenity of the neighbourhood than the existing use, or is in the opinion of the Council closer to the intended uses of the zone.

4.4 Discontinuance of Non-Conforming Use:

- (a) Notwithstanding the proceeding provisions of this Part, when a non-conforming use of any land or building has been discontinued, such land or building shall not thereafter be used other than in conformity with the provisions of the Scheme.
- (b) The Responsible Authority may effect the discontinuance of a non-conforming use by the purchase of the affected property, or by the payment of compensation to the owner or the occupier or to both the owner and the occupier of that property, and may enter into an agreement with the owner for that purpose.

PART V.—FINANCE AND ADMINISTRATION.

5.1 Disposal of Land: The Responsible Authority may deal with or dispose of any land which it owns or which it has acquired pursuant to the provisions of the Scheme, in accordance with the Act and in conformity of the Scheme, and for such purpose may make such agreements with other owners as it deems fit.

5.2 Compensation: Claims for compensation by reason of the Scheme other than for the purpose of Part II shall be made not later than six months from the date on which notice of approval of the Scheme is published in the *Government Gazette*, except in the case of reserved land where the provisions of Part II shall apply.

5.3 Entry to Premises: The Responsible Authority may by its engineer or other authorised officer enter at all reasonable times any building or land for the purpose of ascertaining whether the provisions of the Scheme are being observed.

5.4 Penalties: Any person who fails to comply with any of the provisions of the Scheme is guilty of an offence and without prejudice to any other remedy given herein is liable to such penalties as are prescribed by the Act.

5.5 Where in the implementation of the Scheme, a person is aggrieved by a decision of the Council in the exercise of a discretionary power under this Scheme, that person being the owner of, or having an interest in, and land in respect of which the decision was made, may appeal to the Minister under the provisions of Part V of the Town Planning and Development Act and in accordance with the Appeal Regulations made thereunder.



STATUTE No. 11—LIBRARY STATUTE.

1. In this Statute—
- the "Library" means the Institute Library as from time to time constituted or located and unless the context otherwise requires, includes a reference to all Library materials;
- "Library materials" includes all books, journals, papers, films, tapes, recordings and other materials held by the Library, and other facilities provided by the Library.
- "Rule" includes an amendment to a Rule.
2. This Statute and Rules made under this Statute shall apply to all Staff, students and members of the Council of the Institute and all other persons (whether associated with the Institute or not) who enter the Library or otherwise make use of its facilities in any way.
3. (1) Subject to the Act and the other Statutes of the Institute, the Principal Librarian shall be responsible for the Library.
- (2) The Principal Librarian may delegate any power or duty conferred on him by Rules made under this Statute to any member of the Library staff and he may authorise any member of the Library staff to act under and for the purposes of the Rules, in each case, in accordance with the Rules.

Schedule—*continued.*

4. (1) The Council may by resolution make Rules, not inconsistent with the Act, this Statute or any other Statute, regulating or providing for the regulation of the Library or for carrying out or giving effect to this Statute.

(2) Without in any way limiting the rule-making power contained in paragraph (1) of this section, Rules may be made which—

- (a) prescribe fees to be charged to all or any persons for admission to the Library, or the use of or the borrowing of Library materials;
- (b) make provision for penalties for breaches of the Library Rules; or
- (c) authorise the Principal Librarian to prescribe certain matters for the purposes of the Rules.

(3) The Council may by resolution amend or revoke any Rule made under this Statute.

5. (1) The Administrative Secretary shall seal each Rule made under this Statute and cause it to be published.

(2) A Rule is published by posting a copy of it on the notice board located outside the main entrance to the Administration Block and a Rule takes effect from the date it is published.

(3) If a Rule is revoked, revocation takes effect from the date of the Council's resolution.

(4) A matter to be prescribed by the Principal Librarian under the Rules shall be published on the Library notice board, and takes effect from the date it is published.

6.
