STIPENDIARY MAGISTRATES ACT, 1957-1979.

HIS Excellency the Governor in Executive Council acting under the Stipendiary Magistrates Act, 1957-1979 and section 11 of the Interpretation Act, 1918-1975 has been pleased to make the regulations set out in the Schedule below to take effect on and from the day that the Stipendiary Magistrates Act Amendment Act, 1979 comes into operation.

Schedule.

REGULATIONS.

1. These regulations may be cited as the Stipendiary Magistrates (Examinations) Regulations, 1979.

2. In these regulations unless the contrary intention appears-

"Board" means the Stipendiary Magistrates Examinations Board appointed under regulation 3;

"member" means a member of the Board;

"regulation" means one of these regulations;

"the Act" means the Stipendiary Magistrates Act, 1957.

3. (1) There shall be a Board to be known as the Stipendiary Magistrates Examinations Board.

(2) The Board shall consist of three persons appointed by the Governor.

(3) The Governor may appoint a person to be the deputy of a member of the Board and the person so appointed has, in the event of the member for whom he is the deputy being unable to attend to his duties under these regulations, whether on account of illness or otherwise, all the functions, powers and duties of that member.

4. (1) To the extent that it is not prescribed the Board shall determine its own procedure.

(2) At a meeting of the Board two members shall constitute a quorum.

(3) Any question arising at a meeting of the Board shall be decided by a majority of the members present and voting and in the event of an equality of votes being cast, that question shall be adjourned until the next meeting of the Board at which three members are present.

5. The Board shall conduct the examinations prescribed by regulation 6.

6. (1) The examinations prescribed for the purposes of paragraph (c) of subsection (2) of section 4 of the Act shall comprise examinations in the following subjects—

Legal process; Contract; Criminal Law;

Criminology;

Torts:

Evidence and Legal Interpretation;

Real Property;

Personal Property;

Trusts and Equity;

Constitutional Law;

Administrative Law;

Employment Law;

Family Law; and Practice and Procedure.

(2) An examination may consist of more than one paper and may in the case of a particular candidate be supplemented by an oral examination.

Schedule—continued

(3) Notwithstanding anything in subregulations (1) and (2) of this regulation but subject to subregulation (4) of this regulation where the Board is satisfied that a candidate has passed an examination in—

- (a) a subject in the course prescribed under the Statutes of the University of Western Australia for the degree of Bachelor of Jurisprudence or Bachelor of Laws; or
- (b) a subject in a course conducted by any other body being a course which in the opinion of the Board is of an equivalent standard to the standard required for an examination prescribed under these regulations,

that is similar to a subject prescribed under subregulation (1) of this regulation, the Board may permit a candidate to be accredited with a pass in the subject prescribed under subregulation (1) of this regulation and where it does so the candidate is deemed to have passed the examination in the subject so prescribed.

- (4) A pass in a subject—
 - (a) at an examination conducted by the Board; or
 - (b) at an examination conducted by another body referred to in subregulation (3) of this regulation,

is valid only for a period of five years commencing from the date that the examination is taken unless the Board determines that the candidate has maintained adequate knowledge of the subject.

7. The Board may supply to any person desirous of becoming a candidate for the examinations prescribed under these regulations a syllabus of the course for each subject.

8. An examination referred to in subregulation (1) of regulation 6 shall be held at such time and place as is determined by the Board.

9. A person who before the coming into operation of the Stipendiary Magistrates Act Amendment Act, 1979 passed an examination relating to the appointment of magistrates prescribed under the Public Service Act, 1904 may, subject to the approval of the Board, receive a credit towards the passing of an examination prescribed under these regulations that is similar to the examination passed by him that was prescribed under the Public Service Act, 1904.

10. Where a candidate does not pass all the examinations prescribed by subregulation (1) of regulation 6 within six years of passing the first examination prescribed under that subregulation the candidate shall not sit for any further examination and shall not be credited with a pass in any examination except by leave of the Board.

11. (1) The Board shall issue to a candidate who has passed all the examinations prescribed under subregulation (1) of regulation 6 a certificate to that effect.

(2) A certificate issued pursuant to subregulation (1) of this regulation shall be signed by not less than two members of the Board.

12. (1) The Attorney General may from time to time by notice in the Government Gazette specify the fees payable—

(a) to lecturers and examiners; and

(b) by candidates,

with respect to any examinations referred to in these regulations.

(2) A notice under subregulation (1) of this regulation may be varied or cancelled by the Attorney General.

I, DESMOND HENRY O'NEIL, Minister for Traffic, in exercise of the powers conferred by the Road Traffic Act, 1974 and above cited regulations, do hereby rescind the directions relating to the licensing of certain vehicles of Class "B" and "C" appearing on pages 1494 and 1495 of Government Gazette of the 8th June, 1979 and direct

1. The Road Traffic Authority may issue licences or Temporary Permits for Class "B" and "C" vehicles in accordance with the following directions, subject to the conditions of movements, purpose of use of the vehicle, requisite signs and warning devices being endorsed on the licence documents as specified in the direction.

- 1.1 In this direction "Warning flag" means a red flag of not less than 450 millimetres square.
 - "Warning sign" means a sign bearing the words "OVERWIDTH", "OVERLENGTH" or both as the case may require, in black lettering, 200 millimetres in height on a yellow background.
 - "Peak hour period" means:

Monday to Friday 7.30 a.m.-9.00 a.m.; 4.30 p.m.-6.00 p.m. Saturday—7.30 a.m.-12.30 p.m.

"Hours of darkness" means the hours falling between sunset and sunrise.

2. Fire Fighting Vehicles.

Licences of Class "B" may be issued for any vehicle that is owned by a person engaged in the business of farming or grazing and that is fitted and used solely for the purpose of fire fighting or fire prevention, or its move-ment to the nearest practical place for repair, without the payment of a licence fee but subject to such other charges as are prescribed by law.

Class "B" vehicle-licence or temporary permit for Class "B" may be 3. issued where a vehicle:

- 3.1 Is not equipped with lamps in conformity with the Vehicle Standards Regulations, 1977 provided it is not used during the hours of darkness.
- 3.2 Is a tractor or self propelled agricultural implement not exceeding 8.5 metres in width which is used only for agricultural or pastoral pursuits within such areas as the Road Traffic Authority may direct and subject to the following conditions:
 - (a) where the width of the vehicle exceeds 2.5 metres but not 3.1 metres:
 - (i) a warning sign indicating that the vehicle is overwidth is to be affixed to the front and rear of the vehicle;
 - (ii) the vehicle is not to travel during the hours of darkness;
 - (iii) the vehicle is not to travel during peak hour periods within a radius of 30 kilometres of the General Post Office, Perth
 - (iv) speed limit 35 km/h.
 - (b) Where the width of the vehicle exceeds 3.1 metres but not 4.9 metres they are subject to the conditions set out in paragraph (a) of this clause and, further, subject to the following conditions, namely-

(i) a warning flag to be affixed at each lateral extremity and; where the vehicle is driven, within 30 kilometres of the General Post Office, Perth subject to the following additional conditions, namely-

- (ii) the vehicle is to be preceded by a pilot vehicle bearing a sign indicating that an overwidth vehicle follows it;
- (iii) the headlights of the vehicle and pilot vehicle are to be kept burning in the dipped position.
- (c) Where the width of the vehicle exceeds 4.9 metres but not 8.5 metres, they are subject to the conditions set out in paragraphs (a) and (b) of this clause and, further subject to the following condition, namely-
 - (i) the vehicle is to be preceded by a pilot vehicle bearing a sign indicating that an overwidth vehicle follows it.

- 3.3 Is a tractor or tractor plant other than a tracked vehicle and not exceeding 3.1 metres in width or 12.2 metres in length subject to the following conditions:
 - (a) where the length of the vehicle exceeds 11 metres but not 12.2 metres, or its width exceeds 2.5 metres but not 3.1 metres:
 - (i) a warning sign indicating that the vehicle is overlength, overwidth, or both, as the case may be, is to be affixed to the front and rear of the vehicle;
 - (ii) the vehicle is not to travel during the hours of darkness;
 - (iii) the vehicle is not to travel during peak hour periods within a radius of 30 kilometres of the General Post Office, Perth;
 - (iv) where the vehicle is a mobile crane, a warning flag is to be attached to the hook, which is to be secured.

(b) Irrespective of the number of tyres per axle, the tyre-axle loadings must not exceed the following—

(c) The vehicle must travel unladen except when operating within the confines of a road construction area.

4. Class "C" vehicles—motor vehicles of a dimension, weight or axle loading exceeding those set out in clause 3 of this direction may be licensed as a Class "C" only with my special approval.

Movement of Towed Agricultural Implements.

I, BASIL HENRY LARSEN, Chairman of the Road Traffic Authority acting pursuant to Regulation 1106 of the Vehicle Standards Regulations, 1977 do hereby rescind the order published in the *Government Gazette* of 25th May, 1979 and all previous orders published under this Regulation and give the following direction:

1.0 In this direction-

"Warning flag" means a red flag of not less than 450 millimetres square.

"Warning sign" means a sign bearing the words "OVERWIDTH", "OVER-LENGTH", or both, as the case may require, in black lettering, 200 millimetres in height, on a yellow background.

"Peak hour periods" means Monday to Friday 7.30 a.m.-9.00 a.m.; 4.30 p.m.-6.00 p.m.; Saturday 7.30 a.m.-12.30 p.m.

"Hours of darkness" means the hours falling between sunset and sunrise.

2.0 The movement of towed agricultural implements exceeding 2.5 metres in width or 16.8 metres in length, including the towing vehicle, may be made subject to the following General Conditions of Movement specified in Clause 6.0.

3.0~ On highways and main roads (excluding all freeways and approaches thereto) shown in Schedules 1 and 2 hereto—

3.1 Authorised by virtue of this Direction alone.

3.1.1 Where width exceeds 2.5 metres but not 3.1 metres, condition numbers 1, 2, 3, 4, 5, 7, 8, 9;

- 3.1.2 Where width exceeds 3.1 metres but not 4.9 metres, condition numbers 1, 2, 3, 4, 5, 6, 7, 8, 9, 10;
- 3.1.3 Where length including the towing vehicle, exceeds 16.8 metres but not 18.3 metres, condition numbers 1, 2, 3, 4, 5, 7, 8, 9, 10.
- 3.2 Authorised by a Permit.
 - 3.2.1 Where width exceeds 4.9 metres but not 8.5 metres and/or length exceeds 18.3 metres but not 22.0 metres, condition numbers 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12.
- 4.0 On roads other than those shown in Schedules 1 and 2 hereto-
 - 4.1 Authorised by Virtue of this Direction alone.
 - 4.1.1 Where width exceeds 2.5 metres but not 3.1 metres, condition numbers 1, 2, 3, 5, 7, 8, 9;
 - 4.1.2 Where width exceeds 3.1 metres but not 4.9 metres, condition numbers 1, 2, 3, 4, 5, 7, 8, 9, 10;
 - 4.1.3 Where width exceeds 4.9 metres but not 8.5 metres, condition numbers 1, 2, 3, 4, 5, 6, 7, 8, 9, 10;
 - 4.1.4 Where length including the towing vehicle exceeds 16.8 metres but not 22.0 metres, condition numbers 1, 2, 3, 4, 5, 7, 8, 9, 10.
- 5.0 Special approvals.

Any agricultural implement exceeding 8.5 metres in width and/or 22.0 metres in length, including the towing vehicle, is not permitted to be moved on a road without the special approval of the Chief Executive Officer of the Road Traffic Authority.

- 6.0 General conditions of movement-
 - (1) The movement is not permitted during the hours of darkness unless fitted with lamps, reflectors and signalling lamps approved by an officer of the Authority.
 - (2) The movement is not permitted during peak hour periods within a radius of 30 kilometres of the General Post Office, Perth.
 - (3) Where the weight of the implement does not exceed 2 032 kg, the towing vehicle must be of an equivalent or greater tare.

Where the weight of the implement exceeds $2\ 032$ kg, the towing vehicle must be a Tractor or a Motor Wagon exceeding $2\ 032$ kg tare.

- (4) Warning signs indicating that the implement is overwidth or the combined implement and towing vehicle is overlength, or both as the case may be are to be affixed to the front of the towing vehicle and the rear of the implement.
- (5) Warning flags are to be affixed to each lateral extremity of the implement (where the width of implement exceeds 3.1 metres).
- (6) The towing vehicle is to be preceded by a pilot vehicle bearing a sign indicating that an overwidth vehicle follows it.
- (7) Warning signs are to be removed or covered immediately movement is completed.
- (8) The implement or towing vehicle is not to be parked on the made portion of a road.
- (9) The movement is to be made at a speed not exceeding 35 km/h.
- (10) A movement of an implement execeding 3.1 metres in width or 16.8 metres in length including the towing vehicle, is not to be made within 30 kilometres of the General Post Office, Perth, without the approval in writing of the Commissioner of Main Roads.
- (11) Permit (see 3.2), for which no fee is payable, must be issued by a patrolman, an officer of the Authority or a person authorised by the Authority, for a single movement or a number of movements or for a period not exceeding twelve months.
- (12) Additional limitations relating to time, place and circumstance may be imposed by a patrolman or other officer of the Road Traffic Authority.

SHIRE OF BUSSELTON TOWN PLANNING SCHEME No. 11.

THE Busselton Shire Council, under and by virtue of the powers conferred upon it in that behalf by the Town Planning and Development Act, 1928 (as amended), hereby makes the following Town Planning Scheme for the purpose of—

- (a) setting aside land for future public use as reserves;
- (b) controlling land development;
- (c) controlling the environment;
- (d) permitting the orderly and proper development and subdivision;
- (e) other matters authorised by the enabling Act.

PART 1-PRELIMINARY.

1.1 This Town Planning Scheme may be cited as the Shire of Busselton Town Planning Scheme No. 11 (Biddle Road area) hereinafter called "the Scheme" and shall come into operation on the publication of notice of the Minister's final approval thereof in the *Government Gazette*.

1.2 The Scheme shall apply to the whole of the land contained within the broken black border set out in the maps forming part of the Scheme.

1.3. The Town Planning Scheme for the Shire of Busselton which was published in the *Government Gazette* on the 13th day of September, 1963, and subsequently from time to time amended is hereby revoked for the area detailed in Clause 1.2 above.

1.4 The responsible authority for carrying out the Scheme is the Council of the Shire of Busselton (hereinafter referred to as the Council).

1.5 Arrangement of Scheme: The Scheme Text is divided into the following parts:—

Part 1—Preliminary.

Part 2-Non-conforming Uses.

Part 3—General Provisions.

Part 4—Finance and Administration.

The remaining documents of the Scheme are as follows:—

(a) Land Use Map.

(b) Scheme Map.

1.6 Interpretation: In this Scheme the terms used will have the respective interpretation set out in Appendix D of the Town Planning Regulations 1967, unless otherwise specified by this Scheme.

PART 2-NON-CONFORMING USE OF LAND.

- 2.1 No provision of the Scheme shall prevent-
 - (a) the continued use of any land or building for the purpose for which it was being lawfully used at the time of the coming into force of the Scheme; or

(b) the carrying out of any development thereon for which, immediately prior to that time, a permit or permits required under the Town Planning and Development Act, 1928 (as amended) and any other law authorising the development to be carried out have been duly obtained and was current.

2.2 (a) Where in respect of land reserved under Part 3 of the Scheme a non-conforming use exists or was authorised as mentioned in Clause 2.1 of this Part on that land all or any erections, alterations or extensions of the buildings thereon or use thereof shall not be carried out unless the approval of the Council has been obtained in writing.

(b) Where in respect of land zoned under Part 3 of the Scheme a non-conforming use exists or was authorised as mentioned in Clause 2.1 of the Part on that land, and provided the prior consent in writing of the Council has been obtained, buildings may be extended to the limits prescribed by the Uniform Building By-laws made under the Local Government Act, 1960 (as amended), or by any other by-laws made under the Act for the purpose of limiting the size, location and distance from boundaries and any other matter required by law for that class of use within the boundary of the lot or lots on which the use was carried on immediately prior to the coming into force of the Scheme.

2.3 Change of Non-Conforming Use: The Council may permit the use of any land to be changed from one non-conforming use to another nonconforming use, provided the proposed use is, in the opinion of the Council, less detrimental to the amenity of the neighbourhood than the existing use, or is in the opinion of the Council closer to the intended uses of the zone.

- 2.4 Discontinuance of Non-Conforming Use:
 - (a) Notwithstanding the preceding provisions of this Part, except where a change of non-conforming use has been permitted by the Council under Clause 2.3, when a non-conforming use of any land or building has been discontinued, such land or building shall not thereafter be used other than in conformity with the provisions of the Scheme.
 - (b) The Council may effect the discontinuance of a non-conforming use by the purchase of the affected property, or by the payment of compensation to the owner or the occupier or to both the owner and the occupier of that property, and may enter into an agreement with the owner for that purpose.

PART 3-GENERAL PROVISIONS.

3.1 Subdivision.

3.1.1 The Scheme Map indicates an acceptable method of subdivision and development of the Scheme area which will enable the principles and concepts embodied in the design to be fulfilled. The Town Planning Board after consultation with the Council may permit departures from the design shown on the Scheme Map if it considers the proposed development to be of a similar standard to that shown provided that no departure from the design shown on the Scheme Map will be permitted if it will disadvantage or be detrimental to the development of the Scheme area as a whole.

3.1.2 An owner of land within the Scheme area who desires to subdivide his land either alone or in conjunction with other owners shall submit a plan of the proposed subdivision in the form of the Scheme Map design or in accordance with the provisions of Clause 3.1.1 to the Town Planning Board as required under the Town Planning Board Regulations 1962.

3.1.3 That portion of Biddle Road included within the Scheme is required to be upgraded. Each owner within the Scheme area shall pay to the Council his proportionate share of the cost of upgrading or upgrade Biddle Road prior to the Town Planning Board's final approval to the subdivision of his land. The proportions are set out in the first schedule attached to this Scheme.

3.1.4 Once the Scheme area has been subdivided in whole or in part in accordance with the Scheme map or Clause 3.1.1 no further subdivision of the subdivided Scheme area will be permitted.

3.1.5 The access strips to the lots generally referred to as battleaxe lots and shown cross hatched on the Scheme map are to be constructed to a gravel road base, or limestone base standard prior to the Town Planning Board's final approval of the subdivision thereof.

3.1.6 Every person who applies to the Town Planning Board to subdivide all or any part of the Scheme area will cede to the Crown under section 20A of the Town Planning and Development Act, 1928 (as amended) on approval of subdivision all that area coloured green on the Scheme map to the Crown for recreation that falls within his ownership.

3.1.7~ No lot within the Scheme area shall be less than 2 ha in area.

3.1.8 All lots within the Scheme area shall prior to the Town Planning Board's final approval be connected to a functioning bore or have access to an alternative water supply to the satisfaction of the Council.

3.2 Land Use Control.

3.2.1 No lot shall be used except for single residential purposes save that the following uses may be permitted in the Scheme area where the specific approval of the Council (conditional or otherwise) is first obtained.

Duplex Home occupation Institutional home Private recreation Public recreation Public assembly Public utility Public worship Rural use Stables

Veterinary establishment

3.2.2 It is intended that land coloured green on the Scheme Map shall be reserved for public recreation.

3.2.3 It is intended that land coloured green brown on the Scheme Map shall be used for rural uses and purposes ancillary thereto.

3.2.4 It is intended that land coloured green brown with a brown border shall be used for rural home purposes and in addition to the other provisions of this Scheme the following controls will apply to the area coloured green brown with brown border:—

- (a) No more than 25% of the total area of the lot shall be cleared of trees as defined in Clause 3.3.2 inclusive of clearing necessary for firebreaks, driveways and buildings,
- (b) On or before 30th October of each year each owner of a lot within the area coloured green brown with brown border on the Scheme Map shall clear and dispose of all indigenous and introduced grasses and scrub which would be in the opinion of the Council be a fire hazard.
- 3.3 Development Control.

3.3.1 The Scheme Map defines areas as building envelopes and no dwelling house, outbuilding or structure shall be constructed within the Scheme area unless it is within an area defined as a building envelope on the Scheme Map.

Where in the interest of retaining natural flora or protecting the site's environment, or degree of slope of the site makes siting any structure difficult, the Council's Town Planner may set an alternative building envelope. 3.3.2 The Council may specify that groups or clumps of trees are required to retain the rural character of the locality.

No person shall remove without the prior written consent of Council any of these groups or clumps of trees.

3.3.3 No sign, hoarding or billboard shall be permitted within the Scheme area unless the Council considers it is a necessity provided that no sign so permitted shall have an area greater than 1 square metre.

3.3.4 No dwelling house with a floor area of less than 100 square metres shall be permitted within the Scheme area.

3.3.5 All buildings within the Scheme area shall have external walls constructed of brick unless in the opinion of the Council the design and materials of the proposed buildings are of a sufficiently high standard to complement and blend in with the environment of the area.

3.3.6 All dwelling houses constructed within the Scheme area shall, prior to occupation, be connected to either a functioning water bore or have access to an alternative supply of water satisfactory to the Council.

3.3.7 In addition to the requirements of clause 3.3.6 of this Scheme, each dwelling house constructed in the Scheme area shall be connected to a water storage tank with a minimum storage capacity of 90 000 litres.

- (a) Asbestos.
- (b) Metal sheeting,
- (c) Wooden pickets.

3.3.9 The minimum standard of boundary fencing within the Scheme area shall be tanolith treated pine post and 5 strand wire, 1.0 m to 1.3 mhigh.

3.3.10 No motorised vehicle shall be permitted in the area coloured green on the Scheme Map without the prior consent of Council.

3.3.11 When considering building applications within the Scheme area the Council can either refuse or conditionally approve any application for any building.

3.3.12 Prior to the Town Planning Board granting final approval to the subdivision of whole or part of the Scheme area each lot being subdivided shall have a boundary fire break being no less than 2 m wide constructed to the satisfaction of the Council.

PART 4-FINANCE AND ADMINISTRATION.

4.1 Disposal of Land: The Council may deal with or dispose of any land which it owns or which it has acquired pursuant to the provisions of the Scheme, in accordance with the Act and in conformity with the provisions of the Scheme, and for such purpose may make such agreements with other owners as it deems fit.

4.2 Compensation: Claims for compensation by reason of the Scheme other than for the purpose of Part 2 shall be made not later than six months from the date on which notice of approval of the Scheme is published in the Government Gazette, except in the case of reserved land where the provisions of Part 2 shall apply.

4.3 Entry to Premises: The Council may by an authorised officer enter at all reasonable times any building or land for the purpose of ascertaining whether the provisions of the Scheme are being observed.

4.4 Penalties: Any person who fails to comply with any of the provisions of the Scheme is guilty of an offence and without prejudice to any other remedy given herein is liable to such penalties as are prescribed by the Act. 4.5 Any person aggrieved by a decision of the Council in the use of its discretionary powers under the Scheme may appeal in accordance with Part V of the Town Planning and Development Act, 1928 (as amended), and the regulations made there-under.
