LOTTERIES ACT 1954-1982.

INTERPRETATION ACT 1918-1981.

Sports/Culture Instant Lottery-Rules.

1. Made by the Lotteries Commission in accordance with the authority vested in it pursuant to section 10 (B) of the Lotteries (Control) Act 1954-1982.

2. These rules shall come into operation on the day on which they are published in the Government Gazette.

3. \$2.00, \$5.00, \$50.00 and \$100.00 prizes may be collected immediately from any official lottery sales outlet. All other prize winners must claim from the Lotteries Commission Office, Aherns Ground Floor, Murray Street, Perth.

4. The Commission shall as soon as possible after the Super Draw publish the Name and Address of major prize winners.

5. For inclusion in a Super Draw winning tickets must be presented for payment.

6. Any ticket may be judged void if reported stolen, illegible, mutilated, altered, misprinted, incomplete, any portion of the VOID IF REMOVED panel is exposed or if the ticket is defective in any other manner.

7. The Commission's liability for void tickets, if any, is to be limited to the replacement of the tcket.

8. Proof of postage of a ticket to the Commission will not be accepted as proof of delivery.

9. All winners must complete the appropriate section on the printed ticket to enter a Super Draw by clearly printing in ball point pen, name (including initials) and address and sign in the space provided. Only one name and address will be accepted.

(i) Any ticket not completed in a manner which fully complies with Rule 9 herein shall be deemed ineligible to win a prize in the Super Draw. Provided that defects which, in the opinion of the Commission, are minor, may not cause a ticket to be deemed ineligible. The decision of the Commission as to whether or not a ticket is ineligible shall be final.

10. The Instant Lottery Super Draw will be conducted as frequently as shall be required. Each drawing will be conducted under the supervision of a representative of the State Auditor General's Department, and the decision of the Commission shall be final for the purpose of determining prize winners for the particular Instant Lottery Super Draw.

11. A Super Draw will be conducted when the Commission has processed prize winning tickets that correspond to sales records for 500 000 tickets.

12. Accepted prize winning tickets will be placed in the drawing barrel. A Guest Drawer will be invited to remove eleven tickets, one at a time.

13. Each Super Draw will be identified by a number.

14. There will be a First Prize of \$50 000 and 10 (ten) prizes of \$500.00 in each Super Draw.

15. Tickets as drawn from the barrel will be checked to ensure they are eligible to win a prize. If ruled ineligible another ticket will be drawn to replace the ticket ruled ineligible.

16. A list will then be compiled showing:-

- (i) Value of prize.
- (ii) Name and Address of prize winners.
- (iii) Signature of Supervising Auditor and Commission Officer.

17. The Rules appearing on the back of the ticket are to be read in conjunction and construed as part of these Rules.

18. These Rules shall be displayed at the Office of the Commission, at any branch offices and the place of business of all accredited Agents and may be made public by any other means.

19. Notwithstanding that a ticket bears the name of a syndicate thereon the Commission will only recognize the person whose name and address appears in the space provided on such ticket as the absolute owner thereof.

20. The Commission shall not be bound by any agreement or arrangement made between syndicates or group entrants.

21. The Commission shall not be liable for any loss or damage arising out of unlawful acts of a third party or for Fire, Storm and Tempest, Flood, Earthquake, Riot, Civil Commotion, Lock-outs or Strikes prior to the acceptance of tickets.

22. Acceptance of tickets shall not be deemed to have been effected until the tickets have been received at the Head Office of the Commission, 334 Rokeby Road, Subiaco.

23. All decisions made by the Commission concerning Instant Lotteries and Super Draws, including the determination of prize money and the meaning and effect of these Rules shall be final and binding on all subscribers to such Instant Lotteries and on every person making a claim in respect thereof.

These Rules may be amended and any such amendments, modifications, 24. variations or abrogation shall take effect from the date published in the Government Gazette.

Ravensthorpe Limited Effluent Disposal Scheme.

Schedule.

DETERMINATION.

Rates and charges.

1. Subject to the other clauses in this determination, the rates and charges respectively set forth in Clause 6, of this determination are the amounts to be charged for the services respectively mentioned therein and no greater or lesser charge shall be made.

Additional charges.

2. Where it is agreed between the owner or his agent and the hirer that payment of the amount due from them in respect of a journey or special hiring shall be paid at a time later than the completion of the journey or special hiring, an additional charge of five per centum of the amount due by the hirer shall be made.

Taxi-meter units.

A taxi-meter fitted to a metered taxi-car shall be so adjusted as to register the flagfall and the minimum charge when the taxi-meter is set in operation and to register the amount charged for distance travelled and the detention charge, in progressive units of 10 cents.

No detention charge in cases.

4. A charge shall not be made for detention of a taxi-car arising from any accident involving the taxi-car or from the mechanical failure of, or any deficiency or insufficiency, in respect of, the taxi-car or from the failure of the taxi-car operator to tender correct change.

Hirers to pay tolls and parking fees.

The hirer of a taxi-car shall pay any tolls and parking fees incurred

during a hiring, at the hirer's request.

 - (ii) in the same direction; and
- (c) the total number of passengers in the taxi-car does not exceed the total number that the taxi is licensed to carry at any one time; and
- (d) the fare charged in respect of each hirer at his destination does not exceed seventy-five per centum (75%) of the amount of the fare than recorded on the taxi-meter.

(2) Nothing in this determination affects the right of a person to hire a taxi-car of the kind referred to and at the rates and charges described by Clauses 6 and 9 of this determination.

9. PRIVATE TAXI-CARS.

MAIN ROADS ACT 1930-1982.

MAIN ROADS (ENGINEERING CADETS) REGULATIONS 1982.

MADE by His Excellency the Governor in Executive Council on the recommendation of the Commissioner.

> These regulations may be cited as the Main Roads (Engineering Cadets) Regulations 1982.

Interpretation.

Citation.

2. In these regulations, unless the contrary intention appears-"cadetship" means a cadetship of a class specified in column 1 of Schedule 1 and "cadet" means a person employed in such a cadetship under an agreement which may include a period of service in the employment of the Commissioner after the

cadetship; "Institute" means the Western Australian Institute of Technology; "regulation" means one of these regulations;

"Schedule" means a Schedule to these regulations;

"University" means the University of Western Australia;

"the Act" means the Main Roads Act 1930 and includes any amendment thereto;

"satisfactory progress" in relation to a course of study and training means pursuing to completion the course of study and training and passing examinations for subjects at a rate and in a manner that satisfies the Commissioner.

Applications and selection committee.

3. (1) Applications for appointment to a cadetship shall be invited by the Commissioner by public advertisement.

(2) An officer appointed by the Commissioner shall consider and report to the Commissioner upon applicants for cadetships.

(3) The officer referred to in subregulation (2) of this regulation shall have regard to the applicant's academic record and such other matters as are considered relevant in determining suitability for the course of study and training specified in respect of the cadetship.

Eligibility.

Require-ments for applicants.

4. An applicant for appointment to a cadetship shall-

- (a) be not more than 25 years of age nor less than 16 years of age;
- (b) be qualified for admission to, or have completed and passed one or more years of, a University or Institute course specified in column 2 of Schedule 1 in respect of the Class of cadetship for which he applies; and
- (c) pass any aptitude test required by the Commissioner.

5. An applicant for appointment to a cadetship shall produce to the Commissioner-

- (a) evidence of his date of birth;
- (b) evidence that he has qualified or passed as the case may be in accordance with regulation 4 (b);
- (c) evidence as to character:
- (d) a medical certificate certifying that he is in good health and not affected with any physical infirmity that would interfere with the proper exercise of his professional duties; and
- (e) a questionnaire completed by the applicant on the form supplied at the office of the Commissioner.

Cadetship agreement.

(1) Before a person commences a cadetship he and a surety shall enter into an agreement with the Commissioner in the form of the agreement in Schedule 2.

(2) The surety referred to in subregulation (1) of this regulation shall be the cadet's legal guardian or such other person as the Commissioner approves.

Term of cadetship.

7. (1) Subject to these regulations, the term of a cadetship shall be 4 years.

(2) Where a person has completed and passed one or more years of a University or Institute course before entering into a cadetship agree-ment, the term of the cadetship may be reduced by the Commissioner so that the number of years to be served as a cadet corresponds with the number of years remaining to be undertaken in the University or Institute course that the cadet has partially completed.

Obligations of cadet.

8. A cadet shall—

- (a) take leave without pay to undertake, as a full time student, a University or Institute course specified in Column 2 of Schedule 1 in respect of the class of cadetship in which he is employed;
- (b) if so required by the Commissioner, work for the Commissioner-
 - (i) during vacations between the academic terms or semesters of each year of that course; and
 - (ii) during vacations between each academic year of that course and the next.

Termination, suspension of cadetship. 9. (1) If at any time during the term of a cadetship the Commissioner is not satisfied—

- (a) with examination results obtained by the cadet in a portion of his University or Institute course; or
- (b) as to the cadet's conduct, diligence, efficiency or his fitness to continue the cadetship,

the Commissioner may suspend the cadetship or terminate the cadetship agreement.

(2) Where a cadetship is suspended pursuant to paragraph (a) of subregulation (1) of this regulation the Commissioner may require the cadet to repeat the relevant portion of his course on such terms and conditions as the Commissioner may specify and the Commissioner shall restore the cadetship if he is satisfied with the examination results obtained by the cadet in repeating that portion of the course.

(3) A cadet whose cadetship is suspended remains subject to these regulations, but he is not, whilst the suspension remains in force, entitled—

(a) to be paid any allowance under regulation 12;

(b) to have any tuition fees paid on his behalf under regulation 12,

unless the Commissioner directs otherwise.

(4) If at the end of the term of a cadetship the cadet has not completed a University or Institute course specified in Schedule 1 in respect of the class of cadetship in which he has been employed the Commissioner may—

- (a) extend the term of the cadetship for a further period not exceeding two years;
- (b) require the cadet to enter into a new cadetship agreement; or

(c) terminate the cadetship agreement.

(5) Where pursuant to this regulation the Commissioner suspends a cadetship, requires a cadet to repeat portion of a course, extends the term of a cadetship, requires a cadet to enter into a new cadetship agreement, or terminates a cadetship agreement he shall cause written notification of his decision to be given to the cadet and to the surety under the agreement.

(6) A suspension or extension under this regulation does not relieve or suspend the cadet or the surety of or from liability under the cadetship agreement.

(7) Where under this regulation the Commissioner requires a cadet to enter into a new cadetship agreement he shall cause written notification of his decision to be given to the cadet and his surety under the existing cadetship agreement and if the cadet—

(a) refuses to enter into a new cadetship agreement as requested; or

(b) is unable to procure a person to act as a surety under a new cadetship agreement,

the Commissioner may terminate the existing cadetship agreement.

Salary.

10. (1) In this regulation the term "scale" shall be in accordance with the scale of salaries applicable to Group 1 Officers, as contained in the Main Roads Department General Division Salaries Agreement No. 6 of 1982 as amended from time to time, or the equivalent scale in any agreement made in substitution for that agreement.

(2) A cadet shall be paid a salary in accordance with this regulation during any period when—

- (a) he is working for the Commissioner in accordance with regulation 8 (b);
- (b) he is on annual leave in accordance with regulation 14 (1).

(3) Subject to subregulation (4) of this regulation the salary paid to a cadet shall commence—

- (a) at a rate equivalent to item 5 of the scale; or
- (b) in the case of a cadet who has completed and passed one or more years of a University or Institute course before entering into a cadetship agreement at a rate equivalent to the item on the scale that the Commissioner considers appropriate having regard to the portion of a University or Institute course that the cadet has completed,

and shall increase to the rate equivalent to the next succeeding item on the scale at the completion of each year of the term of the cadetship if the Commissioner is satisfied with examination results obtained by the cadet in his University or Institute course during that year.

(4) The salary paid to a cadet who has attained the age of 21 years shall be at a rate not less than the minimum wage determined from time to time by the Commonwealth Conciliation and Arbitration Commission for a person of that age. Living and transport allowance.

11. If a cadet is employed away from his headquarters, the Commissioner may approve of his being paid an allowance at such rate as the Commissioner determines as compensation for any extra cost of living involved or any extra cost for transport expenses necessarily incurred, or both.

Sustenance and other allowances. 12. (1) During any period when he is not paid a salary in accordance with regulation 10 a cadet is entitled to receive a sustenance allowance.

(2) A sustenance allowance may, with the approval of the Commissioner, be paid—

- (a) at a "category 1" rate to a cadet attending the University or Institute and whose ordinary place of residence is within a radius of 40 km from the Perth G.P.O.;
- (b) at a "category 2" rate to a cadet attending the University or Institute whose ordinary place of residence is outside a radius of 40 km from the Perth G.P.O. and who is obliged to live away from his ordinary residence.

(3) The sustenance rate for each category shall be determined by the Commissioner from time to time and notified in the *Government Gazette*.

(4) A cadet who is receiving a category 2 rate of sustenance allowance and who is living in accommodation at a cost in excess of that allowance is entitled to have his sustenance allowance increased to cover the cost of the accommodation but the allowance shall not exceed the amount payable to a cadet in residence at a University or Institute College.

(5) The Commissioner may approve the payment to a cadet of any further allowances necessary to enable the cadet to undertake his University or Institute course.

(6) A cadet is entitled to have all compulsory tuition fees paid on his behalf for those subjects which are comprised in his University or Institute course but this entitlement does not extend to subjects which are taken as a repetition of or in addition to or substitution for any part of that course.

(7) A cadet is responsible for the payment of his own faculty, service and amenities fees.

Public Service Act and Regulations. 13. During the whole term of his cadetship and during any extension thereof a cadet shall be entitled to the same conditions of service as permanent officers in the employment of the Commissioner, but he is not an officer of the Commissioner for the purposes of section 10 (1) of the Main Roads Act 1930.

Leave entitlements. 14. (1) Notwithstanding regulation 13 a cadet shall not be entitled to any leave entitlements other than an entitlement to take annual leave of absence for recreation at a time approved by the Commissioner.

- (2) A cadet shall be entitled to take leave without pay-
 - (a) during the academic terms or semesters of, and examinations in, each year of his University or Institute course; and
 - (b) unless he is required to work for the Commissioner pursuant to paragraph (b) of regulation 8, during vacations between academic terms or semesters and years of that course.

Completion of training and subsequent employment.

15. (1) A cadet shall be deemed not to have completed his cadetship until he has—

- (a) satisfactorily completed the study and training requirements specified in Column 2 of Schedule 1 in respect of the class of cadetship in which he is employed; and
- (b) served the term of the cadetship together with any due extension of that term.

(2) A person who has completed his term of cadetship shall, if so required by the Commissioner, serve the Commissioner as an Engineer-Class 1--

(a) for a period equivalent to the term of his cadetship together with any due extension of that term; or

(b) for a period of 2 years,

whichever period is the greater.

Repayment allowances etc. on termination of agreement.

16. (1) In the event of the termination of a cadetship agreement by the Commissioner, the cadet and the surety under the agreement shall, subject to subregulation (2) of this regulation, be jointly and severally liable to pay to the Commissioner, by way of reimbursement, a sum of money equivalent to the sum of all allowances and tuition fees paid to or on behalf of the cadet pursuant to regulation 12. (2) Where an agreement is terminated by the Commissioner after a cadet has commenced employment for the Commissioner pursuant to regulation 15 (2) the sum to be reimbursed to the Commissioner shall be reduced in accordance with the following formula—

$$\frac{WS}{WP} \times AF = R$$

where----

- WS is the number of weeks that the cadet has been employed by the Commissioner pursuant to regulation 15 (2), expressed as a number of weeks.
- WP is the period (expressed as a number of weeks) that the cadet is required to serve the Commissioner pursuant to that subregulation.
- AF is the sum of all allowances and tuition fees paid to or on behalf of the cadet pursuant to regulation 12.
- R is the amount by which the sum to be reimbursed to the Commissioner shall be reduced.

(3) For the purposes of a calculation made in accordance with the formula in subregulation (2) of this regulation a fraction of a week shall be deemed to be one week.

Suspension of Agreement.

17. A cadet may apply to the Commissioner for a suspension of the Agreement entered into between the cadet, his surety and the Commissioner and where the Commissioner approves of the application the cadet, his surety and the Commissioner shall enter into a further agreement as set out in Schedule 3.

- 2. Notwithstanding clause 1 of this direction the Authority may approve the transfer of a quota where the application is for the approval of the Authority to the transfer of the whole of a quota to a proposed transferee who is not the holder of a market milk quota.
- A person is associated with a proposed transferee if that person holds a market milk quota and is-
 - (a) a partner of the proposed transferee;
 - (b) a corporation of which the proposed transferee is an officer or director;
 - (c) where the proposed transferee is а corporation, an officer or director of the corporation;

- (d) an officer or director of any corporation of which the proposed transferee is an officer or director;
- (e) an employee or employer of the proposed transferee;
- (f) an employee of a natural person of whom the proposed transferee is an employee;
- (g) a corporation whose directors are accustomed or under an obligation whether formal or informal, to act in an obligation accordance with the directions, instructions or wishes of the proposed transferee or, where the person is a cor-poration, of the directors or manage-ment of that person;
- (h) a corporation in accordance with the directions, instructions or wishes of which, or of the directors or manage-ment of which, the proposed trans-feree is accustomed or under an obligation, whether formal or informal, to act;
- (i) a corporation in which the proposed transferee holds a substantial interest; or
- (j) where that person is a corporation-a person who holds a substantial interest in the corporation,

but persons shall not be regarded as associates if the Authority is satisfied on representations made by one or more of them and after its own enquiries (if any) that they are commercially independent in their respective enterprises.

- Where an application is made under paragraph (b) of subsection (4) of section 30 of the 4. Act-
 - (a) the Authority shall refuse the application if the proposed surrender is subject to payment by the Authority of an amount of compensation exceeding 63 dollars per litre of market milk quota on a daily basis;
 - (b) the Authority shall refuse the application if the proposed surrender would result in the applicant retaining a market milk quota of less than 245 litres on a daily basis;
 - (c) subject to paragraph (d) of this clause, the Authority shall refuse the application if the applicant proposes to sur-render less than 45 litres of market milk quota, on a daily basis; and
 - (d) the Authority shall not refuse the application by reason only of paragraph (c) of this clause if the proposed surrender is for the purpose of ensuring that the applicant will not hold a

market milk quota or market milk quotas exceeding in the aggregate 1 100 litres on a daily basis.

The basis or principles set out in the direc-5. tions made under section 30 of the Act on 22 December 1981 and published in the *Gov-ernment Gazette* on 31 December 1981 at page 5402 shall be of no further effect after the day on which these directions are made.
