WHEREAS by Clause XIV of the Letters Patent passed under the Great Seal of the United Kingdom constituting the office of Governor of the State of Western Australia and its Dependencies, dated 29 October 1900, it is provided that in the event of the Governor having occasion to be temporarily absent from the seat of Government or from the State, he may in every such case, by an instrument under the Public Seal of the State constitute and appoint the Lieutenant-Governor, or if there be no such officer, or if such officer be absent or unable to act, then any other person, to be his deputy during such absence, and in that capacity to exercise, perform, and execute for and on behalf of the Governor during such absence, but no longer, all such powers and authorities vested in the Governor by such Letters Patent, as shall in and by such instrument be specified; and whereas I, the said Governor, propose to absent myself temporarily from the seat of Government: Now, therefore, I, the said Governor, by virtue and in exercise of the powers vested in me as aforesaid, do by this instrument under the Public Seal of the State constitute and appoint you the said Sir Francis Theodore Page Burt as from the date of my departure upon the said absence and during

such absence to be my deputy, and in that capacity to exercise, perform, and execute for and on my behalf, as such Governor, all the powers and authorities vested in me by the said Letters Patent.

At any time during the currency of the lease, subject to the agreed development obligations and other conditions having been met to the satisfaction of the Hon. Minister, the lessee may surrender his lease to the intent that he may apply for purchase of the said land.

- (7) The lessee shall, within twelve months from commencement of the lease, fence the external boundaries with industrial fencing to the satisfaction of the Minister.
- (8) The lessee shall maintain existing and future improvements to the satisfaction of the Minister for Lands.
- (9) The lessee shall indemnify the Minister against all claims for damage to property or persons arising from the use of the land.
- (10) The Minister or his representative may enter the land for inspection at any reasonable time.
- (11) Compensation will not be payable for damage by flooding of the demised land.
- (12) Compensation shall not be payable to the lessee in respect of any improvements effected by him on the demised land and remaining thereon at the expiration or earlier determination of the lease.
- (13) It shall be lawful for the lessee at any time within the three calendar months immediately following the expiration of the term or earlier determination of the lease, to take down, remove, and carry away any buildings, structures, improvements and plant the property of the lessee.

## AGRICULTURE AND RELATED RESOURCES PROTECTION ACT 1976.

## AGRICULTURE AND RELATED RESOURCES PROTECTION (TRAPS) REGULATIONS 1982.

MADE by His Excellency the Governor in Executive Council.

- Citation. 1. These regulations may be cited as the Agriculture and Related Resources Protection (Traps) Regulations 1982.
- Commencement. 2. These regulations shall come into operation on the twenty-eighth day after the day on which they are published in the *Government Gazette*.
- Repeal. 3. The Vermin Act (Traps) Regulations 1975\*, as amended, are repealed.
- Definitions. 4. In these regulations, unless the contrary intention appears—  
“municipal district” means a municipal district as defined by the Local Government Act 1960;  
“regulation” means one of these regulations;  
“trap” means any steel trap, snare or other device (other than a live capture trap) used for the purpose of catching declared animals.
- Application of regulations. 5. These regulations apply to the setting of a trap on any land within the boundaries of the municipal district of a city, town or shire that is named in the Schedule to these regulations.
- Permit to set trap. 6. (1) A person shall not set a trap or traps for the purpose of catching a declared animal unless he has the written permission of the Protection Board to set traps in a manner approved by the Protection Board.  
Penalty: Not less than \$100, nor more than \$500.  
(2) An application for a permit under subregulation (1) shall be in writing and shall specify—  
(a) the month during which it is intended to set the trap or traps;  
(b) the location of the land on which it is intended to set the trap;  
(c) the species of declared animal it is intended to trap; and  
(d) the number and type of traps to be set.
- Duties of person setting trap. 7. Any person who sets a trap shall—  
(a) ensure that all animals caught in the trap are disposed of in a humane manner;  
(b) inspect the trap at reasonable intervals of time to ensure that animals do not remain in the trap longer than is unavoidable;  
(c) exercise reasonable care to ensure that animals which are not declared animals are not caught in the trap;  
(d) set the trap in the manner approved by the Protection Board; and  
(e) produce a copy of the permit when requested to do so by an authorized person, an inspector or an officer of the Royal Society for the Prevention of Cruelty to Animals Western Australia (incorporated).  
Penalty: Not less than \$100, nor more than \$500.
