UNDER section 9(2) of the Marine and Harbours Act 1981, I, the Governor, acting with the advice and consent of the Executive Council, do hereby vary the proclamation made under that Act published in the *Government Gazette* on 5 February 1982 at pages 410 to 412 as amended by proclamations so published on 19 February 1982 at page 584 and 12 April 1985 at pages 1281 to 1282 by deleting the description of the Dampier Port Area as set out in the Schedule to that proclamation and substituting the following description—

"DAMPIER PORT AREA

All that portion of seabed bounded by lines starting at the intersection of the High Water Mark of the Indian Ocean on the northwestern coast of the mainland of the State of Western Australia at east Longitude 116 degrees 36 minutes and extending north along that meridian to south Latitude 20 degrees 23.7

minutes; thence northeasterly to the intersection of south Latitude 20 degrees 18.2 minutes with east Longitude 116 degrees 50 minutes; thence south along that meridian to the High Water Mark of Flying Foam Passage on the northwestern coast of Dolphin Island; thence generally southwesterly along that mark to the westernmost southwestern extremity of Dolphin Island; thence south-westerly crossing the western entrance of Searipple Passage to the High Water Mark of Mermaid Sound at the northwesternmost north-western extremity of Burrop Peninsula; thence generally southwesterly along that mark to the northeastern boundary of DeWitt Location 197; thence northwesterly, generally southwesterly and generally northwesterly along boundaries of that Location to the northeastern corner of Location 199; thence generally northwesterly and generally south-westerly along boundaries of that location to the westernmost northwestern corner of Location 197; thence generally southwesterly and easterly along boundaries of that location to the High Water Mark of Mermaid Sound; thence generally southwesterly along that mark to the northern corner of Location 151; thence generally south-westerly, southeasterly, and northeasterly along boundaries of that location to the western corner of Location 204; thence southeasterly, northeasterly and northwesterly along boundaries of that Location to a south-western boundary of Location 151; thence northeasterly and southeasterly along boundaries of that Location to the westernmost northern corner of Location 200; thence southwesterly, southeasterly generally southerly and east along boundaries of that location to the High Water Mark of King Bay; thence generally easterly and generally southwesterly along that mark and generally southwesterly along the High Water Mark of the Indian Ocean to the starting point.

NOTIFICATION OF DISEASE AMENDMENT REGULATIONS 1985.

MADE by His Excellency the Governor in Executive Council.

- Citation. 1. These regulations may be cited as the Notification of Disease Amendment Regulations 1985.
- Principal regulations. 2. In these regulations the Notification of Disease Regulations* are referred to as the principal regulations.

HEALTH ACT 1911.

HEALTH (NOTIFICATION OF LEAD POISONING)
REGULATIONS 1985.

MADE by His Excellency the Governor in Executive Council.

- Citation. 1. These regulations may be cited as the Health (Notification of Lead Poisoning) Regulations 1985.
- Commencement. 2. These regulations shall come into operation on the day of publication of the Health—Infectious Diseases Order (No. 2) 1985.
- Interpretation. 3. In these regulations unless the contrary intention appears—
 “lead poisoning” means acute or chronic poisoning by taking of lead into the body.
- Lead poisoning a prescribed condition of health. Notification by medical practitioner. 4. Lead poisoning is prescribed as a condition of health to which Part IXA applies.
5. (1) Where a medical practitioner attends a person who is or may be suffering from lead poisoning the medical practitioner shall notify the Executive Director, Public Health upon the day on which he becomes aware of the person's condition.
 (2) Notice given under subregulation (1) in respect of any person shall be in writing and include—
 (a) the full name, address and occupation of the person;
 (b) sex and date of birth of the person;
 (c) the date of presentation of the person and the grounds for diagnosis of lead poisoning or diagnosis of suspected lead poisoning; and
 (d) the known or suspected source of the lead poisoning.
- Fee for notification. 6. A fee of \$2 is payable by the Minister to the medical practitioner in respect of each notice received by the Executive Director, Public Health under regulation 4 except that no fee shall be payable where a medical practitioner is a salaried employee of a government or public institution.

ROAD TRAFFIC ACT 1974.

ROAD TRAFFIC (LICENSING) AMENDMENT REGULATIONS (No. 2) 1985.

Made by His Excellency the Governor in Executive Council.

Citation and
principal regu-
lations.

1. (1) These regulations may be cited as the Road Traffic (Licensing) Amendment Regulations (No. 2) 1985.

(2) In these regulations the Road Traffic (Licensing) Regulations 1975* are referred to as the principal regulations.

Regulation 3
amended.

2. Regulation 3 of the principal regulations is amended in subregulation (1)—

(a) in the definition of "ordinary plates" by deleting "or dealers plates referred to in regulation 26" and substituting the following—

" , dealers plates referred to in regulation 26 or special plates ";
and

(b) by inserting after the definition of "Schedule" the following definition—

" "special plates" means identification tablets or number plates referred to in regulation 24 (4a); "

Regulation 22
amended.

3. Regulation 22 of the principal regulations is amended—

(a) in subregulation (2) by inserting after "number plates" the following—
" other than special plates "; and

(b) by inserting after subregulation (2) the following subregulations—

" (2a) The Board may on behalf of the Crown in right of the State dispose of the right to display special plates by public auction or public tender or private treaty.

(2b) Subject to this regulation, the following charges apply in relation to the transfer of the right to display special plates—

§

(a) single digit numeral special plates5 000.00

(b) 2 digit numeral special plates1 000.00

(c) 3 digit numeral special plates500.00

(d) any other number of digits special plates.....100.00

(e) unique series special plates.....1 000.00

(2c) Where the right to display special plates is transferred—

(a) pursuant to an agreement or order under the Family Law Act 1975 of the Commonwealth; or

(b) to a beneficiary by a trustee of other person in a fiduciary capacity under a trust whether express or implied,

the charge to be paid in respect of the transfer is \$10.00.

(2d) Where the right to display a special plate is owned by a body corporate and the Board is of the opinion that there has been a significant change in the ownership or control of the body corporate the right to display the special plate is deemed to have been transferred and the Board shall require the owner of the right to display the special plate to pay the relevant charge prescribed in subregulation (2b) in respect of the transfer.

(2e) The charge for an application for the issue of special plates to replace special plates bearing the same characters is \$100. ";

(c) in subregulation (3), by deleting "subregulation (2) of this regulation" and substituting the following—

" these regulations ";

(d) in subregulation (4), by inserting after "personalised plates" the following—

" or special plates ";

(e) in subregulation (5)—

(i) by inserting after "personalised plates" where first occurring the following—

" or special plates "; and

(ii) by inserting after "personalised plates" where secondly occurring the following—

" or special plates, as the case may be, ";

- (f) in subregulation (6)—
- (i) by inserting after “personalised plates” where first occurring the following—

“ or special plates ”; and
 - (ii) by inserting after “personalised plates” where secondly occurring the following—

“ or special plates, as the case may be, ”; and
- (g) by inserting after subregulation (6) the following subregulation—
- “ (7) The Board shall not issue special plates in respect of the following kinds of vehicles—
- (a) taxi-cars;
 - (b) omnibuses;
 - (c) motor cycles including mopeds;
 - (d) trailers;
 - (e) semi-trailers. ”.

4. Regulation 23 of the principal regulations is amended—

Regulation 23 amended.

(a) in subregulation (1)—

 - (i) by inserting after “lost” the following—

“ as a result of being stolen or any other cause ”;
 - (ii) by deleting “fresh number plates in respect of the vehicle.” and substituting the following—

“ another set of number plates in respect of the vehicles but where the lost number plate is a special plate the Board shall issue a special plate bearing the same characters or numerals or both, as the case may be. ”; and

(b) in subregulation (2)—

 - (i) by inserting after “the Board shall” the following—

“ where the number plate is an ordinary number plate ”; and
 - (ii) by inserting after “fit” the following—

“ , and where the number plates are special plates issue a special plate bearing the same characters or numerals or both, as the case may be, to replace the special plate that is damaged or dilapidated ”.

5. Regulation 24 of the principal regulations is amended—

Regulation 24 amended.

(a) in subregulation (1), by deleting “subregulation (2) and (3) of”;

(b) by inserting after subregulation (4) the following subregulation—

“ (4a) Special plates may consist of—

 - (a) a non-reflectorized tablet containing the expression “W.A.” in white arranged vertically on the left of the tablet and white numerals arranged horizontally on a black background; or
 - (b) a unique series consisting of the trade name of a particular make or model of vehicle in black letters on a white reflectorized background. ”; and

(c) in subregulation (6), by deleting “The” and substituting the following—

“ Except where the identification tablets or number plates are special plates, the ”.

6. Regulation 25 of the principal regulations is amended in subregulation (1)—

Regulation 25 amended.

 - (a) by deleting “and” after paragraph (a);
 - (b) by deleting the full-stop at the end of paragraph (b) and substituting a semi-colon;
 - (c) by inserting the following paragraph—

“ (c) in the case of an identification tablet or number plate that is a special plate that consists only of the expression “W.A.” and numerals, the special plate is mounted on the vehicle within a reflectorized frame supplied by the Board that provides a border of not less than 10 mm around the perimeter of the special plate. ”.

7. After regulation 25 of the principal regulations the following regulations are inserted—

Regulations 25A and 25B inserted.
Certificate of right to display.

“ 25A. (1) The Board shall issue to a person who is entitled to the right to display special plates issued under these regulations a certificate in the form of Form 5 and a miniature of the special plate in a sized determined by the Board.

(2) A person who is entitled to the right to display special plates may transfer that entitlement.

(3) A transfer for the purposes of subregulation (2) shall be by instrument in writing in duplicate in the form of Form 6 and signed by the vendor and the purchaser.

(4) The vendor of a right to display a special plate shall, within 14 days of the execution of the instrument of transfer by the vendor, lodge with the Board—

 - (a) the duplicate of the instrument of transfer of the special plates;
 - (b) where the special plates in question are not held by the Board, the special plates; and
 - (c) the certificate of ownership issued by the Board in respect of the right to display the special plates.

(5) The purchaser of the right to display special plates shall forward to the Board—

- (a) the original of the instrument of transfer of the right to display the special plates together with the prescribed charge; and
- (b) notification of the vehicle in respect of which the special plates are to be displayed,

the Board shall issue to the purchaser of the right to display the special plates—

- (c) a certificate of ownership of the special plates;
- (d) a miniature of the special plates; and
- (e) subject to regulation 25B, the special plates.

Retention of special plates by Board.

25B. (1) Where the person who is entitled to the right to display a special plate on a vehicle does not nominate a licensed vehicle on which the special plate in question is to be used as an identification tablet or number plate the special plate shall be retained by the Board.

(2) Where a special plate is retained by the Board under subregulation (1) the person who is entitled to the right to display the special plate is liable to pay to the Board a fee of \$10.00 per year or part thereof for storage of the special plate.

(3) Where the person who is entitled to the right to display a special plate on a vehicle fails to pay the fee referred to in subregulation (2) for 3 consecutive years the Board may by notice served on that person at his last known address and published in a newspaper circulating throughout the State notify him that unless he pays all the fees and charges due in respect of the storage of the special plate on or before the date specified in the notice his entitlement to the right to display the special plates will cease.

(4) Where a person is notified under subregulation (3) and fails to comply with the requirements of the notice the entitlement of that person to the right to display the special plates ceases with effect from the date specified in the notice. ”.

The Municipality of the Shire of Three Springs.

By-laws Relating to the Establishment and Maintenance of Bush Fire Brigades.

IN pursuance of the powers conferred upon it by the abovementioned Act and of all other powers enabling it, the Council of the abovementioned Municipality hereby records having resolved on 12 February 1985, to make and submit for confirmation by the Governor the following by-laws:—

Part 1.—Interpretation.

1. In these by-laws:—

“Council” shall mean the Three Springs Shire Council.

2. All previous by-laws relating to the establishment and maintenance of Bush Fire Brigades are repealed.

Part 2.—Establishment of Brigade.

3. By resolution, the Council may establish, maintain and equip a bush fire brigade under the provisions of the Bush Fires Act, 1954 and regulations thereunder, the brigade shall be formed in accordance with these by-laws; and a name shall be given to the brigade.

4. A bush fire brigade may be established for the whole of the Shire or for any specified area thereof.

Part 3.—Appointment of Officers.

5. The brigade members shall appoint a captain, a first lieutenant, a second lieutenant and such additional lieutenants and any other officers as it shall deem necessary to act as officers of the brigade and shall inform the Council accordingly.

6. Members of the brigade shall elect a person to act as Secretary to the brigade and shall inform the Council accordingly.

7. The brigade may appoint an equipment officer who shall be responsible for the custody and maintenance in good order and condition of all equipment and appliances acquired by the Council for the purpose of the brigade. Such officer may station such equipment at a depot approved by the Council where, if possible, motor trucks can easily be called upon. If there are more than one such depot in the area, the equipment officer shall appoint at each depot a person to look after the equipment and have it ready for immediate use when required.

Part 4.—Powers and Duties of Officers.

8. The powers and duties of all officers appointed under these by-laws shall be as laid down in the provisions of the Bush Fires Act, 1954 and each officer so appointed shall be supplied with a copy of the Act and regulations if it is requested.

Part 5.—Membership of Brigade.

9. Brigade members shall be those persons mentioned below, being able bodied persons over fifteen years who are willing to render service at any bush fire when called upon; and if not appointed as a requirement of the Bush Fires Act, 1954 or under above by-laws 5, 6 or 7, then those who sign an undertaking in the form contained in the First Schedule to these by-laws.

Part 6.—Meetings of Brigades.

11. Meetings of brigade will be held as necessary, however, a minimum of one meeting per year will be held.

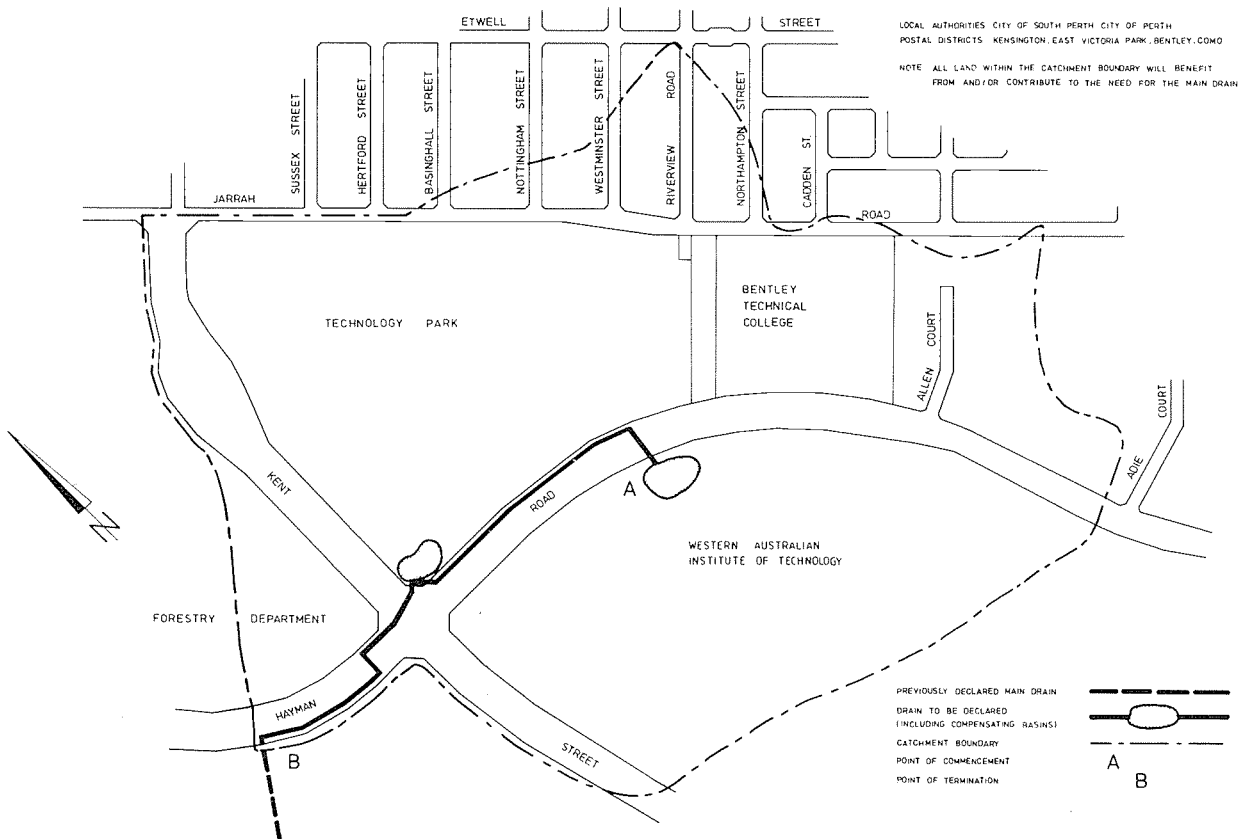

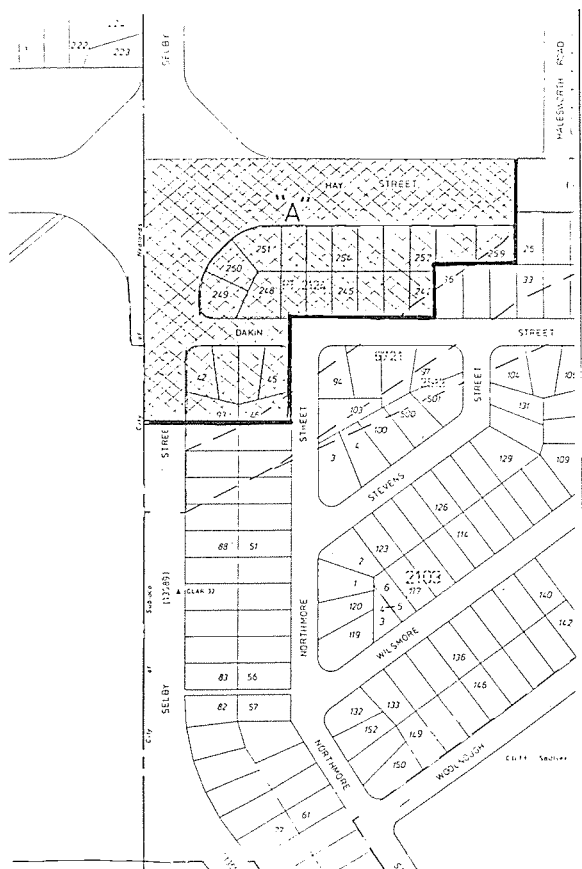
