


BOUNDARY OF VARIATION TO NORTH COASTAL

## TRUSTEES (AUTHORIZED INVESTMENTS) REGULATIONS 1988

MADE by His Excellency the Governor in Executive Council.

## Citation

1. These regulations may be cited as the *Trustees (Authorized Investments) Regulations 1988*.

## Commencement

2. These regulations shall come into operation on the day on which the *Trustees Amendment Act 1987* comes into operation.

## Authorized investments in building societies

3. A trustee may invest any trust funds in the shares of or on deposit in a building society that—

- (a) is carrying on business in the State; and
- (b) was, immediately before the coming into operation of the *Trustees Amendment Act 1987*, a society certified by the Treasurer under section 16 (1) (e) of the *Trustees Act 1962* as a society in which trustees may invest.

## TRUSTEE COMPANIES ACT 1987

## TRUSTEE COMPANIES REGULATIONS 1988

MADE by His Excellency the Governor in Executive Council.

## Citation

1. These regulations may be cited as the *Trustee Companies Regulations 1988*.

## Commencement

2. These regulations shall come into operation on the day on which the *Trustee Companies Act 1987* comes into operation.

## Scale of charges to be published

3. (1) A trustee company shall publish its scale of charges as required under the Act by making available free of charge—

- (a) to any person who approaches the trustee company for the purpose of making a will which names the trustee company as executor; and

(b) to any person who requests a copy of the scale of charges of the trustee company, a copy of its current scale of charges and, where a notice has been published under subregulation (4), a copy of its proposed scale of charges.

(2) A trustee company shall ensure that copies of its current scale of charges and, where a notice has been published under subregulation (4), copies of its proposed scale of charges are available free of charge at any office of the trustee company which is open to the public.

(3) In addition to the statement required under section 18 (9) of the Act the scale of charges as published under subregulations (1) and (2) shall include a statement to the effect that—

- (a) the trustee company is entitled to the reimbursement of all disbursements properly made by the trustee company in the administration or management of an estate; and
- (b) where an estate participates in an Estate Common Trust Fund the fee or commission set out in the scale of charges may apply.

(4) Where a trustee company proposes to alter its scale of charges the trustee company shall cause to be published in the public notices section of a daily newspaper circulated throughout the State a notice—

- (a) stating that the trustee company proposes to alter its scale of charges with effect from a date specified in the notice;
- (b) giving details of the proposed alteration to its scale of charges; and
- (c) stating that copies of the proposed scale of charges are available upon request at any office of the trustee company.

(5) A notice under subregulation (4) shall be published at least 14 days before the day on which the alteration is to come into effect.

(6) The scale of charges as published under subregulations (1) and (2) and any notice under subregulation (4) shall be in print no smaller than 5 point Roman type face.

**Amount prescribed for the purposes of section 10**

4. For the purposes of section 10 of the Act the amount prescribed is \$50 000.

**Form of returns under section 33**

5. A statement lodged under section 33 (1) (a) or (b) of the Act shall be—

- (a) made in accordance with Form 1 in the Schedule; and
- (b) accompanied by a balance sheet and a profit and loss account as set out in Form 2 in the Schedule.

**Completion of forms**

6. A form shall be completed in accordance with such directions and instructions as are specified in, or relate to, the form.

**Compliance with forms**

7. (1) Strict compliance with the style of a form set out in the Schedule is not necessary, unless the Commissioner so requires.

(2) Strict compliance with the substance of, and provision of the information required by, a form set out in the Schedule is necessary unless the Commissioner otherwise approves.

**Fee for lodgement of statement under section 33**

8. The fee for the lodgement of a statement under section 33 (1) (a) or (b) is \$1 000.

" (1A) A person may during the months of November, December, January and February set a fishing net in the waters of Broke Inlet within the period commencing at 5 pm on any day and ending 1 1/2 hours before the next sunrise. ";

" periods referred to in subregulations (1) or (1A) ".

"set net" means a net placed in the water with a cork line at or beneath the surface;

## Notice to all Owners and Occupiers of Land

PURSUANT to the powers contained in section 33 of the above Act you are hereby required, on or before 31 October 1988 to establish firebreaks clear of all flammable material and thereafter maintain such firebreaks clear of all flammable materials up to and including 15 April 1989.

## Notice to all Owners and/or Occupiers of Land in the Shire of Gnowangerup

PURSUANT to powers contained in section 33 of the above Act, you are hereby required on or before 1 November 1988 to clear of all flammable material, firebreaks as stated hereunder and thereafter to maintain the firebreaks clear of inflammable materials up to and including 15 April 1989.

1. (1) Prepare firebreaks not less than three metres wide within 200 metres of all neighbours boundaries whether such land is cleared, part cleared or uncleared, except where neighbours jointly agree to maintain a single firebreak.

Where this variation is sought a permit is required from the Local Fire Control Officer.

(2) Breaks alongside constructed road optional, except where the land is sown to crop for harvesting. In such cases where crop is sown, prepare a three metre wide break immediately inside the boundary adjoining the crop, or mow for hay, and bale a six metre wide strip immediately inside the boundary.

2. Embark on a policy of strategic firebreaks in lieu of property breakdown.

The use of farm roads cleared of inflammable material, graded contours, graded dam catchments all not less than three metres wide are acceptable.

Further use of salt creeks, lakes and naturally bare ground will be allowed so that a ratio of one kilometre of break per 250 hectares exists.

3. Prepare firebreaks not less than three metres wide within 100 metres of, and surrounding all buildings, haystacks and fuel dumps.

4. Prepare firebreaks not less than 10 metres wide immediately around the perimeter of any scrub or timber which has been logged, chained or otherwise prepared for burning within seven days of such work being completed.

No area to exceed 400 hectares.

5. In respect of land within any Townsite within the Shire you shall—

(a) Where the area is 2 000 square metres or less, remove all inflammable material on the land from the whole area of the land.

(b) Where the area exceeds 2 000 square metres firebreaks not less than two metres wide, shall be prepared immediately inside and along all external boundaries of the land.

Penalty for non-compliance: \$400.

If it is considered to be impracticable for any reason to clear firebreaks as required by this Notice, the approval of the Council must be obtained to clear such breaks in an alternative position. Notice to all owners and/or occupiers of land in the Shire of Tammin

Notice to Owners and Occupiers of Land

Firebreak Order

PURSUANT to the powers contained in section 33 of the Bush Fires Act 1954, owners and occupiers of land within the Shire of Victoria Plains are required to, on or before 15 October 1988, remove from the land owned by or occupied by them all inflammable material or to have firebreaks in accordance with the following, and thereafter keep the land or the firebreak clear of all inflammable material up to and including 29 March 1989.

## 1. Rural Land—

- (a) Firebreaks not less than 2.5 m wide shall be provided inside and along and within 20 metres of the whole of the external boundaries of each property, and immediately surrounding all buildings and haystacks, or in such other alternate positions for which permission has been granted under paragraph 4 (d).

Townsites: Owners and Occupiers of land within the townsites of Bolgart, Calingiri, Yerecoin, Piawaning and Mogumber shall clear the land of all inflammable material, or shall clear a firebreak not less than 2.5 m wide around and immediately within the boundaries of each individual lot. Where adjoining land is in common ownership or occupancy, firebreaks may be constructed so as to encompass such lots collectively. Firebreaks not less than 2.5 m wide shall be constructed around all buildings and haystacks situated on the land.

3. Fuel dumps/Tanks/Depots: Where there are flammable liquid or gas containers on the land, whether such containers are full or empty, owners and occupiers shall—

- (a) Townsite Land—clear the whole of the land of inflammable material.
- (b) Rural Land—locate such dumps/tanks/ramps not less than 15 metres from any public thoroughfare or improvement upon the land, and construct firebreaks not less than six metres in width around and immediately adjacent to all such installations.

## 4. General—

- (a) The term "Inflammable Material" for the purposes of this notice includes bush (as defined in the Bush Fires Act 1954), timber, boxes, cartons, paper and the like inflammable materials, rubbish and any combustible matter, but does not include buildings, green standing trees, or growing bushes or plants in gardens or lawns.
- (b) The penalty for failing to comply with this Notice is a fine of not more than one thousand dollars (\$1000) and a person in default is also liable, whether prosecuted or not, to pay the cost of performing the work directed in this Notice.

- (c) If the requirements of this Notice are carried out by burning, such burning must be in accordance with the relevant provisions of the Bush Fires Act.
- (d) If it is considered impractical for any reason to clear firebreaks as required by this notice, you may apply to the Council or its duly authorised officer not later than 5 October 1988, for permission to provide firebreaks in alternative positions on the land. If permission is not granted by the Council or its duly authorised officer, and shall comply with the requirements of this notice.





The Schedule shall apply in the case of contracts made on or after the date of publication of this notice and replaces the schedule published in the *Government Gazette* on 30 August 1985.

## Schedule

1. Application Fee—
  - (i) For loans up to \$100 000—  
\$100.00 non refundable for each loan.  
The Application Fee is a payment against the eventual Brokerage charge.
  - (ii) For loans over \$100 000—  
Fee established by prior mutual agreement in writing between the parties.
2. Inspection Fees—

  - (ii) Subsequent Inspections—
    - (a) For progress advances for residential properties within 30 kilometres radius \$40 per inspection with a maximum of \$160 per property.
    - (b) For progress advances for residential properties beyond 30 kilometres radius and commercial properties in the course of erection by negotiation with the client.
3. Brokerage Fees—
  - (i) Local Money Loans—
    - (a) For loans up to \$100 000—2 per cent.
    - (b) For loans over \$100 000: Fee established by prior mutual agreement in writing between the parties.
  - (ii) Bridging Loans—  
On loans of six months or less \$100 plus one per cent.

  - (iii) Interstate and Overseas Loans: Rates subject to prior written agreement between broker and client. If interim Bridging Finance also arranged additional brokerage of one per cent to be charged. Subject to loans in excess of \$100 000 being by negotiation between parties.
  - (iv) Conditions of Brokerage Charges—
    - (a) Brokerage should NOT be charged by a selling agent where a Contract of Sale or Mortgage to Vendor is arranged. The agent Broker may, however, charge on a time basis for consultations and work done (see miscellaneous charges).
    - (b) Where the selling agent is also the broker a separate written Loan Application is also required before brokerage can be charged.
    - (c) No brokerage or other fees shall be charged by a broker in respect of a Building Society loan expressly for the purpose of financing the purchase of the borrower's principal place of residence.
4. Transfer of Mortgage between Investor Clients: Standard scale of fees plus out of pockets, payable by the Transferor.
5. Extension of Mortgages: Two-fifths standard brokerage inclusive of any reinspection, but revaluations, solicitors costs, stamp duty, and registration should be in addition.
6. Finalisation Fee (discharges): Flat fee of \$60 to include all services required of a broker, in addition to legal costs, out of pockets, and settlement fees.
7. Commission on Interest Collections—
  - (a) Interest Collections only—6 per cent of interest collections inclusive of postages, cheque duty and bank charges.

- (b) Total Mortgage Management—including interest collection and supervision of mortgagor's compliance with all mortgage clauses—

Eight per cent of interest collections, inclusive of postages, cheque duty and bank charges except where the broker is acting as an agent for an insurance company in which case fee of six per cent applies.

## 8. Miscellaneous Charges—

- (a) Production of Title—\$40.
- (b) Titles Office Searches \$8 plus Titles Office fees.
- (c) Additional Interest Statements as provided in the Finance Brokers Code of Conduct \$13 for each statement issued.
- (d) Bank Cheques—\$6 including costs.
- (e) Where no brokerage fees are payable consultations, advice, investigations and negotiations on finance—standard charges of \$60 per hour based on the actual time spent.
- (f) Disbursements directly and reasonably incurred by the broker in the negotiations relating to a loan or a proposed loan and without limiting the generality of the foregoing would include—search fees, production fees, telephone trunk calls, telex, telegrams, accommodation expenses, postages and courier service and relevant Government charges.  
The broker shall at the request of the client produce to the client such evidence of disbursement that the client should reasonably require.
- (g) Where a broker is appointed as an Agent for the mortgagee under the terms of mortgage charge to be negotiated with the mortgagee but not to exceed \$60 per hour.
