HEALTH (LICENSING OF LIQUID WASTE) AMENDMENT REGULATIONS 1989

MADE by the Lieutenant-Governor, and Deputy of the Governor in Executive Council.

Citation

1. These regulations may be cited as the *Health (Licensing of Liquid Waste) Amendment Regulations 1989*.

Principal regulations

2. In these regulations the *Health (Licensing of Liquid Waste) Regulations 1987** are referred to as the principal regulations.

[*Published in the Government Gazette on 11 December 1987 at pp. 4372-4378. For amendments to 3 May 1989 see page 273 of 1987 Index to Legislation of Western Australia and Gazettes of 5 August 1988 and 23 December 1988.]

Regulation 7 amended

3. Regulation 7 of the principal regulations is amended in subregulation (1) by inserting after paragraph (a) the following paragraph—

“ (aa) ensure that the liquid waste is removed by a transporter licensed in accordance with regulation 8; ”.

Regulation 10A inserted

4. After regulation 10 of the principal regulations the following regulation is inserted—

Vehicle identification

“ 10A. A transporter shall display clearly on all vehicles and tanks used by him for the collection or transport of liquid waste in letters and figures not less than 150 mm in height—

(a) his name, which is to be displayed on each side of the vehicle and the rear of the tank; and

(b) the carrying capacity of the tank, in litres, which is to be displayed on each side of the tank. ”.

Regulation 13 repealed and a regulation substituted

5. Regulation 13 of the principal regulations is repealed and the following regulation is substituted—

Fee payable by disposal site operator

“ 13. (1) A disposal site operator shall pay to the Executive Director, in addition to the licence fee referred to in regulation 5, a fee of \$1 for every kilolitre (or part thereof) of liquid waste discharged at the disposal site.

(2) The number of vehicles transporting liquid waste which enter the disposal site and the amount of liquid waste discharged from each of those vehicles shall be recorded each day by the disposal site operator.

(3) The fee referred to in subregulation (1) shall be paid monthly within 14 days of the last day of the month and shall be calculated by totalling the amounts of liquid waste discharged during the month from the records referred to in subregulation (2). ”.

POISONS AMENDMENT REGULATIONS 1989

MADE by the Lieutenant Governor, and Deputy of the Governor in Executive Council.

Citation

1. These regulations may be cited as the *Poisons Amendment Regulations 1989*.

Principal regulations

2. In these regulations the *Poisons Regulations 1965** are referred to as the principal regulations.

Regulation 27 amended

3. Regulation 27 of the principal regulations is amended in paragraph (a) by deleting "sans serif" and substituting the following—
" sans serif ".

Regulation 36 amended

4. Regulation 36 of the principal regulations is amended in subregulation (3) by deleting paragraph (d) and substituting the following paragraph—
" (d) A prescription shall not be dispensed if it is—
(i) marked "cancelled"; or
(ii) more than 12 months old. "

Regulation 38C amended

5. Regulation 38C of the principal regulations is amended—
- (a) by inserting after "except" the following—
" by wholesale dealing or "; and
 - (b) by deleting "qualified specialist practising in the field of gynaecology or obstetrics or both" and substituting the following—
" medical practitioner specializing in gynaecology or obstetrics ".

Regulation 38D amended

6. Regulation 38D of the principal regulations is amended by repealing subregulation (1) and substituting the following subregulations—
- " (1) Etretinate or a substance containing etretinate shall not be supplied except—
- (a) by wholesale dealing; or
 - (b) on the prescription or order of a medical practitioner specializing in general medicine or dermatology.
- (1a) Where etretinate or a substance containing etretinate is supplied in accordance with subregulation (1) (b) the supplier shall—
- (a) when supplying the patient or the agent of the patient with the etretinate or the substance containing etretinate, provide that person with a leaflet approved by the chief executive officer of the department setting out the hazards associated with the use of etretinate; and
 - (b) ensure that the container in which the etretinate or the substance containing etretinate is supplied is labelled with a statement as follows—
"WARNING—CAUSES BIRTH DEFECTS". "

Regulation 38E repealed and a regulation substituted

7. Regulation 38E of the principal regulations is repealed and the following regulation is substituted—

Prostaglandins

- “ 38E. Cloprostenol, dinoprost, fenprostalene, fluprostenol, prostianol or a substance containing any of those prostaglandins shall not be supplied except—
- (a) by wholesale dealing;
 - (b) on the prescription of a veterinary surgeon for use in the treatment of animals; or
 - (c) in the case of dinoprost or a substance containing dinoprost, on the prescription of a—
 - (i) medical practitioner specializing in general medicine;
 - (ii) medical practitioner specializing in gynaecology or obstetrics; or
 - (iii) medical practitioner authorized in writing by the chief executive officer of the department. ”.

Regulation 38F amended

8. Regulation 38F of the principal regulations is amended by repealing subregulation (1) and substituting the following subregulations—

- “ (1) Isotretinoin or a substance containing isotretinoin shall not be supplied except—
- (a) by wholesale dealing; or
 - (b) on the prescription or order of a medical practitioner specializing in general medicine or dermatology.
- (1a) Where isotretinoin or a substance containing isotretinoin is supplied in accordance with subregulation (1) (b) the supplier shall—
- (a) when supplying the isotretinoin or the substance containing isotretinoin to the patient or the agent of the patient, provide that person with a leaflet approved by the chief executive officer of the department setting out the hazards associated with the use of isotretinoin; and
 - (b) ensure that the container in which the isotretinoin or the substance containing isotretinoin is supplied is labelled with a statement as follows—
“WARNING—CAUSES BIRTH DEFECTS”. ”.

Regulation 38G amended

9. Regulation 38G of the principal regulations is amended by inserting after “except” the following—

- “ by wholesale dealing or ”.

Regulation 38H repealed and a regulation substituted

10. Regulation 38H of the principal regulations is repealed and the following regulation is substituted—

Chloramphenicol

- “ 38H. Chloramphenicol or substances containing chloramphenicol shall not be supplied except—
- (a) by wholesale dealing;
 - (b) for human use on the prescription of a medical practitioner; or
 - (c) for use in or on an animal on the prescription of a veterinary surgeon in respect of an animal not used for meat, egg or milk production. ”.

Follicular stimulating hormone and luteinizing hormone

- “ 38I. Follicular stimulating hormone, luteinizing hormone or a substance containing follicular stimulating hormone or luteinizing hormone shall not be supplied except—

 - (b) on the prescription of a medical practitioner specializing in gynaecology or obstetrics;
 - (c) on the prescription of a medical practitioner specializing in general medicine; or
 - (d) for the purpose of the conduct of medical or scientific research including veterinary trials under the direction of a veterinary surgeon.

Fourth Schedule veterinary drugs

38J. 4-aminopyridine, clenbuterol, metergoline, sodium pentosan, polysulphate, sulphatroxazole, tiletamine, zolazepam or a substance containing any of those drugs shall not be supplied except—

- (a) by wholesale dealing; or
- (b) on the prescription of a veterinary surgeon for use in the treatment of animals.

Carnidazole

38K. Carnidazole or a substance containing carnidazole shall not be supplied except—

- (a) by wholesale dealing; or
- (b) on the prescription of a veterinary surgeon for use in the treatment of pigeons. ”.

NATIONAL CRIME AUTHORITY (STATE PROVISIONS) REGULATIONS 1989

MADE by His Excellency the Governor in Executive Council.

Citation

1. These regulations may be cited as the *National Crime Authority (State Provisions) Regulations 1989*.

Commencement

2. These regulations shall come into operation on the day on which the *National Crime Authority (State Provisions) Amendment Act 1988* comes into operation.

Search warrant

3. A warrant issued by a Judge under section 12 of the Act shall be in the form of Form 1 in the Schedule.

Summons to appear before Authority

4. A summons under section 17 of the Act requiring a person to appear before the Authority at a hearing shall be in accordance with Form 2 in the Schedule.

Service of summons to appear before Authority

5. (1) For the purposes of section 19 of the Act, each of the following manners of serving a summons is prescribed—

(a) where the person named in the summons is a natural person—

- (i) tendering a copy of the summons to the person or, if on tender of the copy the person refuses to accept it, putting it down in the presence of the person or leaving it at or upon the place or premises where the person is;
- (ii) if the service in the manner specified in subparagraph (i) is not practicable—leaving a copy of the summons at the last known or usual place of residence or business of the person with another person who is, or is reasonably believed to be, over the age of 16 years and is, or is reasonably believed to be residing, or employed, at that place or sending a copy of the summons by registered post or certified mail to the person at the last known or usual place of residence or business of the person or at the last known or usual postal address of the person;

- (iii) if a Judge has, subject to subregulation (2), given a direction that the summons should be so served—leaving a copy of the summons with another person identified in the direction, being a person who, in the opinion of the Judge, is likely to bring the contents of the summons to the notice of the person, or sending it by registered post or certified mail to an address specified in the direction, being the address of a place that the Judge has reasonable grounds to believe to be a place frequented by the person;
- (b) Where the person named in the summons is a body corporate—
- (i) tendering a copy of the summons to a person who is, or is reasonably believed to be, an officer of, or in the service of, the body corporate and is or is reasonably believed to be, above the age of 16 years at the head office, a registered office, a principal office or a principal place of business of the body corporate or, if on tender of the copy the person refuses to accept it, leaving it at or upon the premises;
- (ii) sending a copy of the summons by registered post or certified mail to the head office, a registered office, a principal office or a principal place of business of the body corporate or at a postal address of the body corporate.
- (2) A Judge shall not give a direction referred to in subparagraph (1) (a) (iii) in relation to the service of a summons on a person unless the Judge is satisfied upon information furnished in writing by a member or an acting member, that—
- (a) service of the summons on the person in a manner specified in subparagraph (1) (a) (i) or (ii) has not been, or is not likely to be, successful; and
- (b) there is a likelihood that service of the summons in a manner specified in subparagraph (1) (a) (iii) would result in the summons coming to the notice of the person.
- (3) In this regulation, “Judge” means—
- (a) a Judge of the Federal Court; or
- (b) a Judge of a court of a State or Territory.

ROAD TRAFFIC ACT 1974

ROAD TRAFFIC (LICENSING) AMENDMENT REGULATIONS 1989

MADE by His Excellency the Governor in Executive Council.

Citation

1. These regulations may be cited as the *Road Traffic (Licensing) Amendment Regulations 1989*.

Commencement

2. These regulations shall come into operation on the 28th day after the day on which they are published in the *Government Gazette*.

Regulations 27A, 27B and 27C inserted

3. After regulation 27 of the *Road Traffic (Licensing) Regulations 1975** the following regulations are inserted—

Meaning of "imitation plate"

" 27A. In regulations 27B and 27C "imitation plate" means—

- (a) a replica or imitation of an identification tablet or number plate issued under these regulations; or
- (b) an article that is so similar to an identification tablet or number plate issued under these regulations that it is likely to be confused with such an identification tablet or number plate.

Restriction on manufacture, sale or supply of imitation plates

27B. A person shall not manufacture, sell or supply an imitation plate except under written authorization granted by the Board.

Confiscation and disposal of imitation plates

27C. (1) A member of the police force may seize and take possession of—

- (a) any imitation plate that the member has reasonable grounds to believe has been manufactured, sold or supplied contrary to regulation 27B; or
- (b) any imitation plate that is fixed to a vehicle.

(2) The Board may, with the approval of a justice, cause an imitation plate seized under this regulation to be destroyed.

(3) An imitation plate may be destroyed under subregulation (2) whether or not any person has been convicted of or charged with an offence under regulation 27B in connection with the plate.

(4) When, or as soon as practicable after, an imitation plate is seized under this regulation a member of the police force shall serve the person from whom it was seized with a notice that informs the person—

- (a) that the plate is liable to be destroyed; and
- (b) that the person may make written representations to the Board in relation to the plate within 10 days after service of the notice.

(5) For the purposes of subregulation (4) an imitation plate that was fixed to a vehicle shall be deemed to have been seized from the person who is the owner of the vehicle within the meaning of paragraph (d) of the definition of owner in section 5 (2) of the Act.

(6) At any time after the expiration of 14 days from service of the notice under subregulation (4) the Board may apply to a justice for approval to destroy the imitation plate.

(7) The application shall be accompanied by copies of any representations received under subregulation (4) (b) in relation to the plate.

(8) The justice, after considering the application, the representations (if any), and the need (if any) for the plate to be retained for evidentiary purposes, may—

- (a) approve of the destruction of the plate;
- (b) direct that the plate be returned to the person from whom it was seized; or
- (c) authorize the continued retention of the plate for evidentiary purposes.

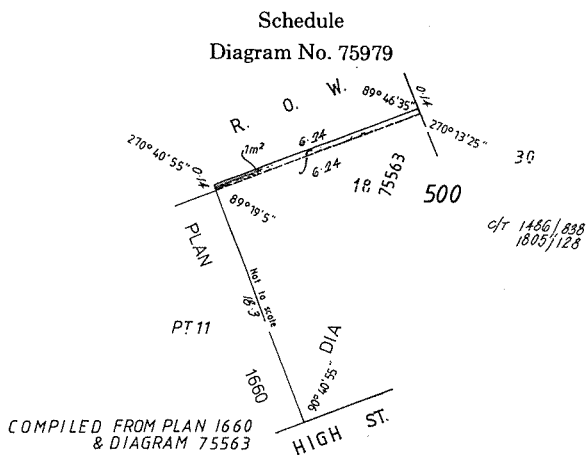

The Municipality of the Town of Narrogin

By-laws Relating to the Care, Control and Management of Roads and Ways

IN pursuance of the powers conferred upon it by the abovementioned Act, the Council of the abovementioned Municipality hereby records having resolved on the 20th October 1987 to make and submit for confirmation by the Lieutenant Governor and Deputy of the Governor the following By-laws—

1. In these By-laws unless the context otherwise requires the following terms shall have the meanings set against them hereunder—
 - "Act" means the Local Government Act 1960, as amended.
 - "Council" means the Council of the Municipality of the Town of Narrogin.

Expressions used in these By-laws have the meanings given to them by the Act.
2. No person shall without the approval of the Council—
 - (a) expose for sale or place or hang up any wares, article or thing upon or over any street, way, footpath or public place;
 - (b) stand or walk in or upon any street, way, footpath or public place offering for sale any article or thing;
 - (c) shout, call aloud or make any noise in or upon any street, way, footpath or public place for the purpose of advertisement.
3. No person shall—
 - (a) permit paper, sand or other materials used during the progress of works during the loading or unloading of goods to be blown about upon any street, way, footpath or public place;
 - (b) spit or expectorate on any portion of a paved street, way, footpath or public place;
 - (c) sound or make any noise by use of a gramophone, amplifier, wireless appliance, bell or other instrument or appliance in or upon any street, way, footpath or public place which unreasonably disturbs or causes annoyance to occupiers of properties in the vicinity;
 - (d) advertise through or throw or discharge any handbill or other printed matter in the street, way, footpath or public place;
 - (e) damage, deface, remove or otherwise interfere with any signpost, direction plate, guidepost, notice, shelter, shed, fence or any structure erected by the Council in or over any street, way, footpath or public place;

- (f) except in a receptacle provided for that purpose by the Council, deposit any rubbish, bottles, glass or litter in any street, way, footpath or public place except in a receptacle provided for that purpose by the Council;
- (g) throw, place or leave or cause to be thrown, placed or left, fruit or fruit skins or peel or other vegetable substances in any street, way, footpath or public place except in a receptacle provided for that purpose by the Council;
- (h) light a fire or burn rubbish or other material in a street, way, footpath or public place;
- (i) in any street or way train or race any animal.
4. No person shall without the authority of a licence issued by the Council—
- (a) erect or maintain or permit to be erected or maintained any sign, signboard, awning, blind, hoarding or other advertisement in, on or over any street, way, footpath or public place;
- (b) set up, post, paint, stencil, place or affix any advertisement on hoardings in any street, way, footpath or public place.
5. No person shall without the written consent of the Council and subject to the conditions (if any) imposed thereby—
- (a) provide, erect, install or use in or on any building, structure, or land abutting on any street, way, footpath or other public place any hoist or other thing for use above the level of such street or way;
- (b) excavate or otherwise damage the surface of any street, way, footpath or other public place;
- (c) play any musical instrument or sing in any street, way, footpath or public place which unreasonably disturbs or causes annoyance to occupiers of property in the vicinity;
- (d) permit goods or merchandise, including firewood, soil, fertilisers and building material from remaining in a street, way, footpath or other public place for longer period than is necessary for delivering the goods or merchandise into the place of delivery;
- (e) fell a tree on or across a street, way or footpath and prevent vehicles or persons having the free or unhindered use of the street, way, or footpath.
6. If any verandah or part of a building or structure protrudes into or above a street, way, footpath or other public place as to constitute in the opinion of the Council an obstruction of the street, way, footpath, or public place or a danger to the users of the street, way, footpath or public place the Council may by notice in writing to the occupier or owner of the land from which such building, verandah or structure protrudes require such person to remove the part so protruding.
7. In this By-law unless the context otherwise requires—
- “Corner land” means land which is bounded in part by a section of a street that is at or nearby the intersection of that street with another street.
- “Fence or tree” means a fence, wall, tree or hedge or other like structure or thing.
- (a) If on corner land there is standing a fence or tree that is in the opinion of the Council so situated as to constitute an obstruction or interference with the vision of other vehicles by persons driving vehicles approaching, entering or passing through the intersection, the Council may give notice in writing to the owner or occupier of that corner land calling upon him to alter, trim, take down or remove the fence or tree within the time specified in the notice, and the manner specified in the notice.
8. A person who fails to comply with a notice issued to him pursuant to By-law 6 or 7 hereof commits an offence.
9. If a person to whom notice has been given pursuant to By-law 6 or 7 hereof fails to comply with the requirements of the notice, the Council may by its employees or contractors carry out the requirements of the notice at the expense of the person to whom the notice was given and recover the amount of the expense from him in a Court of competent jurisdiction.
10. The Council may by its employees, agents or contractors take possession of and remove to a place appointed by the Council and without being liable in damages or otherwise dispose of anything deposited upon a street, way, footpath or public place at the expense of the person or persons responsible for the deposit, excavation or injury to the street, way, footpath or other public place and recover from him or them in a Court of competent jurisdiction the expense incurred in the taking possession, removal or disposal of the thing deposited or in such reinstatement.
11. The Council may, by its employees, agents or contractors, remove any tree lying upon or any obstruction to any street, way, footpath, bridge, gutter, drain or culvert.
