### CARNARVON BANANA INDUSTRY (COMPENSATION TRUST FUND) ACT 1961

### CARNARVON BANANA INDUSTRY (COMPENSATION TRUST FUND) AMENDMENT REGULATIONS 1990

Made by His Excellency the Lieutenant-Governor and Administrator in Executive Council.

#### Citation

1. These regulations may be cited as the *Carnarvon Banana Industry (Compensation Trust Fund) Amendment Regulations 1990*.

#### Principal regulations

2. In these regulations the *Banana Industry Compensation Trust Fund Act Regulations 1962\** are referred to as the principal regulations.

#### Regulation 1 amended

3. Regulation 1 of the principal regulations is amended by deleting "Banana Industry Compensation Trust Fund Act Regulations, 1962" and substituting the following—

*Carnarvon Banana Industry (Compensation Trust Fund) Regulations 1962*”.

#### Regulation 2 repealed and a regulation substituted

4. Regulation 2 of the principal regulations is repealed and the following regulation is substituted—

#### Interpretation

2. In these regulations unless the context requires otherwise—  
“election” means the election of an elective member of the Committee;  
“electoral roll” means the electoral roll kept pursuant to regulation 5.”.

#### Regulations 19A, 19B and 19C inserted

5. After regulation 19 of the principal regulations the following regulations are inserted—

#### Prescribed capacity

“  
19A. For the purpose of section 19 (1a) (a) of the Act, 13 kilograms is prescribed as the capacity of a carton.

#### Prescribed sum

19B. For the purpose of section 19 (1a) (b) of the Act, a sum of 20 cents per carton is prescribed.

**Prescribed rate of compensation**

19C. For the purpose of section 25 (3) of the Act, a rate of \$2.60 per carton is prescribed. ”.

### LOCAL GOVERNMENT ACT 1960

#### *The Municipality of the City of Melville*

#### By-Laws Relating to Hawkers, Stallholders and Street Traders

In pursuance of the powers conferred upon it by the abovementioned Act, and of all other powers enabling it, the Council of the abovementioned Municipality hereby records having resolved on 26 September 1989 to repeal the whole of the By-laws relating to Hawkers and Stallholders published in the *Government Gazette* (No. 42) of 15 July, 1977 and to make and submit for confirmation by the Lieutenant-Governor and Administrator the following By-laws.

#### Definitions

1. In these By-laws, unless the context requires otherwise—
  - “Act” means the Local Government Act 1960 (As Amended).
  - “Council” means the Council of the Municipality of the City of Melville or an Officer duly authorised to carry out the functions of these By-laws.
  - “Licence” means a Licence issued pursuant to these By-laws.
  - “Licencee” means a person who has attained the age of 18 years and is the holder of a current Licence issued pursuant to these By-laws, and where appropriate includes an Assistant, Nominee or corporation named in the Licence.
  - “Schedule” means a Schedule to these By-laws.

#### Application

2. (i) These By-laws shall apply to the whole of the Municipality.  
(ii) These By-laws shall not apply to the holder of a Licence granted under the provisions of the By-laws relating to outdoor eating areas.
3. Subject to the provisions of sections 217 ET SEQ of the Act, any person who conducts trade as a Hawker, Stallholder or Street Trader while not being the holder of a current Licence commits an offence.
4. A person who desires to be a Hawker, Stallholder or Street Trader shall make application to Council in the form or to the effect of Form 1 or 2 of the First Schedule.

#### Licence

5. Subject to these By-laws Council may issue a licence at its discretion, for a period not exceeding one year and prescribe fees and charges from time to time in accordance with the Act and Schedule 2.
6. A licence shall be in the form or to the effect of Form 3 of the First Schedule and current upon payment of the Prescribed Fees and Charges.
7. A Licence or any Part thereof is—
  - (i) Not Transferable;
  - (ii) Valid only for the purpose for which it is issued;
  - (iii) Valid only for the portion of the District for which it is granted;
  - (iv) Valid only for the Business stated on the Licence.
8. (1) Council shall not issue a Hawker's Licence (other than a renewal of a Licence) to an applicant, unless a Certificate is produced to Council signed by two Justices of the Peace certifying that the applicant is of good character and reputation, and is a fit person to exercise the trade of a Hawker.

(2) Council may refuse to issue a Licence or may cancel a Licence in the event that the Applicant or Licensee—

- (a) Is an Undischarged Bankrupt or becomes Bankrupt;
- (b) Has been twice convicted during the preceding five years or is twice convicted in the space of five years of an offence against the By-laws of any Local Authority relating to Hawkers;
- (c) Does not conform with the requirements of the Health Act, 1911, or any other current Act, By-law or Regulation.

(3) Council may refuse to issue a Licence, if in its opinion the needs of the District or the portion thereof for which the Licence is sought are adequately catered for by established shops or by persons to whom Licences have been issued.

9. Council may revoke any Licence issued by it on any of the grounds set out in By-law 8 hereof, or on the grounds—

- (a) That the Licensee has committed a Breach of the terms or conditions of the Licence;
- (b) That the Licensee is not conducting the Business in a respectable or sober manner;
- (c) That the Licence has been assigned or that the Business is not being carried out by the Licensee;
- (d) That the Licensee is not regularly carrying on the Business for which the Licence was granted;
- (e) That the Licensee is convicted of any offence under any Act, By-law or Regulation in respect of any Act, matter or thing done or omitted to be done on or in respect of the Business specified in the Licence; or
- (f) That the Licensee fails to comply with any of the provisions of the By-laws.

10. Upon the cancellation of a Licence the holder thereof shall forthwith return the Licence to Council and shall forfeit all fees and Charges paid in respect of the Licence.

11. (1) Council shall issue to every Licensee a Badge in or to the effect of Form 4 of the First Schedule and the Licensee shall pay for such a Badge a fee in accordance with the Act.

(2) A Licensee shall display the Badge while conducting Business.

(3) A person shall not display a Badge unless Authorised to do so by a current Licence.

(4) Upon cancellation of a Licence the holder shall forthwith return the Badge to Council and shall forfeit the fee and charges paid in respect thereof.

#### Miscellaneous

12. A Licensee shall—

- (a) Carry the Licence and shall produce the same to any officer of Council on demand;
- (b) Have the Licensee's name legibly and conspicuously displayed on the Vehicle, Barrow, Bag, Tray, or Stall;
- (c) Attend at any Stall or Trading Location specified in the Licence, at all times when business is to be conducted on or from that permitted place;
- (d) When selling goods, wares or merchandise by weight, carry and use for that purpose, scales, tested and certified in accordance with the provisions of the Weight and Measures Act, 1915;
- (e) Keep the permitted place and any stall specified in the Licence in a clean and safe condition and in good repair;
- (f) Keep the permitted place and any stall specified in the Licence free from trade refuse and other refuse and rubbish; and
- (g) Relocate if so directed by Council or the Police.

13. A Licensee shall not—

- (a) Conduct Business in any Highway within the District;
- (b) Operate between the hours of sunset and the and the next sunrise, or on any Sunday, or on Christmas Day or Good Friday, unless so prescribed in the Licence;
- (c) Loiter within a distance of two hundred metres of any shop or permanent place of Business operating in any Business being offered by the Licensee.
- (d) Call Business or make or cause to be made any Outcry, noise or disturbance likely to be a nuisance or annoyance to any person in that vicinity;

- (e) Deposit or store any Box or Basket under any vehicle or on the Roadway or Footpath;
- (f) Obstruct the free passage of pedestrians or vehicles on any footpath or roadway; or
- (g) Act in an offensive manner; or cause or permit or suffer any nuisance to exist, arise or continue on or from the place specified in the Licence;
- (h) Subject to By-law 11 and 12 Use, Display or permit to be used or displayed any Advertisement, Placard, Poster, Streamer, Sign or Signboard on or about the place specified in the Licence other than price Tickets or Labels on the items with Labels not exceeding 200 square centimetres in area and relating to the Business specified in the Licence;

13. (i) Use or permit to be used any flashing or Intermittent Lighting apparatus or device on or from the place specified in the Licence;

- (ii) Use or permit to be used Apparatus or device including any flap or shelf whereby the dimensions of a stall are increased beyond any specified in the Licence.

14. The person to whom a Stallholder's Licence is issued shall remove the Stall and all associated equipment from the permitted place and leave the permitted place clean and vacant in all respects:—

- (i) At the conclusion of the permitted hours of operation specified in the Licence;
- (ii) Whenever not conducting business on the Permitted Place unless otherwise specified in the Licence.

15. Where a Licensee by reason of illness, accident or other cause is unable to comply with the By-laws, Council may at the request of that Licensee issue a permit in writing authorising a person named in the permit to be a Nominee to occupy and Manage the Business specified in that Licence during the period of the Licensee's inability to comply with the Licence or until the expiration of the term of the Licence whichever is the earlier.

16. No person shall conduct a stall on private property unless the prior written consent of the owners and occupiers of the property has been obtained and there is adequate provision on the private property adjacent to the Stall for Parking of Customer's Vehicles.

17. Notwithstanding any of the provisions of these By-laws, Council may grant without fee, Licences to conduct stalls in any street or way or on any Land for any period specified in such a Licence if such Stalls are conducted solely for a Community Association.

Penalty

18. A person who contravenes or fails to comply with any provisions of these By-laws commits an offence and is then liable to a penalty commensurate with the Act sections 190 (7) (d) (i) and (ii); 242 (4); 244 (4); & 671.

In pursuance of the powers conferred upon it by the abovementioned Act and of all other powers enabling it the Council of the abovementioned Municipality hereby records having resolved on 1 June 1989 to make and submit for confirmation by the Lieutenant-Governor and Administrator the following amendment to its By-laws Relating to Stalls which was published in the *Government Gazette* on 15 April 1983.

By-law 7 of the abovementioned By-laws is amended as follows:

- (a) by deleting By-law 7 completely;  
(b) by inserting new By-law 7 as follows:—

- “7. (1) No fee is payable by a charitable organisation in respect of the issue of a licence to it or the renewal thereof.
- (2) A fee of forty dollars (\$40) is payable in respect of an annual licence to a person other than a charitable organisation or the renewal thereof.
- (3) A fee of twenty five dollars (\$25) is payable in respect of the issue of a licence to a person other than a charitable organisation valid for a period of no more than two (2) consecutive days.

Every owner or occupier of land upon whom a notice is served under By-law 2 of these By-laws, shall comply with such notice within the time therein specified or in that time give satisfactory reason why the materials should be retained or be given extra time in which to comply and any owner or occupier of land who fails to comply with the terms of the notice so served commits an offence.
4. Where the owner or occupier does not clear the land or, re-site or screen such refuse, rubbish, motor vehicle bodies, old machinery, disused materials, or unsightly items or objects or comply with the provisions of Clause 3 of these By-laws as required by a notice given by the Council, the Council may, without payment of any compensation in respect thereof, clear or remove it and dispose of it at the expense of and recover in a court of competent jurisdiction, the amount of the expenses from the owner or occupier to whom the notice was given.
5. Any person who commits a breach of any of these By-laws shall be liable to:
  - a) a maximum penalty of two hundred dollars (\$200.00); and
  - b) a maximum daily penalty during the breach of twenty dollars (\$20.00) per day. "






