2. These regulations shall come into operation on 1 July 1990.

**SOIL AND LAND CONSERVATION ACT 1945**

**SOIL AND LAND CONSERVATION (PINGELLY LAND CONSERVATION DISTRICT—ESTABLISHMENT OF COMMITTEE) ORDER 1990**

Made by His Excellency the Governor in Executive Council under section 23 of the *Soil and Land Conservation Act 1945*.

**Citation**

1. This order may be cited as the *Soil and Land Conservation (Pingelly Land Conservation District—Establishment of Committee) Order 1990*.

**Interpretation**

2. In this order—
- “appointed member” means a person appointed under clause 4 (1) (b), (c), (d) or (e) to be a member of the committee;
- “committee” means the Land Conservation District Committee for the Pingelly Land Conservation District;
- “member” means a member of the committee;
- “the district” means the Pingelly Land Conservation District constituted under the *Soil and Land Conservation (Pingelly Land Conservation District) Order 1989*;
- “the producer organizations” means the bodies known respectively as the Western Australian Farmers Federation (Inc.) and the Pastoralists and Graziers Association of Western Australia.

**Establishment of the committee**

3. Pursuant to section 23 (2) of the *Soil and Land Conservation Act 1945* there is hereby established for the district a land conservation district committee to be known as the Land Conservation District Committee for the Pingelly Land Conservation District.

**Constitution of the committee**

4. (1) It is hereby determined, on the recommendation of the Minister, after consultation with the Shire of Pingelly and the producer organizations, that the committee shall comprise 12 members of whom—

- (a) one shall be the Commissioner for Soil Conservation or his nominee;
- (b) one shall be appointed by the Minister on the nomination of the Shire of Pingelly;
- (c) 2 shall be appointed in accordance with subclause (2);
- (d) one shall be appointed in accordance with subclause (3); and
- (e) 7 shall be appointed by the Minister, and shall be actively engaged in, or affected by or associated with, land use in the district.

(2) The Western Australian Farmers Federation (Inc.) shall submit to the Minister a panel containing the names of persons willing to be appointed as members of the committee and, where such a panel is submitted in accordance with this order, 2 persons whose names appear on the panel submitted by the Western Australian Farmers Federation (Inc.) shall be appointed by the Minister.

(3) The Pastoralists and Graziers Association of Western Australia shall submit to the Minister a panel containing the names of persons willing to be appointed as members of the committee and, where such a panel is submitted in accordance with this order, one person whose name appears on the panel submitted by the Pastoralists and Graziers Association of Western Australia shall be appointed by the Minister.

(4) Subject to this clause, each appointed member shall hold office for such period not exceeding 3 years as is specified in the instrument of his appointment and is eligible for reappointment.

(5) The Minister may grant leave of absence to an appointed member on such terms and conditions as the Minister determines.

(6) The Minister may terminate the appointment of an appointed member for inability, inefficiency or misbehaviour.

(7) If an appointed member—

- (a) is or becomes an undischarged bankrupt or person whose property is subject to an order or arrangement under the laws relating to bankruptcy;
- (b) has his appointment terminated by the Minister, pursuant to subclause (5);
- (c) is absent, except on leave duly granted by the Minister, from 3 consecutive meetings of the committee of which he has had notice; or
- (d) resigns his office by written notice addressed to the Minister,

the office of that appointed member becomes vacant.

**Proceedings of the committee**

5. (1) The committee shall hold its meetings at such place on such days and at such intervals as the committee shall from time to time determine.

(2) At any meeting of the committee—

- (a) a majority of the members constitute a quorum;
- (b) the Chairman shall preside and where he is absent from the meeting the members may appoint one of their number to preside at that meeting;
- (c) each member present is entitled to a deliberative vote; and
- (d) where the votes cast on any question are equally divided the Chairman, or the presiding member in terms of paragraph (b), shall have a casting vote.

(3) The committee shall cause accurate minutes to be kept of the proceedings at its meetings.

(4) To the extent that it is not prescribed, the committee may determine its own procedure.

**SOIL AND LAND CONSERVATION ACT 1945****SOIL AND LAND CONSERVATION (CUBALLING LAND CONSERVATION DISTRICT) ORDER 1990**

Made by His Excellency the Governor in Executive Council under sections 22 and 23 of the *Soil and Land Conservation Act 1945* and on the recommendation of the Minister for Agriculture.

**Citation**

1. This order may be cited as the *Soil and Land Conservation (Cuballing Land Conservation District) Order 1990*.

**Interpretation**

2. In this order—

“appointed member” means a person appointed under clause 5 (1) (b), (c) or (d) to be a member of the committee;

“committee” means the Land Conservation District Committee for the Cuballing Land Conservation District;

“member” means a member of the committee;

“the district” means the Cuballing Land Conservation District constituted by clause 3;

“the producer organizations” means the bodies known respectively as the Western Australian Farmers Federation (Inc.) and the Pastoralists and Graziers Association of Western Australia.

**Cuballing Land Conservation District**

3. The land described in the Schedule is hereby constituted the Cuballing Land Conservation District.

**Establishment of the committee**

4. Pursuant to section 23 (2) of the *Soil and Land Conservation Act 1945* there is hereby established for the district a land conservation district committee to be known as the Land Conservation District Committee for the Cuballing Land Conservation District.

**Constitution of the committee**

5. (1) It is hereby determined, on the recommendation of the Minister, after consultation with the Shire of Cuballing and the producer organizations, that the committee shall comprise 12 members of whom—

- (a) one shall be the Commissioner for Soil Conservation or his nominee;
- (b) one shall be appointed by the Minister on the nomination of the Shire of Cuballing;
- (c) 3 shall be appointed in accordance with subclause (2);
- (d) 7 shall be appointed by the Minister, and shall be actively engaged in, or affected by or associated with, land use in the district.

(2) The Western Australian Farmers Federation (Inc.) shall submit to the Minister a panel containing the names of persons willing to be appointed as members of the committee and, where such a panel is submitted in accordance with this order, 3 persons whose names appear on the panel shall be appointed by the Minister.

(3) Subject to this clause, each appointed member shall hold office for such period not exceeding 3 years as is specified in the instrument of his appointment and is eligible for reappointment.

(4) The Minister may grant leave of absence to an appointed member on such terms and conditions as the Minister determines.

(5) The Minister may terminate the appointment of an appointed member for inability, inefficiency or misbehaviour.

(6) If an appointed member—

- (a) is or becomes an undischarged bankrupt or person whose property is subject to an order or arrangement under the laws relating to bankruptcy;
- (b) has his appointment terminated by the Minister, pursuant to subclause (5);
- (c) is absent, except on leave duly granted by the Minister, from 3 consecutive meetings of the committee of which he has had notice; or
- (d) resigns his office by written notice addressed to the Minister,

the office of that appointed member becomes vacant.

**Proceedings of the committee**

6. (1) The committee shall hold its meetings at such place on such days and at such intervals as the committee shall from time to time determine.

(2) At any meeting of the committee—

- (a) a majority of the members constitute a quorum;
- (b) the Chairman shall preside and where he is absent from the meeting the members may appoint one of their number to preside at that meeting;

## BUSH FIRES BOARD

**BUSH FIRES ACT 1954***Municipality of the City of Rockingham*

By-laws Relating to the Establishment, Maintenance and Equipment of Bush Fire Brigades

In pursuance of the power conferred upon in by the abovementioned Act, the Council of the abovementioned Municipality hereby records having resolved on 26 September 1989 to make and submit for confirmation by the Governor the following by-laws—

**Previous by-law**

1. The By-law of the City of Rockingham relating to the Establishment, Maintenance and Equipment of the Bush Fire Brigades, published in the *Government Gazette* of 25 February 1949 and amended in the *Government Gazette* of 21 January 1977 is hereby revoked.

**Establishment of Brigade**

2. (a) On the resolution of Council to establish, maintain and equip a Bush Fire Brigade in accordance with the provisions of the Bush Fires Act 1954, (as amended) and Regulations hereunder, the Brigade shall be formed in accordance with these by-laws; and a name shall be given to the Brigade.
- (b) A Bush Fire Brigade may be established for the whole of the Municipality or for any specified area thereof.

**Appointment of Officers**

3. By the Authority of Council the Bush Fire Brigades shall duly elect as determined by the Constitution of the Brigade, a Captain, 1st Lieutenant (Vice Captain), 2nd Lieutenant, Secretary, Treasurer, Equipment Officer, and such additional Officers that be deemed necessary to act as Officers of the Brigade and who, in the Council's opinion have the necessary qualification and knowledge of the District required in such capacities.

4. The Equipment Officer shall be responsible for the maintenance in good order and condition of all equipment and appliances acquired by Council for the purpose of the Brigade. The Equipment Officer may station such equipment at a depot approved by the Chief Bush Fire Control Officer where, if possible, motor vehicles can easily be called upon. If there is more than one such depot in the area, the Equipment Officer shall appoint at each depot a person to look after the equipment and have it ready for immediate use when required.

5. The Council retains the express authority to appoint, determine and restrict the Powers of Bush Fire Control Officers. Such appointments to be in accordance with the requirements of the district and may prescribe an area over which the Bush Fire Control Officer shall have jurisdiction.

#### Duties of Officers

6. The duties of all Officers appointed under these by-laws shall be as stipulated in the provisions of the Bush Fires Act 1954 and each Officer so appointed shall be supplied with a copy of the Act and Regulations. In the absence of a Fire Control Officer, the Captain shall have full control over the members of the Brigade whilst engaged in fire fighting and shall issue instructions as to the methods to be adopted by the fire fighters.

In the absence of the Captain, the 1st Lieutenant (Vice Captain), the 2nd Lieutenant or Senior Officer of the Brigade present at the fire shall exercise all the powers and duties of the Brigade Captain.

#### Membership of Brigade

7. (a) The membership of a Bush Fire Brigade consists of the fire fighting members.
- (b) Fire fighting members shall be those persons, being members of either sex and being fifteen (15) years of age and over who are willing to render service when possible at any bush fire and who sign an undertaking in the form contained in the First Schedule to these by-laws.
- (c) The enrolment of persons as fire fighting members shall in every case be subject to the approval of the Council.

#### Finance

8. The expenditure incurred by the Council in the purchase of equipment, payment of services and generally for the purposes of this Act, shall be a charge on the ordinary revenue of the Council, but the Town Clerk shall direct that a record of expenditure incurred under the Act be kept.

#### Meetings of Brigades

9. Meetings will be held as necessary.



" 70A. The charges for berthing in North Quay Berths Nos. 1, 2, 4, 5, 6, 7, 8, 9, 11 and 12 at Victoria Quay Berth H, are set out in the Table.

(2) A vessel which remains at anchor in the Outer Harbour, having arrived solely for orders or supplies (including bunkers) for her own use, or to be refitted or repaired, or being in distress or under duress, shall occupy a berth for the actual time the vessel remains at anchor. ”.

11. Regulation 127 of the principal regulations is repealed and the following regulation is substituted—

**General rates payable**

“ 127. Subject to regulation 129 the tonnage rates payable shall be assessed at the rate of—

- (a) \$0.0053;
- (b) where a vessel has an inboard incinerator \$0.0045; or
- (c) where regulation 126 (2) applies to the vessel \$0.0016,

for each ton of the registered tonnage of the vessel for each hour or part thereof during which the vessel occupies a berth. ”.

(3) The master or agent of any vessel which may, under this regulation, be qualified for a rebate of tonnage rates during the whole or any portion of the time in port shall, prior to or within 24 hours of the vessel's arrival in port, or within one hour of the commencement of the operations or delay referred to in subregulation (1), make a declaration in writing to the Secretary setting forth the circumstances applicable, and where a rebate applies for portion only of the vessel's time in port, a declaration of the actual times for which the rebate is claimed, must be lodged within 24 hours of the completion of the fitting, refitting, repairs or period under distress or duress provided that where the circumstances arise during other than ordinary working hours the declaration shall be made within 24 hours of the commencement of business on the next working day.

(4) Subject to subregulation (5), where a declaration is not lodged in accordance with subregulation (3), full tonnage rates shall be payable.

(5) The Port Authority may in its discretion, at any time and from time to time and according to the circumstances of each particular case, allow any rebates of tonnage rates it considers reasonable. ”.






