APPLE SALES RESTRICTIONS

I, the undersigned Minister for Agriculture, being the Minister charged with the administration of the Agricultural Products Act 1929, acting in exercise of the power in this behalf conferred upon me by section 3D of the Act, do hereby prohibit the sale, except for the purpose of export, of Class 3 apples, in accordance with the schedule hereunder.

The provisions of this notice shall be read in conjunction with the Apple Grading and Packing Code 1990.

A person shall not sell, except for the purpose of export from the State, any apples of which the sale is pursuant to section 3D of the Act, prohibited, and any person who contravenes the provision of this section commits an offence.

Pursuant to the powers contained in section 25B of the Bush Fires Act 1954, I hereby revoke the suspension relating to the burning of refuse at the Council's disposal sites on Kent Location 1403 at Jerramungup, part of Kent Location 1731 at Bremer Bay and part Kent Location 1453 at Needilup as published in the *Government Gazette* dated February 4th 1983 and hereby approve pursuant to the powers contained in section 25B of the said Act, the suspension of the operations of section 25 that relate to a fire to be lit, or which is lit, for the purpose of destroying garden refuse or rubbish or any like purpose during the declared Prohibited and Restricted Burning Times on land set aside for the purpose in the Municipal District of the Shire of Jerramungup. This notice shall have effect until revoked and is issued subject to the following specifications.

Jerramungup Rubbish Disposal Site, Kent Location 1747 (Reserve 25460)

1. All bush and grass, save standing live trees, to be removed from the site area within the perimeter firebreaks.
2. Two signs to be erected and maintained at the entrance of the site, warning of prohibition and unauthorised lighting of fires and to inform the public that dumping in any other place is prohibited.
3. The height of the earth wall around the central dump site and the wire fence are to be maintained at their present level.
4. That the rubbish burnt and unburnt be pushed up regularly.
5. That burning on the dump be carried out only between Monday and Thursday, in any week, inclusive, between the hours of 1600 and 2000 hours.
6. That a Fire Control Officer or such other person specifically authorised to do so by the Shire Clerk, be in attendance with a fire unit when burning is being carried out.
7. The Shire Clerk or the Chief Fire Control Officer for the Shire to be informed each day when burning is to be carried out.
8. No fires to be lit on land subject to this suspension on a day for which the fire danger forecast issued by the Bureau of Meteorology in Perth in respect of the locality is "Extreme" or "Very High".

Bremer Bay Rubbish Disposal Site, Part Kent Location 1731 (Part of Reserve 511)

1. All bush and grass, save standing live trees, to be removed from the site area within the perimeter firebreaks.
2. Two signs to be erected and maintained at the entrance of the site, warning of prohibition and unauthorised lighting of fires and to inform the public that dumping in any other place is prohibited.
3. The height of the sand wall around the central dump site is to be maintained at their present level.
4. That the rubbish burnt and unburnt be pushed up regularly.
5. Fires to be lit only by the Shire Councils rubbish collecting contractors or such persons as specifically authorised to do so by the Shire Clerk.
6. That burning on the dump be carried out only between Monday and Thursday in any week, inclusive, between the hours of 1600 and 2000 hours.
7. That at least two men be in attendance with a fire unit when burning is being carried out.
8. The local Fire Control Officer or the Shire Clerk to be informed each day when burning is to be carried out.
9. No fires to be lit on land subject to this suspension on a day for which the fire danger forecast issued by the Bureau of Meteorology in Perth in respect of the locality is "Extreme" or "Very High".

Needilup Rubbish Disposal Site, Part Kent Location 1453

1. All bush and grass, save standing live trees, to be removed from the site area within the perimeter firebreaks.
2. Two signs to be erected and maintained at the entrance of the site, warning of prohibition and unauthorised lighting of fires and to inform the public that dumping in any other place is prohibited.
3. That burning on the dump be carried out only between Monday and Thursday in any week, inclusive, between the hours of 1600 and 2000 hours.
4. That a Fire Control Officer nominated by the Shire, be in attendance with a fire unit when burning is being carried out.
5. No fires to be lit on land subject to this suspension on a day for which the fire danger forecast issued by the Bureau of Meteorology in Perth in respect of the locality is "Extreme" or "Very High".

The management plan proposed that Reserve 18447 be vested in NPNCA and management by CALM as a Conservation Park. This bushland area is a major reserve within Bridgetown townsite. The amendments will enable the Department of Land Administration to vest the Reserve in the Shire of Bridgetown-Greenbushes for the purpose of Parkland and Recreation.

SUPREME COURT ACT 1935

CORPORATIONS (WESTERN AUSTRALIA) ACT 1990

SUPREME COURT (CORPORATIONS LAW) (TRANSITIONAL) RULES 1991

Made by the Judges of the Supreme Court.

Citation

1. These rules may be cited as the *Supreme Court (Corporations Law) (Transitional) Rules 1991*.

Commencement

2. These rules shall be taken to have come into operation on the day on which the *Corporations (Western Australia) Act 1990* came into operation.

Object

3. The object of these rules is to make the *Companies (Western Australia) (Transitional Provision) Rules 1982* applicable to some proceedings under the Corporations Law in the Supreme Court.

Interpretation

4. In these rules, unless the contrary intention appears—

“Code” means the *Companies (Western Australia) Code*;

“principal rules” means the *Companies (Western Australia) (Transitional Provision) Rules 1982**.

Principal rules to apply

5. (1) So far as is practicable, the principal rules apply with any necessary modifications to a proceeding under the Corporations Law in the Supreme Court in the same way as they would apply to a proceeding of the same, or substantially the same kind under the Code.

(2) For the purposes of subrule (1), a proceeding under the Corporations Law may be regarded as of the same, or substantially the same kind as a proceeding under the Code although the proceeding under the Corporations Law—

(a) is not required or permitted by the Code; or

(b) is not required or permitted to be brought by the person who is required or permitted to bring it by the Code.

KIMBERLEY PRAWN FISHERY NOTICE 1991

Citation1. This notice may be cited as the *Kimberley Prawn Fishery Notice 1991*.**Prohibition on trawling**

2. All persons are prohibited from taking any species of fish by means of trawling from—

- (a) (i) 0600 hours western standard time on 1 December in any year to 1000 hours western standard time on 1 April next following; and
 (ii) 1000 hours western standard time on 6 June in any year to 1600 hours western standard time on 1 August next following,
 in the waters specified in Schedule 1; and
 (b) 1000 hours western standard time on 1 December in any year to 1000 hours western standard time on 1 August next following in the waters specified in Schedule 2.

**Determination of position
 by reference to the
 Australian Geodetic Datum**

3. (1) Where, for the purposes of this notice it is necessary to determine a position on the surface of the Earth by geographical coordinates, that position shall be determined on the Australian Geodetic Datum which is defined by an ellipsoid having a semi-major axis (equatorial radius) of 6 378 160 metres and a flattening of 1/298.25 and fixed by the position of the origin being the Johnston Geodetic Station in the Northern Territory of Australia.

(2) The Johnston Geodetic Station referred to in subclause (1) shall be taken to be situated at 25°56'54.5515" south latitude and at 133°12'30.0771" east longitude and to have a ground level elevation of 571.2 metres above the ellipsoid referred to in that subclause.

HOSPITALS (SERVICES CHARGES) REGULATIONS 1984
HOSPITALS (SERVICES CHARGES FOR COMPENSABLE PATIENTS)
DETERMINATION 1991

Made by the Minister for Health under section 37 (3) (af) and regulation 5 (2).

Citation

1. This determination may be cited as the *Hospitals (Services Charges for Compensable Patients) Determination 1991*.

Commencement

2. This determination comes into operation on 1 March 1991.

Interpretation

3. Unless the contrary intention appears, a word or phrase to which a meaning is attributed by, or by virtue of its use in, the *Hospitals (Services Charges) Regulations 1984** has the same meaning when it is used in this determination.

3. Substitute a new By-law 29 and heading to read as follows—

Keeping of Poultry and Pigeons

29. (a) In this By-law:

- (i) "approved" means approved by a health surveyor;
- (ii) "poultry" shall include fowls, peafowls, turkeys, geese, ducks and other domestic fowls;
- (iii) "District Zoning Scheme" shall mean the town planning scheme titled "District Zoning Scheme" made under the *Town Planning and Development Act 1928* and currently in force in the municipal district of the City of Gosnells;

(b) The occupier of any premises shall not keep poultry or pigeons:

- (i) unless that occupier has first received the written approval of the Local Authority to do so; and
- (ii) except in accordance with the provisions of this By-law.

- (c) (i) The occupier of any land zoned for residential purposes under the District Zoning Scheme shall not keep on that land:
- A. both poultry and pigeons simultaneously;
 - B. one or more roosters, peacocks or turkeys;
 - C. more than six head of poultry; or
 - D. subject to subclause (c) (ii), more than 20 pigeons.
- (ii) Where:—
- A. an occupier referred to in sub-clause (c) (i) is a member of a duly constituted pigeon club or association; and
 - B. that occupier is able to produce, to the satisfaction of the Local Authority, written evidence of such membership,
- the Local Authority may permit that occupier to keep on the land more than 20 pigeons, provided that the number of pigeons so permitted does not exceed 75.
- (d) The occupier of any land zoned for rural purposes under the District Zoning Scheme may keep such number of poultry and pigeons as is approved by the Local Authority and the Local Authority may make the approval subject to such conditions concerning the keeping of the poultry and pigeons as it considers appropriate.
- (e) An occupier of land, other than land zoned for residential or rural purposes under the District Zoning Scheme, shall not keep poultry or pigeons on that land unless the poultry or pigeons:
- (i) are being kept on commercial premises for immediate sale; or
 - (ii) are being kept at a veterinary clinic for the purpose of veterinary treatment.
- (f) occupier of any premises where poultry or pigeons are kept shall provide a structure which:
- (i) is of sound construction;
 - (ii) has the roof and walls constructed of galvanised iron, colourbond or other approved material;
 - (iii) has the framework and roost constructed of smooth sealed material;
 - (iv) has a floor area constructed of concrete or other approved material with a smooth impervious finish laid with a fall of 1 in 50 toward the front.
- (g) The occupier of any premises where poultry is kept shall provide an enclosure which:
- (i) is fenced to a height of not less than 1.8 metres;
 - (ii) has a floor area of not less than two square metres for each turkey, goose, duck or peafowl kept; and
 - (iii) has a floor area of not less than one square metre for each fowl kept.
- (h) occupier of any premises shall not keep poultry or pigeons less than:
- (i) 9 metres from any dwelling house, or place where food is manufactured, stored or exposed for sale;
 - (ii) 18 metres from any street or road, except in the case of corner properties when the minimum distance from any street shall be 9 metres; and
 - (iii) 1.2 metres from the boundary of an adjoining property.
- (i) Clauses (f), (g) and (h) shall not apply to pigeons and poultry kept:
- (i) on commercial premises for immediate sale; or
 - (ii) at a veterinary clinic for the purpose of veterinary treatment.
- (j) (i) Any person keeping poultry or pigeons shall keep them continually confined.
- (ii) Notwithstanding Subclause (i), where an occupier of premises:
- A. is a member of a duly constituted pigeon club or association; and
 - B. keeps racing or homing pigeons,
- that person may release those pigeons:
- C. for exercise on any day during the two hour period commencing at sunrise or the two hour period immediately preceding sunset; or
 - D. to participate in races organised by the pigeon club or association.

- (k) Any person keeping poultry or pigeons shall:
 - (i) at all times maintain in a clean condition all structures, enclosures, cages, crates or lofts within which they are kept;
 - (ii) clean, disinfect and carry out such other tasks in respect of structures, enclosures, cages, crates or lofts within which poultry and pigeons are kept in accordance with any direction to do so by a Health Surveyor;
 - (iii) store poultry or pigeon food in fly and vermin proof containers; and
 - (iv) dispose of poultry and pigeon faeces and other waste regularly and in such a manner so as not to create a nuisance or be accessible to flies and other vermin.
- (l) Notwithstanding any other provision of this By-law, the Local Authority may at any time and in its absolute discretion revoke an existing approval, or refuse an application for approval, to keep poultry and pigeons.
