

### PAINTERS' REGISTRATION ACT 1961

#### PAINTERS' REGISTRATION BOARD AMENDMENT RULES 1991

Made by the Painters' Registration Board and approved by His Excellency the Governor in Executive Council.

#### Citation

1. These rules may be cited as the *Painters' Registration Board Amendment Rules 1991*.

#### Commencement

2. These rules shall come into operation on 1 January 1992.

#### Principal rules

3. In these rules the *Painters' Registration Board Rules 1962\** are referred to as the principal rules.

**Second Appendix amended**

4. The Second Appendix to the principal rules is amended—
- (a) in Form No. 2 by deleting “of \$30.00”;
  - (b) in Form No. 4 by deleting “of \$6.30”;
  - (c) in Form No. 6 by deleting “of \$30.00”; and
  - (d) in Form No. 7 by deleting “of \$30.00”.

**Third Appendix amended**

5. The Third Appendix to the principal rules is amended—
- (a) by deleting “75.00” and substituting the following—

**CREDIT ACT 1984**  
Order under Section 19

Made by His Excellency the Governor in Executive Council.

**Citation**

1. This Order may be cited as *Credit (Credit Union Calculation of Annual Percentage Rate and Accrued Credit Charge) Order No. 67 of 1991*.

**Commencement**

2. This Order shall take effect on and from 1 January 1992 and shall remain in force until 31 December 1992.

**Application of Order**

3. This Order applies where—
- (a) the credit provider is a Credit Union registered under the *Credit Unions Act 1979*; and
  - (b) the whole of the credit charge payable under a regulated loan contract is determined in the manner described in clause 4 (3).

**Calculation of Annual Percentage Rates—Exemption**

4. (1) Subject to the conditions set out in sub-clause (2), section 36 (1) (e), 39 (2), 40 and 42 (1) (c) of the *Credit Act 1984* and regulation 18A of the *Credit Regulation 1985* do not have effect in relation to a regulated loan contract where this Order applies.
- (2) The conditions referred to in sub-clause (1) are that—
- (a) (i) the loan contract include a statement of the annual percentage rate in accordance with sub-clause (3); or

- (ii) where, in accordance with section 39 (1) of the Act, a loan contract includes two annual percentage rates, the contract includes a statement in respect of each rate in accordance with sub-clause (3);
- (b) subject to—
  - (i) sub-paragraph (ii) of paragraph (a) of this sub-clause; and
  - (ii) the Credit (Credit Union—Variation of Annual Percentage Rate) Order No. 20A of 1989 or any future Order to like effect,
 the loan contract not include—
  - (iii) a statement of, or a reference to, more than one annual percentage rate for the purposes of the contract;
  - (iv) a statement of, or a reference to, any rate other than the contract rate to the effect that the credit charge under the contract is or is to be determined by the application of that rate to the whole or any part of the amount financed; or
  - (v) a statement of, or a reference to, a right of the credit provider or any other person to increase, or take any action that results in the increase of, the annual percentage rate; and
- (c) there is no reference in any advertisement published by the credit provider to a rate of interest that is expressed otherwise than as annual percentage rate calculated in accordance with sub-clause (3).
- (3) The annual percentage rate required under sub-clause (2) to be stated in a loan contract is—where the whole of the credit charge is determined by the application of a percentage rate per annum—
  - (a) the amount financed for each day in the month of funding; and
  - (b) the monthly unpaid balance of the amount financed for each subsequent calendar month—that percentage rate.
- (4) If, in a case to which sub-clause (3) applies, the contract provides for variation of the annual percentage rate in accordance with the Act and regulations or any applicable exemption order, the annual percentage rate required to be stated in the contract is the rate that applies on the date the contract is made.

#### Calculation of Accrued Credit Charge—Exemption

5. (1) Subject to the condition set out in sub-clause (2), the definition of “accrued credit charge” in section 5 (1) of the *Credit Act 1984* and section 11 (2) of the Act do not have effect in relation to a regulated loan contract to which this Order applies.

(2) The condition referred to in sub-clause (1) is that the credit provider observe those provisions of the Act in which reference is made to the accrued credit charge on the footing that the expression “accrued credit charge” has the meaning assigned to it by sub-clause (3).

(3) “Accrued credit charge” means the amount of the credit charge which has accrued at a particular time calculated by adding together—

- (a) the amounts ascertained by applying, for each day in the month of funding, the annual percentage rate divided by 365 to the amount financed; and
- (b) the amounts ascertained by applying, in each subsequent calendar month, to the monthly unpaid balance of the amount financed—
  - (i) the annual percentage rate disclosed in the contract divided by 12; or
  - (ii) the annual percentage rate as varied in accordance with the Act and regulations or any applicable exemption order, divided by 12, as the case requires.

#### Interpretation

6. For the purposes of this order—

- (1) “month of funding” means the period commencing on the date on which credit is first provided (including that day), and finishing on the last day of the calendar month in which credit is first provided (including that day); and

“monthly unpaid balance of the amount financed” means the unpaid balance of the amount financed at the commencement of the first day of each calendar month other than the month of funding.

Declaration of School Boundaries pursuant to paragraph (a) of subsection (2) of section 21.

The Honourable Minister for Education has declared that the boundaries for the schools listed hereunder shall be as stated in this notice. Children who live within the areas and boundaries stated shall attend the schools to which such boundaries apply unless directed otherwise or unless an option is provided. Children who live outside the areas and boundaries shall not attend the schools to which such boundaries apply unless written approval for such admission is obtained from the undersigned.

**Armadale Primary School**

The boundary for the abovementioned school is as follows:

From Churchman Brook at the point where it is crossed by the locality boundary between Bedforddale and Roleystone, west and northwest along this boundary until it meets the locality boundary between Bedforddale and Kelmscott, northwest, west and southwest along this boundary to Paterson Road, in a general southerly direction along Paterson Road to Canns Road, southwest along Canns Road to Carradine Road, southwest and south along Carradine Road to Albany Highway, west along Albany Highway to Armadale Road, west along Armadale Road to the railway line, south along the railway line to Eleventh Road, east along Eleventh Road to South Western Highway, south along South Western Highway to where the local authority boundary between the City of Armadale and the Shire of Serpentine-Jarrahdale turns east and in a general eastsoutheasterly direction along this local authority boundary to Wungong Reservoir.

The boundary parts of Albany Highway (south side), Armadale Road (south side), Eleventh Road (north side) and South Western Highway (east side), are included within the area for Armadale Primary School, while the boundary parts of Paterson Road (both sides), Canns Road (both sides) and Carradine Road (both sides), are excluded from the area for Armadale Primary School.

Younger siblings of children currently attending Armadale Primary School but who reside outside its boundary, will not be permitted to enrol at Armadale Primary School unless written approval is obtained from the District Superintendent. The following is an optional area between Armadale and Kingsley Primary Schools:

From the junction of Albany Highway and Carradine Road, north and northeast along Carradine Road to Canns Road, northeast along Canns Road to Paterson Road, in a general northerly direction along Paterson Road to Salter Road, west along Salter Road and its westerly extension to Haslemere Drive, west along Haslemere Drive to Albany Highway, and south and east along Albany Highway to Carradine Road.

The boundary parts of Carradine Road (both sides), Canns Road (both sides), Paterson Road (both sides), Salter Road (both sides) and Albany Highway (east and north sides), and the boundary street of Haslemere Drive (both sides) are included within the optional area.

**Beaumaris Primary School**

The boundary for the abovementioned school is as follows:

From Ocean Reef Boat Harbour, east to the extension of Hodges Drive, northeast along Hodges Drive to Marmion Avenue, north along Marmion Avenue to Moore Drive, east along Moore Drive to Connolly Drive, north along the proposed extension of Connolly Drive to Burns Beach Road, eastnortheast along Burns Beach Road to the proposed extension of the Mitchell Freeway, north along the alignment of the Mitchell Freeway to the northern boundary of the locality of Kinross,

and west along this locality boundary to the Indian Ocean. The boundary parts of Hodges Drive (north side), Marmion Avenue (west side), Moore Drive (north side), Connolly Drive (west side), Burns Beach Road (north side) and the Mitchell Freeway (west side) are included within the area for Beaumaris Primary School.

The following is an optional area between Beaumaris Primary School and Connolly Primary School: The area bounded by Marmion Avenue (east side), Shenton Avenue (north side), Connolly Drive (west side) and Moore Drive (south side).

Children living in the locality of Burns Beach and in Year 7 in 1992, and who currently (1991) attend a school in Wanneroo, may complete their primary education at that school or may transfer to Beaumaris Primary School. All other children from Burns Beach shall attend Beaumaris Primary School.

#### **Beechboro Primary School**

The boundary for the abovementioned school is as follows:

From the intersection of Altone Road and Benara Road, west along Benara Road to Bottlebrush Drive, north from this point to the western extremity of Silver Place, northeast from this point to the junction of Ironbark Road and Darwin Crescent, north from this point to the junction of King Road and Platte Way, northwest from this point to the western extremity of Jana Court, northeast along Jana Court to Platte Way, northnorthwest along Platte Way to Amazon Drive, eastnortheast along Amazon Drive to St Lawrence Drive, northnorthwest along St Lawrence Drive to Pentecost Avenue, north from this point to Coast Road, east along Coast Road to the extension of Altone Road, and south to and along Altone Road to Benara Road.

The boundary parts of Benara Road (north side), Platte Way (both sides), Amazon Drive (both sides), St Lawrence Drive (both sides), Coast Road (both sides) and Altone Road (west side) and the boundary street of Jana Court (both sides) are included within the area for Beechboro Primary School.

#### **Bibra Lake Primary School**

The boundary for the abovementioned school is as follows:

From the proposed intersection of the future extension of the Kwinana Freeway with the proposed Roe Highway, south along the extension of the Kwinana Freeway to the railway line, southwest along the railway line to Forrest Road, northwest along Forrest Road to Bibra Drive, in a general northerly direction along Bibra Drive to the proposed Roe Highway, and east along the alignment of the proposed Roe Highway to the future extension of the Kwinana Freeway.

The boundary parts of the Kwinana Freeway (west side), Forrest Road (east side), Bibra Drive (both sides) and the Roe Highway (south side), are included within the area for Bibra Lake Primary School.

#### **Blackmore Primary School**

The following is an optional area for Blackmore, Girrawheen, Hainsworth and Montrose Primary Schools:

From the alignment of the proposed Hepburn Avenue at a point north of the extension of Addington Way, south from this point to and along Addington Way to Marangaroo Drive, east along Marangaroo Drive to the southern extension of Evandale Road, north to and along Evandale Road to the alignment of the proposed Hepburn Avenue and west along this alignment to the northern extension of Addington Way.

The boundary parts of Marangaroo Drive (north side), Evandale Road (both sides) and the proposed Hepburn Avenue (south side), are included within the optional area, while the boundary part of Addington Way is excluded from the optional area.

#### **Calista Primary School**

The boundary for the abovementioned school is as follows:

From the intersection of Wellard Road and Gilmore Avenue, north along Gilmore Avenue to Summerton Road, west along Summerton Road to Stanyford Way, west and north along Stanyford Way to Gentle Road, west along Gentle Road to Tasker Road, west along Tasker Road to the proposed Fremantle-Rockingham Highway, south along the proposed Fremantle-Rockingham Highway to Wellard Road and east along Wellard Road to Gilmore Avenue.

The boundary parts of the proposed Fremantle-Rockingham Highway (east side) are included within the area for Calista Primary School, while the boundary parts of Gilmore Avenue (both sides), Stanyford Way (both sides), Tasker Road (both sides), Wellard Road (both sides), and the boundary streets of Summerton Avenue (both sides) and Gentle Road (both sides) are excluded from the area for Calista Primary School. The following is an optional area for Calista, North Parmelia and Orelia Primary Schools for families moving into that area or for those sending a child to school for the first time:

The area bounded by Challenger Avenue (both sides), Gilmore Avenue (both sides), Sulphur Road (both sides), and Parmelia Avenue (both sides).

The following is a limited optional area for Calista, Leda and North Parmelia Primary Schools:

The area bounded by Gilmore Avenue, Challenger Avenue, Parmelia Avenue, Sutherland Parade, the locality boundary of Parmelia and Casuarina, Bertram Road and Wellard Road.

The boundary parts of Bertram Road (both sides), and Gilmore Avenue (both sides), are included within the limited optional area, while the boundary parts of Parmelia Avenue (both sides), and

Wellard Road (both sides) and the boundary streets of Challenger Avenue (both sides) and Sutherland Parade (both sides), are excluded from the limited optional area.

Children currently (1991) attending either Calista Primary School or North Parmelia Primary School, and living within the abovementioned limited optional area, may remain at their 1991 school or may transfer to Leda Primary School.

Children of families moving into the abovementioned limited optional area after 1991, and children of families who are sending a child to school for the first time, shall attend Leda Primary School.

#### **Cloverdale Primary School**

The boundary for the abovementioned school is as follows:

From the junction of Hardey Road and Esther Street, southwest along Esther Street to Belmont Avenue, southeast along Belmont Avenue to Fulham Street, northeast along Fulham Street to Hardey Road and northwest along Hardey Road to Esther Street.

The boundary parts of Esther Street (southeast side), Belmont Avenue (both sides), Fulham Street (both sides) and Hardey Road (southwest side), are included within the area for Cloverdale Primary School.

#### **Connolly Primary School**

The boundary for the abovementioned school is as follows:

From the intersection of Marmion Avenue and Hodges Drive, east along Hodges Drive to the proposed alignment of the Mitchell Freeway, in a general northerly direction along the Mitchell Freeway alignment to Burns Beach Road, westsouthwest along Burns Beach Road to the extension of Connolly Drive, south along Connolly Drive to Shenton Avenue, west along Shenton Avenue to Marmion Avenue and south along Marmion Avenue to Hodges Drive. The boundary parts of Hodges Drive (north side), the Mitchell Freeway (west side), Burns Beach Road (south side), Connolly Drive (east side), Shenton Avenue (south side) and Marmion Avenue (east side), are included within the area for Connolly Primary School.

The following is an optional area between Connolly Primary School and Beaumaris Primary School:

The area bounded by Marmion Avenue (east side), Shenton Avenue (north side), Connolly Drive (west side) and Moore Drive (south side).

Until a primary school is established in the locality of Joondalup, children resident in Joondalup may attend either Connolly, Eddystone, Heathridge or Poseidon Primary Schools or, subject to the availability of accommodation and with the approval of the District Superintendent, any other Government school in the area.

#### **Davallia Primary School**

The boundary for the abovementioned school is as follows:

From the junction of Beach Road and Poynter Drive, north along Poynter Drive to Quilter Drive, east and north along Quilter Drive to and across Granadilla Street to Karo Place, west to the westerly extremity of Karo Place, north from this point to Nicholli Street, east along Nicholli Street to Bernedale Way, north along the eastern arm of Bernedale Way to Warwick Road, east along Warwick Road to the Mitchell Freeway, south along the Mitchell Freeway to Balcatta Road, west along Balcatta Road to Duffy Road, north along Duffy Road to the proposed alignment of the Reid Highway, west along this alignment to Okely Road, north along Okely Road to Beach Road and west along Beach Road to Poynter Drive.

The boundary parts of Warwick Road (south side), the Mitchell Freeway (west side), Balcatta Road (north side), Duffy Road (east side), Reid Highway (north side), Okely Road (east side) and Beach Road (north side), and the boundary street of Karo Place (both sides), are included within the area for Davallia Primary School, while the boundary parts of Poynter Drive (both sides), Nicholli Street (both sides) and Bernedale Way (both sides), and the boundary street of Quilter Drive (both sides), are excluded from the area for Davallia Primary School.

#### **Eden Hill Primary School**

The boundary for the abovementioned school is as follows:

From the junction of Morley Drive East and Wicks Street, south along Wicks Street to Walter Road East, east along Walter Road East and its extension to the Swan River, northeast along the Swan River to the locality boundary between Caversham and Eden Hill, northeast, northwest and west along this locality boundary to Morley Drive East and west along Morley Drive East to Wicks Street. The boundary parts of Morley Drive East (south side) and Walter Road East (north side) are included within the area for Eden Hill Primary School, while the boundary street of Wicks Street (both sides), is excluded from the area for Eden Hill Primary School.

The following is an optional area between Eden Hill Primary School and Anzac Terrace Primary School:

From the intersection of Walter Road East and Ivanhoe Street, south along Ivanhoe Street to Anzac Terrace, east along Anzac Terrace to Fourth Avenue, south along Fourth Avenue and its extension to the railway line, east along the railway line to the Swan River, northwest and north along the Swan River to the extension of Walter Road East, and west from this point to and along Walter Road East to Ivanhoe Street.

The boundary parts of Ivanhoe Street (both sides), Anzac Terrace (north side), Fourth Avenue (both sides) and Walter Road East (south side), are excluded within the optional area.

**Ferndale Primary School**

The boundary for the abovementioned school is as follows:

From the junction of Metcalfe Road and Ferndale Crescent, northwest along Ferndale Crescent to the Canning River, southsouthwest along the Canning River to the extension of Duff Road, south to and along Duff Road to High Road, east and southeast along High Road to Metcalfe Road and northeast along Metcalfe Road to its second junction with Ferndale Crescent.

The boundary parts of High Road (north and northeast sides), and Metcalfe Road (northwest side) and the boundary street of Duff Road (both sides) are included within the area for Ferndale Primary School, while the boundary parts of Ferndale Crescent (both sides) are excluded from the area for Ferndale Primary School.

**Forest Crescent Primary School**

The following is an optional area between Forest Crescent and Huntingdale Primary Schools:

From the junction of Ranford Road and Southern River Road, northeast along Southern River Road to Gay Street, northwest along Gay Street and its extension to Warton Road, southwest along Warton Road to Ranford Road and southeast along Ranford Road to Southern River Road.

The boundary parts of Southern River Road (both sides), Warton Road (both sides), Ranford Road (both sides) and the boundary street of Gay Street (both sides), are included within the optional area.

The nucleus of the catchment area for Forest Crescent Primary School, as published in the *Government Gazette* of 24 December, 1986, p. 5002, remains unchanged.

**Gidgegannup Primary School**

The southern boundary for the abovementioned school is as follows:

Toodyay Road at the point where it crosses Strelley Brook, eastnortheast along Toodyay Road to Lillydale Road, east along Lillydale Road to Breeze Road, east along Breeze Road to Mayo Road, northnorthwest along Mayo Road to Toodyay Road and northeast along Toodyay Road.

The boundary parts of Toodyay Road (both sides), Lillydale Road (both sides), Mayo road (both sides) and the boundary street of Breeze Road (both sides), are included within the area for Gidgegannup Primary School. Properties having a frontage to any of the boundary parts of the abovementioned roads are included within the area for Gidgegannup Primary School. Children attending Government schools in Year 7 in 1992 and living within the area for Gidgegannup Primary School, may complete their primary education at their 1991 school or may transfer to Gidgegannup Primary School.

Children in Years 1 to 6 inclusive in 1992 (Years 1 to 7 inclusive thereafter), and living within the area for Gidgegannup Primary School, shall attend Gidgegannup Primary School, except that younger siblings of Year 7 (1992) children shall have the option of remaining with any year 7 siblings who elect to complete their primary education at their 1991 school. Transport will not be provided for these younger siblings unless complementary places are available.

The area defined below is an optional area between Gidgegannup Primary School and other appropriate neighbouring schools. For the purposes of this notice, "appropriate" means a school served by a bus route catering for specific parts contained within the optional area.

The following constitutes the abovementioned optional area:

Toodyay Road at a point coinciding with the western extension of Cameron Road, east from this point to and along Cameron Road and its extension to Bunning Road, north along Bunning Road to the boundary between the Shire of Swan and the Shire of Mundaring, east, north, east and north along this boundary to Wooroloo Brook, in a northwesterly direction along Wooroloo Brook to Toodyay Road, southwest along Toodyay Road to Mayo Road, southsoutheast along Mayo Road to Breeze Road, west along Breeze Road to Lillydale Road, west along Lillydale Road to Toodyay Road and westsouthwest along Toodyay Road to the western extension of Cameron Road.

The boundary part of Bunning Road (both sides), and the boundary street of Cameron Road (both sides), are included within the optional area, while the boundary parts of Mayo Road (both sides), Lillydale Road (both sides), Toodyay Road (both sides) and the boundary street of Breeze Road (both sides) are excluded from the optional area.

**Girrawheen Primary School**

The following is an optional area for Girrawheen, Hainsworth, Koondoola and Montrose Primary Schools:

From the intersection of the alignment of the proposed Hepburn Avenue and Evandale Road, south along Evandale Road and its extension to Marangaroo Drive, east along Marangaroo Drive to the southern extension of Gerosa Place, north to and along Gerosa Place to Hillcrest Road, northeast along Hillcrest Road to Derbi Road, north along Derbi Road to the extension of Rangeview Road, north along Rangeview Road to the alignment of the proposed Hepburn Avenue and west along this alignment to Evandale Road.

The boundary parts of Marangaroo Drive (north side), and Hepburn Avenue (south side), are included within the optional area, while the boundary parts of Evandale Road (both sides), Hillcrest Road (both sides) and Rangeview Road (both sides) and the boundary streets of Gerosa Place (both sides) and Derbi Road (both sides) are excluded from the optional area.

The following is an optional area for Girrawheen, Blackmore, Hainsworth and Montrose Primary Schools:

From the alignment of the proposed Hepburn Avenue at a point north of the extension of Addington Way, south from this point to and along Addington Way to Marangaroo Drive, east along Marangaroo Drive to the southern extension of Evandale Road, north to and along Evandale Road to the alignment of the proposed Hepburn Avenue and west along this alignment to the northern extension of Addington Way.

The boundary parts of Marangaroo Drive (north side), Evandale Road (both sides) and the proposed Hepburn Avenue (south side), are included within the optional area, while the boundary part of Addington Way is excluded from the optional area.

#### **Hainsworth Primary School**

The following is an optional area for Hainsworth, Girrawheen, Koondoola and Montrose Primary Schools:

From the intersection of the alignment of the proposed Hepburn Avenue and Evandale Road, south along Evandale Road and its extension to Marangaroo Drive, east along Marangaroo Drive to the southern extension of Gerosa Place, north to and along Gerosa Place to Hillcrest Road, northeast along Hillcrest Road to Derbi Road, north along Derbi Road to the extension of Rangeview Road, north along Rangeview Road to the alignment of the proposed Hepburn Avenue and west along this alignment to Evandale Road.

The boundary parts of Marangaroo Drive (north side), and Hepburn Avenue (south side), are included within the optional area, while the boundary parts of Evandale Road (both sides), Hillcrest Road (both sides) and Rangeview Road (both sides) and the boundary streets of Gerosa Place (both sides) and Derbi Road (both sides) are excluded from the optional area.

The following is an optional area for Hainsworth, Blackmore, Girrawheen and Montrose Primary Schools:

From the alignment of the proposed Hepburn Avenue at a point north of the extension of Addington Way, south from this point to and along Addington Way to Marangaroo Drive, east along Marangaroo Drive to the southern extension of Evandale Road, north to and along Evandale Road to the alignment of the proposed Hepburn Avenue and west along this alignment to the northern extension of Addington Way. The boundary parts of Marangaroo Drive (north side), Evandale Road (both sides) and the proposed Hepburn Avenue (south side), are included within the optional area, while the boundary part of Addington Way is excluded from the optional area.

#### **Hampton Park Primary School**

The boundary for the abovementioned school is as follows:

From the junction of Wicks Street and Walter Road East, west along Walter Road East to Broun Avenue, westsouthwest along Broun Avenue to Tonkin Highway, north along Tonkin Highway to Morley Drive, west along Morley Drive to Emberson Road, north along Emberson Road to Spruce Road, east along Spruce Road and its extension to Tonkin Highway, north along Tonkin Highway to Benara Road, east along Benara Road to Beechboro Road North, south along Beechboro Road North to Devonshire Street, east from this point, between Eugene Court and Redgum Way to the north and Elletra Close to the south, to Arbor Park, southeast and east along the southern boundary of Arbor Park to Challenger Avenue, north and east along Challenger Avenue to Bottlebrush Drive, south, southeast and south along Bottlebrush Drive to Morley Drive East, west and westsouthwest along Morley Drive East to Wicks Street and south along Wicks Street to Walter Road East.

The boundary parts of Walter Road East (north side), Broun Avenue (north side), Tonkin Highway (east side), Morley Drive (north side), Emberson Road (both sides), Benara Road (south side), Beechboro Road (west side), Challenger Avenue (both sides), Bottlebrush Drive (west and south sides) and Morley Drive East (north side) and the boundary streets of Spruce Road (both sides) and Wicks Street (both sides) are included within the area for Hampton Park Primary School.

The following is an optional area between Hampton Park Primary School and Noranda Primary School:

From the junction of Deschamp Road and Emberson Road, east from this point to Lindsay Drive, east along the eastwest arm of Lindsay Drive and its extension to Tonkin Highway, south along Tonkin Highway to a point adjacent to the eastern extension of Spruce Road, west from this point to and along Spruce Road to Emberson Road and north along Emberson Road to Deschamp Road. The boundary parts of Lindsay Drive (both sides), Tonkin Highway (west side) and Emberson Road (both sides) are included within the optional area, while the boundary street of Spruce Street (both sides) is excluded from the optional area.

#### **Hannans Primary School**

The boundary for the abovementioned school is as follows:

The Kalgoorlie-Menzies Railway line at a point adjacent to the northern limit of the Kalgoorlie Golf Course, southsoutheast along the railway line to Killarney Street, southwest along Killarney Street and its extension to the Pipeline and northwest along the Pipeline.

The boundary street of Killarney Street (both sides) is included within the area for Hannans Primary School.

Children attending Government schools in Year 7 in 1992, and living within the area for Hannans Primary School, may complete their primary education at their 1991 school or may transfer to Hannans Primary School. Children in Years 1 to 6 inclusive in 1992 (Years 1 to 7 inclusive thereafter) and living within that area for Hannans Primary School, shall attend Hannans Primary

School, except that younger siblings of Year 7 (1992) children shall have the option of remaining with any Year 7 siblings who elect to complete their primary education at their 1991 school.

#### **High Wycombe Primary School**

The boundary for the abovementioned school is as follows:

From the junction of Kenneth Road and Kalamunda Road, southeast along Kalamunda Road to Range Court, south along Range Court to Range View Road, southwest along Range View Road to Range View Park, northwest along the northern boundary of Range View Park to Jeanhulley Road, southwest along Jeanhulley road to Wycombe Road, northwest along Wycombe Road to Norling Road, southwest along Norling Road to Kiandra Way, west along Kiandra Way to Cassowary Road, south from this point to and along Finch Court to Newburn Road, west, northwest and north along Newburn Road to Sorenson Road, west and southwest along Sorenson Road and its extension across Dundas Road to the railway line, north along the railway line to Great Eastern Highway Bypass, east along Great Eastern Highway Bypass to Roe Highway, south along Roe Highway to the extension of Adelaide Street, west to and along Adelaide Street to Larwood Crescent, southwest along Larwood Crescent and its extension to the western part of Kenneth Road, and in a general southwesterly direction along Kenneth Road to Kalamunda Road.

The boundary parts of Great Eastern Highway Bypass (south side), Roe Highway (west side), Larwood Crescent (both sides) and Adelaide Street (both sides), are included within the area for High Wycombe Primary School, while the boundary parts of Kalamunda Road (both sides), Wycombe Road (both sides), Norling Road (both sides), Kiandra Way (both sides), Newburn Road (both sides), Sorenson Road (both sides), and Kenneth Road (both sides) and the boundary streets of Range Court (both sides), Jeanhulley Road (both sides), Finch Court (both sides), and Range View Road (both sides), are excluded from the area for High Wycombe Primary School.

The following are optional areas between High Wycombe and Edney Primary Schools:

(i) The area bounded by Sorenson Road, Newburn Road, Butcher Road, the eastern arm of Palmer Crescent, a line joining the eastern arm of Palmer Crescent to Dundas Road and Dundas Road.

Both sides of the abovementioned boundary streets or part thereof, are included within the optional area.

(ii) the area bounded by Kalamunda Road (both sides), Roe Highway (west side), Adelaide Street (both sides) (as far west as Larwood Crescent) and a line drawn south from Adelaide Street along the western arm of Kenneth Road to Kalamunda Road.

#### **Huntingdale Primary School**

The following is an optional area between Huntingdale Primary School and Forest Crescent Primary School:

From the junction of Ranford Road and Southern River Road, northeast along Southern River Road to Gay Street, northwest along Gay Street and its extension to Warton Road, southwest along Warton Road to Ranford Road and southeast along Ranford Road to Southern River Road. The boundary parts of Southern River Road (both sides), Warton Road (both sides), Ranford Road (both sides) and the boundary street of Gay Street (both sides), are included within the optional area.

The nucleus of the catchment area for Huntingdale Primary School, as published in the *Government Gazette* of 31 December, 1976, p. 5144, remains unchanged.

#### **Kalamunda Primary School**

The following is an optional area between Kalamunda and Maida Vale Primary Schools:

From the junction of Kalamunda Road with West Terrace, south along West Terrace to Norwood Road, west along Norwood Road to Holmes Road, south along Holmes Road to Maud Road, east from this point to Simeon Close, east along Simeon Close to West Terrace, south and southeast along West Terrace to the walk trail, east along the walk trail to a point just east of Brie Brie Crescent, north from this point to Nangana Way, north along the north-south alignment of Nangana Way to Kalamunda Road and northwest along Kalamunda Road to West Terrace.

The boundary parts West Terrace (southern section, both sides), Nangana Way (both sides) and Kalamunda Road (south side) and the boundary street of Simeon Close (both sides), are included within the optional area, while the boundary parts of West Terrace (northern section, both sides), Norwood Road (both sides) and Holmes Road (both sides) are excluded from the optional area.

#### **Kardinya Primary School**

The boundary for the abovementioned school is as follows:

From the junction of Somerville Boulevard and North Lake Road, north along North Lake Road to Garling Street, west along Garling Street to the locality boundary between Kardinya and O'Connor, south along this boundary to South Street, eastsoutheast along South Street to North Lake Road, south along North Lake Road to Progress Drive, east and north along Progress Drive to Farrington Road, northeast along Farrington Road to Windelya Road, north along Windelya Road to South Street, east and northeast along South Street to Prescott Drive, in a general northerly direction along Prescott Drive to Somerville Boulevard, and in a general westerly direction along Somerville Boulevard to North Lake Road.

The boundary parts of North Lake Road (north section, west side, southern section, east side), Garling Street (south side), South Street (north side), Progress Drive (both sides), Farrington Road (both sides), and Somerville Boulevard (south side) and the boundary road of Windelya Road (both sides), are included within the area for Kardinya Primary School, while the boundary street of Prescott Drive (both sides) is excluded from the area for Kardinya Primary School.

The following is an optional area between Kardinya and Bateman Primary Schools:

The area bounded by Prescott Drive (both sides), South Street (north side), Murdoch Drive (west side) and Somerville Boulevard (south side).

#### **Koondoola Primary School**

The following is an optional area for Koondoola, Girrawheen, Hainsworth and Montrose Primary Schools:

From the intersection of the alignment of the proposed Hepburn Avenue and Evandale Road, south along Evandale Road and its extension to Marangaroo Drive, east along Marangaroo Drive to the southern extension of Gerosa Place, north to and along Gerosa Place to Hillcrest Road, northeast along Hillcrest Road to Derbi Road, north along Derbi Road to the extension of Rangeview Road, north along Rangeview Road to the alignment of the proposed Hepburn Avenue and west along this alignment to Evandale Road.

The boundary parts of Marangaroo Drive (north side), and Hepburn Avenue (south side), are included within the optional area, while the boundary parts of Evandale Road (both sides), Hillcrest Road (both sides) and Rangeview Road (both sides) and the boundary streets of Gerosa Place (both sides) and Derbi Road (both sides) are excluded from the optional area.

#### **Leda Primary School**

The boundary for the abovementioned school is the locality of Leda, as delineated in the *1991 Perth StreetSmart Directory*.

Children attending Government schools in Year 7 in 1992 and living within the area for Leda Primary School, may complete their primary education at their 1991 school or may transfer to Leda Primary School.

Children in Years 1 to 6 inclusive in 1992 (Years 1 to 7 inclusive thereafter) and living within the area for Leda Primary School, shall attend Leda Primary School, except that younger siblings of Year 7 (1992) children shall have the option of remaining with any Year 7 siblings who elect to complete their primary education at their 1991 school.

The following is an optional area between Leda Primary School and Medina Primary School:

The locality of Wellard as delineated in the *1991 Perth StreetSmart Directory*.

Transport will not be provided to Leda Primary School for children living in the locality of Wellard.

#### **Lockridge Junior Primary School and Lockridge Primary School**

The boundary for the abovementioned schools is as follows:

From the junction of Bottlebrush Drive and Morley Drive East, east along Morley Drive East to Lord Street, north along Lord Street to the alignment of the unmade Harper Street, northeast from this point to Bennett Brook, in a northerly direction along Bennett Brook to Benara Road, west along Benara Road to the extension of Milligan Avenue, south and southwest along Milligan Avenue to Bottlebrush Drive and south, southeast and south along Bottlebrush Drive to Morley Drive East.

The boundary parts of Morley Drive East (north side), Lord Street (both sides), Benara Road (south side) and Bottlebrush Drive (east and northeast sides), are included within the area for Lockridge Junior Primary School and Lockridge Primary School, while the boundary street of Milligan Avenue (both sides), is excluded from the area for these schools.

#### **Maida Vale Primary School**

The following is an optional area between Maida Vale and Kalamunda Primary Schools:

From the junction of Kalamunda Road with West Terrace, south along West Terrace to Norwood Road, west along Norwood Road to Holmes Road, south along Holmes Road to Maud Road, east from this point to Simeon Close, east along Simeon Close to West Terrace, south and southeast along West Terrace to the walk trail, east along the walk trail to a point just east of Brie Brie Crescent, north from this point to Nangana Way, north along the north-south alignment of Nangana Way to Kalamunda Road and northwest along Kalamunda Road to West Terrace.

The boundary parts West Terrace (southern section, both sides), Nangana Way (both sides) and Kalamunda Road (south side) and the boundary street of Simeon Close (both sides), are included within the optional area, while the boundary parts of West Terrace (northern section, both sides), Norwood Road (both sides) and Holmes Road (both sides) are excluded from the optional area.

#### **Marangaroo Primary School**

The boundary for the abovementioned school is as follows:

From the junction of Hepburn Avenue and Wanneroo Road, south along Wanneroo Road to Marangaroo Drive, southeast and east along Marangaroo Drive to Addington Way, north along Addington Way and its extension to the alignment of the proposed Hepburn Avenue and west along this alignment to Wanneroo Road.

The boundary parts of Wanneroo Road (east side), Marangaroo Drive (north side), Addington Way (both sides) and the proposed Hepburn Avenue (south side), are included within the area for Marangaroo Primary School.

The following is an optional area for Marangaroo, Alinjarra, Wanneroo Junior and Wanneroo Primary Schools:

The locality of Landsdale.

Younger siblings of children currently (1991) attending Marangaroo Primary School and who live in the optional area for Girrawheen, Hainsworth and Montrose Primary Schools, may attend Marangaroo Primary School.

**Medina Primary School**

The boundary for the abovementioned school is as follows:

From the intersection of Thomas Road and the proposed Fremantle-Rockingham Highway, south along the proposed Fremantle-Rockingham Highway to Tasker Road, east along Tasker Road to Gentle Road, east along Gentle Road to Stanyford Way, south and east along Stanyford Way to Summerton Road, east along Summerton Road to Gilmore Avenue, north along Gilmore Avenue to Thomas Road and west along Thomas Road to the proposed Fremantle-Rockingham Highway.

The boundary parts of the proposed Fremantle-Rockingham Highway (east side), Tasker Road (both sides), Stanyford Way (both sides), Gilmore Avenue (west side), Thomas Road (south side), and the boundary streets of Gentle Road (both sides), and Summerton Road (both sides), are included within the area for Medina Primary School.

The following is an optional area between Medina Primary School and Leda Primary School:

The locality of Wellard as delineated in the *1991 Perth StreetSmart Directory*.

Transport will not be provided to Leda Primary School for children living in the locality of Wellard.

**Montrose Primary School**

The following is an optional area for Montrose, Girrawheen, Hainsworth and Koondoola Primary Schools:

From the intersection of the alignment of the proposed Hepburn Avenue and Evandale Road, south along Evandale Road and its extension to Marangaroo Drive, east along Marangaroo Drive to the southern extension of Gerosa Place, north to and along Gerosa Place to Hillcrest Road, northeast along Hillcrest Road to Derbi Road, north along Derbi Road to the extension of Rangeview Road, north along Rangeview Road to the alignment of the proposed Hepburn Avenue and west along this alignment to Evandale Road.

The boundary parts of Marangaroo Drive (north side), and Hepburn Avenue (south side), are included within the optional area, while the boundary parts of Evandale Road (both sides), Hillcrest Road (both sides) and Rangeview Road (both sides) and the boundary streets of Gerosa Place (both sides) and Derbi Road (both sides) are excluded from the optional area.

The following is an optional area for Montrose, Blackmore, Girrawheen and Hainsworth Primary Schools:

From the alignment of the proposed Hepburn Avenue at a point north of the extension of Addington Way, south from this point to and along Addington Way to Marangaroo Drive, east along Marangaroo Drive to the southern extension of Evandale Road, north to and along Evandale Road to the alignment of the proposed Hepburn Avenue and west along this alignment to the northern extension of Addington Way.

The boundary parts of Marangaroo Drive (north side), Evandale Road (both sides) and the proposed Hepburn Avenue (south side), are included within the optional area, while the boundary part of Addington Way is excluded from the optional area.

**North Kalgoorlie Primary School**

The boundary for the abovementioned school is as follows:

From the northernmost point of Killarney Street, southwest along Killarney Street and its extension to the Pipeline, southeast along the Pipeline to the extension of Bourke Street, northeast from this point to and along Bourke Street to Varden Street, east along Varden Street and its extension to the Kalgoorlie-Menzies railway line, north along the railway line to Hare Street, northeast along Hare Street and its extension to Broad Arrow Road, and west from this point to the northernmost point of Killarney Street.

The boundary parts of Varden Street (both sides) and the boundary streets of Bourke Street (both sides) and Hare Street (both sides) are included within the area for North Kalgoorlie Primary School, while the boundary street of Killarney Street (both sides) is excluded from the area for North Kalgoorlie Primary School.

**North Parmelia Primary School**

The boundary for the abovementioned school is as follows:

From the the junction of Sutherland Parade and Parmelia Avenue, north along Parmelia Avenue to Sulphur Road, west along Sulphur Road to Casserley Way, north along Casserley Way and continuing in a northerly direction to Hennessy Avenue, west along Hennessy Avenue to Orelia Avenue, north along Orelia Avenue to Thomas Road, east along Thomas Road to the locality boundary of Parmelia and Casuarina, south, west and south along this locality boundary to Sutherland Parade, and west along Sutherland Parade to Parmelia Avenue. The boundary parts of Thomas Road (south side) and the boundary street of Sutherland Parade (both sides) are included within the area for North Parmelia Primary School, while the boundary parts of Parmelia Avenue (both sides), Sulphur Road (both sides), Casserley Way (both sides), Hennessy Avenue (both sides) and Orelia Avenue (both sides), are excluded from the area for North Parmelia Primary School.

The following is an optional area for North Parmelia, Calista and Orelia Primary Schools for families moving into that area or for those sending a child to school for the first time:

The area bounded by Challenger Avenue (both sides), Gilmore Avenue (both sides), Sulphur Road (both sides) and Parmelia Avenue (both sides).

The following is a limited optional area for North Parmelia, Calista and Leda Primary Schools:  
The area bounded by Gilmore Avenue, Challenger Avenue, Parmelia Avenue, Sutherland Parade, the locality boundary of Parmelia and Casuarina, Bertram Road and Wellard Road.

The boundary parts of Bertram Road (both sides), and Gilmore Avenue (both sides) are included within the limited optional area, while the boundary parts of Parmelia Avenue (both sides), and Wellard Road (both sides) and the boundary streets of Challenger Avenue (both sides) and Sutherland Parade (both sides), are excluded from the limited optional area.

Children currently (1991) attending either Calista Primary School or North Parmelia Primary School, and living within the abovementioned limited optional area, may remain at their 1991 school or may transfer to Leda Primary School.

Children of families moving into the abovementioned limited optional area after 1991, and children of families who are sending a child to school for the first time, shall attend Leda Primary School.

#### **Orelia Primary School**

The boundary for the abovementioned school is as follows:

From the junction of Thomas Road and Gilmore Avenue, south along Gilmore Avenue to Sulphur Road, east along Sulphur Road to Casserley Way, north along Casserley Way and continuing in a northerly direction to Hennessy Avenue, west along Hennessy Avenue to Orelia Avenue, north along Orelia Avenue to Thomas Road and west along Thomas Road to Gilmore Avenue. The boundary parts of Gilmore Avenue (east side), Casserley Way (both sides), Hennessy Avenue (both sides), Orelia Avenue (both sides) and Thomas Road (south side) are included within the area for Orelia Primary School, while the boundary parts of Sulphur Road (both sides) are excluded from the area for Orelia Primary School.

The following is an optional area for Orelia, Calista and North Parmelia Primary Schools for families moving into that area or for those sending a child to school for the first time:

The area bounded by Challenger Avenue (both sides), Gilmore Avenue (both sides), Sulphur Road (both sides) and Parmelia Avenue (both sides).

#### **Padbury Primary School**

The boundary for the abovementioned school is as follows:

From the junction of Forrest Road and Marmion Avenue, south along Marmion Avenue to the westerly extension of Jardine Place, east from this point between Buchanan Way (to the north) and Lushington Drive (to the south) to and across Grey Road, continuing in an eastnortheasterly direction between Lindsay Way, Young Place and Hann Place (to the north) and Stubb Place, Eyre Place, Wright Place, Wills Place and Clay Place (to the south) to the junction of Giles Avenue and Barclay Avenue, southeast along Barclay Avenue to Gibson Avenue, northeast and north along Gibson Avenue to Giles Avenue, in a general westerly direction along Giles Avenue to Marmion Avenue with Warner Drive, Byrne Close, Hubbard Drive, Wells Place, Rowlands Court, Mason Way and Forrest Road to the north and Giles Avenue, Simpson Drive, Carnegie Way, Durack Way, Gillen Court and Elder Place to the south.

The boundary parts of Marmion Avenue (east side), and Gibson Avenue (west side), are included within the area for Padbury Primary School, while the boundary street of Barclay Street (both sides) is excluded from the area for Padbury Primary School.

Until further notice, children resident within the area for South Padbury Primary School may attend Padbury Primary School.

#### **Parkwood Primary School**

The optional area between Parkwood (formerly West Lynwood), Ferndale and Lynwood Primary Schools, published in the *Government Gazette* of 8 December 1976, p. 4660, is hereby rescinded. This area will henceforth contribute to Ferndale Primary School.

From the junction of Warburton Avenue and Marmion Avenue, southsoutheast along Marmion Avenue to Hepburn Avenue, east along Hepburn Avenue to the Mitchell Freeway, north along the Mitchell Freeway to a point adjacent to the extension of Dulwich Place, west from this point to the southern end of Holleton Terrace, in a westnorthwesterly direction to Gibson Avenue, between

Burbank Court and Mararda Court to the north and Copperhead Avenue to the south, westsouthwest along Gibson Avenue to Warburton Avenue, and in a general westerly direction along Warburton Avenue to Marmion Avenue.

The boundary parts of Marmion Avenue (east side), Hepburn Avenue (north side), the Mitchell Freeway (west side) and Gibson Avenue (west side) and the boundary street of Warburton Avenue (both sides), are included within the area for South Padbury Primary School.

The following are optional areas between Padbury and South Padbury Primary Schools:

(i) the area bounded by Gibson Avenue, Pinnaroo Drive (northern section), Kintore Place, Leviathan Way, Holleton Terrace, a line drawn from Holleton Terrace (between Burbank Court and Mararda Court to the north and Copperhead Avenue to the south) to Gibson Avenue, and Gibson Avenue.

The boundary parts of Gibson Avenue (east side) and all the abovementioned boundary streets, with the exception of Copperhead Avenue, are included within the optional area.

(ii) The area bounded by Marmion Avenue, Warburton Avenue, Gibson Avenue, Barclay Avenue and a line drawn in a westsouthwesterly direction from the junction of Giles Avenue and Barclay Avenue to Marmion Avenue, so that Wills Place, Wright Place, Eyre Place, Stubbs Place, Lushington Drive, Jardine Place and Hume Place are included within the optional area, while Hann Place, Young Place, Lindsay Way and Buchanan Way are excluded from the optional area.

The boundary parts of Marmion Avenue (east side), and Gibson Avenue (west side) are included within the optional area while the boundary street of Warburton Avenue is excluded from the optional area.

Until further notice, children resident within the area for South Padbury Primary School may attend Padbury Primary School.

#### **Weld Square Primary School**

#### **West Beechboro Primary School**

From the junction of Bottlebrush Drive and Benara Road, north from this point to the western extremity of Silver Place, northeast from this point to the junction of Ironbark Road and Darwin Crescent, north from this point to the junction of King Road and Platte Way, northwest from this point to the western extremity of Jana Court, northeast along Jana Court to Platte Way, northnorthwest along Platte Way to Amazon Drive, eastnortheast along Amazon Drive to St Lawrence Drive, northnorthwest along St Lawrence Drive to Pentecost Avenue, north from this point to Coast Road, west along Coast Road to Beechboro Road North, south along Beechboro Road North to Reid Highway, southwest along Reid Highway to Tonkin Highway, south along Tonkin Highway to Benara Road, east along Benara Road to Beechboro Road North, south along Beechboro Road North to Devonshire Street, east from this point, between Eugene Court and Redgum Way to the north and Elletra Close to the south, to Arbor Park, southeast and east along the southern boundary of Arbor Park to Challenger Avenue, north and east along Challenger Avenue to Bottlebrush Drive, north along Bottlebrush Drive to Milligan Avenue, northeast and north along Milligan Avenue and its extension to Benara Road and west along Benara Road to Bottlebrush Drive.

The boundary parts of Coast Road (both sides), Beechboro Road North (east side), Reid Highway (southeast side), Tonkin Highway (east side), Benara Road (eastern section south side, western section north side) and Bottlebrush Drive (west side) and the boundary street of Milligan Avenue (both sides) are included within the area for West Beechboro Primary School, while the boundary parts of Platte Way (both sides), Amazon Drive (both sides), St Lawrence Drive (both sides) and the boundary streets of Jana Court (both sides) and Challenger Avenue (both sides) are excluded from the area for West Beechboro Primary School.

Children attending Government schools in Year 7 in 1992 and living within the area for West Beechboro Primary School, may complete their primary education at their 1991 school or may transfer to West Beechboro Primary School.

Children in Years 1 to 6 inclusive in 1992 (Years 1 to 7 inclusive thereafter) and living within the area for West Beechboro Primary School, shall attend West Beechboro Primary School except that:

(a) Younger siblings of Year 7 (1992) children shall have the option of remaining with any Year 7 siblings who elect to complete their primary education at their 1991 school.

(b) Children currently living in the area for West Beechboro Primary School south of Benara Road may complete their primary education at their 1991 school. This option is extended to younger siblings of such children.

Families moving into this area after the end of 1991, and those from this area who send children to school for the first time after 1991, will be required to attend West Beechboro Primary School.

#### **West Midland Primary School**

#### **Wooroloo Primary School**

From Muranine Gully north to the junction of Great Eastern Highway and Chedaring Road, northwest along Chedaring Road to Werribee Road, northeast along Werribee Road to Doys Road, north along Doys Road to Burma Road, and continuing in a northerly direction along the northern extension of Doys Road for an additional two kilometres.

Students resident in the boundary parts of Chedaring Road (both sides), Werribee Road (north side) and Doys Road (both sides) shall attend Wooroloo Primary School. Students resident in the boundary part of Werribee Road (south side) shall attend Wundowie Primary School. Wundowie Primary School

The boundary for the abovementioned school is as follows:

From Muranine Gully north to the junction of Great Eastern Highway and Chedaring Road, northwest along Chedaring Road to Werribee Road, northeast along Werribee Road to Doys Road, north along Doys Road to Burma Road, and continuing in a northerly direction along the northern extension of Doys Road for an additional two kilometres.

Students resident in the boundary parts of Chedaring Road (both sides), Werribee Road (north side) and Doys Road (both sides) shall attend Wooroloo Primary School. Students resident in the boundary part of Werribee Road (south side) shall attend Wundowie Primary School.





## DOG ACT 1976

*The Municipality of the Shire of Greenough*

## By-Laws Relating to Dogs

In pursuance of the powers conferred upon it by the abovementioned Act and of all other powers enabling it, the Council of the abovementioned Municipality hereby records having resolved on the 27th day of March 1991, to make and submit for confirmation by the Governor the following By-laws:

## By-laws Relating to Dogs

## 1. Revocation

The By-laws of the Shire of Greenough Relating to Dogs published in the *Government Gazette* on 20th August, 1976 and amendment published in the *Government Gazette* on 24th October, 1980 are hereby revoked.

## 2. Citation

These By-laws may be cited as the Shire of Greenough By-laws Relating to Dogs.

## Part I—Interpretation

## 3. In these By-laws, unless the context requires otherwise—

“Act” means the Dog Act 1976 as amended.

“Authorized Person” means a person who is authorized by or under Section 29 of the Dog Act.

“Council” means the Council of the municipality of the Shire of Greenough.

“District” means the district of the municipality of the Shire of Greenough.

“Public Building” means a public building defined in Section 173 of the Health Act 1911 as amended.

“Regulations” means the Dog Regulations 1976 as amended.

All other words and expressions have the same meaning as they have in the Act.

## Part II—Impounding of Dogs

4. Council may establish and maintain a Pound or Pounds for the impounding of dogs seized pursuant to the provisions of the Act or these By-laws as it deems necessary.

5. Charges in relation to the seizure and maintenance of a dog in accordance with Section 29(4) of the Act, and the fees payable in relation to a dog having been destroyed at the request of its owner are specified in the First Schedule attached hereto.

6. The Pound or Pounds maintained by Council for the detention of dogs seized shall be attended by an Authorized Person at such times and on such days as determined from time to time by Council.

7. A person liable for the control of a dog, as defined in Section 3(1) of the Act, is not excused from liability under the provisions of the Act, Regulations or these By-laws by virtue of the payment of fees or charges prescribed therein for the seizure, care, detention or destruction of a dog.

8. Any person applying for the release of a dog seized or impounded shall prove to the satisfaction of an authorized person the ownership of the dog and his authority to take delivery of it. An authorised person may accept such proof as he considers satisfactory and no person shall have any right of action against him or Council in respect of delivery of a dog in good faith.

## Part III—Exercise Areas

9. The land specified in the Second Schedule to these By-laws are designated as Dog Exercise Areas for the purposes of the Act. The exercising of dogs in dog exercise areas are subject to the provisions of the Act.

## Part IV—Restricted Areas

## 10. Except for a dog:

(a) being used for guiding a blind person;

(b) being trained for the purposes of becoming a guide dog for the blind;  
or

(c) being used in accordance with Section 8(3) of the Act whereby the Minister has authorized a person to be accompanied by a specified dog,

a person liable for the control of a dog, as defined in Section 31(1) of the Act, shall prevent that dog from entering or being in any of the following places:

(d) any public building;

- (e) any shop not being a shop where dogs are sold or treated for illness or injury.
- (f) Coastal Beach Areas—excluding that area of public beach bounded by the Southern boundary of the City of Geraldton and the Western boundary of Glendinning Road Reserve and the south western prolongation of the Southern boundary of the public walkway adjacent to Pinner Place Road Reserve to the low water mark of the Indian Ocean.

#### Part V—Keeping of Dogs

11. The owner or occupier of premises within the district on which a dog is ordinarily kept shall ensure that the means exist on the premises for effectively confining the dog within the premises.
12. The owner or occupier of any premises within the district shall not, unless the premises have been granted exemption under Section 26(3) of the Act, keep, permit or suffer to remain thereon more than two dogs over the age of three months, unless such premises are licensed as an approved kennel establishment.
13. An application for a licence to keep an approved kennel establishment shall be in the form of the Third Schedule and shall be accompanied by two copies of a plan showing the details and specifications of all kennels and yards appurtenant thereto and showing the distances from the said kennels to the boundaries of the land the subject of the application and all buildings on the said land together with such other information as the Council may require.
14. A person seeking the issue of a licence to keep an approved kennel establishment shall, unless the Council decides otherwise, give notice of the proposed use of the land in writing to the owners and occupiers of all adjoining land and premises at least 14 days before application is made to the Council.
15. A licence to keep an approved kennel establishment shall be in the form of the Fourth Schedule.
16. The fees payable for the issue of a licence to keep an approved kennel establishment and for the renewal of such licence are specified in the First Schedule.
17. A licence to keep an approved kennel establishment shall remain valid for a period of twelve (12) months from the date of issue thereof.
18. A person seeking the renewal of a licence to keep an approved kennel establishment shall make application to the Council in the form of the Third Schedule.
19. The occupier of premises licensed as an approved kennel establishment shall ensure that the dogs in that establishment are kept in kennels and yards appropriate to the breed or kind in question and in accordance with the following requirements:
  - (a) each kennel shall have a yard appurtenant thereto which is capable of retaining the dog within its confines;
  - (b) each kennel and each yard and every part thereof shall be at a distance of not less than 18 metres from any boundary road or street of the land the subject of the licence;
  - (c) each kennel and each yard and every part thereof shall be at a distance of not less than 15 metres from any dwelling, church, school room, hall, factory, dairy or any premises wherein food is manufactured, prepared, packed or stored for human consumption.
  - (d) the walls of each kennel shall be constructed of concrete, brick, stone or timber framing sheathed with fibre cement sheeting or galvanized iron internally and externally;
  - (e) the roof of each kennel shall be constructed of impervious material;
  - (f) the lowest internal height of the kennel shall be at least two metres from the floor;
  - (g) all painted external surfaces of the kennel shall be kept in good condition and well painted;
  - (h) all gates shall be provided and fitted with proper catches or means of a secure fastening;
  - (i) each yard for a kennel shall be securely fenced with a fence not less than two metres in height constructed of material approved by the Council;
  - (j) the upper surface of a kennel floor shall be at least 10cms above the surface of the surrounding ground and shall be constructed of granolithic cement finished to a surface having a fall of not less than 1 in 100 to a drain which shall be properly laid, ventilated and trapped in accordance with the health requirements of the Council;

- (k) all floor washings shall pass through the drain and shall be disposed of in accordance with the health requirements of the Council;
  - (l) the floor area of each kennel shall be an area of not less than 2.5 square metres for every dog kept therein over the age of three months;
  - (m) the yard of any kennel or group of kennels shall not be less than twice the area of the kennel or group of kennels;
  - (n) all kennels and yards and all feeding and drinking vessels shall be maintained in a clean disinfected and sanitary condition and shall be cleansed and disinfected when so ordered by an authorized person or health surveyor;
  - (o) every approved kennel establishment shall be provided with reticulated water in the form of a supported stand pipe and hose for the hosing down of the kennels and yards.
20. The holder of a licence to keep an approved kennel establishment shall:
- (a) maintain the establishment in a clean, sanitary and tidy condition;
  - (b) dispose of all refuse, faeces and food waste daily in a manner approved by the Council;
  - (c) take all practical measures for the destruction of fleas, flies and other vermin.

#### Part VI—General

21. Any person who contravenes or fails to comply with any provision of these By-laws commits an offence and shall upon conviction be liable to a penalty not exceeding \$200.

22. The offences described in the Fifth Schedule are prescribed pursuant to Section 45A(2) of the Act as offences in relation to which a modified penalty applies and the amount appearing directly opposite each such offence is the prescribed modified penalty payable in respect of that offence.

23. (1) Where an authorized person has reason to believe that a person has committed an offence against these By-laws as prescribed in By-law 22, he may serve on that person an infringement notice and the infringement notices issued under these By-laws shall be in the form depicted in Form 7 of the First Schedule of the Regulations.

(2) An infringement notice may be served on an alleged offender personally or by posting it to his address as ascertained from him, at the time of or immediately following the occurrence giving rise to the allegation of the offence, or as recorded by Council pursuant to the Act.

(3) Where a person who receives an infringement notice fails to pay the prescribed penalty within the time specified in the notice, or within such further time as may in any particular case be allowed, he is deemed to have declined to have the allegation dealt with by way of a modified penalty.

(4) An alleged offender on whom an infringement notice has been served may, within the time specified in that notice or such further time as may in any particular case be allowed, send or deliver to the Council the amount of the prescribed penalty, with or without a reply as to the circumstances giving rise to the allegation, and the Council may thereupon:

- (a) appropriate that amount in satisfaction of the penalty and issue an acknowledgement; or
- (b) withdraw the infringement notice and refund the amount so paid.

(5) An infringement notice may, whether or not the prescribed penalty has been paid, be withdrawn by the Council by sending a notice in the prescribed form to the alleged offender at the address specified in the notice or his last known place of residence or business.

(6) The prescribed form of Withdrawal of Infringement Notice issued under these By-laws shall be in the form depicted in Form 8 of the First Schedule of the Regulations.






2. These regulations shall come into operation on 1 January 1992.

**Regulation 1307 inserted**

3. After regulation 1306 of the *Road Traffic Code 1975\** the following regulation is inserted —

**Bicycle helmets to be worn**

“ 1307. (1) In this regulation —

“appointed day” means 1 July 1992;

“protective helmet” means a helmet that is, or is of a standard or type that is, approved by the Board, for the purposes of this regulation, by notice in the *Government Gazette*.

(2) Except as provided in this regulation, a person shall not, on or after the appointed day, ride a bicycle on a road or a dual use path unless —

- (a) that person is wearing a protective helmet securely fastened on his or her head; and
- (b) where any other person is being carried on that bicycle, that other person is wearing a protective helmet securely fastened on his or her head.

(3) Subregulation (2) does not apply to a person who —

- (a) is a member of a religious or cultural group and who is wearing a headdress customarily worn by members of that group if the wearing of that headdress makes it impractical for a person to wear a protective helmet; or
- (b) has been exempted in writing by the Board from wearing a protective helmet for medical reasons, and is complying with any terms and conditions of that exemption.

(4) The Board may at any time, by notice in writing to the person, amend or revoke an exemption granted under subregulation (3) (b).

(5) Subregulation (2) does not apply to an employee of the Australian Postal Corporation who, in the course of his or her employment, is riding a bicycle while engaged in the delivery of postal articles; but this exception ceases on 31/12/93.

(6) Subregulation (2) does not apply to a person who is riding or being carried on a bicycle which has been hired from a person who is *bona fide* engaged in the business of hiring out bicycles for reward; but this exception ceases on 31/12/92.
