

By-Laws Relating to Crossing Places

In pursuance of the powers conferred upon it by the abovementioned Act and of all other powers enabling it, the Council of the abovementioned Municipality hereby records having resolved on the 7th day of October 1991 to make and submit for confirmation by the Governor the following by-laws:—

1. General By-Law 91 published in the *Government Gazette* 5 July 1918 is hereby repealed.

2. In these by-laws unless the context otherwise requires the following terms shall have the meanings set against them hereunder:—

"Act" means the Local Government Act 1960 (as amended) and, except as otherwise in this by-law provided, words and expressions have the same meanings as they have in the Act;

"carriageway" means a portion of a road that is proved, designed or ordinarily used for vehicular traffic, and includes the shoulders, and areas, including embayments, at the side or centre of road, used for the standing or parking of vehicles; but does not include a lane, right of way or crossing place;

"Council" means the Council of the Municipality of the City of Armadale;

"intersection" includes the area comprised with imaginary straight lines joining in succession the points of transection of the property lines of two or more roads that meet each other; except that where the property lines are curved or truncated at any corner, the point transection of the property lines shall be regarded as the point on curve or truncation nearest to the point at which those property lines, extended in straight lines from each end of the curve, or truncation, would meet;

"property line" means the boundary between the land comprising a street and the land that abuts thereon;

“verge” means and includes that portion of a surveyed road which is between the kerb of the edge of the portion of the road paved for the use of vehicular traffic and the boundary of the surveyed road.

3. All crossings are to be constructed in concrete unless prior written permission of Council has been obtained by the property owner, construction only to be by Council workmen or contractors.
4. The minimum width of a crossing at the property line shall be 3 metres for residential developments and 6 metres for industrial or commercial developments, and the maximum width of a crossing at the edge of the carriageway shall be 6 metres for a residential development and 10.7 metres for an industrial or commercial development.
5. Where necessary, a culvert of reinforced concrete pipes, complete with masonry headwalls, shall be constructed as part of the crossing with the pipe size to be determined by the City Engineer.
6. A standard crossing shall be one that is 3 metres wide at the property line, 5 metres at the edge of the carriageway, and 6 metres in length from the property line to the edge of the carriageway. Construction specifications shall be as determined by Council policy.
7. The crossing place is to be as approved by the City Engineer but no crossing is to be nearer than 500 mm from any side boundary of a lot or nearer than 7 metres from any intersection.
8. All crossings are to be at 90° to the carriageway however, in special circumstances variations of up to 20° may be authorised by the City Engineer.
9. Subject to By-Law 12 hereof, no person shall drive a vehicle over or across a verge to gain access to any property other than at a crossing place constructed in accordance with these By-Laws.
10. At the time of lodging an application for a building licence for the construction of a building on a property, sufficient funds to cover the cost of construction of a crossing place to the property line from the carriageway by Council workmen or contractors are to be lodged with the Council.
11. An application for a building licence relating to the construction of a building shall show on the accompanying site plan the width and location of the crossing place proposed for access to the property.
12. During construction of a building, temporary access to a property by vehicles may be obtained across that part of the verge shown as the proposed crossing place on the application for the building licence.
13. Only two crossing places are permitted per lot.
14. Any crossing constructed with Council authority prior to the coming into operation of these By-Laws shall be deemed to comply with the By-Laws, except that should reconstruction be required or requested, such reconstruction shall comply to these By-Laws.
15. A person who commits an offence against these By-Laws is liable, upon conviction, to a maximum penalty of \$500 with a maximum daily penalty during the breach of \$50 per day.



12. The developer of the estate shall maintain the trees and shrubs planted within the "Tree Planting Area" to the satisfaction of the Council until the land as a whole or in lots is sold. Thereafter the new landowner(s) shall be responsible for the maintenance and the replacement (if and where necessary) of those trees and shrubs planted by the developer to the satisfaction of the Council.
13. Any residence and all other outbuildings shall only be constructed within the building envelopes shown on the proposed subdivisional guide plan.


