CONSERVATION AND LAND MANAGEMENT ACT 1984

Purnululu (Bungle Bungle) National Park

Access to the Park Airstrip-Compatible Operations Notice

Made by the Executive Director of the Department of Conservation and Land Management under section 33A of the Conservation and Land Management Act 1984 with reference to compatible operations.

Reserve number A39897, known as Bungle Bungle, is to be named the Purnululu National Park. The Department of Conservation and Land Management has been approached by the Kimberley travel industry to make the national park's airstrip available for tourist flights.

The Department proposes to call for expressions of interest which may allow two commercial operators to use the park's airstrip on a trial basis for 12 months. Any flights using the airstrip may also allow the visitors to camp overnight in the park.

A final management plan for the national park is in progress but has been substantially delayed. It is therefore intended to seek to allow use of the airstrip under the compatible operations powers of the Conservation and Land Management Act which apply when there is no management plan for operations compatible with the purpose of the park.

Before any expressions of interest are decided upon, the proposal is being publicly notified and public submissions are invited up until 31 March 1992. Details of the proposal may be obtained from—

FINANCE BROKERS CONTROL ACT 1975 Sections 44(1) and (2)

The Finance Brokers Supervisory Board has fixed the following schedule to be the maximum amounts of remuneration for services rendered by persons carrying on the business of a Finance Broker. The Schedule shall apply in the case of contracts made on or after the date of publication of this notice and replaces the schedule published in the Government Gazette on 20 April 1990.

Schedule

1. Application Fee:

(i) For loans up to \$50 000:

\$100 non refundable for each loan. The Application fee is a payment against the eventual Brokerage charge.

(ii) For loans over \$50 000:

Fee establishment by prior mutual agreement in writing between the client and broker.

- 2. Inspection Fees:
 - (i) Initial Inspection:

Up to 30 Kilometres radius-\$85.

Over 30 Kilometres radius-\$85 plus \$85 per hour spent outside the 30 kilometre radius with a maximum of \$200 per half day or part thereof or \$400 per day.

- (ii) Subsequent Inspections:
 - (a) For progress advances for residential properties within 30 kilometres radius \$85 per inspection with a maximum of \$200 per property.
 - (b) For progress advances for residential properties beyond 30 kilometres radius and commercial properties in the course of erection by negotiation with the client.
- 3. Brokerage Fees:
 - (i) Local Money Loans:
 - (a) For loans up to \$100 000-2%.
 - (b) For loans over \$100 000-
 - Fee established by prior mutual agreement in writing between the parties.
 - (ii) Bridging Loans:
 - On loans of 6 months or less \$100 plus 1 per cent.

Over 6 months-normal rates.

(iii) Interstate and Overseas Loans:

Rates subject to prior written agreement between broker and client. If interim Bridging Finance also arranged additional brokerage of 1 per cent to be charged. Subject to loans in excess of \$100 000 being by negotiation between parties.

- (iv) Conditions of Brokerage Charges:
 - (a) Brokerage should NOT be charged by a selling agent where a Contract of Sale or Mortgage to Vendor is arranged. The agent Broker may, however, charge on a time basis for consultations and work done (see miscellaneous charges).
 - (b) Where the selling agent is also the broker a separate written Loan Application is also required before brokerage can be charged.
 - (c) No brokerage or other fees shall be charged by a broker in respect of a Building Society loan expressly for the purpose of financing the purchase of the borrower's principal place of residence.
- 4. Transfer of Mortgage between Investor Clients:
 - Standard scale of fees plus out of pockets, payable by the Transferor.
- Extension of Mortgages: 5. Two-fifths standard brokerage inclusive of any reinspection, but revaluations, solicitors costs, stamp duty and registration should be in addition.

6. Finalisation Fee (discharges):

Flat fee of \$85 to include all services required of a broker, in addition to legal costs, out of pockets, and settlement fees.

- 7. Commission on Interest Collections:
 - (a) Interest Collections only-6% of interest collections inclusive of postages, cheque duty and bank charges.
 - (b) Total Mortgage Management—including interest collection and supervision of mortgagor's compliance with all mortgage clauses—

8% of interest collections, inclusive of postages, cheque duty and bank charges except where the broker is acting as an agent for an insurance company in which case fee of 5% applies.

- 8. Miscellaneous Charges:
 - (a) Production of Title-\$85.
 - (b) Titles Office Searches \$20 plus Titles Office fees.
 - (c) Additional Interest Statements as provided in the Finance Brokers Code of Conduct \$20 for each statement issued.
 - (d) Bank cheques—\$10 including costs.
 - (e) Where no brokerage fees are payable consultations, advice, investigations and negotiations on finance—standard charges of \$100 per hour based on the actual time spent.
 - (f) Disbursements directly and reasonably incurred by the broker in the negotiations relating to a loan or a proposed loan and without limiting the generality of the foregoing would include—search fees, production fees, telephone trunk calls, telex, telegrams, accommodation expenses, postages and courier service and relevant Government charges.

The broker shall at the request of the client produce to the client such evidence of disbursement that the client should reasonably require.

(g) Where a broker is appointed as an Agent for the mortgagee under the terms of mortgage charge to be negotiated with the mortgagee but not to exceed \$100 per hour.

Citation

1. These regulations may be cited as the *Retail Trading Hours Amendment Regulations 1992*.

FISHERIES ACT 1905 ONSLOW PRAWN LIMITED ENTRY FISHERY AMENDMENT NOTICE 1992 Notice No. 529

FD134/75.

Made by the Minister under section 32.

Citation

1. This notice may be cited as the Onslow Prawn Limited Entry Fishery Amendment Notice 1992.

Principal notice

2. In this notice the Onslow Prawn Limited Entry Fishery Notice No. 477^* is referred to as the principal notice.

Clause 2 amended

3. Clause 2 of the principal notice is amended by inserting in the appropriate alphabetical position the following—

" "Nursery" means a part of the fishery as described in schedule 3; ".

Clause 3 amended

4. Clause 3 of the principal notice is amended—

- (a) in subclause (1) by deleting the words "item 1 of the" and inserting after "Schedule" the number "1";
- (b) in subclause (2) by deleting the words "item 2 of the" and inserting after "Schedule" the number "2".

Clause 10 repealed and substituted

5. Clause 10 of the principal notice is repealed and the following clause is substituted—

- 10.(1) A person, other than a person to whom section 32 (5) of the Act applies, shall not take or attempt to take prawns from the fishery at any time, except for those parts of the fishery specified in schedule 4—
 - (a) during the periods and times specified in schedule 4; or
 - (b) at any other time and period specified in writing by the Minister.
 - (2) Notwithstanding subclause 10(1) the Minister may, in writing, open or close any part of the fishery for any specified time or period. ".

Clause 12 repealed and substituted

6. Clause 12 of the principal notice is repealed and the following clause is substituted—

- " 12.(1) Except as otherwise provided in subclause (2) and (3), a boat licensed to operate in the fishery shall have all otter boards stowed on board and trawl nets unshackled from the otter boards and lowered on deck while moving through or anchoring in—
 - (a) an area of the fishery in which the boat is not authorised to operate;
 - or
 - (b) a part of the fishery which is closed to the taking of prawns under clause 10.
 - (2) A boat which is authorised to operate in area 1 of the fishery is permitted to move through or anchor in the Ashburton Nursery provided that the otter boards and trawl nets are securely attached to the boat and kept clear of the water at all times.
 - (3) A boat referred to in subclause (1) may be rigged to commence trawling 24 hours prior to the opening of an area provided that—
 - (a) the boat is not in a nursery which is closed to the taking of prawns;
 - (b) the otter boards and trawl nets are securely attached to the boat and kept clear of the water at all times; and
 - (c) the boat is in an area of the fishery in which it is licensed to operate.
 - (4) Boats licensed to operate in the Fishery are exempted from the provisions of this clause when they are trialling gear in the waters described in schedule 5 provided that—
 - (a) the codend is open when nets are being trialled;
 - (b) no prawns are being held on board the boat; and
 - (c) trials are only being undertaken during the hours of daylight. ".

Clause 14 is amended

- 6. Clause 14 of the principal notice is amended-
 - (a) in subclause (1) by inserting after the paragraph commencing "underdeck tonnage" the following paragraph—
 - "boat units" means the number of units calculated by the formula-

 - (3) With the prior written approval of the Director, a boat other than a boat referred to in subclause (2) may be replaced by a boat provided that the replacement boat does not exceed 375 boat units. ".

3. Area 3 being the waters of the Fishery east of a line commencing at the high water mark of the mainland at Robe Point at the mouth of the northern arm of Robe River drawn northerly to the lighthouse at Beagle Island; thence north westerly to the high water mark at Town Point on Barrow Island; thence along the high water mark of the eastern shore of that island to Cape Dupuy; thence due north.

Schedule 3

1. Ashburton Nursery: All waters between Beadon Point and 114° 52' east longitude, and within 2 nautical miles of the high water mark on the mainland.

2. Coolgra Point West Nursery: All waters bounded by a line commencing at the seaward extremity of the Beadon Creek breakwater and extending to the high water mark on the western extremity of South West Twin Island; thence to the northern most point of South West Twin Island; thence generally north easterly to the high water mark to the westernmost point on North East Twin Island; thence to the high water mark on the eastern most point on North East Twin Island; thence on a bearing of 135° true to a point where it intersects a line bearing 45° true from Coolgra Point; thence on a bearing of 225° true to Coolgra Point and thence along the high water mark to the point of commencement.

Coolgra Point East Nursery: All waters bounded by a line commencing at Coolgra Point and extending on a bearing of 45° true to where it intersects with a line bearing 135° true from the eastern most point of North East Twin Island; thence on a bearing of 315° true to where it intersects with the eastern side of North East Twin Island; thence to the high water mark on the northern most point on Weld Island; thence due south to the mainland and thence along the high water mark to the point of commencement.

4. Fortescue East Nursery: All waters bounded by a line commencing from the high water mark at Cape Preston and extending to the high water mark on the northern most part of Fortescue Island; thence southwesterly to the high water mark on the northern most point of Mardie Island; thence due south to the high water mark on the mainland and then along the high water mark to the point of commencement.

5. Fortescue West Nursery: All waters bounded by a line commencing from the high water mark at Robe Point and extending northwesterly to the light house on Great Sandy Island; thence northeasterly to the high water mark on the northern most point on Passage Island; thence northeasterly to the high water mark on the western most part of Angle Island; thence northerly to the high water mark on the western most part of Long Island; thence northerly to the high water mark on the southern most part of Round Island; thence northeasterly to the high water mark on the southern most part of Sholl Island; thence northeasterly to the high water mark on the northern most part of Fortescue Island; thence southwesterly to the high water mark on the northern most point of Mardie Island; thence due south to the mainland and thence along the high water mark to the point of commencement.

- (ii) The provisions for controlling land use, development and subdivision relating to land within a specific Special Development Zone shall be as laid down in Appendix 3 to the Scheme, and the development plan shall form part of the Scheme.
- (iii) Before making provision for a Special Development Zone, Council will prepare or will require the owner(s) to prepare a submission supporting the creation of the Special Development Zone and such submission shall include—
 - (a) A statement as to the purpose or intent for which the zone is being created.
 - (b) A plan or plans showing contours at such intervals as to adequately depict the land form of the area and physical features such as existing buildings, rock outcrops, vegetation cover, lakes, rivers, creeks and swamps and any other significant features or improvements.

- (c) A development plan in sufficient detail so that Council may determine the possible impact of the development on the environment of the locality within which the development is proposed.
- (d) Information regarding the method whereby the development and subdivision will be provided with services.
- (e) The proposed staging (if any) of the proposed development and subdivision.
- (f) Any other information that Council considers it pertinent having regard to the development proposed.
- (iv) In addition to the development plan the Scheme provisions in Appendix 2 for a specific Special Development Zone may specify—
 - (a) Particular matters that should be addressed before approval to subdivision and/or development is given.
 - (b) Any other special provisions appropriate to secure the objectives of the zone.
- (v) Notwithstanding the provisions of the Scheme any proposed subdivision that may be shown on the development plan referred to in Appendix 2 the Scheme shall not prevent the State Planning Commission from approving minor variations to such proposed subdivision.
- (vi) Notwithstanding anything that may be contained for a specific Special Development Zone in Appendix 2 no person shall commence or carry out development within a Special Development Zone without having applied for and obtained the approval of the Council as required by Clause 5.1 of the Scheme ".
- B. Amending the heading to Appendix 2 of the Scheme Text to read-

" Schedules relating to the additional requirements and modifications to the provisions of the Scheme Text for the specified special residential zones, short stay residential zones and special development zones ".

- C. Excluding Lot 1 of Nelson Location 1216 from the Rural Zone and including it in the Special Development Zone.
- D. Including within Appendix 2 to the Scheme Text the following particulars—

Area No. 2—Warren River Resort (Lot 1 of Nelson Location 1216).

- Special Provisions-
 - (i) The development of Special Development Area No. 2 shall be generally in accordance with "Development Plan No. 2" appended hereto.
 - (ii) The uses permitted within Special Development Zone Area No. 2 are those related to a tourist resort including—

Caravan Park Holiday Chalets Private Recreation Facilities Shop and Office Staff Accommodation

- (iii) The extent of earthworks shall be limited to that required to provide the internal driveways, construction of buildings, provision of caravan park bays, and recreational facilities.
- (iv) Clearing of existing vegetation on the land shall be restricted to only that which is required to accommodate the proposed development and the necessary licenses shall be obtained from the Water Authority and Agriculture Department.
- (v) All internal driveways shall be of gravel construction.
- (vi) A detailed analysis of the drainage requirements of the proposed development shall be carried out in consultation with the Shire Engineer.
- (vii) The developer shall comply with the recommendations of CALM and the Local Bush Fire Brigade control officer in respect of fire control measures.

The owners shall take such steps as are necessary to prevent users of the Resort from straying from the footpaths outside the immediate confines of the development, and particularly in the Warren River foreshore reserve.
- (xii) The developer shall comply with the requirements of the Local Authority in respect of ingress and egress from the site.
- (xiii) The provision of an on-site effluent disposal system to be to the specifications and satisfaction of the Environmental Protection Authority, Health Department and Local Authority.
