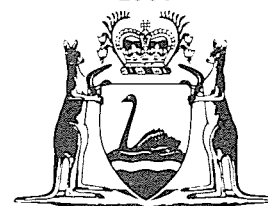

### PRISONS ACT 1981

### PRISONS AMENDMENT REGULATIONS 1992

Made by His Excellency the Governor in Executive Council.

#### Citation

1. These regulations may be cited as the *Prisons Amendment Regulations 1992*.

### Commencement

2. These regulations shall come into operation on the day on which section 6 of the *Prisons Amendment Act (No. 2) 1991* comes into operation.

### Principal regulations

3. In these regulations the *Prisons Regulations 1982\** are referred to as the principal regulations.

### Regulation 26 amended

4. Regulation 26 of the principal regulations is amended —

- (a) by repealing subregulations (1) to (3) and substituting the following subregulations —

“ (1) Where a prison officer has reasonable grounds for suspecting that a prisoner has committed an aggravated prison offence under section 70 (d), (e) or (f) of the Act, the prison officer may take the prisoner to the superintendent, who —

- (a) subject to subregulation (2), may direct an officer to take a sample of the blood, saliva or urine of the prisoner; and  
(b) may request the prison medical officer or a medical officer to assess the prisoner to determine whether he requires medical attention.

(1a) Where a prison officer has reasonable grounds for suspecting that a prisoner has committed an aggravated prison offence under section 70 (f) of the Act, the prison officer may, subject to subregulation (2a), require the prisoner to provide, as directed by the prison officer, a sample of his breath.

(1b) Subject to subregulations (2) and (2a), the superintendent may direct an officer to take —

- (a) samples of the blood, saliva or urine of prisoners at random to detect whether an aggravated prison offence under section 70 (d), (e) or (f) of the Act has been committed by any prisoner; or  
(b) samples of the breath of prisoners at random to detect whether an aggravated prison offence under section 70 (f) of the Act has been committed by any prisoner.

(2) A sample of the blood of a prisoner —

- (a) shall be taken by a prison medical officer, a medical officer or an officer who is registered as a nurse under the *Nurses Act 1968*; and  
(b) shall be taken with a sterile syringe and discharged into a sterile container.

(2a) A sample of the breath of a prisoner shall be taken —

- (a) by means of apparatus of a type approved by the chief executive officer; and
- (b) by an officer who has been authorized by the chief executive officer to use that apparatus.

(3) A prisoner who is required to provide a sample for the purposes of subregulation (1) (b), (1a) or (1b) shall submit himself for the taking of the sample. ”;

- (b) in subregulation (3a) by inserting after “alcohol” the following —  
“ , glue containing toluene ”; and
- (c) in subregulations (4) and (5) by deleting “under this regulation” and substituting the following —  
“ under subregulation (1) (b) or (1b) (a) ”.

#### Regulation 29 repealed and a regulation substituted

5. Regulation 29 of the principal regulations is repealed and the following regulation is substituted —

##### Admissibility of results of breath tests

“ 29. The results of a test of a sample of breath taken from a prisoner under regulation 26 shall be admissible in evidence against the prisoner on a charge of a prison offence. ”.

#### Regulation 85A inserted

6. After regulation 85 of the principal regulations, the following regulation is inserted —

##### Identification system for persons entering specified prisons

- “ 85A. (1) A person shall not be permitted to enter a prison specified in the Table to this regulation unless he is stamped by an officer on a visible part of his skin with an identification mark that is visible under an ultraviolet lamp.
- (2) Subregulation (1) does not apply to —
    - (a) a person who is in possession of a current identification card issued by the Department to that person; or
    - (b) a child under 12 years of age.
  - (3) A person who is admitted to a prison specified in the Table to this regulation may be required to submit to, and satisfy, a system for checking the identification mark applied under subregulation (1) before being permitted to leave the prison, and an officer may have reasonable physical contact with such a person for this purpose.

### EDUCATION ACT 1928

### EDUCATION AMENDMENT REGULATIONS 1992

Made by the Minister for Education.

#### Citation

1. These regulations may be cited as the *Education Amendment Regulations 1992*.

#### Principal regulations

2. In these regulations the *Education Act Regulations 1960\** are referred to as the principal regulations.

#### Regulation 4 amended

3. Regulation 4 of the principal regulations is amended by inserting in the correct alphabetical positions the following definitions —

“ **“approved”** means approved by the chief executive officer;

**“four-year teaching qualification”** means the successful completion of one or more courses comprising an aggregate of 4 years full-time study or part-time equivalent where —

(a) at least one year's study was in teacher education;

and

(b) each course was undertaken at a tertiary institution in Australia or an approved tertiary institution outside Australia;

**“promotion”** means movement from one position to another position that has a salary and conditions of employment that, when viewed as a whole, are, in the opinion of the Minister or the chief executive officer (whichever will effect the promotion), superior to those of the first position; ”.

#### Regulations 169 and 170 repealed and a regulation substituted

4. Regulations 169 and 170 of the principal regulations are repealed and the following regulation is substituted —

##### Eligibility of teacher for appointment by promotion

“ **169.** (1) A teacher applying for appointment by promotion to a position in a primary school shall have —

(a) an approved four-year teaching qualification; and

(b) such other qualifications as may be specified by the Minister or the chief executive officer in the advertisement for the position.

(2) For the purposes of subregulation (1), the Teachers' Higher Certificate awarded by the Minister shall be deemed to be an approved four-year teaching qualification.

(3) Notwithstanding subregulation (1), a teacher who has an approved three-year teaching qualification, and such other qualifications as may be specified by the Minister or the chief executive officer in the advertisement for the position, may be appointed by promotion to a position in a primary school before 1 January 1994.

**Regulation 185 repealed  
and a regulation substituted**

5. Regulation 185 of the principal regulations is repealed and the following regulation is substituted —

**Eligibility of teacher for  
appointment by promotion**

“ 185. (1) A teacher applying for appointment by promotion to a position in a secondary school shall have —

- (a) an approved four-year teaching qualification; and
- (b) such other qualifications as may be specified by the Minister or the chief executive officer in the advertisement for the position.

(2) For the purposes of subregulation (1), the Teachers' Higher Certificate awarded by the Minister shall be deemed to be an approved four-year teaching qualification.

**Regulation 193G inserted**

6. After regulation 193F of the principal regulations the following regulation is inserted —

**Eligibility of teacher for  
appointment by promotion**

“ 193G. (1) A teacher applying for appointment by promotion to a position in a senior college shall have —

- (a) an approved four-year teaching qualification; and
- (b) such other qualifications as may be specified by the Minister or the chief executive officer in the advertisement for the position.

(2) For the purposes of subregulation (1), the Teachers' Higher Certificate awarded by the Minister shall be deemed to be an approved four-year teaching qualification.

**Heading to Part XIA amended**

7. The heading to Part XIA of the principal regulations is amended by deleting “BRANCH”.

**Regulation 262D amended**

8. Regulation 262D (1) of the principal regulations is amended by deleting “branch”.



**Regulation 262E repealed  
and a regulation substituted**

9. Regulation 262E of the principal regulations is repealed and the following regulation is substituted —

**Eligibility of teacher for  
appointment by promotion**

“ **262E.** (1) A teacher applying for appointment by promotion to a position in an education support school shall have —

- (a) an approved four-year teaching qualification; and
- (b) such other qualifications as may be specified by the Minister or the chief executive officer in the advertisement for the position.

(2) For the purposes of subregulation (1), the Teachers' Higher Certificate awarded by the Minister shall be deemed to be an approved four-year teaching qualification. ”

### FISHERIES ACT 1905

### FISHERIES AMENDMENT REGULATIONS (NO. 3) 1992

Made by His Excellency the Governor in Executive Council.

#### Citation

1. These regulations may be cited as the *Fisheries Amendment Regulations (No. 3) 1992*.

#### Regulation 3AB amended

2. Regulation 3AB of the *Fisheries Regulations 1938\** is amended —

(a) by repealing subregulation (3) and substituting the following subregulation —

“ (3) A person who takes any species of fish the names of which are listed in Division 4 of Part B of the Schedule to this regulation over a period during which he has lived on board a boat shall not bring into Western Australian waters or on land any fish in excess of the number or quantity, as the case may be, that is the product of the number or quantity of fish prescribed by this regulation in relation to those species of fish and the number of days in the period during which he has lived on board the boat. ”;

and

(b) in the Schedule to that regulation by —

(i) deleting “*australis*” from the item in Part A commencing with “Bream” and substituting the following —

“ *latus* ”;

- (ii) inserting after the item in Part A commencing with "Skipjack trevally" the following —
- " Snapper, red (*Centroberyx gerrardi*) 20 ”;
- (iii) deleting both items in Part A commencing with "Cod";
- (iv) deleting "Cods (*Serranidae* family) 4" in Division 1 of Part B and substituting the following —
- " Cod —
- (a) (*Serranidae* family) 4
- (b) (*Epinephelus spp.*, in excess of 30 kg weight or of 1 200 mm in length) 0 ”;
- (v) deleting the item commencing with "Snapper, red" in Division 2 of Part B; and
- (vi) deleting "Cephalopods" from the first item in Division 3 of Part B and substituting the following —
- " Cephalopods ”.



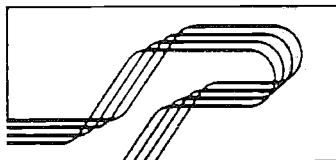
