**FINANCE BROKERS CONTROL ACT 1975
CODE OF CONDUCT AMENDMENT NOTICE 1992**

Pursuant to the provisions of section 81 of the Finance Brokers Control Act 1975, the Finance Brokers Supervisory Board has amended the Code of Conduct for Finance Brokers by adding clause 17 and the schedule following.

17. A broker shall have a knowledge of his duties and in particular a broker shall be aware that his obligation to his client is one which requires him not to put his duty to his client in conflict or in any likelihood of conflict with his own interests or that of any other person.

A broker may sometimes act for both parties to a loan transaction. The test to apply is to consider whether in the interest of one he should withhold some information or advice from the other. If he should, then he should inform both clients that he is compromised.

He shall not continue to act for one party in the same matter if the other party has provided confidential information which he would be obliged to disclose to the selected party to the other parties detriment.

Where a borrower proposes to appoint a broker to act on his behalf in respect to a loan transaction which is to be negotiated by the broker and the broker is also acting on behalf of the lender and is to receive a fee, commission or any other form of financial reward from the lender in connection with the loan transaction then before the appointment required under section 43 is effected, the broker shall give to the borrower a notice in writing in the form of Form 1 in the Schedule to this Code of Conduct stating the name of the lender for whom he acts and that a fee, commission or other form of financial reward may be received from the lender in connection with the particular loan.

Notice amended

2. The notice given under section 134 (53) of the *Health Act 1911* in the *Gazette* of 6 July 1984 at page 2024 is amended by —

- (a) deleting "asbestos waste" in the first place where it occurs and substituting the following —

" material containing asbestos "; and

- (b) deleting "asbestos waste disposal" and substituting the following —

" the disposal of such material ".

HEALTH ACT 1911
HEALTH (ASBESTOS) REGULATIONS 1992

Made by the Lieutenant-Governor, and Deputy of the Governor in Executive Council under sections 134 (53), 199 (21) and 343 (5) of the *Health Act 1911*.

PART 1 — PRELIMINARY

Citation

1. These regulations may be cited as the *Health (Asbestos) Regulations 1992*.

Interpretation

2. In these regulations, unless the contrary intention appears —

“asbestos” means the asbestiform variety of mineral silicates belonging to the serpentine or amphibole groups of rock-forming minerals and includes actinolite, amosite, anthophyllite, chrysotile, crocidolite, tremolite, and any mixture containing 2 or more of those;

“asbestos cement sheet” means a sheet or part of a sheet, whether flat or corrugated, containing asbestos in a cement binder;

“authorized person” means an environmental health officer or a person authorized under regulation 5;

“material containing asbestos” means material in which —

- (a) fibrous material is able to be detected by stereoscopic light microscopy at a magnification of not less than 10 times and not greater than 40 times; and
- (b) the fibrous material is able to be identified as asbestos by polarised light microscopy at a magnification of not greater than 400 times or by a method approved by the Executive Director, Public Health.

Application

3. (1) Subject to subregulation (2) these regulations have effect in all districts.

(2) These regulations do not apply to or in relation to any place that is a mine, petroleum well, or petroleum pipeline to which the *Mining Act 1978*, the *Mines Regulation Act 1946*, the *Coal Mines Regulation Act 1946*, the *Petroleum Act 1967*, the *Petroleum (Submerged Lands) Act 1982* or the *Petroleum Pipelines Act 1969*, applies.

Asbestos declared hazardous

4. Asbestos is declared to be a hazardous substance.

Authorized persons

5. The Executive Director, Public Health may authorize a person in writing to be an authorized person for the purposes of these regulations.

PART 2 — ASBESTOS CEMENT SHEET

Sale or supply of asbestos cement sheet

6. A person who sells or supplies asbestos cement sheet to another commits an offence, except when —

- (a) that person has the prior written approval of the Executive Director, Public Health and does so in accordance with that approval;
- (b) the supply of the asbestos cement sheet to another was for the purpose of having that other person dispose of it in accordance with these regulations;
- (c) the asbestos cement sheet formed part of a fixture on land that was sold or supplied; or
- (d) the asbestos cement sheet formed part of a structure designed to be movable that was sold or supplied without substantially dismantling it.

Use of asbestos cement sheet

7. (1) Subject to subregulation (2), a person who uses any asbestos cement sheet commits an offence, except —

- (a) where the person is maintaining, repairing, removing or disposing of the asbestos cement sheet; or
- (b) when that person has the prior written approval of the Executive Director, Public Health and does so in accordance with that approval.

(2) Subregulation (1) does not apply to the use of asbestos cement sheet where —

- (a) the asbestos cement sheet was in use as part of a structure (which term includes a fence) when these regulations came into operation; and
- (b) the use of the asbestos cement sheet as part of that structure has continued since these regulations came into operation.

(3) A person who stores, breaks, damages, maintains, repairs, removes, moves, or disposes of, or uses any asbestos cement sheet without taking reasonable measures to prevent asbestos fibres entering the atmosphere commits an offence.

(4) For the purposes of subregulation (3), "reasonable measures" includes —

- (a) using water or other practical measures to keep airborne material containing asbestos to a minimum;
- (b) not using any tools other than non-powered hand tools or portable power tools that incorporate dust suppression or dust extraction attachments designed to collect asbestos fibres;
- (c) using only vacuum cleaning equipment designed to collect asbestos fibres or wetting the area before sweeping up material containing asbestos;
- (d) not using compressed air, or a high pressure water jet, when working with material containing asbestos;
- (e) handling asbestos cement sheet in such a manner as to minimise its breakage or abrasion;
- (f) ensuring that waste material containing asbestos is disposed of in accordance with these regulations as soon as practicable.

PART 3 — MATERIAL CONTAINING ASBESTOS

Directions by authorized persons

8. (1) An authorized person may, by a written notice served on —
- (a) the owner of material containing asbestos; or
 - (b) the owner or occupier of premises on which material containing asbestos is present; or
 - (c) a person handling material containing asbestos,

direct that person to maintain, repair, remove, move, dispose of, or handle the material containing asbestos in such manner and within such time as is specified in the direction.

(2) The power conferred by subregulation (1) to direct a person to maintain, repair, remove, move, dispose of, or handle material containing asbestos includes power to direct that person to do any two or more of those things in combination.

(3) A person who is served with a notice under subregulation (1) may, within 28 days of the service of the notice, appeal in writing against the notice to the Executive Director, Public Health who may uphold, revoke, or amend the notice.

(4) A person who fails to comply with a direction in a notice under subregulation (1) commits an offence.

Executive Director may prohibit or restrict use, sale or supply of material containing asbestos

9. (1) The Executive Director, Public Health may, by notice published in a newspaper circulating in the State —
- (a) prohibit; or
 - (b) impose conditions or restrictions on,

the use, sale, or supply of material containing asbestos.

(2) A person aggrieved by a notice made under subregulation (1) may appeal in writing against the notice to the Minister who may uphold, revoke, or amend the notice.

(3) A person who uses, sells, or supplies material containing asbestos in contravention of a notice made under subregulation (1) commits an offence.

PART 4 — DISPOSAL OF MATERIAL CONTAINING ASBESTOS

Disposal of material containing asbestos

10. (1) Material containing asbestos in a district referred to in Schedule 1 shall be disposed of —
- (a) at a place referred to in Schedule 2; or
 - (b) if the material containing asbestos is asbestos cement sheet and the volume of the asbestos cement sheet is not more than a cubic metre — at a place referred to in Schedule 2 or Schedule 3.
- (2) Material containing asbestos in a district other than a district referred to in Schedule 1 shall be disposed of at a place approved in writing as a place for the disposal of material containing asbestos by —
- (a) an environmental health officer appointed by the local authority of the district; or
 - (b) the Executive Director, Public Health.

(3) Except as provided by regulation 11, a person who disposes of material containing asbestos otherwise than in accordance with subregulation (1) or (2) commits an offence.

Executive Director, Public Health may approve alternative place for disposal

11. A person does not commit an offence under regulation 10 (3) if the person has the prior written approval of the Executive Director, Public Health to dispose of material containing asbestos other than in accordance with regulation 10 and does so in accordance with that approval.

Material for disposal to be wrapped in plastic

12. A person shall not take material containing asbestos to a place referred to in Schedule 2 or 3, or to a place approved by the Executive Director, Public Health as a place for the disposal of material containing asbestos, unless the material containing asbestos is wrapped in plastic so as to prevent asbestos fibres entering the atmosphere, or is packaged in such other manner as is approved in writing by the Executive Director, Public Health.

Method of disposal

13. A person who operates or controls a place referred to in Schedule 2 or 3, or a place approved by the Executive Director, Public Health as a place for the disposal of material containing asbestos, shall dispose of material containing asbestos in such manner as is approved in writing by the Executive Director, Public Health.

PART 5 — MISCELLANEOUS

Penalties

15. (1) A person who does not comply with these regulations commits an offence.

(2) A person who commits an offence under these regulations is liable on conviction to —

- (a) a penalty of not more than \$1 000 and not less than —
 - (i) in the case of a first offence, \$100;
 - (ii) in the case of a second offence, \$200; and
 - (iii) in the case of a third or subsequent offence, \$500; and
- (b) if that offence is a continuing offence, a daily penalty of not more than \$100 and not less than \$50.

16. The *Health (Disposal of Asbestos Waste) Regulations 1984* are repealed.

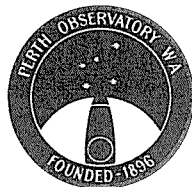

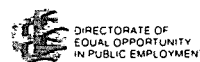
