PETROLEUM ACT 1967 PROCLAMATION

WESTERN AUSTRALIA FRANCIS BURT, Governor. [L.S.] By His Excellency the Honourable Sir Francis
Theodore Page Burt, Companion of the Order of
Australia, Knight Commander of the Most Distinguished Order of Saint Michael and Saint
George, Queen's Counsel, Governor of the State
of Western Australia.

Whereas it is enacted by subsection (2) of section 15 and subsection (2) and (3) of section 152 of the Petroleum Act 1967 that notwithstanding the Land Act 1933 or any other Act the Governor, by proclamation may declare that any land of the Crown or part thereof reserved for or dedicated to any public purpose under any Act and howsoever classified that—

- (a) is not Crown land within the meaning of that expression in section 5 of the Act; and
- (b) is specified in the proclamation, is Crown Land for the purposes of the Petroleum Act 1967 and is land to which that Act applies, so long as the proclamation remains in force.

Now, therefore, I the Governor acting with the advice and consent of the Executive Council and in the exercise of the powers under subsection (2) of section 15 of the Petroleum Act 1967, do hereby declare that the land of the Crown comprising Reserve No. 25581 classified as Class "C" and set apart for the purpose of Public Utility and Reserve No. 23600 classified in Class "C" and set apart for the purpose of Flora pursuant to the provisions of the Land Act 1933 is Crown Land for the purpose of the Petroleum Act 1967 and is land to which the Petroleum Act 1967 applies so long as this proclamation remains in force.

SOIL AND LAND CONSERVATION ACT 1945 SOIL AND LAND CONSERVATION (WEST KIMBERLEY LAND CONSERVATION DISTRICT) ORDER 1992

Made by His Excellency the Governor in Executive Council under Sections 22 and 23 of the Soil and Land Conservation Act 1945 and on the recommendation of the Minister for Agriculture.

Citation

1. This order may be cited as the Soil and Land Conservation (West Kimberley Land Conservation District) Order 1992.

Interpretation

- 2. In this order-
- "appointed member" means a person appointed under clause 5 (1)(b), (c), (d) or (e) to be a member of the committee;
- "committee" means that Land Conservation District Committee for the West Kimberley Land Conservation District;
- "member" means a member of the committee;
- "the district" means the West Kimberley Land Conservation District constituted by clause 3;
- "the producer organisations" means the bodies known respectively as the Western Australian Farmers Federation (Inc.) and the Pastoralists and Graziers Association of Western Australia.

West Kimberley Land Conservation District

3. The land described in the Schedule to this order is hereby constituted the West Kimberley Land Conservation District.

Establishment of the committee

4. Pursuant to Section 23 (2) of the *Soil and Land Conservation Act 1945* there is hereby established for the district a land conservation district committee to be known as the Land Conservation District Committee for the West Kimberley Land Conservation District.

Constitution of the committee

- 5. (1) It is hereby determined, on the recommendation of the Minister, after consultation with the Shire of Derby/West Kimberley, that the committee shall comprise 17 members of whom—
 - (a) one shall be the Commissioner of Soil and Land Conservation or his nominee;
 - (b) one shall be appointed by the Minister on the nomination of the Shire of Derby/West Kimberley;
 - (c) one shall be appointed in accordance with subclause (2);
 - (d) 2 shall be appointed in accordance with subclause (2a);
 - (e) 12 shall be appointed by the Minister being persons actively engaged in, or affected by or associated with, land use in the district
- (2) The Western Australian Farmers Federation (Inc.) shall submit to the Minister a panel containing the names of persons willing to be appointed as members of the committee and, where such a panel is submitted in accordance with this order, one person whose name appears on the panel shall be appointed by the Minister.
- (2a) The Pastoralists and Graziers Association of Western Australia shall submit to the Minister a panel containing the names of persons willing to be appointed as members of the committee and, where such a panel is submitted in accordance with this order, 2 persons whose names appear on the panel shall be appointed by the Minister.
- (3) Subject to this clause, each appointed member shall hold office for such period not exceeding 3 years as is specified in the instrument of his appointment and is eligible for reappointment.
- (4) The Minister may grant leave of absence to an appointed member on such terms and conditions as the Minister determines.
- (5) The Minister may terminate the appointment of an appointed member for inability, inefficiency or misbehaviour.
 - (6) If an appointed member-
 - (a) is or becomes an undischarged bankrupt or person whose property is subject to an order or arrangement under the laws relating to bankruptcy;
 - (b) has his appointment terminated by the Minister, pursuant to subclause (5);
 - (c) is absent, except on leave duly granted by the Minister, from 3 consecutive meetings of the committee of which he has had notice; or
 - (d) resigns his office by written notice addressed to the Minister,

the office of that appointed member becomes vacant.

Proceedings of the committee

- 6. (1) The committee shall hold its meetings at such place on such days and at such intervals as the committee shall from time to time determine.
 - (2) At any meeting of the committee-
 - (a) a majority of the members constitute a quorum;
 - (b) the Chairman shall preside and where he is absent from the meeting the members may appoint one of their number to preside at that meeting;
 - (c) each member present is entitled to a deliberative vote; and
 - (d) where the votes cast on any question are equally divided the Chairman, or the presiding member in terms of paragraph (b), shall have a casting
- (3) The committee shall cause accurate minutes to be kept of the proceedings at its meetings.
- (4) To the extent that it is not prescribed, the committee may determine its own procedure.

Repeal

7. The Soil and Land Conservation (Derby-West Kimberley Soil Conservation District) Order 1984* is repealed.

All that portion of land bounded by lines starting from the intersection of the High Water Mark of King Sound with the prolongation easterly of the northernmost northern boundary of Dampier Location 268 (P/L 3114/1198 -Yeeda) and extending westerly to and westerly, southerly, easterly, again southerly, again easterly, again southerly, again westerly, again southerly and again easterly along boundaries of that location to the northwestern corner of Location 266 (P/L 3114/1194 - Yakka Munga); thence southerly along the western boundary of that location to the northernmost northern boundary of Location 267 (P/L 3114/844 - Dampier Downs); thence westerly, southerly, again westerly, again southerly, easterly, again southerly, again easterly, again southerly and again easterly along boundaries of that location to the westernmost northwestern corner of Location 274 (P/L 3114/1036 - Mowla Bluff); thence southerly and easterly along boundaries of that location and easterly, northerly, again easterly and again northerly along boundaries of Jarmura Location 6 (P/L 3114/1036 - Mowla Bluff) to the southernmost southern boundary of Location 5 (P/L 3114/1165 - Luluigui); thence easterly along that boundary to the western boundary of Location 8 (P/L 3114/571 - Nerrima); thence southerly and easterly along boundaries of that location and easterly along the southern boundary of Location 7 (P/L 3114/757 - Kalyeeda) to the westernmost northwestern corner of Location 9 (P/L 3114/1210 - Millijidee); thence southerly, easterly, again southerly and again easterly along boundaries of that location and easterly along the southern boundary of Yurabi Location 60 (P/L 3114/1210 - Millijidee) to the northwestern corner of Location 77 (P/L 398/817); thence southerly and easterly along boundaries of that location and easterly along the southern boundary of Location 64 (P/L 398/812) to the northwestern corner of Location 65 (P/L 398/813); thence southerly and easterly along boundaries of that location and easterly along the southernmost southern boundary of Location 80 (P/L 3114/1261 - Bulka) to the western boundary of Location 62 (P/L 398/533 - Yougga Walla); thence northerly and easterly along boundaries of that location to the southernmost southwestern corner of Location 66 (P/L 398/800 -Larrawa); thence easterly, northerly, westerly and generally northerly along boundaries of that location and generally northerly and generally westerly along boundaries of Location 50 (P/L 398/808 - Louisa Downs) to the eastern boundary of Location 70 (P/L 3114/1257 - Christmas Creek); thence northerly and westerly along boundaries of that location to an eastern boundary of Location 63 (P/L 3114/1248 - Fossil Downs); thence northerly, westerly, again northerly, easterly, again northerly, again westerly, southerly, again westerly, again northerly, again westerly, again northerly, again westerly, generally southwesterly and generally northwesterly along boundaries of that location to the prolongation southerly of the eastern boundary of Fitzroy Location 30 (P/L 3114/750 - Leopold Downs); thence northerly to and northerly, westerly, again northerly, again westerly, southerly, again westerly and again southerly along boundaries of that location to a northern corner of Location 250 (P/L 3114/750 - Leopold Downs); thence southerly, westerly and generally northwesterly along boundaries of that location to the northernmost eastern boundary of Location 240 (P/L 3114/748 - Fairfield); thence northerly and westerly along boundaries of that location and westerly along the northern boundary of Location 249 (P/L 3114/682 - Napier Downs) and onwards to a northeastern corner of Meda Location 22 (P/L 3114/682 - Napier Downs); thence westerly, northerly, again westerly, again northerly, again westerly, again northerly, again westerly, again northerly and again westerly along boundaries of that location to the northernmost eastern boundary of Location 23 (P/L 3114/594 - Meda); thence northerly, westerly, southerly and again westerly along boundaries of that location and onwards to the High Water Mark of King Sound and thence generally southwesterly and generally northwesterly along that mark to the starting point.

SOIL AND LAND CONSERVATION ACT 1945

SOIL AND LAND CONSERVATION (ORD RIVER IRRIGATION AREA LAND CONSERVATION DISTRICT) ORDER 1992

Made by His Excellency the Governor in Executive Council under Sections 22 and 23 of the *Soil and Land Conservation Act 1945* and on the recommendation of the Minister for Agriculture.

Citation

1. This order may be cited as the Soil and Land Conservation (Ord River Irrigation Area Land Conservation District) Order 1992.

Interpretation

- 2. In this order-
 - "appointed member" means a person appointed under clause 5 (1)(b) and (c) to be a member of the committee;
 - "committee" means that Land Conservation District Committee for the Ord River Irrigation Area Land Conservation District;
 - "member" means a member of the committee;
 - "the district" means the Ord River Irrigation Area Land Conservation District constituted by clause 3;
 - "the producer organisations" means the bodies known respectively as the Western Australian Farmers Federation (Inc.) and the Pastoralists and Graziers Association of Western Australia.

Ord River Irrigation Area Land Conservation District

3. The land described in the Schedule to this order is hereby constituted the Ord River Irrigation Area Land Conservation District.

Establishment of the committee

4. Pursuant to Section 23 (2) of the *Soil and Land Conservation Act 1945* there is hereby established for the district a land conservation district committee to be known as the Land Conservation District Committee for the Ord River Irrigation Area Land Conservation District.

Constitution of the committee

- 5. (1) It is hereby determined, on the recommendation of the Minister, after consultation with the Shire of Wyndham-East Kimberley, that the committee shall comprise 16 members of whom—
 - (a) one shall be the Commissioner of Soil and Land Conservation or his nominee;
 - (b) one shall be appointed by the Minister on the nomination of the Shire of Wyndham-East Kimberley;
 - (c) 14 shall be appointed by the Minister, of whom-
 - (i) 13 shall be persons actively engaged in, or affected by or associated with, land use in the district; and
 - (ii) one shall be a representative of the Water Authority of Western Australia
- (2) Subject to this clause, each appointed member shall hold office for such period not exceeding 3 years as is specified in the instrument of his appointment and is eligible for reappointment.
- (3) The Minister may grant leave of absence to an appointed member on such terms and conditions as the Minister determines.
- (4) The Minister may terminate the appointment of an appointed member for inability, inefficiency or misbehaviour.
 - (5) If an appointed member-
 - (a) is or becomes an undischarged bankrupt or person whose property is subject to an order or arrangement under the laws relating to bankruptcy;
 - (b) has his appointment terminated by the Minister, pursuant to subclause (4):
 - (c) is absent, except on leave duly granted by the Minister, from 3 consecutive meetings of the committee of which he has had notice; or
 - (d) resigns his office by written notice addressed to the Minister,

the office of that appointed member becomes vacant.

Proceedings of the committee

- 6. (1) The committee shall hold its meetings at such place on such days and at such intervals as the committee shall from time to time determine.
 - (2) At any meeting of the committee—
 - (a) a majority of the members constitute a quorum;
 - (b) the Chairman shall preside and where he is absent from the meeting the members may appoint one of their number to preside at that meeting;
 - (c) each member present is entitled to a deliberative vote; and
 - (d) where the votes cast on any question are equally divided the Chairman, or the presiding member in terms of paragraph (b), shall have a casting vote.
- (3) The committee shall cause accurate minutes to be kept of the proceedings at its meetings.
- (4) To the extent that it is not prescribed, the committee may determine its own procedure.

Schedule

(Clause 3).

Ord River Irrigation Area Land Conservation District

All that portion of land bounded by lines starting from the northeastern corner of King Location 373 (Reserve 31165) and extending south along the eastern boundary of that location and Location 374 (Reserve 31165) to South Latitude 16 degrees, 9 minutes, 10 seconds; thence west along that line of latitude to the high water mark of Lake Argyle; thence generally westerly along that mark to the centreline of the Ord River; thence generally northerly downwards along that centreline to the prolongation easterly of the southern boundary of Location 512 (Reserve 35289); thence westerly to and westerly, northerly and northwesterly along boundaries of that location and onwards to the centreline of the Dunham River; thence generally northeasterly downwards along that centreline to the prolongation southerly of an eastern boundary of Location 710 (P/L 3114/640 - Ivanhoe); thence northerly to and generally northerly along boundaries of that location to the southern boundary of Reserve 1062; thence easterly, northerly and westerly along boundaries of that reserve and generally northerly along eastern boundaries of Location 710 to a southern corner of Location 709 (P/L 3114/1176 - Carlton Hill); thence northeasterly and southeasterly along boundaries of that location to a southwestern corner of Location 711 (P/L 3114/640 - Ivanhoe); thence generally southeasterly, generally northeasterly, northerly, easterly, again northerly, again easterly, southerly, southwesterly, again easterly, again southerly, again southwesterly and again southerly along boundaries of that location to the northern boundary of Kununurra Townsite; thence easterly, generally southerly and northwesterly along boundaries of that townsite to the prolongation northerly of the eastern boundary of King Location 438; thence southerly to and southerly and generally westerly along boundaries of that location and westerly along the southern boundaries of Locations 520 and 448 to a northwestern corner of Location 711 (P/L 3114/640 - Ivanhoe); thence southerly along a western boundary of that location to the northern boundary of Location 373 (Reserve 31165) and thence easterly along that boundary to the starting point.

Part X-Offences

Offences and penalties

- 1. (1) A person who is required by a provision of Part IV and Part VII to do anything or refrain from doing anything and who fails to comply with that provision commits an offence and is liable to-
- (a) a fine that is not more than \$2 500 and not less than-
 - (i) in the case of a first offence \$250;
 - (ii) in the case of a second offence, \$500;
 - (iii) in the case of a third or subsequent offence, \$1 250;
- (b) if the offence is a continuing offence, a daily penalty which is not more than \$250 and not less than \$125.
- (2) A person who is required by any provision of these By-laws, other than a provision of Part IV or Part VII, to do anything or refrain from doing anything and who fails to comply with that provision commits an offence and is liable to-
- (a) a fine that is not more than \$1 000 and not less than-
 - (i) in the case of a first offence, \$100;
 - (ii) in the case of a second offence, \$200; and
 - (iii) in the case of a third or subsequent offence \$500;

and

- (b) if the offence is a continuing offence, a daily penalty which is not more than \$100 and not less than \$50.
- 2. Any expense incurred by the Local Authority in consequence of a breach or non observance of these By-laws or in the execution of work directed to be executed by a person and not executed by him shall be paid by the person committing the breach or non observance or failing to execute the work.

4.3 Part VII-Food

By-law 51 is amended by deleting "ten dollars" in Sub-bylaw (2) and inserting "two hundred dollars".
