

FIREBREAKS NOTICE

City of Gosnells

Notice to all Owners and/or Occupiers of land in the Municipality of the City of Gosnells

Pursuant to the powers contained in section 33 of the above Act, you are hereby required on or before 1st day of November 1992 or within fourteen days of the date of your becoming owner or occupier should this be after the 1st day of November, 1992 and thereafter up to and including the 26th day of April, 1993 to have, and maintain a firebreak, clear of inflammable material, at least 3 metres wide immediately inside all external boundaries of each single lot owned or occupied by you and also immediately surrounding all buildings situated on the land.

All land situated within the Western Australian Fire Brigades Board District of 1 012 square metres or less is exempt from the above requirements but Council does retain the right to remove any fire hazard at the owner and/or occupiers expense following failure of an owner and/or occupier to comply with the requisitions of an order in writing to clear a fire hazard or fire break in accordance with section 33 of the Act.

Where land is greater than 1 012 square metres, a three metre fire break is required as per this fire break notice.

If it is considered to be impracticable for any reason to clear firebreaks as required by this notice, you may apply to the Council or its duly authorised officer not later than the 15th October, 1992 for permission to provide firebreaks in alternative positions on that land. If permission is not granted by the Council or its duly authorised officer, you shall comply with the requirements of this notice.

The penalty for failing to comply with this notice is a fine of not more than \$1 000 and a person in default is also liable, whether prosecuted or not, to pay the cost of performing the work directed in this notice if it is not carried out by the owner or occupier by the date required by this notice.

If the requirements of this notice are carried out by burning, such burning must be in accordance with the relevant provisions of the Bush Fires Act.




Example A

**1992/93 FIREBREAK NOTICE**

*Shire of Albany*

Notice to all Owners and/or Occupiers of Land in the Shire of Albany

Pursuant to the powers contained in section 33 of the Bush Fires Act 1954, you are required to have ploughed, scarified, cultivated, burned, chemically sprayed or otherwise cleared and maintained clear of inflammable matter all firebreaks as are required and specified by this notice.

**NORTH EAST SECTOR:** (See plan). A minimum of three (3) metre wide firebreak (\*) to be installed on or by the 15th day of November, 1992 and maintained clear of all inflammable matter to and including the 30th day of March 1993 (or as otherwise gazetted).

**SOUTH & SOUTH WEST SECTOR:** (See plan). A minimum of two (2) metre wide firebreak (\*) to be installed on or by the 15th day of December, 1992 and maintained clear of all inflammable matter to and including the 30th day of March, 1993 (or as otherwise gazetted).

**1 LAND HAVING AN AREA OF 2100 SQUARE METRES (1/2 ACRE) OR LESS:**

A firebreak is not required—however:

- (a) The land will be inspected by a Fire Control Officer appointed by the Shire of Albany and notice may be served if action is deemed necessary to prevent the outbreak or spread of a bushfire on the land;
- (b) Such land is required to be made safe from fire by the reduction of fire hazards;
- (c) Compliance with such requirements need not necessarily require the removal of all ground cover.

**2 ALL OTHER LAND EXCEEDING 2100 SQUARE METRES (1/2 ACRE) IN AREA:**

- (a) Firebreaks shall be constructed as otherwise specified in this notice and:
  - (i) Immediately inside all external boundaries, or within 19.8 metres (1 chain) of those boundaries if so determined by the conditions; whether the land be cleared, partly cleared, bulldozed, chained, used for pasture or undeveloped;
  - (ii) Immediately surrounding all buildings that may be erected thereon.
- (b) Firebreaks shall be constructed as otherwise specified in this notice on all land being under crop during the period 15th November, 1992 to 30th March, 1993 immediately inside the external boundary and around the standing crop so that the crops are broken up into areas not exceeding approximately 200 hectares. Owners and/or occupiers of land in the North Eastern Sector ONLY have the option of providing a 6 metre width of crop cut and raked for hay as a firebreak around the standing crop.
- (c) A suitable operational fire fighting unit comprising a minimum of a 400 litre tank with motorised pump shall be placed inside the boundary of any land where the harvesting of a crop is taking place. Such equipment is to be adjacent to the harvest and in place for the entire period of the harvest.

(\*) Firebreak width is considered to include a vertical plane to a height of five (5) metres, i.e., all scrub must be cut back so as not to overhang a firebreak.

**APPLICATIONS TO VARY THE ABOVE REQUIREMENTS:**

If it is considered to be impractical for any reason whatever to carry out works as required by this notice, you may apply through the Fire Control Officer of your Local Bush Fire Brigade NO LATER THAN 21 DAYS PRIOR to the date by which the firebreaks are required by this notice for permission to provide firebreaks in an alternative position, to take alternative action to abate the fire hazards on the land or to alter or vary this notice in any other way.

**LATE APPLICATIONS WILL NOT BE ACCEPTED:**

Applications for this purpose are available from all Bush Fire Control Officers. It should be noted that residential and minimum equipment level requirements apply where total exemptions from firebreaks are sought for areas in excess of 2ha. Full details are available from the Shire Council or your local Fire Control Officer.

**NOTE:**

Where an unauthorised vessel enters or remains in the safety zone specified in contravention of this instrument, the owner and the person in command or in charge of the vessel are each guilty of an offence against section 119 of the Act and are punishable, upon conviction, by a fine not exceeding \$100 000 or imprisonment for a term not exceeding 10 years, or both, pursuant to section 119 (3) of the Act.

Council is also requested to consider a higher density bonus in selected locations of the Scheme Area in view of the opportunities to maximise the use of commercial, transport, service, and community infrastructure within the Railway Precinct. This would be consistent with the discretion available to the Council via the District Zoning Scheme to permit in the Residential B zone residential development to a maximum density of R60.
- (v) Clause 4.2(c) to be deleted and replaced with the following Clause—  
"Where a proposed traffic control device, entry statement, or other feature as shown on the Scheme Map is located adjacent to a development site and it is required to be installed as part of that development by the Scheme the landowner may be required to fund the full cost of the installation of that work by the Council.  
In this event of the Scheme will re-imburse the landowner for any contribution made in excess of the amount that represents the Scheme Works contribution pursuant to Clause 6 of the Scheme."
- (vi) A Clause to be inserted that ensures that the landowner or developer receives the reimbursement (with interest) within a reasonable period of time.
- (vii) The need to include a provision that details the procedures to be followed by the Council to amend the "Residential Development Guide—Gosnells" is questionable, given that the Guide does not form part of the Scheme. The procedures to amend the Guide could be included by reference in the Guide itself. Council should therefore consider deleting Clause 4.3.

## 5. Development and Scheme Works

- (i) The first paragraph of this Clause to be modified to read as follows—

"An owner of land within the Scheme Area who desires to develop land either alone or in conjunction with another owner or owners shall submit the required application form, details and plans to Council for planning approval as required by the City of Gosnells District Zoning Scheme. Where the application, details and plans conform with the requirements of the District Zoning Scheme the application will be processed in the normal manner subject to the payment of the contribution for Scheme Works under the Scheme."

- (ii) Council to nominate the "services" referred to in "(a)" of Clause 5.
- (iii) Modify "(c)" of Clause 5 to include the words "and landscaping" between the words "construction" and "of compensating basins".
- (iv) Clause 5 "(d)—cost of establishing recreation facilities ... and provision of recreation equipment and buildings" and "(e)—planting of street trees and trees in recreation areas ...", to be deleted.

Council is advised that it is not at this time, legally possible under the Town Planning and Development Act to require developers of residential units to contribute towards the upgrading of existing recreation facilities or the provision of recreation equipment and buildings. The Department of Planning and Urban Development is presently examining a consultants report on the need for contributions for public open space and community facilities and which provides recommendations on the contribution mechanism and guidelines that could be applied.

- (v) Modify "(f)" of Clause 5 by deleting reference to "dual use paths". Dual use paths shall be identified on the Scheme Map.
- (vi) Clause 5 "(g)—a contribution to underground power" to be deleted.

Council is advised that this contribution has not been adequately justified as it does not appear essential or necessary for the orderly development of the Scheme Area and would appear to be contrary to paragraph two of Clause 5 which states that Scheme Works are not related to a particular piece of land (in this instance the contribution is according to the Scheme Report required for "the undergrounding of power in selected sites (not nominated) within the Scheme").

## 6. Scheme Costs

- (i) The heading of this Clause to read Scheme Works Costs.
- (ii) Delete Clause 6.1 as this Clause is ambiguous and the intent can be covered by modification to Clauses 6.2 and 6.3 (refer below) and by the inclusion of "(a) and (b)" of Clause 6.1 as Scheme Works under Clause 5.
- (iii) Clause 6.2 to become Clause 6.1 and shall be modified to read as follows—

## Calculation of Scheme Works Costs

"The costs of Scheme Works as described in Clause 5 to be paid by each owner of land within the Scheme Area shall be calculated at the time of issue of the building licence and shall be calculated at the time of total payment or revised at the time of *pro rata* payments and shall be the lesser of—

- (a) the actual costs of the works compounded annually at 10% as an inflationary factor.
- (b) the estimated costs of the works at the time of full or part payment determined by an independent expert and in default of agreement, by arbitration."

The wording of (a) and (b) above is in accordance with the wording used in other recently gazetted City of Gosnells Guided Development Schemes.

## Payment of Scheme Works Costs

"Subject to the provision of the Scheme each owner of land shall prior to the issue of the building licence pay to the Council an amount equivalent to 0.1% of the total Scheme Works Costs for each residential unit approved by that building licence. Payment of the Scheme Works Costs are not applicable for existing habitable dwellings."

Council is also requested to clarify whether it is the intent of the Scheme that landowners proposing development other than residential units be required to make a contribution for Scheme Works particularly as these landowners may receive the benefits of the Scheme Works.

- (iv) Add as Clause 6.2 the following—

"If an owner of land disagrees with Council's determination of the proportion of Scheme Works Costs that is required to be paid by that owner the matter may be determined by arbitration in the manner specified in Clause "X" (number to be inserted) provided that the owner notifies the Council of the intention to take the matter to arbitration within 30 days of receiving notice of his costs."

## 7. Scheme Account

- (i) The first sentence of this Clause shall be modified to read as follows—

“The Council shall establish a Scheme Account for the purpose of receiving contributions towards Scheme Works Costs as required to be paid to the Scheme by landowners within the Scheme Area.”

## 8. Powers of Council

- (i) The first sentence of this Clause to read as follows—

“In carrying out the provisions of the Scheme the Council shall have the following powers and authorities subject to the arbitration provisions of Clause (number to be inserted).

9. Add additional Clauses headed “Arbitration” and “Land Owned or Acquired by the Council” and which shall address the matters referred to under similar Clauses to be found in the City of Gosnells Town Planning Scheme No. 17.


