RETAIL TRADING HOURS ACT 1987**RETAIL TRADING HOURS EXEMPTION ORDER (No. 15) 1992**

Made by the Minister for Consumer Affairs under section 5.

Citation

1. This order may be cited as the *Retail Trading Hours Exemption Order (No. 15) 1992*.

Commencement

2. This order shall come into operation on 17 August 1992.

Exemption

3. (1) A person who operates a filling station in the metropolitan area may sell, or allow to be sold—

(a) fuel;

(b) requisites; or

(c) goods prescribed under section 14 (5) (b) of the Act,

at that filling station, and keep that filling station open, during such hours as the operator thinks fit, other than—

(d) between the hours of 7 am and 10 pm on any Sunday; or

(e) on Anzac Day, Good Friday and Christmas Day,

and to that extent the *Retail Trading Hours Act 1987*, does not apply to filling stations in the metropolitan area.

(2) During the times set out in subclause (1) (d) and (e), filling stations in the metropolitan area shall be subject to such orders in relation to opening hours as are made by the Minister from time to time, under section 14 (8) of the Act.

RETAIL TRADING HOURS ACT 1987**PETROL ROSTER ORDER (No. 3) 1992**

Made by the Minister for Consumer Affairs.

Citation

1. This Order may be cited as the *Petrol Roster Order (No. 3) 1992*.

Commencement

2. This Order shall come into operation on 17 August 1992.

Petrol Roster

3. Shopkeepers of zoned filling stations specified in the Schedule shall be open during the days and times respectively specified in that Schedule for the sale of fuel and requisites.

Fuel and Requisites to be sold

4. All forms of fuel and the following requisites, namely:—

(a) oil;

(b) lubricants;

(c) tyres;

(d) batteries;

(e) distilled water; and

(f) such other requisites as the shopkeeper has in stock at the filling station

shall be sold by shopkeepers of the zoned filling stations specified in the Schedule during the days and times specified.

ABALONE LIMITED ENTRY FISHERY NOTICE 1992

Notice No. 542

Made by the Minister under section 32.

Citation

1. This Notice may be cited as the *Abalone Limited Entry Fishery Notice 1992*.

Interpretation

2. In this Notice unless the contrary intention appears—

“abalone” means all species of gastropod mollusc of the genus *Haliotis*;

“approved form” means in a form approved by the Director;

“Brownlip abalone” means the species of abalone *Haliotis conicopora*;

“Fishery” means the Abalone Limited Entry Fishery declared under clause 3;

“form ALEF 2” means the reporting form supplied by the Fisheries Department;

“Greenlip abalone” means the species of abalone *Haliotis laevigata*;

“meat weight” means the drained weight of the adductor muscle or foot of the abalone;

“nominated diver” means either the licensee or another person nominated by the licensee in accordance with clause 10 to operate the licence;

“quota” means the maximum weight of each species of abalone authorised to be taken by a person authorised to operate in the Fishery or by a specified group of such persons in accordance with clause 14;

“Roe’s abalone” means the species of abalone *Haliotis roei*;

“shell size” means the length of an abalone measured from edge to edge across the longest diameter of its shell;

“shuck” means to remove the adductor muscle or foot of the abalone from the shell;

“transfer” means the passing of ownership or effective control of the licence from one person to another person;

“whole weight” means the weight of a whole abalone in its shell;

“Zone 1” means the area of water described in Item 1 of Schedule 1;

“Zone 2” means the area of water described in Item 2 of Schedule 1;

“Zone 3” means the area of water described in Item 3 of Schedule 1.

Declaration of Limited Entry Fishery

3. (1) It is hereby declared that the taking of any species of abalone from all waters of the Southern Ocean, the Indian Ocean and the Timor Sea shall constitute a limited entry fishery to be called the Abalone Limited Entry Fishery.

(2) The Fishery shall be divided into three zones as described in Items 1, 2 and 3 of Schedule 1.

Prohibition on taking abalone

4. A person, other than a person to whom section 32 (5) of the Act applies, shall not take, or attempt to take, abalone in the Fishery unless that person is authorised by a licence issued in accordance with this notice.

Prohibition on selling or dealing

5. A person shall not sell or deal in, or attempt to sell or deal in, abalone in contravention of this notice.

Criteria for entry

6. The criterion that shall be applied to determine the person who may hold a licence to engage in the Fishery is that immediately before the coming into operation of this notice the person was the holder of a licence authorising that person to take abalone in the Abalone Fishery as declared by a notice published in the *Government Gazette* of 17 September, 1976.

Application for a licence

7. A person who fulfils the criterion in clause 6 may apply in accordance with clause 22 for a licence to engage in the Fishery.

Details on licence

8. A licence shall contain the following details—

- (a) The name and address of the licensee;
- (b) the name and address of the nominated diver;
- (c) the name and licensed fishing boat number of the boat, or boats, if any, which are authorised to be used in the Fishery;
- (d) the licence number;
- (e) the date of issue;
- (f) the period for which the licence is valid;
- (g) the quota of each species of abalone authorised to be taken;
- (h) the zone in which the nominated diver is authorised to operate; and
- (i) any conditions imposed on the licence.

Publication of details

9. The Director may from time to time give notice of—

- (a) the names of licensees;
- (b) the names of nominated divers;
- (c) the names and registration numbers of boats endorsed on the licences; and
- (d) the zone to which each licence relates,

by publishing that information in such a manner as deemed appropriate.

Nominated divers

10. (1) A licensee may nominate another person as the person authorised to operate the licence.

(2) A nomination made under subclause (1) shall be in writing to the Director on the approved form.

(3) The approved nominated diver shall be endorsed on the licence.

(4) A nominated diver shall not be replaced by another person unless authorised in writing by the Director.

(5) If the licensee does not nominate another person as the nominated diver then the licensee shall be deemed to be the nominated diver and the licence shall be endorsed accordingly.

(6) Only the person endorsed on the licence as the nominated diver may operate the licence.

Authorised means of operating in the fishery

11. A person authorised to operate in the Fishery may take abalone using diving apparatus dependent on the use of compressed air.

Restrictions on taking abalone—species

12. (1) A person authorised to operate in Zone 1 shall not take Greenlip abalone, Brownlip abalone or Roe's abalone from any area other than the area described in Item 1 of Schedule 1.

(2) Subject to subclause 17 (4), a person authorised to operate in Zone 2 shall not take—

- (a) Greenlip abalone or Brownlip abalone from any area other than the area described in Item 2 of Schedule 1; or
- (b) Roe's abalone from any area other than the area described in Item 4 of Schedule 1.

(3) Subject to clause 16, a person authorised to operate in Zone 3 may take Roe's abalone from all waters of the Fishery but shall not take any Greenlip abalone or Brownlip abalone.

Restrictions on taking abalone—sizes

13. (1) A person authorised to operate in Zone 1 shall not, when operating in the area described in Item 5 of Schedule 1, take, transport aboard any boat or land ashore any Greenlip abalone or Brownlip abalone of a meat weight less than 125 grams.

(2) A person authorised to operate in Zone 2 shall not, except when operating in the area described in Item 6 of Schedule 1, take, transport aboard any boat or land ashore any Greenlip abalone or Brownlip abalone of a shell size less than 145 millimetres.

(3) A person authorised to operate in Zone 3 shall not, when operating in the area described in Item 7 of Schedule 1, take, transport aboard any boat or land ashore any Roe's abalone of a shell size less than 70 millimetres.

Restrictions on taking abalone—quotas

14. (1) Unless otherwise approved by the Minister—

(a) a person authorised to operate in Zone 1 shall not, when operating in the area described in Item 5 of Schedule 1, take more than—

(i) 5,000 kilograms meat weight of Greenlip abalone in any year;

(ii) a combined total of 6,000 kilograms meat weight of Greenlip and Brownlip abalone in any year; or

(iii) 1,000 kilograms whole weight of Roe's abalone in any year;

(b) a person authorised to operate in Zone 2 shall not take more than a combined total of 5,000 kilograms meat weight of Greenlip and Brownlip abalone in any year; and

(c) a person authorised to operate in Zone 3 shall not—

(i) when operating in the area described in Item 3 of Schedule 1, continue to take Roe's abalone when the total catch of Roe's abalone taken from those waters by persons authorised to operate in Zone 3 has reached 75,000 kilograms whole weight in any year;

(ii) when endorsed to operate in the area described in Item 4 of Schedule 1, continue to take Roe's abalone when the total catch of Roe's abalone taken from those waters by persons authorised to operate in Zone 3 has reached 12,000 kilograms whole weight in any year;

(iii) when endorsed to operate in the area described in Item 5 of Schedule 1, continue to take Roe's abalone when the total catch of Roe's abalone taken from those waters by persons authorised to operate in Zone 3 has reached 12,000 kilograms whole weight in any year;

(iv) take more than 9,000 kilograms whole weight of Roe's abalone from the waters of the Fishery in any year; and

(v) when operating in the area described in Item 7 of Schedule 1, take or bring ashore more than 100 kilograms whole weight of Roe's abalone on any one day.

(2) For the purpose of subclauses—

(a) 14 (1) (a) "year" means the period commencing on 1 March each year and ending on the last day of February next following;

(b) 14 (1) (b) "year" means the period commencing on 1 May and ending 30 April next following; and

(c) 14 (1) (c) (i), (ii), (iii), and (iv) "year" means the period commencing on 1 October each year and ending on 30 September next following.

Restrictions on taking abalone—general

15. (1) A person authorised to operate in Zone 1 shall retain both the meat and the shell of all abalone taken until the meat is consigned to a processing establishment specified in Schedule 2.

(2) A person authorised to operate in Zone 2—

(a) shall not shuck any Greenlip or Brownlip abalone within 30 minutes of landing the abalone ashore;

(b) shall retain both the shell and the shucked meat of all abalone taken until the meat is consigned to a processing establishment specified in Schedule 2; and

(c) shall not hold or transport any shucked Greenlip or Brownlip abalone on board any boat whilst at sea.

- (3) A person authorised to operate in Zone 3—
- (a) shall not shuck Roe's abalone taken from the area described in Item 7 of Schedule 1;
 - (b) shall, when operating in an area other than that described in Item 7 of Schedule 1, retain both the shell and the shucked meat of all abalone taken until the meat is consigned to a processing establishment specified in Schedule 2;
 - (c) shall not, when operating in the area described in Item 8 of Schedule 1, stand or remain on any reef top while taking or attempting to take any abalone; and
 - (d) shall not, when operating in the area described in Item 8 of Schedule 1, take or attempt to take abalone other than from a licensed fishing boat authorised to be used in Zone 3 of the Fishery.

Zone 3 authorisation endorsements

16. (1) A person authorised to operate in Zone 3—
- (a) shall not take any abalone from the areas described in Items 1 and 4 of Schedule 1, other than in accordance with a licence endorsement specifying—
 - (i) the area from which the abalone may be taken; and
 - (ii) the period during which abalone may be taken.
 - (b) shall carry the licence endorsement referred to in subclause (1) (a) at all times when operating in the area described in Items 1 and 4 of Schedule 1, and shall produce such endorsements to an Inspector of Fisheries on demand.
- (2) The issue of a licence endorsement referred to in subclause (1) (a) automatically cancels any previous licence endorsement issued under that subclause.

Closures within the fishery

17. (1) The Minister may at any time declare in writing the times and dates during which abalone shall not be taken from any part of the Fishery.
- (2) Where any part of the Fishery is closed by the Minister a person authorised to operate in the Fishery shall not take, or attempt to take, any abalone in that part of the Fishery during the period of closure.
- (3) Notwithstanding subclause (2), the Minister may authorise a person to take abalone from any specified waters of the Fishery at any specified time.
- (4) A person authorised to operate in Zone 2 shall not take, or attempt to take, any abalone from the area described in Item 6 of Schedule 1.
- (5) A person authorised to operate in Zone 3 shall not—
- (a) take, or attempt to take, any abalone from the area described in Item 9 of Schedule 1;
 - (b) when operating in the area described in Item 7 of Schedule 1, take, or attempt to take abalone on any Saturday, Sunday or public holiday; or
 - (c) take, or attempt to take, abalone from the area described in Item 7 of Schedule 1, from the first Saturday on, or next following the 19th December in any year, to the first Sunday on, or next following the 12th October in the following year.

Reporting procedures

18. (1) A person authorised to operate in the Fishery shall—
- (a) within 30 minutes of landing abalone ashore complete, in full, the form ALEF 2 in triplicate in Part A and in duplicate in Part C;
 - (b) not depart from the point of landing abalone ashore until the form ALEF 2 has been completed, in full, in accordance with subclause 1 (a);
 - (c) cause the original copy of the completed form ALEF 2 to accompany the abalone from the point of landing to the processing establishment specified on the form; and
 - (d) retain the triplicate copy of each form ALEF 2 in the book in which they are supplied and shall produce such book to an Inspector of Fisheries on demand.
- (2) A person authorised to operate in Zone 1 shall, within 24 hours of landing abalone ashore, forward the duplicate copy of the completed form ALEF 2 to the Esperance office of the Fisheries Department.
- (3) A person authorised to operate in Zone 2 shall, within 24 hours of landing abalone ashore, forward the duplicate copy of the completed form ALEF 2 to the Albany office of the Fisheries Department.

- (4) A person authorised to operate in Zone 3 shall—
- (a) within 24 hours of landing abalone ashore, forward the duplicate copy of the completed form ALEF 2 to the Fremantle office of the Fisheries Department; and
 - (b) prior to completing the form ALEF 2, weigh all abalone brought ashore and record the whole weight on the form.

Disposal of product

19. A person authorised to operate in the Fishery shall not deliver, or cause to be delivered, any abalone for any purpose whatsoever to any person who operates a business in the course of which fish are sold to any other person, unless that business is one of the processing establishments specified in Schedule 2.

Transfer of licence

20. (1) Subject to the prior written approval of the Director, the holder of a licence to operate in the Fishery may transfer that licence to another person.

(2) When a licence is transferred under subclause (1) and the transferor has been subject to a quota in accordance with clause 14, the transferee shall be entitled to take no more than the amount of abalone which the transferor would have been entitled to take for the remainder of the quota year had the transfer not taken place.

Use of boats

21. A person authorised to operate in the Fishery shall not—

- (a) use a boat within the Fishery unless that boat is endorsed on a licence issued in accordance with this notice; or
- (b) use more than one boat at any one time.

Applications and fees

22. Applications under clauses 7 and 20 shall be—

- (a) in the approved form;
- (b) lodged in accordance with the instructions, if any; and
- (c) accompanied by the fee prescribed by regulation.

Revocation

23. The notice made under section 32 relating to the Abalone Fishery published in the *Government Gazette* of 17 September, 1976 is revoked.

BUSH FIRES ACT 1954*Shire of Boyup Brook***FIREBREAK ORDER 1992/93**

Important Information Relating to Your Responsibility
as a Landholder in the Boyup Brook Shire

With reference to Section 33 of the Bush Fires Act 1954, you are required to carry out fire prevention work on land owned or occupied by you in accordance with the provisions of this Order.

This work must be carried out by 30th November, 1992. Unless approved otherwise, and kept maintained throughout the summer months until the 15th April, 1993.

An inspection of firebreaks will be carried out in all areas of the Shire by an Authorised Officer.

Persons who fail to comply with the requirements of this Order may be issued with an Infringement Notice (Penalty \$80) or prosecuted, and additionally, Council may carry out the required work at cost to the Owner or Occupier.

If it is considered for any reason to be impractical to clear firebreaks or remove flammable materials, as required by this notice, or if natural features render firebreaks unnecessary, you may apply to the Council in writing not later than the 1st day of November 1992, for permission to provide firebreaks in alternative positions or to take alternative action to abate fire hazards on the land, if permission is not granted by the Council, you shall comply with the requirements of this notice.

Rural Land

- a. Firebreaks are to be installed within 100 metres of the crop perimeter by 30th November, unless alternative positioning has been approved by using either of the following methods when crops are to be harvested for grain—
 1. A 2.5 metre firebreak inside the crop paddock free of flammable material.
 2. A 2.5 metre firebreak in the adjoining paddock free of flammable material.
 3. Where the crop is to be harvested, a 10 metre closely mown perimeter cleanly raked will be accepted as an alternative to a ploughed firebreak. Council is to be advised of this variation by the 1st November and is to be inspected by the Fire Control Officer for the Brigade by the 15th November.

Persons not intending to harvest crops must notify Council in writing by 30th November.

- b. A 2.5 metre break be installed adjacent to all buildings, homesteads, haysheds and fuel storage areas and that a second break of 2.5 metres in width be installed not less than 20 metres and no more than 100 metres from the initial break and be cleared by 30th November.

Whilst buildings are under construction, all flammable material is to be removed within a 15 metre radius of the construction site. The Chief Fire Control Officer and Fire Control Officer for the area will be notified by Council of building permits granted for that area. This is applicable from the 9th October to the 1st April.

Plantations—Tree Farms

A Plantation—Tree Farm is defined as an area exceeding three (3) hectares within townsites or an area exceeding twenty (20) hectares within rural areas of trees planted for commercial purpose (Subject to separate Firebreak Notice).

1. Boundary Firebreaks

1.1 Firebreaks shall be constructed ten (10) metres wide on the boundaries of all Plantations, Tree Farms, or such other locations as may be agreed to by Council, in accordance with the requirements of Definition—Specification 2.2.

1.2 Firebreaks shall be constructed around Plantation Compartments of approximately fifty (50) hectares, in accordance with the requirements of Definition—Specification 2.3.

2. Definitions—Specifications**2.1 Plantations—Tree Farms**

A Plantation—Tree Farm is defined as an area exceeding three (3) hectares within townsites or an area exceeding twenty (20) hectares within rural areas of trees planted for commercial purpose.

2.2 Boundary Firebreaks—Ten (10) metre requirements

A boundary firebreak is defined as an area ten (10) metres wide cleared of all flammable material and having no overhanging tree branches for a vertical clearance of at least ten (10) metres.

2.3 Planting Compartments

A Planting Compartment is defined as an individual area of approximately fifty (50) hectares surrounded by firebreaks cleared of all flammable material ten (10) metres wide.

Internal firebreaks must be maintained in a trafficable condition and if needed trees on both sides of breaks are to be progressively pruned to allow unrestricted access to maintenance and fire fighting equipment and so as to maintain an effective width of fire break.

3. S.E.C.—Clearance

The S.E.C. have a minimum requirement of ten (10) metres clearance either side of the outside power pole.

As a general rule the clearance distance from the pole should be no less than the expected mature height of the trees planted in the outside row.

However, in all instances where power lines are crossing land where plantations are proposed to be planted the owner should consult the State Energy Commission—Bunbury, Phone (097) 25 5333.

Townsites

On or before the 15th December, 1992, all town lots other than those zoned Rural or Special Rural under the Shire of Boyup Brook Town Planning Scheme No. 1, 4000 sq. metres or less in area and all Fuel Depots within the Shire are required to be cleared of all debris and flammable material. Lots 4000 sq. metres and over not zoned Rural or Special Rural are to have a minimum 2.5 metre firebreak installed around all external boundaries.

Lots zoned Rural or Special Rural under the Shire of Boyup Brook Town Planning Scheme No. 1 must comply to the Rural Land Firebreak Order.

Special Note to Landowners and Occupiers

The Council forwards a copy of this Firebreak Order with rate assessments each year. The Notice is also published in Local Newspapers and *Government Gazette* and additional copies are obtainable at the Shire Council Office Counter.

The requirements of this Order are considered to be the minimum standard of fire prevention work required to protect not only individual properties, but the district generally. In addition to the requirements of this Order, Council may issue separate Special Orders on Owners or Occupiers if hazard removal is considered necessary in some specific areas.



Government offers an enormous range of services to people in our community which enhances their lives.


Departments and agencies do not operate behind closed doors. These organisations are making every effort to be increasingly responsive to the needs of customers and citizens.




