

BUSH FIRES ACT 1954 SUSPENSION OF SECTION 25

It is hereby notified that I, Graham Edwards administering the Bush Fires Act 1954, hereby revoke all previous orders under section 25B of the said Act with relation to the Wagin Rubbish Disposal Site located on Wagin Lots 666, 667, 668 and 669 and pursuant to the powers contained in section 25B of the said Act, approve the suspension of the operations of section 25 that relate to a fire to be lit, or which is lit, for the purpose of destroying garden refuse or rubbish or any like purpose during the declared Prohibited and Restricted Burning Times on land set aside for the purpose in the Municipal District of the Shire of Wagin.

The notice shall have effect until revoked and is issued subject to the following specified conditions.

Specified Conditions

Wagin Rubbish Disposal Site Situated on Wagin Lots 666, 667, 668 and 669.

1. All dumping of rubbish to be confined to the area that Council has provided for that purpose and that a sign be erected and maintained in good condition at the site to inform the public that dumping in any other area is prohibited.
2. A sign warning "Unauthorised Lighting of Fires Prohibited" to be erected and maintained in good condition and be located at the entrance to the site.
3. A wire mesh fence at least 2 metres in height and maintained in good condition for the duration of the suspension is to surround the dump site and all dumping to be confined within the fenced area.
4. That a 3 metre firebreak be installed on the boundary of the rubbish disposal site and maintained free of inflammable material.
5. The accumulated refuse to be lit by Councils refuse contractor or such persons specifically authorised to do so by the Shire Council between the hours of 4pm and midnight of the same day and extinguished by midnight of the same day.
6. That all flammable material save standing trees situated with 20 metres radius of the dump site be removed prior to the first fire being lit.
7. A mobile Fire Fighting Unit consisting of a tank with a minimum of 600 litres of water with 5kw motor 38mm pump and 30 metres of 19mm rubber hose mounted on a vehicle to be left in attendance with not less than two fire fighters to be on site whilst the burn is being carried out and until declared safe.
8. No fire to be lit on land subject to the suspension on a day for which to forecast by the Bureau of Meteorology in Perth in respect of the locality is "Extreme" or "Very High".

RETAIL TRADING HOURS ACT 1987 RETAIL SHOPS ADVISORY COMMITTEE (APPOINTMENT OF MEMBERS AMENDMENT INSTRUMENT) (No. 2) 1993

EDUCATION**ED301****EDUCATION ACT 1928****EDUCATION AMENDMENT REGULATIONS (NO. 3) 1993**

Made by the Minister for Education.

Citation

1. These regulations may be cited as the *Education Amendment Regulations (No. 3) 1993*.

Schedule 2 repealed and a Schedule substituted

2. Schedule 2 to the *Education Act Regulations 1960** is repealed and the following Schedule is substituted —

SCHEDULE 2

[Regulation 222]

FEES — TECHNICAL AND FURTHER EDUCATION**Community adult education — tuition fees for class instruction**

1. Subject to clauses 2 and 3, the tuition fee for class instruction in a course classified as a community adult education course is the amount calculated on the basis of \$4.15 for each hour, or part of each hour, of instruction in the course.

Concession fees for class instruction in community adult education courses

2. Subject to clause 3, the tuition fee for class instruction in a course classified as a community adult education course for —

- (a) a person who holds —
 - (i) a Health Benefit Card;
 - (ii) a Health Care Card;
 - (iii) a Pensioner Health Benefits Card/Travel Card;
 - (iv) a Veterans Health Benefits Card, issued by the Department of Social Security or the Department of Veterans' Affairs of the Commonwealth; or
 - (v) a Rates Concession Card, issued by the Department for Community Development in this State,and a dependant of such a person; and
- (b) a person who holds a Seniors Card, issued by the Office of Senior's Interests in this State,

is the amount calculated on the basis of \$1.55 for each hour, or part of each hour, of instruction in the course but the fee payable by the person is not to exceed \$24.40 for each community adult education course to which the person is admitted.

Tuition fees for class instruction in community adult education courses that have commenced

3. Where a person is admitted to a course classified as a community education course after the course has commenced, the tuition fee for the course is the amount calculated by multiplying the number of hours of instruction remaining in the course by the amount prescribed in clause 1 or 2 as the case may be.

Community adult education — tuition fees for correspondence instruction

4. The tuition fee for correspondence instruction in a course classified as a community adult education course is the amount calculated, without regard to when the person is admitted to the course, on the basis of twice the hourly rate prescribed in clause 1 or 2 as the case may be, for each lesson.

Vocational courses — administration fees

5. (1) Subject to clause 6, the administration fee for admission to a vocational course in which class instruction is given is the amount calculated on the basis of 70 cents for each hour, or part of each hour, of instruction in the course but the fee payable by a person is not to exceed \$238 for each semester in which the person is admitted to a vocational course or courses.

(2) The administration fee for a vocational course in which instruction is given by a method other than traditional class instruction (namely, the open learning program or correspondence instruction) is the same as the fee calculated under subclause (1) for class instruction in the course.

(3) In this regulation and in regulation 6 “**vocational course**” means a course that is not classified as a course for community adult education, small business management, equity and access, customised training, contracted higher education, traineeship or tertiary entrance examinations.

Exemptions from administration fees for vocational courses

6. A person —

(a) who holds —

- (i) a Health Benefit Card;
- (ii) a Health Care Card;
- (iii) a Pensioner Health Benefits Card/Travel Card;
- (iv) a Veterans Health Benefits Card, issued by the Department of Social Security or the Department of Veterans' Affairs of the Commonwealth; or
- (v) a Rates Concession Card, issued by the Department for Community Development in this State,

and a dependant of such a person;

(b) in receipt of a benefit under the AUSTUDY scheme or ABSTUDY scheme described in the *Students Assistance Act 1973* of the Commonwealth, as amended from time to time; or

(c) who was enrolled in a secondary school during 1992 and who was less than 20 years of age on 31 December 1992,

is exempt from paying an administration fee for a vocational course.

Small business management courses — tuition fees

7. The tuition fee for class instruction in a course classified as a small business management course is the amount calculated on the basis of \$4.15 for each hour, or part of each hour, of instruction in the course.

Fees to be rounded to whole dollars

8. Where the calculation under clause 1, 2, 3, 4, 5 or 7 of a fee results in an amount that is not in whole dollars, that amount is to be rounded to the nearest, highest whole dollar and the resulting amount is the fee payable.

Other fees

9. The fee for a matter set out in column 1 of the table to this clause is set out in column 2 opposite the matter.

ENVIRONMENTAL PROTECTION ACT 1986

ENVIRONMENTAL PROTECTION (GOLD EXTRACTION OPERATIONS) EXEMPTION ORDER 1993

Made by the Minister with the approval of His Excellency the Governor in Executive Council under section 6.

Citation

1. This order may be cited as the *Environmental Protection (Gold Extraction Operations) Exemption Order 1993*.

Interpretation

2. In this order, unless the contrary intention appears —

“gold extraction operation” means any operation to extract gold or gold concentrate from ore by means of —

(a) a carbon in leach process;

- (b) a carbon in pulp process;
 - (c) a combination of the process referred to in paragraph (a) and the process referred to in paragraph (b); or
 - (d) a process involving the use of any cyanide solution,
- but does not include any operation which involves the use of micro-organisms;

“heap leach” means a heap of ore stockpiled on a synthetic liner through which a solution is passed and collected to extract metal from the ore;

“mine de-watering discharge” means water, whether from the surface or underground, that is discharged from a mine;

“tailings dam” means a dam or other containment structure used for the long term storage of processing waste slurry following the extraction of metal from ore;

“the regulations” means the *Environmental Protection Regulations 1987*;

“vat leach” means a synthetically lined containment structure in which ore is stockpiled and through which a solution is passed and collected to extract metal from the ore.

Exemption

3. (1) Sections 52 to 64 inclusive of the Act are declared not to apply to premises on which gold extraction operations are carried out, subject to —

- (a) in the case of premises which contain a tailings dam, heap leach or vat leach, the premises satisfying the conditions specified in Schedule 1;
- (b) in the case of premises which have any mine de-watering discharge, the discharge complying with the conditions specified in Schedule 2; and
- (c) in the case of premises that contain grinding and milling works or screening works within the meaning of those terms in the regulations, the premises satisfying the condition specified in Schedule 3.

(2) The exemption in subclause (1) does not apply to premises that are prescribed premises by reason of an activity other than gold extraction operations also being carried out on those premises.

Revocation

4. The *Environmental Protection (Gold Extraction Operations) Exemption Order 1992* is revoked.

SCHEDULE 1

[Clause 3 (1)(a)]

CONDITIONS FOR PREMISES CONTAINING A TAILINGS DAM, HEAP LEACH, OR VAT LEACH

The premises or any part of the premises containing the tailings dam, heap leach, or vat leach must not be located —

- (a) in, or within 2 kilometres of the boundary of, an occupied townsite;
- (b) in, or within 2 kilometres of the boundary of, a national park, marine park, State forest, conservation park, nature reserve or marine nature reserve (as those terms are defined in the *Conservation and Land Management Act 1984*);

- (c) in, or within 1 kilometre of the boundary of, a timber reserve (as that term is defined in the *Conservation and Land Management Act 1984*);
- (d) in, or within 1 kilometre of the boundary of, any land (other than land referred to in paragraphs (b) and (c)) that is reserved under the *Land Act 1933* and vested by order under that Act in the Lands and Forest Commission or the National Parks and Nature Conservation Authority;
- (e) in, or within 2 kilometres of the boundary of, an area that has been recommended for reservation in any of the following publications —
 - (i) “Conservation Reserves for Western Australia as recommended by the Environmental Protection Authority 1975 (systems 4,8,9,10,11,12)”;
 - (ii) “Conservation Reserves for Western Australia as recommended by the Environmental Protection Authority 1976 (systems 1,2,3,5)”;
 - (iii) “Conservation Reserves for Western Australia as recommended by the Environmental Protection Authority 1980 (system 7)”;
 - (iv) “Conservation Reserves for Western Australia as recommended by the Environmental Protection Authority 1983 (system 6)”;
- (f) in —
 - (i) a catchment area or water reserve constituted under the *Country Areas Water Supply Act 1947*, the *Metropolitan Water Supply, Sewerage, and Drainage Act 1909* or any other Act; or
 - (ii) an underground water pollution control area constituted under the *Metropolitan Water Supply, Sewerage, and Drainage Act 1909*;
- (g) within 2 kilometres of any surface waters that are used, whether at that point or at any other point downstream, for human or stock consumption or irrigation of vegetation;
- (h) within 2 kilometres of the ocean or an estuary;
- (i) in an area where the groundwater has a natural salinity level (expressed as total dissolved solids) of less than 15,000 milligrams per litre; or
- (j) in an area of land referred to in the Third Schedule to the *Mining Act 1978*.

SCHEDULE 2

[Clause 3 (1)(b)]

CONDITIONS FOR PREMISES HAVING ANY MINE DE-WATERING DISCHARGE

Mine de-watering discharge from the premises must not—

- (a) enter any permanent or perennial stream, lake, wetland, estuary, or other significant natural surface water body;
- (b) enter, or adversely affect, any waters used for recreational activities;
- (c) enter, or adversely affect, any potable waters used, or capable of being used, for human drinking water supplies;
- (d) where it affects, or is likely to affect, water that is used for watering stock or irrigation purposes, exceed the relevant limits or ranges set out in the Table to this Schedule;
- (e) threaten any significant natural fauna or flora in the environment;
- (f) interfere with any lawful activity conducted by a government agency.

Citation

1. This order may be cited as the *Environmental Protection (Goldfields Residential Areas) (Sulphur Dioxide) Policy Approval Order 1992*.

Approval of environmental protection policy

2. The environmental protection policy set out in the Schedule is approved.

Revocation of approval of earlier environmental protection policy

3. The approval given under section 31 (d) of the Act by the *Environmental Protection (Kalgoorlie-Boulder Control of Sulphur Dioxide in the Air) Order 1988** is revoked.

SCHEDULE**ENVIRONMENTAL PROTECTION ACT 1986****ENVIRONMENTAL PROTECTION (GOLDFIELDS RESIDENTIAL AREAS) (SULPHUR DIOXIDE) POLICY 1992**

APPROVED by the Minister under section 31 (d).

Citation

1. This policy may be cited as the *Environmental Protection (Goldfields Residential Areas) (Sulphur Dioxide) Policy 1992*.

Purpose of policy

2. The purpose of this policy is to provide for ambient air quality limits and an ambient air quality standard for the concentration of sulphur dioxide in the relevant portion of the environment.

Interpretation

3. In this policy —

“**industrial source**” means point or area within industrial premises (whether inside or outside a protected area) from which sulphur dioxide is discharged into the air environment;

“**limit**” means concentration of sulphur dioxide which shall not be exceeded;

“**protected area**” means area described in clause 4 (1) (a) (i), (ii), (iii) or (iv);

“**relevant portion of the environment**” means portion of the environment described in clause 4 (1) (b);

“**standard**” means concentration of sulphur dioxide which it is desirable not to exceed;

“**the Regulations**” means the regulations made under the Act to supplement this policy.

Application**4. (1) This policy applies to —**

(a) the areas delineated on the map set out in Schedule 1, those areas comprising —

- (i) the area delineated on the map of the City of Kalgoorlie-Boulder set out in Schedule 2 and having the shape of a trapezoid, the boundaries of which run from a point 6600000 mN and 349000 mE easterly to a point 6600000 mN and 356000 mE, thence generally southeasterly to a point 6591000 mN and 358000 mE, thence westerly to a point 6591000 mN and 349000 mE and thence northerly to the point 6600000 mN and 349000 mE;
- (ii) the area delineated on the map of the town of Kambalda set out in Schedule 3 and having the shape of a rectangle, the boundaries of which run from a point 6548000 mN and 366000 mE easterly to a point 6548000 mN and 374000 mE, thence southerly to a point 6544000 mN and 374000 mE, thence westerly to a point 6544000 mN and 366000 mE and thence northerly to the point 6548000 mN and 366000 mE;
- (iii) the area delineated on the map of the Town of Coolgardie set out in Schedule 4 and having the shape of a trapezoid, the boundaries of which run from a point 6576000 mN and 323500 mE easterly to a point 6576000 mN and 325000 mE, thence generally southeasterly to a point 6572000 mN and 326000 mE, thence westerly to a point 6572000 mN and 323500 mE and thence northerly to the point 6576000 mN and 323500 mE; and
- (iv) the area delineated on the map of the Kurrawang Aboriginal Reserve (being Reserve No. 23648, Jaurdi Location 23) set out in Schedule 5, and shown on Land Titles Office Diagram 37886;

and

(b) that portion of the environment comprising a layer of air 5 metres thick —

(i) immediately above, and immediately surrounding, the external surfaces of any residential premises situated in;

and

(ii) immediately above the surface of the remainder of, a protected area.

(2) The co-ordinates of the points referred to in subclause (1) (a) (i), (ii) and (iii) are referenced to the Australian Map Grid.

Beneficial use to be protected

5. Any lawful human activity within the relevant portion of the environment which is conducive to the health, welfare, convenience, comfort or amenity of persons within the relevant portion of the environment is declared to be a beneficial use to be protected under this policy.

Air quality objectives

6. (1) The air quality objectives for the concentration of sulphur dioxide in the relevant portion of the environment that are sought to be achieved to provide an acceptable level of protection for the beneficial use identified and declared under clause 5 are the limit and the standard specified in Schedule 6 when averaged over the period specified in that Schedule.

(2) In Schedule 6 —

“ $\mu\text{g}/\text{m}^3$ ” means concentration of sulphur dioxide in micrograms per cubic metre of dry air at 0 degrees Celsius and one atmosphere pressure (101.325 kilopascals).

Ambient air quality limits and ambient air quality standard for sulphur dioxide

7. (1) The ambient air quality limits for the concentration of sulphur dioxide in the relevant portion of the environment that are intended to assist in the achievement of the air quality objectives referred to in clause 6 —

- (a) are the limits specified in the Regulations in respect of successive periods specified therein; and
- (b) shall be complied with in accordance with the Regulations and with conditions to which any relevant licences are subject.

(2) The ambient air quality standard for the concentration of sulphur dioxide in the relevant portion of the environment that is intended to assist in the achievement of the air quality objectives referred to in clause 6 is the standard specified in the Regulations.

Chief Executive Officer may require monitoring

8. (1) If significant industrial sources are located within particular industrial premises, the Chief Executive Officer may, as a condition of a licence referred to in section 62 (1) (e) of the Act, require the occupier of those premises to carry out a specified monitoring programme to monitor the concentration of sulphur dioxide at specified locations in the relevant portion of the environment.

(2) In subclause (1) —

“**significant industrial source**” means industrial source from which the discharge of sulphur dioxide is, in the opinion of the Chief Executive Officer, such as to affect, or to be likely to affect, the relevant portion of the environment;

“**specified**” means specified in the licence concerned.


Review of policy

9. Subject to section 36 of the Act, if concentrations of sulphur dioxide in the relevant portion of the environment exceed the ambient air quality standard referred to in clause 7 (2) in any period of 12 calendar months specified in the Regulations for more than the number of hours so specified in respect of that period, the Authority shall consider that excess and may recommend to the Minister that this policy be reviewed under that section.




MAP SHOWING RESIDENTIAL AREA OF CITY OF KALGOORLIE-BOULDER


MAP SHOWING RESIDENTIAL AREA OF TOWN OF KAMBALDA


MAP SHOWING RESIDENTIAL AREA OF TOWN OF COOLGARDIE

ENVIRONMENTAL PROTECTION (GOLDFIELDS RESIDENTIAL AREAS) (SULPHUR DIOXIDE) REGULATIONS 1992

Made by His Excellency the Governor in Executive Council on the recommendation of the Environmental Protection Authority.

Citation

1. These regulations may be cited as the *Environmental Protection (Goldfields Residential Areas) (Sulphur Dioxide) Regulations 1992*.

Commencement

2. These regulations shall come into operation on the day on which the Policy comes into operation.

Interpretation

3. In these regulations —

- (a) “µg/m³” means concentration of sulphur dioxide in micrograms per cubic metre of dry air at 0 degrees Celsius and one atmosphere pressure (101.325 kilopascals);

“the Policy” means the *Environmental Protection (Goldfields Residential Areas) (Sulphur Dioxide) Policy 1992* approved under the *Environmental Protection (Goldfields Residential Areas) (Sulphur Dioxide) Policy Approval Order 1992* and set out in the Schedule to that Order;

and

- (b) unless the contrary intention appears, other words and expressions have the same respective meanings as they have in the Policy.

**Ambient air quality limits and
ambient air quality standard
for sulphur dioxide**

4. (1) For the purposes of clause 7 (1) (a) of the Policy, the ambient air quality limit for the concentration of sulphur dioxide in the relevant portion of the environment for the period beginning on the commencement of these regulations and ending on 31 December 1993 is 1300 µg/m³ when averaged over a period of 3 hours.

(2) For the purposes of —

- (a) clause 7 (1) (a) of the Policy, the ambient air quality limit for the concentration of sulphur dioxide in the relevant portion of the environment for a particular period of 12 calendar months commencing on a date specified in the first column of Schedule 1 is the limit specified in the second column of that Schedule in respect of that period when averaged over the period specified opposite thereto in the third column of that Schedule;
- (b) clause 7 (2) of the Policy, the ambient air quality standard for the concentration of sulphur dioxide in the relevant portion of the environment after the commencement of these regulations is 700 $\mu\text{g}/\text{m}^3$ when averaged over one hour.

Compliance with ambient air quality standard

5. (1) For the purposes of clause 9 of the Policy, 131 hours is the number of hours in any period of 12 calendar months commencing within the period beginning on the commencement of these regulations and ending on 31 December 1993.

(2) For the purposes of clause 9 of the Policy, the number of the hours in any period of 12 calendar months commencing within a year —

- (a) commencing on 1 January and ending on 31 December; and
- (b) specified in the first column of Schedule 2,

is the number specified in the second column of Schedule 2 in respect of that year.

Prescribed licence condition for certain industrial premises

6. (1) There is prescribed for the purposes of section 62 (1) (h) of the Act as a condition that may be specified in a licence granted in respect of industrial premises (whether inside or outside a protected area) within which a significant industrial source is located the condition that the occupier of those premises shall conduct the operations on those premises in such a way as neither to cause, nor to contribute to causing, the relevant ambient air quality limit referred to in regulation 4 (1) or (2) (a) to be exceeded.

(2) In this regulation —

“significant industrial source” means industrial source from which the discharge of sulphur dioxide is, in the opinion of the Chief Executive Officer, such as to affect, or to be likely to affect, the relevant portion of the environment.

DRAFT ENVIRONMENTAL PROTECTION (JANDAKOT MOUND GROUNDWATER)
POLICY 1993

In October 1992 the Environmental Protection Authority published for comment an environmental protection policy to protect groundwater of the Jandakot Mound. In response to comments in submissions received a new draft policy has been prepared, and made available for further public review and comment in accordance with section 26 (d) of the *Environmental Protection Act 1986*.

This new draft Policy endeavours to protect the quality of groundwater on or under the Jandakot Mound, and applies to the Jandakot Public Water Supply Area. The policy proposes controls on land use over the groundwater mound and prevents certain land uses between existing and proposed public water supply borelines.
