Quarantine area

4. (1) The land specified in the Schedule to this notice is declared to constitute a property quarantine area.

(2) Land in the property quarantine area constituted by this notice is quarantined land for the purposes of the regulations by reason of the presence of the declared animal Codling moth (*Cydia pomonella*).

Removal from quarantined land

5. (1) Where land is, pursuant to this notice, quarantined land, any—

- (a) fruit that may host Codling moth;
- (b) fruit trees or parts of fruit trees;
- (c) packaging material;
- (d) bulk bins;
- (e) any equipment which has been in contact with infested fruit,

that is on the quarantined land shall not be moved from the quarantined land except pursuant to an approval given under regulation 7 of the regulations or a general exemption having effect under regulation 9 of the regulations.

(2) Application for approval to move anything the movement of which would otherwise be contrary to this notice may be made to an inspector or authorised person in accordance with regulation 7 of the regulations.

1. The official regalia of this University shall be as follows—

- (a) The Chancellor's gown shall be made from black ottoman or silk, and having facings down each side in front and a square collar at the back of the same black material. The gown shall be trimmed with five centimetres gold oak-leaf lace down each front, and continued around the full hemline, and square collar. The cape-style sleeves are completely open and lined with black waterwave moire taffeta and trimmed around all open edges and hemline with the same gold oak-leaf lace. The Chancellor's cap shall be black velvet trencher cap with gold tassel and button trimmed with three centimetres gold braid.
- (b) The Pro-Chancellor's gown shall be of the same pattern and material as that worn by the Chancellor, but the facings, collar and sleeves edged with three centimetres gold lace. The Pro-Chancellor's cap shall be a black velvet trencher cap with gold tassel and button and trimmed with one point five centimetres of gold braid.
- (c) The Vice-Chancellor's gown shall be of the same pattern and material as that worn by the Chancellor and Pro-Chancellor, but the facings, collar and sleeves edged with three centimetres silver braid. The Vice-Chancellor's cap shall be a black velvet trencher cap with silver tassel and button and trimmed with three centimetres silver braid.
- (d) The gown for members of the University Council shall be the habit of their degrees, or similar to the Cambridge University Bachelor of Arts gown with closed sleeves, made from black stuff, with the addition of ten centimetres black satin fronts, and a yoke of the same material as the gown trimmed all around with one centimetre black braid. Each sleeve is pleated up in front eight centimetres and trimmed with the same black braid continuing to the shoulder. The Council members cap shall be a black cloth trencher cap.

2. The academic dress for graduates of this University shall be—

(a) Gowns

Undergraduates, Graduates or Graduate Diplomas, Graduate Certificates, Post Graduate Diplomas: Black stuff or silk gown similar in shape to that worn by Bachelors of Arts of the University of Cambridge.

Masters: Black stuff or silk gown similar in shape to that worn by Masters of Arts of the University of Cambridge.

Doctors of Philosophy: Blue stuff or silk gown as prescribed for Bachelors of Arts of the University of Cambridge but with facings of Red Satin ten centimetres wide the full length of the front with a trimming of one half centimetre wide gold cotton braid and with the sleeves faced on the outside in ten centimetre wide Red Satin trimmed at the top edge with one half centimetre wide gold cotton braid.

(b) Sashes

To be worn by graduates of Diploma, Associate Diploma and Certificate awards. Sashes for graduates of Diploma awards are to have a single diagonal stripe and those for other awards to be plain. The sashes shall bear the institution logo in use at the time of conferral of the award and be of a coloured stuff as follows:



1. Aircraft Landings—

- (a) Regular Passenger Transport Operators—a per capita tax of \$11.00 for full fare passengers and \$5.50 for half fare passengers commencing or terminating a journey at Esperance.

(b) Other than Regular Passenger Transport Service—

Where the maximum take off mass of the aircraft is less than 15 000 kg—a fee of \$5.00/1 000 kg per landing.

Owners or operators of aircraft with a MTOM less than 2 000 kg may select to pay a maximum annual fee of \$50.00.

Where the maximum take off mass of the aircraft is greater than 15 000 kg a fee of \$20.00/1 000 kg per landing.

2. Other Associated Fees—

Hangar site lease—\$250 per annum.

Parking Fees—\$20 per month or part thereof with the first five days being free.

3. Late Payment Fee

Charges and fees are payable by the end of the month in which they are billed, after which they become overdue for payment. Overdue amounts attract a late payment fee calculated as the greater of \$25.00 or 1.5% of the unpaid amount for each month or part month they remain overdue.

DOG ACT 1976

Municipality of the City of Bunbury

By-laws Relating to Dogs

In pursuance of the powers conferred upon it by the abovementioned Act and of all other powers enabling it, the Council of the abovementioned Municipality hereby records having resolved on the 8th day of June 1992, to repeal the By-laws Relating to Dogs published in the *Government Gazette* on the 8th day of November 1974 and to make and submit for the confirmation by the Governor the following By-laws.

In these By-laws unless the context otherwise requires—

“Act” shall mean the Dog Act 1976 and amendments and regulations appurtenant thereto.

“Council” shall mean the Bunbury City Council.

“Pound” shall mean any land including any enclosures or structures thereon, established or maintained by Council pursuant to the Dog Act 1976.

“Schedule” shall mean a schedule of these By-laws.

“Authorised officer” shall mean an officer of the council authorised by the Council to perform duties in accordance with these By-laws, and includes an inspector, and may also be referred to as a “Ranger” or “Poundkeeper”.

“District” shall mean the District of the City of Bunbury.

Part 1—Impounding Dogs

- (1) The Council may establish and maintain a pound or pounds for the impounding of dogs seized pursuant to the provisions of the Dog Act 1976 or these By-laws.
- (2) The pound to be used by Council is established on part of Bunbury Lot 521, Robertson Drive, Bunbury and is an approved pound situated within the Council area.
- (3) A dog seized by an officer of the WA Police Force or by an authorised officer of the Council may be placed in the pound.
- (4) The poundkeeper shall be in attendance at the pound for the release of dogs at such time on such days of the week as shall from time to time be determined by the Council.
- (5) Where a dog has been seized or placed in a pound the keeper of the pound or other officer authorised by the Council shall, in accordance with section 29(8)(a) of the Act, if the dog is wearing a registration tag or the owner is otherwise readily identifiable, forthwith notify such person that the dog has been impounded.
- (6) Any person applying for the release of a dog seized or impounded shall provide to the satisfaction of the poundkeeper or other officer authorised by the Council, evidence of the ownership of the dog and his authority to take delivery of it. The poundkeeper or officer may accept such proof as he considers satisfactory and no persons shall have any right of action against him or the Council in respect of the delivery of a dog in good faith.
- (7) If the owner or person apparently acting on behalf of the owner of a dog impounded shall claim such dog, then upon payment of the fees specified in the First Schedule hereto (“the said fees”) the dog shall be released to such person.

- (8) If the Council arranges destruction of a dog at the request of its owner, then whether such dog shall have been seized or not, the owner shall pay to Council the fees specified in the First Schedule hereto.
- (9) If a dog shall not be claimed and the said fees paid within 72 hours of its being seized, or if a dog having a collar around its neck with a registration label for the current year affixed thereto shall not be claimed and the said fees paid within 72 hours of the service of a notice upon the registered owner, the poundkeeper or other officer authorised by the Council may sell such dog.
- (10) Upon sale of a dog the proceeds of sale shall be the property of the Council and may be disposed of in such a manner as the Council thinks fit. The owner of a dog sold pursuant to these By-laws shall have no claim against the Council in respect of the proceeds thereof.
- (11) If within the times mentioned in By-law 9 hereof or at any time before the destruction of a dog, the dog has not been claimed as aforesaid, and the said fees paid, and if no offer has been received for its purchase, the dog may be destroyed.
- (12) Notwithstanding anything herein contained, but subject to the provisions of section 29 (12) of the Dog Act 1976, any dog seized or impounded, which is, in the opinion of an Authorised officer suffering from injury, disease or sickness to such an extent that it is impracticable to maintain the dog, may be destroyed upon the written authority of a registered veterinary surgeon, medical practitioner or health surveyor.
- (13) The payment of fees in respect of the seizure, care, detention or destruction of a dog shall not relieve the owner of liability to a penalty under the Dog Act Regulations or these By-laws.
- (14) No person shall—
 - (a) unless a poundkeeper or other officer of the Council duly authorised in that regard release or attempt to release a dog from a pound;
 - (b) destroy, break into, damage, or in any way interfere with or render not dog-proof any pound;
 - (c) destroy, break into, damage, or in any way interfere with or render not dog-proof any vehicle or container used for the purpose of catching, holding or conveying dogs which have been seized.
- (15) Any person who shall commit a breach of By-law 14 shall, upon conviction, be liable to a penalty not exceeding the maximum set down in section 43 of the Dog Act 1976.

Part 2—Prohibited Areas

- (16) (1) The owner or person liable for the control of a dog, other than a person accompanied by a guide dog, shall prevent that dog from entering or being in any of the following places—
 - (a) A public building.
 - (b) A theatre or picture gardens.
 - (c) A house of worship.
 - (d) A shop or other public business premises.
 - (e) PT Reserve 9997.
The areas of public beach delineated by the western boundary of Ocean Drive northerly to the prolongation of the southern boundary of Wellington Street, the low water mark of the Indian Ocean to the west and southerly to the prolongation of the northern boundary of William Street; from 1 October to 30 April each year.
 - (f) PT Reserves 9997 and Reserve 18574, PT Lot 670 Endowment Land.
The areas of public beach delineated by the western boundary of Ocean Drive northerly to the prolongation of the southern boundary of Hayward Street, the low water mark of the Indian Ocean to the west, and southerly to the prolongation of the northern boundary of Hastie Street; from 1 October to 30 April each year.
 - (g) That portion of Koombana Bay from the low water mark and extending south in a foreshore corridor 100 metres wide from the western boundary of Reserve 27297 easterly to the eastern boundary of Reserve 41411; from 1 October to 30 April each year.

Part 3—Dog Exercise Areas

- (17) The land specified in the 3rd Schedule to these By-laws is designated as dog exercise areas for the purposes of the Dog Act 1976. The exercising of dogs in dog exercise areas shall be subject to the provisions of the Dog Act 1976.

Part 4—Limitations—Number of Dogs

- (18) The owner or occupier of any premises within the District shall not keep, permit or suffer to remain thereon more than two dogs over the age of three months unless such premises are situated within that area of the district where kennels are permitted under the City of Bunbury Town Planning Scheme as amended and unless such premises are licensed as an approved kennel establishment.
- (19) A person wishing to keep more than two dogs but not more than six dogs on any premises may seek, upon application to Council, exemption for those provisions under section 26 (3) of the Dog Act 1976.

Part 5—General

- (20) The owner or occupier of premises within the City of Bunbury on which a dog is kept shall cause the portion of those premises on which the dog is kept to be fenced in a manner capable of confining the dog to that portion and in accordance with the provisions of this By-law. Any owner or occupier failing to comply with this requirement commits an offence.
- (a) The fence used to confine a dog and every part of the fence shall be of a type, height and construction which, having regard to the species, age, size and physical condition of the dog prevents the dog from passing over, under or through the fence.
- (b) If there is a gate in the fence, the gate shall be kept closed at all times except when the dog is not kept on the premises, but nothing in this sub-by-law prevents a person from opening the gate, in order to enter or leave the premises.
- (21) A person liable for the control of a dog which excretes on any street or public place or on private property within the City of Bunbury without the consent of the occupier commits an offence unless the excreta is removed forthwith and disposed of on private land with the consent of the occupier.
- (22) No person shall obstruct or hinder an employee of the Council or a member of the Police Force in the performance of anything authorised by the provisions of the Dog Act 1976.

Part 6—Penalties Etc.

- (23) (1) Any person who commits a breach of any of the provisions of these By-laws commits an offence and shall upon conviction in a court of competent jurisdiction be liable to a penalty not exceeding \$200.
- (2) (a) The offences described in column two of the Second Schedule are prescribed pursuant to the respective by-laws as offences in relation to which modified penalties apply and the amount appearing in column three of that Schedule directly opposite an offence is the modified penalty payable in respect of that offence if dealt with pursuant to section 45A of the Dog Act 1976.
- (b) Infringement notices issued pursuant to these By-laws shall be in the form depicted in Form 7 of the First Schedule of the Dog Act Regulations 1976.
- (c) Where an authorised person has reason to believe, upon reasonable grounds, that a person has committed any such offence against these By-laws as is prescribed by these By-laws, he may serve on that person an infringement notice informing the person that if he does not wish to have a complaint of the alleged offence heard and determined by a Court, he may pay to the Council, within the time therein specified, the amount prescribed as the modified penalty.
- (d) An infringement notice may be served on an alleged offender personally or by posting it to his address as ascertained from him at the time of or immediately following the occurrence giving rise to the allegation of the offence, or as recorded by Council pursuant to the Act.
- (e) Where a person who received an infringement notice fails to pay the prescribed penalty within the specified time in the notice, or within such further time as may in any particular case be allowed, he is deemed to have declined to have the allegation dealt with by way of a modified penalty.
- (f) An alleged offender on whom an infringement notice has been served may, within the time specified in that notice or such further time as may in any particular case be allowed, send or deliver to the Council the amount of the prescribed penalty, with or without a reply as to the circumstances giving rise to the allegation, and the Council may thereupon issue an acknowledgement accordingly.
- (g) Withdrawal of infringement notices issued under this By-law shall be in the form depicted in Form 8 of the First Schedule to the Dog Act Regulations 1976.







Notice is hereby given that at a meeting of the Committee of the Western Australian Trotting Association held at Gloucester Park, East Perth, on the 2nd day of February 1993, it was resolved by an absolute majority of the members of the Committee that the Rules of Trotting be amended as follows:

Delete the existing Rule 116 and insert a new Rule 116 which reads:

- (a) All stakes shall be paid within seven days of the date of the meeting unless the gross stake of the race excluding trophies shall be in excess of \$15 000.
- (b) In races carrying a gross stake excluding trophies in excess of \$15 000, all stakes shall be paid within seven days of the date of the meeting unless an enquiry affecting the result of the race shall be pending or the result of a report on a swab taken from the horse in respect of which the stakes are payable shall not have been received.
- (c) Where any horse is disqualified from a race, any stakemoney paid out by the Controlling Body or any Club shall become immediately repayable by the person to whom it was paid.






