Made by His Excellency the Governor in Executive Council under section 23 (2d) of the *Soil and Land Conservation Act 1945* and on the recommendation of the Minister for Primary Industry.

Citation

1. This order may be cited as the *Soil and Land Conservation (Chapman Valley Land Conservation District) Amendment Order 1993*.

Principal Order

2. In this order the *Soil and Land Conservation (Chapman Valley Land Conservation District) Order 1991* is referred to as the principal order.

Clause 5 amended

3. Clause 5 of the principal order is amended in subclause (1)—

(a) by deleting "9" and substituting the following—

" 12 "; and

(b) in paragraph (e) by deleting "3" and substituting the following—

" 6 ".

AG302**SOIL AND LAND CONSERVATION ACT 1945****SOIL AND LAND CONSERVATION (YALLINGUP LAND CONSERVATION DISTRICT) ORDER 1993**

Made by His Excellency the Governor in Executive Council under sections 22 and 23 of the *Soil and Land Conservation Act 1945* and on the recommendation of the Minister for Primary Industry.

Citation

1. This order may be cited as the *Soil and Land Conservation (Yallingup Land Conservation District) Order 1993*.

Interpretation

2. In this order—

"appointed member" means a person appointed under clause 5 (1) (b) or (c) to be a member of the committee;

"committee" means that Land Conservation District Committee for the Yallingup Land Conservation District;

"member" means a member of the committee;

"the district" means the Yallingup Land Conservation District constituted by clause 3;

"the producer organisations" means the bodies known respectively as the Western Australian Farmers Federation (Inc.) and the Pastoralists and Graziers Association of Western Australia.

Yallingup Land Conservation District

3. The land described in the Schedule to this order is hereby constituted the Yallingup Land Conservation District.

Establishment of the committee

4. Pursuant to section 23 (2) of the *Soil and Land Conservation Act 1945* there is hereby established for the district a land conservation district committee to be known as the Land Conservation District Committee for the Yallingup Land Conservation District.

Constitution of the committee

5. (1) It is hereby determined, on the recommendation of the Minister, after consultation with the Shire of Busselton, that the committee shall comprise 11 members of whom—
- (a) one shall be the Commissioner of Soil and Land Conservation or his nominee;
 - (b) one shall be appointed by the Minister on the nomination of the Shire of Busselton;
 - (c) 9 shall be appointed by the Minister and shall be persons actively engaged in, or affected by or associated with, land use in the district.
- (2) Subject to this clause, each appointed member shall hold office for such period not exceeding 3 years as is specified in the instrument of his appointment and is eligible for reappointment.
- (3) The Minister may grant leave of absence to an appointed member on such terms and conditions as the Minister determines.
- (4) The Minister may terminate the appointment of an appointed member for inability, inefficiency or misbehaviour.
- (5) If an appointed member—
- (a) is or becomes an undischarged bankrupt or person whose property is subject to an order or arrangement under the laws relating to bankruptcy;
 - (b) has his appointment terminated by the Minister, pursuant to subclause (4);
 - (c) is absent, except on leave duly granted by the Minister, from 3 consecutive meetings of the committee of which he has had notice; or
 - (d) resigns his office by written notice addressed to the Minister,
- the office of that appointed member becomes vacant.

Proceedings of the committee

6. (1) The committee shall hold its meetings at such place on such days and at such intervals as the committee shall from time to time determine.
- (2) At any meeting of the committee—
- (a) a majority of the members constitute a quorum;
 - (b) the Chairman shall preside and where he is absent from the meeting the members may appoint one of their number to preside at that meeting;
 - (c) each member present is entitled to a deliberative vote; and
 - (d) where the votes cast on any question are equally divided the Chairman, or the presiding member in terms of paragraph (b), shall have a casting vote.
- (3) The committee shall cause accurate minutes to be kept of the proceedings at its meetings.
- (4) To the extent that it is not prescribed, the committee may determine its own procedure.

Schedule

(Clause 3)

Yallingup Land Conservation District

All that portion of land bounded by lines starting from the intersection of the High Water Mark of the Indian Ocean with the northern boundary of Sussex Location 4308 (Class A Reserve 8427) and extending easterly, southerly, again easterly, again southerly and again easterly along boundaries of that location to the centreline of Yallingup Brook; thence generally southwesterly downwards along that centreline to the centreline of Yallingup Caves Road; thence generally northwesterly along that centreline to the prolongation easterly of the southern boundary of Location 4309 (Class A Reserve 8427); thence westerly to and along that boundary to the northeastern corner of Part Location 360 (Class A Reserve 8427); thence southerly along the eastern boundary of that location and southerly and southeasterly along boundaries of Location 4421 to the northwestern corner of the northeastern severance of Location 4422; thence southeasterly and southwesterly along boundaries of that severance and onwards to the centreline of Yallingup Beach Road; thence southeasterly along that centreline and onwards to the centreline of Caves Road; thence generally southerly along that centreline to the prolongation northeasterly of the centreline of Quininup Road; thence southwesterly to and generally southwesterly along that centreline to the eastern boundary of Location 4751; thence southerly and westerly along boundaries of that location and westerly along the southern boundary of Location 348 to the southernmost southeastern corner of Location 4918 (Class A Reserve 8428); thence westerly along the southernmost southern boundary of that location and westerly along the northern boundary of Location 4690 (Class A Reserve 8429) to the High Water Mark of the Indian Ocean and thence generally northwesterly and generally northeasterly along that water mark to the starting point.

1. This order may be cited as the *Soil and Land Conservation (Sussex Land Conservation District) Order 1993*.

Interpretation

2. In this order—

“appointed member” means a person appointed under clause 5 (1) (b), (c) or (d) to be a member of the committee;

“committee” means that Land Conservation District Committee for the Sussex Land Conservation District;

“member” means a member of the committee;

“the district” means the Sussex Land Conservation District constituted by clause 3;

Sussex Land Conservation District

3. The land described in the Schedule to this order is hereby constituted the Sussex Land Conservation District.

Establishment of the committee

4. Pursuant to section 23 (2) of the *Soil and Land Conservation Act 1945* there is hereby established for the district a land conservation district committee to be known as the Land Conservation District Committee for the Sussex Land Conservation District.

Constitution of the committee

5. (1) It is hereby determined, on the recommendation of the Minister, after consultation with the Shire of Busselton, that the committee shall comprise 16 members of whom—

(a) one shall be the Commissioner of Soil and Land Conservation or his nominee;

(3) Subject to this clause, each appointed member shall hold office for such period not exceeding 3 years as is specified in the instrument of his appointment and is eligible for reappointment.

(4) The Minister may grant leave of absence to an appointed member on such terms and conditions as the Minister determines.

(5) The Minister may terminate the appointment of an appointed member for inability, inefficiency or misbehaviour.

(6) If an appointed member—

(a) is or becomes an undischarged bankrupt or person whose property is subject to an order or arrangement under the laws relating to bankruptcy;

(b) has his appointment terminated by the Minister, pursuant to subclause (5);

(c) is absent, except on leave duly granted by the Minister, from 3 consecutive meetings of the committee of which he has had notice; or

(d) resigns his office by written notice addressed to the Minister,

the office of that appointed member becomes vacant.

Proceedings of the committee

6. (1) The committee shall hold its meetings at such place on such days and at such intervals as the committee shall from time to time determine.
- (2) At any meeting of the committee—
- (a) a majority of the members constitute a quorum;
 - (b) the Chairman shall preside and where he is absent from the meeting the members may appoint one of their number to preside at that meeting;
 - (c) each member present is entitled to a deliberative vote; and
 - (d) where the votes cast on any question are equally divided the Chairman, or the presiding member in terms of paragraph (b), shall have a casting vote.
- (3) The committee shall cause accurate minutes to be kept of the proceedings at its meetings.
- (4) To the extent that it is not prescribed, the committee may determine its own procedure.

SOIL AND LAND CONSERVATION (CAPEL LAND CONSERVATION DISTRICT) ORDER 1993

Made by His Excellency the Governor in Executive Council under Sections 22 and 23 of the *Soil and Land Conservation Act 1945* and on the recommendation of the Minister for Primary Industry.

Citation

1. This order may be cited as the *Soil and Land Conservation (Capel Land Conservation District) Order 1993*.

Interpretation

(5) The Minister may grant leave of absence to an appointed member on such terms and conditions as the Minister determines.

(6) The Minister may terminate the appointment of an appointed member for inability, inefficiency or misbehaviour.

(7) If an appointed member—

- (a) is or becomes an undischarged bankrupt or person whose property is subject to an order or arrangement under the laws relating to bankruptcy;
- (b) has his appointment terminated by the Minister, pursuant to subclause (6);
- (c) is absent, except on leave duly granted by the Minister, from 3 consecutive meetings of the committee of which he has had notice; or
- (d) resigns his office by written notice addressed to the Minister,

SOIL AND LAND CONSERVATION (NEWDEGATE LAND CONSERVATION DISTRICT) ORDER 1993

Made by His Excellency the Governor in Executive Council under Sections 22 and 23 of the *Soil and Land Conservation Act 1945* and on the recommendation of the Minister for Primary Industry.

Citation

1. This order may be cited as the *Soil and Land Conservation (Newdegate Land Conservation District) Order 1993*.

Interpretation

2. In this order—

“appointed member” means a person appointed under clause 5 (1)(b), (c), (d) or (e) to be a member of the committee;

“committee” means that Land Conservation District Committee for the Newdegate Land Conservation District;

“member” means a member of the committee;

“the district” means the Newdegate Land Conservation District constituted by clause 3;

“the producer organisation” means the bodies known respectively as the Western Australian Farmers Federation (Inc.) and the Pastoralists and Graziers Association of Western Australia.

Newdegate Land Conservation District

3. The land described in the Schedule to this order is hereby constituted the Newdegate Land Conservation District.

Establishment of the committee

4. Pursuant to Section 23 (2) of the *Soil and Land Conservation Act 1945* there is hereby established for the district a land conservation district committee to be known as the Land Conservation District Committee for the Newdegate Land Conservation District.

Constitution of the committee

5. (1) It is hereby determined, on the recommendation of the Minister, after consultation with the Shire of Lake Grace, that the committee shall comprise 14 members of whom—

- (a) one shall be the Commissioner of Soil and Land Conservation or his nominee;
- (b) one shall be appointed by the Minister on the nomination of the Shire of Lake Grace;
- (c) 2 shall be appointed in accordance with subclause (2);
- (d) one shall be appointed in accordance with subclause (3);
- (e) 9 shall be appointed by the Minister and shall be persons actively engaged in, or affected by or associated with, land use in the district.

(2) The Western Australian Farmers Federation (Inc.) shall submit to the Minister a panel containing the names of persons willing to be appointed as members of the committee and, where such a panel is submitted in accordance with this order, 2 persons whose names appear on the panel shall be appointed by the Minister.

(3) The Pastoralists and Graziers Association of Western Australia shall submit to the Minister a panel containing the names of persons willing to be appointed as members of the committee and, where such a panel is submitted in accordance with this order, one person whose name appears on the panel shall be appointed by the Minister.

(4) Subject to this clause, each appointed member shall hold office for such period not exceeding 3 years as is specified in the instrument of his appointment and is eligible for reappointment.

(5) The Minister may grant leave of absence to an appointed member on such terms and conditions as the Minister determines.

(6) The Minister may terminate the appointment of an appointed member for inability, inefficiency or misbehaviour.

(7) If an appointed member—

- (a) is or becomes an undischarged bankrupt or person whose property is subject to an order or arrangement under the laws relating to bankruptcy;
- (b) has his appointment terminated by the Minister, pursuant to subclause (6);
- (c) is absent, except on leave duly granted by the Minister, from 3 consecutive meetings of the committee of which he has had notice; or
- (d) resigns his office by written notice addressed to the Minister,

the office of that appointed member becomes vacant.

Proceedings of the committee

6. (1) The committee shall hold its meetings at such place on such days and at such intervals as the committee shall from time to time determine.

(2) At any meeting of the committee—

- (a) a majority of the members constitute a quorum;
- (b) the Chairman shall preside and where he is absent from the meeting the members may appoint one of their number to preside at that meeting;
- (c) each member present is entitled to a deliberative vote; and
- (d) where the votes cast on any question are equally divided the Chairman, or the presiding member in terms of paragraph (b), shall have a casting vote.

(3) The committee shall cause accurate minutes to be kept of the proceedings at its meetings.

(4) To the extent that it is not prescribed, the committee may determine its own procedure.

which in the opinion of the Council is likely to affect adversely the value of adjoining property or the health, comfort or convenience of the inhabitants thereof, the Council may cause a notice under the hand of the Town Clerk to be served on the owner or occupier of such land requiring him within the time specified in such notice, to clear the land of such trees, scrub, undergrowth, refuse or rubbish, or remove such refuse, rubbish or disused material and unregistered motor vehicles, motor vehicle bodies or parts thereof from such land.

5. Every owner or occupier of land upon whom a notice is served under by-law 4 of these By-laws shall comply with such notice within the time therein specified or in that time give a satisfactory reason why the materials should be retained or be given extra time in which to comply.
6. Where the owner or occupier does not comply with the notice given by the Council, the Council may, without payment of any compensation in respect thereof, undertake the requirements of the notice at the expense of, and recover in a court of competent jurisdiction the amount of the expense, from the owner or occupier to whom the notice was given.
7. Any person who fails to comply with any notice served under by-law 4 of these By-laws commits an offence against these By-laws and on conviction shall be liable to a penalty commensurate with the section 190 (7) (d) (i) and (ii) of the Local Government Act 1960.
