### FISHERIES ACT 1905

#### PART IIIB—PROCESSING LICENCE

The public is hereby notified that I have issued a permit to Ivan John Dawe of Lancelin to establish a processing establishment to process Wetfish in pursuance of the provisions of section 35C of the Fisheries Act 1905 on board licensed fishing boat "Coon" registered number LFB 766, subject to the following conditions;

That the processing establishment—

1. Shall comply with the requirements of the Fisheries Act 1905, and all Regulations, Orders in Council and Notices and Ministerial Directions issued thereunder.
2. Shall not be used for the processing of Rock Lobster, Scallops or Salmon.
3. Shall comply with the requirements of the Health Act 1911 (amended).
4. Shall be registered as an export establishment pursuant to the provisions of the Parliament of the Commonwealth Export Control Act 1982, and orders made thereunder more specifically the prescribed Goods (General) Orders and the Fish Orders, should it be used to process fish for export.
5. Shall not be used for the processing of marron (*Cherax tenuimanus*) unless a licence is held under section 39C of the Fisheries Act 1905.
6. Shall not be used for the processing of fish or crustacea caught by any other vessel.

In accordance with the provision of section 35K, any person aggrieved by this decision may, within fourteen days after publication of this notice, appeal against the decision or order by serving on the Minister for Fisheries a statement, in writing on the grounds of their appeal.

## TOBACCO CONTROL ACT 1990

## TOBACCO CONTROL (EXEMPTION) NOTICE (NO. 5) 1993

Made by the Minister for Health under section 14 after consultation with the Minister for Sport and Recreation.

**Citation**

1. This notice may be cited as the *Tobacco Control (Exemption) Notice (No. 5) 1993*.

**Exemption**

2. Subject to the conditions set out in clause 3, competitors, and persons officially supporting or directly assisting competitors, in the ocean racing event known as the Whitbread Round The World Race ("the Race") are exempted from the operation of sections 5 and 8 of the *Tobacco Control Act 1990*, while participating in the Race, from 10 December 1993 to 9 January 1994 inclusive.

**Conditions**

3. The conditions subject to which the exemption referred to in clause 2 is granted are that —

- (a) any trademark or brand name of a tobacco product shall be displayed only —
  - (i) on the hull of yachts that are participating in the Race;
  - (ii) on the sails of yachts when they are under way and participating in the Race;
  - (iii) on the clothing of the competitors and the persons officially supporting or directly assisting the competitors in the Race, if the trademark or brand name is accompanied by the health warning —
    - (I) "SMOKING CAUSES LUNG CANCER"; or
    - (II) "SMOKING CAUSES HEART DISEASE",together with the statement "Health Authority Warning"; or
  - (iv) when incidentally or accidentally present in photographs used to publicize the Race;
- (b) the area exclusively devoted to the display of the health warning referred to in paragraph (a) and the statement "Health Authority Warning" shall be not less than 25% of the area devoted to the display of the trademark or brand name referred to in that paragraph;
- (c) the health warning referred to in paragraph (a) shall —
  - (i) appear directly beneath the trademark or brand name referred to in that paragraph and directly adjacent to the statement "Health Authority Warning";
  - (ii) occupy, together with the statement "Health Authority Warning", not less than 80% of the area devoted to the display of that warning and that statement;
- (d) the letters in the statement "Health Authority Warning" shall not exceed half the height of the letters used for the health warning referred to in paragraph (a); and

- (e) any items or material, such as hats, t-shirts, posters and cards, that are sold or otherwise supplied in connection with the Race shall not display a trademark or brand name of a tobacco product.

**FIREBREAK ORDER (SECTION 33)**

*Shire of Mullewa*

Notice to Owners and Occupiers of Land in the Shire of Mullewa

Pursuant to the powers contained in section 33 of the above Act, you are hereby required on or before the 1st October 1993 to plough, scarify, cultivate or otherwise clear, and thereafter maintain free from all flammable material until 31st March, 1994, firebreaks in accordance with the following—

1. RURAL LAND

(b) If the area of land exceeds 2 023 square metres (half an acre) clear of all flammable material firebreaks at least two (2) metres wide immediately inside all external boundaries of the land.

3. HOMESTEADS, BUILDINGS, HAYSTACKS, STACKS OF FODDER, BULK FUEL, DRUMS AND LIQUID PETROLEUM

Owners and Occupiers of land shall—

During the period from 1st day of October, 1993, to the 31st day of March, 1994 inclusive, have firebreaks at least two (2) metres wide in such positions as are necessary to completely surround the perimeter of any homestead, building, fuel installation (including drums), haystack (where such a haystack is situated within 200 metres of any homestead, building, fuel installation) or group of such structures or installations.

4. HARVESTING

A fully operational mobile fire fighting unit complete with a container with at least 400 litres minimum capacity of water is to be readily available to any paddock being harvested. The responsibility to supply the unit being that of the landholder.

5. GENERAL INFORMATION

If for any reason it is considered impractical to comply with any provision of this notice a written application for a variation may be made to the Shire Council and must reach the Shire Clerk by the 30th day of September, 1993. Any such application must bear the signature of the Fire Control Officer of the area signifying his agreement to the variation.

Prohibited burning, period from 29 October 1993 to 6 February 1994.

Restricted burning from 15 October 1993 to 28 October 1993 and 7 February 1994 to 18 March 1994.

#### GENERAL PROVISIONS

If it is considered to be impractical for any reason to provide fire breaks in the position or adhere to the provisions required by this notice, the approval of the Council must be obtained to prepare such firebreaks in an alternative position. Approval to any such variation will only be granted where the Bush Fire Control Officer for the area has first signified approval for the variation. (Example of reasons to relocate firebreaks include where there are natural firebreaks or areas liable to soil erosion).

The penalty to failing to comply with this notice is a fine of not more than \$1 000 and a person in default is also liable, whether prosecuted or not, to pay the cost of performing the work directed in this notice if it is not carried out by the owner or occupier and by the date required by this notice.






