## PLANT DISEASES ACT 1914

## PLANT DISEASES AMENDMENT REGULATIONS (NO. 7) 1993

Made by His Excellency the Governor in Executive Council.

## Citation

1. These regulations may be cited as the *Plant Diseases Amendment Regulations (No. 7) 1993*.

## Regulation 17D inserted

2. Division 1 of Part 4 of the *Plant Diseases Regulations 1989\** is amended by inserting after regulation 17C, the following regulation —

“

**Western Flower Thrips — (*Frankliniella occidentalis*)**

17D. (1) A grower who detects Western Flower Thrips on his property must, as soon as practicable —

- (a) apply a control spray treatment to the infested crops; and
- (b) maintain a monitoring programme,

approved by the Director General.

(2) A grower who contravenes subregulation (1) commits an offence.

(3) A person must not remove cut flowers from an area within a 50 km radius of an outbreak of Western Flower Thrips unless the flowers —

- (a) have been treated as approved by the Director General; or
- (b) have been inspected by an authorized inspector and found to be free from Western Flower Thrips; or
- (c) are from a property which has been declared to be free from Western Flower Thrips by the Director General; or
- (d) are from a property on which a spraying and monitoring programme approved by the Director General has been applied.

(4) A person who contravenes subregulation (3) commits an offence.

(5) For the purposes of regulation 16 (1) Western Flower Thrips is a specified disease.

## PLANT DISEASES ACT 1914

## PLANT DISEASES AMENDMENT REGULATIONS (NO. 8) 1993

Made by His Excellency the Governor in Executive Council.

## Citation

1. These regulations may be cited as the *Plant Diseases Amendment Regulations (No. 8) 1993*.

## Schedule 1 amended

2. Schedule 1 to the *Plant Diseases Regulations 1989\** is amended in Part B by deleting clause 41 and substituting the following clause —

“

41. Cut flowers and foliage, fruit, plants and vegetables —  
Melon Thrips (*Thrips palmi*).

The entry of any plant or part of a plant, other than seeds, underground parts and dried or processed plant material of species of the Dicotyledons and families Orchidaceae, Amaryllidaceae, Alliaceae and Poaceae of the Monocotyledons is prohibited from any area within 500 km of an outbreak of Melon Thrips, unless certified as —

- (a) grown and packed in an area free from Melon Thrips established by an approved trapping and inspection programme; or
- (b) grown and packed on a property free from Melon Thrips established by an approved trapping and inspection programme; or
- (c) in the case of cut flowers or fruit, inspected at the approved sampling rate and found to be free from Melon Thrips; or
- (d) fumigated with methyl bromide for 2 hours at one of the following rates —
  - 56 g/m<sup>3</sup> at 5° — 10°C
  - 48 g/m<sup>3</sup> at 11° — 15°C
  - 40 g/m<sup>3</sup> at 16° — 20°C
  - 32 g/m<sup>3</sup> at 21° — 25°C
  - 24 g/m<sup>3</sup> at 26° — 30°C
  - 16 g/m<sup>3</sup> at 31° and above; or
- (e) fumigated with ethylene dibromide at 12 g/m<sup>3</sup> for 2 hours at 20°C or above or in a manner approved for the control of fruit fly in the case of a particular fruit or vegetable; or
- (f) when post harvest, treated in an approved manner.

”

## PLANT DISEASES AMENDMENT REGULATIONS (NO. 9) 1993

Made by His Excellency the Governor in Executive Council.

**Citation**

1. These regulations may be cited as the *Plant Diseases Amendment Regulations (No. 9) 1993*.

**Principal regulations**

2. In these regulations the *Plant Diseases Regulations 1989\** are referred to as the principal regulations.

**Regulation 17 repealed and a regulation substituted**

3. Regulation 17 of the principal regulations is repealed and the following regulation is substituted —

“

**Citrus, Fortunella, Poncirus — Citrus Leaf Miner**

17. (1) A person may bring or send into the part of the State south of 21° South Latitude from the part of the State north of 21° South Latitude, any plant of any of the genera *Citrus*, *Fortunella* and *Poncirus* —

(a) if —

- (i) the area in which the plant was grown is declared free of citrus leaf miner by the Department of Agriculture;
- (ii) it is accompanied by a statutory declaration by the grower to the effect that the plant was grown in an area so declared by the Department of Agriculture; and
- (iii) it has affixed to it a label bearing the address of the place where the plant was grown;

or

(b) if the plants are certified as —

- (i) free from leaves and flush growth; and
- (ii) having —
  - (I) been treated for citrus leaf miner with a solution of 6 ml of diazinon (80% active ingredient) and 120 ml of white petroleum oil in 10 litres of water; or
  - (II) come from an approved nursery where the plants were treated in accordance with subparagraph (I).

(2) A consignment from an approved nursery referred to in subregulation (1) (b) (ii) (II) must be accompanied by a declaration made by the occupier of the approved nursery specifying that the plants were treated in accordance with subregulation (1) (b) (ii) (I) no more than 3 days before the plants were consigned.

(3) For the purposes of regulation 16 (1) citrus leaf miner is a specified disease.

#### Schedule 1 amended

4. Schedule 1 to the principal regulations is amended in Part B —

(a) in clause 4 by deleting paragraph (b) and substituting the following paragraphs —

“

(b) to be from an accredited fruit fly free area;

or

(c) to be certified as having been treated for fruit fly control at one of the following temperatures —

0°C ± 0.5°C for 14 days; or  
1.0°C ± 0.5°C for 16 days; or  
1.5°C ± 0.5°C for 18 days.

and

(b) by repealing clause 27 and substituting the following clause —

“

27. Citrus, Fortunella and Poncirus plants — Citrus Leaf Miner (*Phyllocnistis citrella*)

Plants must —

(a) be certified as grown in an area free from citrus leaf miner and have a label affixed bearing the address of the place where the plant was grown;

or

(b) be certified as free from leaves or flush growth.

#### SOIL AND LAND CONSERVATION COUNCIL (APPOINTMENT OF MEMBERS) INSTRUMENT No. 2 of 1993

Made by His Excellency the Governor in Executive Council.

#### Citation

1. This instrument may be cited as the *Soil and Land Conservation Council (Appointment of Members) Instrument No. 2 of 1993*.

#### Definitions

2. In this instrument—

“the Act” means the *Soil and Land Conservation Act 1945*;

“the Council” means the Soil and Land Conservation Council established under the Act;  
and

“the Minister” means the Minister for Primary Industry.

**Appointment of Members**

3. The following persons are appointed to be members of the Council—

- (a) Under section 9 (2) (a) of the Act and on nomination of the Minister, Mr Kevin Frederick Goss, Commissioner of Soil and Land Conservation *ex officio*.
- (b) Under section 9 (2) (b) of the Act and on nomination of the Minister, Dr Graeme Albert Robertson, an officer of the Public Service of the State employed in the Department of Agriculture for a term expiring on 31 May 1994.
- (c) Under section 9 (2) (fa) of the Act, and on the nomination of the Minister after consultation with voluntary organisations, Ms Rachel Siewert, for a term of office expiring on 31 May 1994.
- (d) Under section 9 (2) (4) of the Act, Gary English as Deputy Chairman of the Council for a term expiring on 31 May 1994.

**COAL INDUSTRY SUPERANNUATION AMENDMENT REGULATIONS

Made by His Excellency the Governor in Executive Council.

**Citation**

1. These regulations may be cited as the *Coal Industry Superannuation Amendment Regulations 1993*.

**Principal regulations**

2. In these regulations the *Coal Industry Superannuation Regulations 1990\** are referred to as the principal regulations.

**Regulation 21 amended**

3. Regulation 21 of the principal regulations is amended by deleting

“shall become entitled to —

- (a) a cash termination benefit calculated in accordance with Schedule 1; or
- (b) a preserved benefit calculated in accordance with Schedule 2,

as elected by the member at the time the member ceases employment with the employer.”

and substituting the following —

“

shall —

(a) become entitled to —

- (i) a cash termination benefit calculated in accordance with Schedule 1; or

- (ii) a preserved benefit calculated in accordance with Schedule 2,

as elected by the member at the time the member ceases employment with the employer; and

- (b) become entitled to a preserved benefit calculated in accordance with Schedule 2B.

”

#### Regulation 21A amended

4. Regulation 21A of the principal regulations is amended by deleting

“is entitled at the member’s election —

- (a) to a preserved benefit in respect of membership calculated in accordance with Part 1 of Schedule 2A; or
- (b) to a cash benefit in respect of membership calculated in accordance with Part 2 of Schedule 2A.”

and substituting the following —

“

- (a) entitled at the member’s election to a full preserved benefit in respect of membership calculated in accordance with Part 2 of Schedule 2A; or
- (b) entitled at the member’s election —
  - (i) to a cash benefit in respect of membership calculated in accordance with Part 2 of Schedule 2A; and
  - (ii) to a post-1992 preserved benefit in respect of membership calculated in accordance with Part 3 of Schedule 2A.

”

#### Regulation 22 amended

5. Regulation 22 (5) of the principal regulations is repealed and the following subregulation is substituted —

“

(5) The Board shall pay or transfer to any other superannuation fund, approved deposit fund, deferred annuity fund or other like fund, an amount calculated in accordance with Schedule 2C, if —

- (a) the member requests in writing that the Board do so; or
- (b) the Board is satisfied that the balance paid or transferred will be subject to the preservation requirements contained in any standards prescribed from time to time by regulation under the *Occupational Superannuation Standards Act 1987* of the Commonwealth.

”

6. Regulation 52 of the principal regulations is amended by deleting “a copy of the annual report and with” and substituting the following —

“

a report to members as required under the *Occupational Superannuation Standards Act 1987* of the Commonwealth and, upon request, a copy of the annual report and

**Schedule 2 amended****7. Schedule 2 to the principal regulations is amended —**

- (a) by deleting “PB = FAS x AP x f” and substituting the following —  
 “ PB = FAS x APB x f ”; and
- (b) by deleting the definition of “AP” and substituting the following definition —  
 “ APB is the sum of all the accrual products of the member associated with service before 1 July 1992; ”.

**Schedule 2A amended****8. Schedule 2A to the principal regulations is amended —**

- (a) in Part 2 —
- (i) by deleting “CB = (0.3 x FAS x AP) + [0.7 x FAS x AP x (1+DR)<sup>-n</sup>]” and substituting the following —  
 “ CB = (0.3 x FAS x AP) + (0.7 x FAS x APB x [1+DR]<sup>-n</sup>) ”;  
 and
- (ii) by inserting after the definition of “AP” the following definition —  
 “ APB is the sum of all the accrual products of the member associated with service before 1 July 1992; ”;  
 and
- (b) by inserting after Part 2 the following Part —

**PART 3**  
**CALCULATION OF POST-1992 PRESERVED**  
**BENEFIT UNDER APPROVED RETRENCHMENT**  
**SCHEME**

The formula for calculating a post-1992 preserved benefit in respect of a member under an approved retrenchment scheme is —  

$$PB = 0.7 \times FAS \times APA$$

where —

PB is the preserved benefit;  
 FAS is the final average salary which applies to the member;  
 APA is the sum of all accrual products of the member applicable to membership after 30 June 1992 at the time of cessation of employment.

**CALCULATION OF PRESERVED BENEFIT ON RESIGNATION**

The formula for calculating a preserved benefit for the purposes of regulation 21 (b) is —

$$PB = 0.7 \times FAS \times APA$$

where —

PB is the preserved benefit;  
 FAS is the final average salary which applies to the member;  
 APA is the sum of all accrual products of the member applicable to membership after 30 June 1992 at the time of cessation of employment.

## CALCULATION OF CASH TRANSFER VALUE

The formula for calculating a cash transfer value in respect of a member is —

$$TV = MFE - MFC + ([EFE - UEFP] \times DF)$$

- MFC is the member financed cash benefit multiple previously paid, calculated as the lesser of —

 $0.7 \times AP$ ;
  - if the member had resigned and had not been paid a benefit under regulation 21 (a) (i) —  
 $(0.7 \times APA) + ([f - 0.3] \times APB)$ ; or
  - if the member had resigned and had been paid a benefit under regulation 21 (a) (i) —  
 $0.7 \times APA$ ;
- UEFP is the undiscounted employer financed multiple applicable to any payment previously made, calculated as —
- if the member received a payment under regulation 21A (b) —  
 $0.7 \times APB$ ; or
  - in other cases, 0;
- DF is the discount factor calculated as —  
 $(1 + DR)^n$ ;
- AP is the sum of all accrual products of the member at the time of cessation of employment;
- PC is the amount of any cash benefit paid under regulation 21 (a) (i) or 21A (b) (i);
- PFAS is the final average salary which applied to the member at the time of the payment of PC;
- APA is the sum of all the accrual products of the member applicable to membership after 30 June 1992 at the time of cessation of employment;
- f is the vesting factor, calculated in the same manner as in Schedule 2;
- APB is the sum of all the accrual products applicable to membership at 30 June 1992;

##### Town of Kwinana

##### Model Health By-laws Series "A"

The Town of Kwinana being a Local Authority under the provisions and having adopted the Model By-law Series "A" made under the Act. In pursuance of the powers conferred upon it by the Act and all other powers enabling it, Council resolves to make and publish the following By-law—

1. In these By-laws the Model By-laws Series "A" as amended from time to time adopted by the Town of Kwinana by resolution published in the *Government Gazette* on 28 February 1964 and amended from time to time are referred to as "The Principal By-laws".

2. The Principal By-laws are amended in Part I relating to General Sanitary Provisions by deleting By-law 19 Subsection (3) and (4) and inserting a new By-law 19 Subsection (3) and (4) to read as follows—

(19) (3) The driver of a vehicle upon entering land set aside by Council for the purpose of depositing garbage, refuse, rubbish, waste and other disused material shall be subject to the payment of a fee as follows:

**SANITARY LANDFILL SITE FEES:**

**Item No.**

1. Council may permit owners/occupiers or occupiers of residential premises including rural or special rural premises within the Town of Kwinana to deposit domestic waste from any vehicle not exceeding one tonne capacity comprising of a car utility van or single axle trailer not exceeding 1.8m x 1.2m x 0.6m on not more than four (4) occasions free of charges subject to the production of their current waste disposal entitlement card issued by the Town of Kwinana ..... free
2. Any vehicle not exceeding one tonne capacity comprising of a car, utility van or trailer with dimensions of not more 1.8m x 1.2m x 0.6m to deposit domestic commercial or trade waste from any premises without a current waste disposal entitlement card issued by the Town of Kwinana ..... \$10.00
3. General waste:
  - 3.1 Domestic, putrescible or similar commercial waste ..... \$25.00 p/tonne
  - 3.2 Bricks rubble scalpings sand ..... \$25.00 p/tonne
  - 3.3 Tree lopping, vegetation, garden waste ..... \$21.00 p/tonne
  - 3.4 Minimum charge per entrance to the Thomas Road Landfill site for general waste under item 3 ..... \$25.00

In the event of any material being deposited as detailed in By-law 19(3) item 3.1 to 3.3 inclusive being mixed, the higher rate will apply.
4. Motor Vehicle Bodies:
  - 4.1 Truck bodies from commercial or industrial undertakings cut into three or four pieces ..... \$80.00
  - 4.2 Truck bodies from commercial or industrial undertakings uncut ..... \$130.00
  - 4.3 Car bodies from any premises when a free recycling service is provided to Council for the disposal of vehicle bodies from within the Town of Kwinana upon the production of a current waste entitlement card ..... \$5.00
  - 4.4 From any premises and when there is no free of charge recycling service provided to Council ..... \$65.00
5. Tyres:
  - 5.1 Car tyres per tyre un-shredded ..... \$5.00
  - 5.2 Truck tyres (road vehicles) per tyre un-shredded ..... \$20.00
6. Special burials:
 

In addition to the charges set out in the above items the following charges apply for special burials—

  - 6.1 Asbestos waste delivered in a trailer of dimensions not more than 1.8 metres by 1.2 metres by 0.6 metres correctly wrapped in plastic ..... \$20.00

9. Materials for deposit which require special disposal procedures will be subject to an extra fee above that stipulated under By-Law 19(3) Item 3—General waste will be determined by the Principal Environmental Health Officer of the Town of Kwinana.
10. Where any material being deposited is in the opinion of the Principal Environmental Health Officer of the Town of Kwinana suitable for the operation of the Sanitary Landfill Site and is required at the time for such purposes the scheduled fee may be waived by the Officer.
11. Council may permit owners/occupiers or occupiers of residential premises including Rural or Special rural premises within the Town of Kwinana to deposit domestic waste suitable for recycling from a car, utility, van or single axle trailer not exceeding either 1.8m x 1.2m x 0.6m or one tonne free of charge at the Recycling Depot located at the Thomas Road Sanitary Landfill site.
12. Council may permit owners/occupiers or occupiers of residential premises including Rural or Special rural premises within the Town of Kwinana to deposit non-contaminated segregated domestic green waste suitable for greenwaste recycling from a car, utility or van or single axle trailer not exceeding 1.8m x 1.2m x 0.6m free of charge at the Greenwaste Recycling Depot located at the Thomas Road Sanitary Landfill site.
13. Where in the opinion of the Principal Environmental Health Officer waste material taken into the Recycling Depot is unsuitable for either general or greenwaste recycling, the Principal Environmental Health Officer, or any other authorised officer or employee of Council may direct the waste to be deposited at the Thomas Road Sanitary Landfill Site and the appropriate scheduled fees shall be paid.
14. When in the opinion of the Principal Environmental Health Officer the waste material is not of a type or nature which is suitable for disposal at the Thomas Road Landfill Site the Principal Environmental Health Officer may direct the waste to be disposed of at another approved Sanitary Landfill Site on advice from the Health Department of Western Australia.
15. Weighbridge Breakdown
- In the event of the Sanitary Landfill site weighbridge breaking down due to power failure, maintenance, repairs or being inoperative for any other reason the following fee shall apply in lieu of item 3.
- (1) All other vehicles carrying non-compacted waste \$15.00 per wheel of a truck or trailer.
  - (2) All other vehicles carrying compacted waste \$20.00 per wheel of the truck and/or trailer.

(19) (4) Any person who fails to pay the fees set out in By-law 19 subclause (3) or is loitering on the Thomas Road Sanitary Landfill site at any time or trespassing on the site outside normal operating hours, or when visiting the site fails to comply with any instruction given by a Environmental Health Officer or any other authorised officer or employee of Council, commits an offence.

**LOCAL GOVERNMENT ACT 1960**  
*City of Rockingham*  
Model By-laws Series "A"  
General Sanitary Provisions—Part 1  
Mobile Rubbish Carts—By-laws

Pursuant to the provisions of the Health Act 1911 the City of Rockingham, being a local authority within the meaning of the Health Act 1911, having adopted the Model By-laws described as Series "A" made under the Health Act 1911 and as reprinted pursuant to the Reprinting of Regulations Act 1954 in the *Government Gazette* on 17 July 1963 and as amended from time to time, has resolved and determined that the adopted by-laws shall be amended as follows—

1. The principal by-laws are amended by deleting by-laws 10, 12, 13, 14, 15, 15A and 16 of Part 1 and substituting the following:

10. All vehicles used by the local authority or its contractor in carrying out of sanitary services shall be daily cleansed and shall be maintained in such a condition as not to be offensive.

12. Interpretation:

In this by-law and by-laws 13, 14, 15 and 16, unless the context requires otherwise:

"Council" means the Council of the municipality of the City of Rockingham.

"building line" has the meaning given to it in and for the purposes of the Local Government Act 1960.

"clinical waste" means any materials derived from the operation of Medical and veterinarian practices and hospitals.

"collection day" means the collection day from time to time notified to the occupier of premises upon which rubbish and refuse is collected and removed by the Local Authority or its contractor.

"commercial waste" means refuse and other rubbish generated by or emanating from other premises and includes trade waste.

"domestic waste" means refuse and other rubbish generated by or emanating from residential premises and includes house refuse.

"Manager Technical Services" means the Manager Technical Services of the local authority.

"other premises" means premises used for other than residential purposes.

"Principal Health Surveyor" means the Principal Health Surveyor of the local authority.

"receptacle" means—

- (a) in the case of residential premises, a polyethylene cart fitted with wheels, a handle and a lid, a capacity of 240 litres, supplied by the local authority or its contractor, or other type of receptacle specified or approved by the Manager Technical Services.
- (b) in the case of other premises a rubbish receptacle approved by the Manager Technical Services.

"residential premises" means premises used for residential purposes.

"street alignment" has the meaning given to it in and for the purposes of the Local Government Act 1960.

13. Refuse to be deposited in Receptacles.

- 1. The occupier of every premises, where a receptacle has been provided shall:
  - (a) subject to paragraph (c) hereof cause all household refuse and rubbish to be deposited in the receptacle;
  - (b) at all times keep the lid of the receptacle tightly closed except when depositing refuse or cleaning the receptacle.
  - (c) not deposit or permit to be deposited in the receptacle
    - (i) not more than 70kg of refuse at any one time.
    - (ii) any material being or consisting of:
      - A. hot or burning ashes;
      - B. oil;
      - C. liquid;
      - D. paint;
      - E. solvent;
      - F. bricks, concrete, earth or other like substances;
      - G. clinical waste.
    - (iii) heavy material.
    - (iv) an object which is greater in length, width or breadth than the corresponding dimensions of the receptacle or which will not allow the lid of the receptacle to be tightly closed.
    - (v) refuse which is likely to become offensive or a nuisance or to give off an offensive or noxious odour or to attract flies or cause fly breeding unless it is first wrapped in absorbent or impervious material or placed in a sealed impervious container;
  - (d) except for collection keep the receptacle on the premises located behind the building line or in a position approved by the Manager Technical Services.
  - (e) collection of refuse shall be once weekly commencing at 6.30am on the advised collection day. Prior to this time, the occupier shall:
    - (i) at kerbside facing squarely to the kerb or road on the day of collection and so as not to cause an appreciable interference to public use of the road or footpath.
    - (ii) after the contents of the receptacle have been removed, the receptacle on that day shall be replaced on the premises behind the building line.
  - (f) at all times keep the receptacle clean and whenever directed by a Health Surveyor, cleanse and disinfect the receptacle.
  - (g) notify the local authority within seven (7) days after the event if the receptacle is lost, stolen, damaged or becomes defective.
  - (h) pay to the local authority any costs associated with theft or damage to the receptacle whilst the receptacle is located on private property.
  - (i) not mark or disfigure the receptacle in any manner other than by the placement of a street or unit number upon it in numerals no higher than 100 mm in the manner approved by the Manager Technical Services.
  - (j) not use the receptacle for any purpose other than the collection and storage of refuse and rubbish.

2. In the case of premises used for multi-residential, commercial or industrial purposes the local authority may require the use of a receptacle or receptacles other than a polyethylene cart fitted with wheels and a handle and the occupier of those premises shall comply with and observe the directions given by the Manager Technical Services.
3. The occupier of every premises in the district who is required under sub-by-law (2) of this by-law to use a receptacle other than a polyethylene cart fitted with wheels and a handle shall—
  - (a) cause all refuse to be deposited in a receptacle in a manner which is compatible with the type of receptacle used;
  - (b) take all reasonable steps to prevent fly breeding in and emission of offensive or noxious odour from the receptacle;
  - (c) cause the receptacle to be located on the premises in a position approved by the Manager Technical Services;
  - (d) at all times keep the receptacle clean and whenever directed by a Health Surveyor cleans and disinfect the receptacle.
4. The Manager Technical Services may direct that refuse derived from the manufacture, preparation or sale of food or any putrescible waste from premises, be collected and removed more often than once per week.

#### 14. Ownership of Receptacles.

A receptacle supplied by the local authority or its contractor remains the property of the local authority or its contractor as the case may be.

#### 15. Collection of Refuse.

1. A person shall not unless he is authorised by the local authority to do so remove any house or trade refuse or other rubbish from any premises in the district.
2. Where Council provides approval pursuant to By-law 15(1) hereof such rubbish or refuse shall be disposed of at a refuse site approved by the Executive Director, Public Health pursuant to the provisions of the Health Act 1911.
3. The local authority or its contractor shall ensure that all household and food refuse and putrescible and offensive waste are removed and disposed of at least once per week.
4. The local authority or its contractor shall cause all refuse and rubbish collected and removed to be taken to and disposed of at a refuse disposal site approved by the Executive Director, Public Health under the Act.

#### 16. Prescribed Area—Section 112A.

The area described in the Schedule hereto is prescribed as the area within which the provisions of Section 112A of the Act shall operate and have effect.

The whole of the District of the City of Rockingham.

2. By-law 18 of Part 1 of the principal by-laws is amended by deleting 'cart' in line 2 and substituting 'collection vehicle'.

## POISONS ACT 1964

## POISONS AMENDMENT REGULATIONS (NO. 4) 1993

Made by His Excellency the Governor in Executive Council.

**Citation**

1. These regulations may be cited as the *Poisons Amendment Regulations (No. 4) 1993*.

**Commencement**

2. These regulations shall come into operation on the day that is one month after the day on which these regulations are published in the *Government Gazette*.

**Principal regulations**

3. In these regulations the *Poisons Regulations 1965\** are referred to as the principal regulations.

*For amendments to 1 September 1993 see Gazettes of 28 May, 25 June and 9 July 1993.*]

**Regulation 44 amended**

4. Regulation 44 of the principal regulations is amended in subregulation (1) by deleting "or to the effect of Appendix B or in any other form".

**Regulation 44A inserted**

5. After regulation 44 of the principal regulations the following regulation is inserted —

“

**Destruction of drugs of addiction**

44A. (1) Subject to subregulations (2) and (3) a person authorized to manufacture, distribute, procure, sell or possess a drug of addiction (other than a person who possesses a drug of addiction under a prescription from a medical practitioner, dentist or veterinary surgeon) shall not wilfully destroy that drug of addiction.

(2) Subject to regulation 31 a drug of addiction may be destroyed by —

(a) or under the personal supervision of a person authorized by the Minister under section 54 (1) of the Act; or

(b) a police officer acting under the *Misuse of Drugs Act 1981*.

(3) Subject to regulation 31 a person referred to in subregulation (1), other than a person to whom subregulation (2) applies, who seeks to destroy a drug of addiction shall carry out that destruction under the supervision of a witness selected, in accordance with subregulation (7), from any of the following categories —

(a) pharmaceutical chemists authorized to possess and supply Eighth Schedule drugs;

- (b) medical practitioners authorized to supply Eighth Schedule drugs; and
- (c) directors of nursing.

(4) A person who destroys a drug of addiction in accordance with subregulation (3) shall maintain a register in ink, and enter at the time of destruction —

- (a) the date of destruction;
- (b) the reasons for destruction and the name, strength and quality of the destroyed drug,

and the person and witness shall each sign the entry.

(5) A pharmaceutical chemist required to provide a monthly return under regulation 52C shall, as part of the return, provide details of the entries recorded in the register, maintained in accordance with subregulation (4), for the relevant period.

(6) Where the monthly return referred to in subregulation (5) is made —

- (a) on the original of the approved duplicate form, the details shall be entered by the person who destroyed the drug of addiction and that person and the person who supervised the destruction shall each sign the entry;
- (b) on the original of the completed printout of the approved computerised recording system, the details shall be accompanied by the name of the person who destroyed the drug of addiction and that of the witness who supervised the destruction of the drug.

(7) For the purposes of subregulation (3) a witness shall not be a member of the same category as that of the person who seeks to destroy the drug of addiction.

Note: Boundary firebreaks are not compulsory within the Shire of Woodanilling rural area for a 12 month trial period but landholders are encouraged to provide breaks.

**2. TOWNSITE LAND**

During the period from the 1st November, to the 31st March inclusive you shall have firebreaks in the following positions:

- 2.1 All blocks less than 2.0 hectares shall have the whole of the land grazed or mowed to the satisfaction of the local Bushfire Control Officer.
- 2.2 Where the area of land exceeds 2.0 hectares a firebreak of not less than 2.5 metres in width immediately inside and around all external boundaries of the land.

**GENERAL INFORMATION**

If it is considered impracticable for any reason to clear firebreaks on the land as required by this notice you may apply to Council or its duly authorised officer in writing for permission to provide firebreaks in alternative positions or to take alternative action to abate fire hazards on the land. If permission is not granted by Council or its duly authorised officer you shall comply with the requirements of this notice.

Note: Duly authorised officer is the Shire Clerk and Bushfire Control Officer of the brigade area concerned.

**PENALTY**
