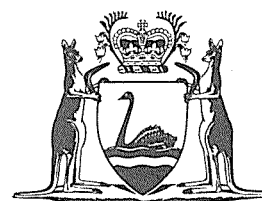

**CONSERVATION AND LAND MANAGEMENT ACT 1984**  
**PROPOSED MANAGEMENT PLAN FOR SOUTH-WEST STATE FORESTS AND TIMBER RESERVES**

Public Submissions Invited

The Lands and Forest Commission through the agency of the Department of Conservation and Land Management has prepared a proposed management plan for South-West State forests and timber reserves.

The plan is essentially concerned with the management of State forests and timber reserves for conservation, recreation, timber production on a sustained yield basis, water catchment protection and other compatible uses. The plan also makes recommendations with respect to other specified land areas, including national park, nature reserve, conservation park and land reserved in accordance with section 5(g) of the CALM Act, and propose a number of changes of tenure, mostly from State forest to national park, conservation park and nature reserve.

After publication of the proposals in February 1992 there was a formal assessment in accordance with the provisions of the Environmental Protection Act 1985 ("EPA Act").

Pursuant to section 58 of the CALM Act any person may make written submissions on the proposed management plan within the time and at the place specified below.

Management Strategies for the South-West Forests of Western Australia—A Review. Draft for Public Comment (February 1992)

**FISHERIES****FI401****PEARLING ACT 1990**

In accordance with the Pearling Act 1990, the Western Australian Fisheries Joint Authority has determined the following resolution in relation to the further allocation of pearl oyster licences and quotas for zone 1 of the Western Australian pearl oyster fishery.

"The Western Australian Fisheries Joint Authority, by this Resolution, determines that—

- (a) the following order of preference in the allocation of pearl oyster licences and quotas in Zone 1 of the Western Australian pearl oyster fishery is approved—
  1. Morgan & Co Pty Ltd (an existing operator with a farm in Zone 1)—10 units; subject to the condition that it conforms to strict performance criteria on the percentage of shell seeded to round pearl; ie that the percentage is to at least equal the industry average;
  2. Larard family—15 units; new pearl farm lease;
  3. Dampier Pearling (Crane and Arrow)—15 units; new pearl farm lease; subject to the conditions that—
    - (i) the quota be retained in Zone 1, and
    - (ii) that a hatchery development be undertaken in Zone 1;
  4. Exmouth Pearls (MG Kailis Group)—15 units; new pearl farm lease; subject to the conditions that—
    - (i) the quota be retained in Zone 1, and
    - (ii) that a hatchery development be undertaken in Zone 1;
  5. Cossack Pearls (Brady & Barker)—an existing operator with existing quota and a farm within Zone 1—5 units;
  6. Kempthorne family—first reserve;
  7. Toombridge Pty Ltd (Male & Johnson)—second reserve;
  8. Northwest Pearls Pty Ltd—third reserve;
- (b) it is stipulated that, if either Dampier Pearling or Exmouth Pearls does not accept the condition applicable to its allocation, then the allocation shall be withdrawn and an allocation with the same condition shall be offered to the Kempthorne family and other reserve applicants in the order specified above; and

- (c) the Selection Committee's views about the allocation of quota to Clipper Holdings Pty Ltd and Maxima Pearling Company Pty Ltd, as set out on page 6 of its Report of 25 May 1992, shall be referred for deliberation by the Western Australian Pearling Industry Advisory Committee at its first meeting following the date of this decision for the purpose of making an appropriate recommendation to the Joint Authority.

6. Shall not be used for the processing of marron (*Cherax tenuimanus*) unless a licence is held under Section 39C of the Fisheries Act 1905.
7. Live koonacs and/or yabbies shall not be purchased from any person other than a person authorised under Part V of the Fisheries Act 1905.
8. Shall not be used to process koonacs and/or yabbies other than by cleaning and packing whole.
9. Shall not consign package koonacs or yabbies unless each container is marked with the species it contains, the place of packaging and the destination of the consignment.

In accordance with the provision of Section 35K, any person aggrieved by this decision may, within fourteen days after publication of this notice, appeal against the decision or order by serving on the Minister for Fisheries a statement, in writing on the grounds of their appeal.

Requirements to Clear Firebreaks**

Pursuant to the powers contained in section 33 (1) of the Bush Fires Act you are hereby required to plough, cultivate, scarify, burn or otherwise clear firebreaks on all land owned or occupied by you by the 1 November 1993 and thereafter to keep these firebreaks clear of all flammable material until 15 March 1994.

Firebreaks are required in locations and to the specifications detailed below:

- (d) Haystacks must not be located closer than 20 metres to an external boundary. They shall be surrounded by a 10 metre wide firebreak situated between 10 and 20 metres distant from the stack.
- (e) Stored fuel, oil and flammable materials shall be protected from fire as prescribed in the Explosives and Dangerous Goods Act 1961 and the Flammable Liquids Regulations 1967.

**Rural Land**

- (a) Firebreaks 3 metres wide shall be constructed immediately inside and adjoining all property boundaries.
- (b) Firebreaks 3 metres wide shall be constructed immediately surrounding all buildings.
- (c) Firebreaks 3 metres wide shall be constructed between 10 and 20 metres distant from and surrounding all haystacks.
- (d) Firebreaks 3 metres wide shall be constructed immediately surrounding all areas of crop.
- (e) Stored fuel, oil and flammable materials shall be protected from fire as prescribed in the Explosives and Dangerous Goods Act 1961 and the Flammable Liquids Regulations 1967 and which include that a firebreak 6 metres wide will be provided immediately surrounding storage areas.

**General**

If for any reason it is considered by the owner or occupier of land that it is impractical to comply with the requirements of this notice a request may be made to the Council to approve alternative fire protection measures. Such application shall be accompanied by a sketch or drawing of the proposed variations and should be lodged at the Council Offices not later than 31 October 1993.

Where approval of a proposed variation is not granted by Council you shall comply with the requirements of this notice.

The penalty for non-compliance with this notice is a maximum of \$1 000 and notwithstanding prosecution, Council may enter on the land and carry out the requisite works at the owner/occupiers expense.

## DANGEROUS GOODS AMENDMENT REGULATIONS (NO. 3) 1993

Made by the deputy of the Governor in Executive Council.

## Citation

1. These regulations may be cited as the *Dangerous Goods Amendment Regulations (No. 3) 1993*.

## Principal regulations

2. In these regulations the *Dangerous Goods Regulations 1992\** are referred to as the principal regulations.

FREEDOM OF INFORMATION REGULATIONS 1993

Made by the deputy of the Governor in Executive Council under section 112 of the *Freedom of Information Act 1992* and section 25 of the *Interpretation Act 1984*.

## Citation

1. These regulations may be cited as the *Freedom of Information Regulations 1993*.

**Commencement**

2. These regulations come into operation on the day on which section 10 of the *Freedom of Information Act 1992*\* comes into operation.

[\* *Act No. 76 of 1992.*]

**General provisions relating to charges**

3. For an applicant who is —

- (a) impecunious, in the opinion of the agency to whom the application is made; or
- (b) the holder of a currently valid pensioner concession card issued on behalf of the Commonwealth to that person, or any other card which may be prescribed as being a pensioner concession card under the *Rates and Charges (Rebates and Deferments) Act 1992*,

the charge payable under regulation 5 is reduced by 25%.

**Application fee (section 12 (1) (e))**

4. The fee in column 2 of item 1 of the Schedule is prescribed as the application fee payable under section 12 (1) (e) of the Act.

**Charges (section 16 (1))**

5. The charges set out in column 2 of item 2 of the Schedule are prescribed as payable under section 16 (1) of the Act for the purposes set out opposite those charges in column 1 of that item.

**Advance deposits (section 18 (1) and (4))**

6. The amount or rate set out in column 2 of item 3 of the Schedule is prescribed as the amount or rate of an advanced deposit which may be payable under section 18 of the Act in the circumstances set out opposite those amounts or rates in column 1 of that item.

**“Suitably qualified person” defined (section 28)**

7. For the purposes of section 28 of the Act —

“suitably qualified person” means a medical practitioner within the meaning of the *Medical Act 1894*.

**Information or details to be included in a complaint (section 66 (1) (d))**

8. For the purposes of section 66 (1) (d) of the Act, a complaint made against an agency's decision under section 65 (1) of the Act is to be accompanied by a copy of the agency's notice of its decision, unless the decision complained of is the result of the non-receipt of a decision under section 13 (2) of the Act.

**GAMING COMMISSION AMENDMENT REGULATIONS (No. 5) 1993**

Made by His Excellency the Governor in Executive Council.

**Citation**

1. These regulations may be cited as the *Gaming Commission Amendment Regulations (No. 5) 1993*.

**Regulations 18A and 18B inserted**

2. After regulation 18 of the *Gaming Commission Regulations 1988*\* the following regulations are inserted—

“ **Regulation of certain gaming machines**

18A. (1) The possession or use of a gaming machine that is—

- (a) a machine of the kind generally known or described as a "Skilltester" or "Merchandiser" machine;
- (b) a display case machine containing prizes that is in the nature of, or similar to a machine referred to in paragraph (a); or
- (c) a machine played by inserting a coin into the machine and operating a mechanical assembly to pick up or otherwise convey a prize to the player,

is unlawful unless the conditions in subregulations (2), (3), (4) and (5) are met.

- (2) A gaming machine may only be located in—

- (a) an amusement centre;
- (b) an arcade;
- (c) a shopping centre; or
- (d) a mall.

- (3) The maximum amount which may be charged per game for a machine is \$5.00.
- (4) The prizes which may be won by using a gaming machine must be prizes in the nature of goods and not money.
- (5) The maximum retail value of a prize which may be won using a gambling machine is \$50.00.

**Regulation of certain games used for gaming**

18B. (1) The possession or use of a game the playing of which can result in vouchers being dispensed, at the conclusion of a sequence of play, that may be exchanged for prizes is unlawful unless the conditions in subregulations (2), (3), (4) and (5) are met.

(2) A game may only be located in—

- (a) an amusement centre;
- (b) an arcade;
- (c) a shopping centre; or
- (d) a mall.

(3) The maximum amount which may be charged per sequence of play is \$5.00.

(4) The maximum value of the voucher or vouchers which may be dispensed per sequence of play must not exceed a value which is 10 times the amount charged per sequence of play for that game.

(5) The prizes which may be won by exchanging a voucher or a number of vouchers must be prizes in the nature of goods and not money.

(6) The maximum retail value of a prize which may be won by exchanging a voucher or a number of vouchers is \$500.00.

(7) In this regulation, "voucher" includes a ticket, a token, or any other symbolic item of exchange. "
