**PROHIBITION OF ENTRY INTO A SAFETY ZONE**

I, Ian Fraser, Director, Petroleum Division of the Department of Minerals and Energy of the said State by instrument of delegation dated the 2nd day of March 1993, and pursuant to Section 119 of the above Act, hereby prohibit all vessels other than vessels under control of the registered holders of Exploration Permit EP-342 from entering or remaining in the area of the safety zone without the consent in writing of the Director, Petroleum Division. This safety zone extends to a distance of five hundred metres, measured from one point of the outer edge of the “Ron Tappmeyre” mobile offshore drilling unit, whilst conducting petroleum operations at the “Mydas” well location (latitude 21° 45' 07.61" S, longitude 114° 22' 40.10" E) and the “Hawksbill” well location (latitude 21° 41' 23.39" S, longitude 114° 31' 44.35" E).

Where an unauthorised vessel enters or remains in the safety zone specified in contravention of this instrument, the owner and the person in command or in charge of the vessel are each guilty of an offence against Section 119 of the Act and are punishable, upon conviction, by a fine not exceeding \$100 000 or imprisonment for a term not exceeding 10 years, or both, pursuant to Section 119 (3) of the Act.






