




Notice is hereby given that the Hon Kevin Minson MLA, Minister for the Environment, has approved the management plan titled Forest Management Plan 1994-2003.

The Forest Management Plan 1994-2003 is a management plan for State forests, timber reserves and certain other reserves in the Department of Conservation and Land Management's Swan, Central and Southern Forest Regions.

Notice is also hereby given that—

- (a) the management plan specifies that the State forests and timber reserves it applies to will be managed, jointly and severally, for the following combination of purposes—
- (i) conservation;
 - (ii) recreation;
 - (iii) timber production on a sustained yield basis;
 - (iv) water catchment protection; and
 - (v) other purposes being purposes prescribed by the regulations;

(b) the Minister has made no modifications under section 60 (2) of the Conservation and Land Management Act 1984 to the proposed management plan submitted to him by the Lands and Forest Commission;

ABROLHOS ISLANDS AND MID WEST TRAWL LIMITED ENTRY FISHERY AMENDMENT NOTICE (No. 2) 1994

Made by the Minister under section 32.

Citation

1. This notice may be cited as the *Abrolhos Islands and Mid West Trawl Limited Entry Fishery Amendment Notice (No. 2) 1994*.

Principal notice

2. In this notice the *Abrolhos Islands and Mid West Trawl Limited Entry Fishery Notice 1993** is referred to as the principal notice.

Clause 10 amended

3. Clause 10 of the principal notice is amended—

(a) in subclause (1) by inserting after "Item 2" the following—

" or Item 4 ";

(b) in part (i) of subclause 2 (a) by deleting " 12.8 " and substituting " 14.62 ";

(c) in part (a) of subclause (4) by inserting after "Item 2" the following—

" or Item 4 "; and

(d) by inserting after subclause (5) the following subclause—

" (6) A boat, when being operated in the waters described in Item 2 or Item 4 of the Schedule, shall not be used to take, or attempt to take, prawns or scallops with more net measured at the headrope than the amount specified in gear units on the licence for that boat ".

Clause 12 repealed and substituted

4. Clause 12 of the principal notice is repealed and the following clause substituted—

" 12. (1) No person shall take, or attempt to take prawns or scallops in the waters described in Item 2 of the Schedule during the period commencing on 1 July in any year and ending on 4 April in the following year.

(2) No person shall take, or attempt to take, prawns or scallops in the waters described in Item 3 of the Schedule during the period commencing on 1 November in any year and ending on 23 March in the following year.

(3) No person shall take, or attempt to take, prawns or scallops in the waters described in Item 4 of the Schedule during the period—

(a) commencing on 11 April, or on an earlier day if declared in writing by the Minister, in any year and ending on 23 March in the following year; or

(b) commencing at 1800 hours on any day to 0600 hours on the following day commencing on 24 March in any year and ending on 10 April, or on an earlier day if declared in writing by the Minister, in the same year.

(4) Unless otherwise authorised in writing by the Minister, no person shall take, or attempt to take prawns or scallops in the waters described in Item 5 of the Schedule ".

Clause 12A inserted

5. After clause 12 of the principal notice, the following clause is inserted—

“ Stowage of otter boards and otter trawl nets

12A. Unless otherwise approved in writing by the Minister, otter boards, trawl wires and otter trawl nets carried on or attached to any boat shall be secured out of the water and inside the gunwale of the boat at any time the boat is in a part of the Fishery closed to the taking of prawns or scallops ”.

Clause 13 amended

6. Clause 13 of the principal notice is amended in part (b) of subclause (1) by deleting “one gear unit” and substituting the following—

“ one half of one gear unit and that any transfer of more than one half of one gear unit shall be in multiples of one half of one gear unit ”.

Schedule amended

7. The Schedule to the principal notice is amended—

(a) by repealing Item 1 and substituting the following Items—

“ Item 1. All the waters of the Indian Ocean between 27°51' south latitude and 29°03' south latitude on the landward side of the 200 metre isobath. ”; and

(b) by deleting Item 4 and substituting the following items—

“ Item 4. The waters of the Indian Ocean bounded by a line commencing at the intersection of 28°31' south latitude and 114°11' east longitude; thence due east to the intersection of 28°31' south latitude and 114°17' east longitude; thence due south to the intersection of 28°36' south latitude and 114°17' east longitude; thence due west to the intersection of 28°36' south latitude and 114°11' east longitude; thence due north to the commencement point.

Item 5. All the waters of the Fishery not defined in Items 2, 3 and 4 of the Schedule ”.

1. This notice may be cited as the *Trawling Prohibition (Whole of State) Amendment Notice 1994*.

Principal notice

2. In this notice the *Trawling Prohibition (Whole of State) Notice 1992, Notice No. 556** is referred to as the principal notice.

Schedule amended

3. The Schedule to the principal notice is amended by repealing items (3) and (4) and substituting the following items—

“ (3) All the waters of the Indian Ocean bounded by a line commencing at the intersection of 31°43'27" south latitude and the high water mark on the mainland of Western Australia; thence due west along 31°43'27" south latitude to where it intersects with the 200 metre isobath; thence generally in a northwesterly direction along the 200 metre isobath to its intersection with 29°03' south latitude; thence due east along 29°03' south latitude to where it intersects with the high water mark on the mainland of Western Australia; thence generally southeasterly along the high water mark to the commencement point.

(4) All the waters of the Indian Ocean bounded by a line commencing at the intersection of 27°51' south latitude and the high water mark on the mainland of Western Australia; thence west along 27°51' south latitude to where it intersects with the 200 metre isobath; thence generally southeasterly along the 200 metre isobath to where it intersects with 29°03' south latitude; thence east along 29°03' south latitude to where it intersects with the high water mark on the mainland of Western Australia; thence generally northwesterly and northerly along the high water mark to the commencement point. ”

DETERMINATION OF STANDARD RATES OF INTEREST HOMESWEST (STATE HOUSING COMMISSION)

Perth 17 February 1994

Pursuant to Section 42 of the Housing Act 1980, the State Housing Commission by this determination which was approved by the Honourable Minister for Housing on 15 January 1994 fixes the following standard rates of interest to apply in respect of the following classes of loans granted by it.

1. 




