Made by the Minister for Fair Trading.

**Citation**

1. This Order may be cited as the *Petrol Roster Order (No. 3) 1994*.

**Commencement**

2. This Order shall come into operation on 1 May 1994.

**Petrol Roster**

3. Shopkeepers of zoned filling stations specified in the Schedule shall be open during the days and times respectively specified in that Schedule for the sale of fuel and requisites.

**Fuel and Requisites to be sold**

4. All forms of fuel and the following requisites, namely—

- (a) oil;
- (b) lubricants;
- (c) tyres;
- (d) batteries;
- (e) distilled water; and

(f) such other requisites as the shopkeeper has in stock at the filling station,

shall be sold by shopkeepers of the zoned filling stations specified in the Schedule during the days and times so specified.

## By-laws Relating to the Removal of Refuse, Rubbish and Disused Materials

In pursuance of the powers conferred upon it by the abovementioned Act and of all other powers enabling it, the Council of the abovementioned Municipality hereby records having resolved on the 17th day of August, 1993, to make and submit for confirmation by the Governor the following By-laws:

**Citation**

1. These By-laws may be cited as the Shire of Broome By-laws Relating to the Removal of Refuse, Rubbish and Disused Materials.

**Revocation**

2. From the date of coming into operation of these By-laws the By-laws made by virtue of the resolution of the Council of the Municipality of the Shire of Broome adopting By-laws (Relating to Disposing and Removal of Refuse, Rubbish, Litter and Disused Materials) which were published in the *Government Gazette* of the 17th day of August, 1966, are hereby revoked.

**Interpretation**

3. In these By-laws—

“Council” means the Broome Shire Council.

“District” means the District of the Shire of Broome.

4. If there is—

(a) on any vacant land within the district any trees, scrub, undergrowth or rubbish;  
or

(b) on any land within the district any refuse, rubbish, disused materials or unsightly items/objects whether of the same kind or a different kind from that here specified;

which in the opinion of the Council is likely to affect adversely the value of adjoining property, or the health, comfort or convenience of the inhabitants thereof, the Council may cause a notice under the hand of the Shire Clerk to be served on the owner or occupier of such land requiring him, within the time specified in such notice, to clear the land of such trees, scrub, undergrowth or remove such refuse, rubbish, disused materials or unsightly items/objects from such land.

5. Every owner or occupier of land upon whom a notice is served under By-law 4 of these by-laws, shall comply with such notice within the time therein specified or in that time give satisfactory reason why the notice should not be complied with or be given extra time in which to comply and any owner or occupier of land who fails to comply with the terms of the notice so served commits an offence.

6. Where the owner or occupier does not clear the land of such trees, scrub, undergrowth, or remove the refuse, rubbish or disused material or unsightly items/objects as required by a notice given by the Council, the Council is authorised without payment of any compensation in respect thereof to remove it and dispose of it at the expense of and recover in Court of competent jurisdiction, the amount of the expense from the owner or occupier to whom the Notice was given.

**Penalties**

7. Any person who shall commit a breach of any of these By-laws shall be liable to—

(a) a maximum penalty of two hundred dollars (\$200); and

(b) a maximum daily penalty during the breach of thirty dollars (\$30) per day.

**LOCAL GOVERNMENT ACT 1960***Municipality of the Shire of Broome***By-laws Relating to the Control and Management of Council Property**

In pursuance of the powers conferred upon it by the abovementioned Act and of all other powers enabling it, the Council of the abovementioned Municipality hereby records having resolved on the 17th day of August 1993, to make and submit for confirmation by the Governor the following By-laws:

**Citation**

1. These By-laws may be cited as the Shire of Broome By-laws Relating to Control and Management of Council Property.

**Interpretation**

2. In these By-laws, unless the context requires otherwise—

“Clerk” means the Shire Clerk of the Council;

“Council” means the Broome Shire Council;

“Hirer” means the applicant who is granted permission to hire property;

“Municipality” means Shire of Broome;

“Property” means any land, other than street reserves, or building or portion thereof owned by, vested in or otherwise under the care, control or management of the Municipality and includes any trees, shrubs, plants, lawn, or other vegetation, sign, furniture, plant, fittings, effects, cutlery, crockery, glassware or other utensils or materials whether of the same kind as, or a different kind from those here specified on any such land or on or in any such building.

3. Nothing in these By-laws shall be construed to inhibit or preclude employees, contractors or agents of the Council carrying out their normal and lawful duties.

4. Nothing in these By-laws shall be construed to limit the power of the Council to enter into leases for land or buildings, subject to the Act, in such manner and terms as it sees fit.

5. In these By-laws a reference to the Council having the power to do something in its discretion and subject to any condition it thinks fit shall be deemed to include a reference to any officer or committee to whom the Council has delegated the power of doing of the thing exercising such discretion and imposing any condition thought fit.

**Use of Council Property Generally**

6. Subject to other written law, the Council may in its discretion determine the extent of public access to and the activities which may or may not be pursued on its property.

7. The Council may give effect to any determination in respect of the use of its property by publishing notices or erecting signs on the respective property and a person shall not carry on any activity in contravention of any such notice or sign or which otherwise contravenes these By-laws.

8. A person shall not without the permission of the Council, destroy, damage, deface or interfere with or remove any Council property.

9. On Council property a person shall not—

- a. climb upon any wall, building or tree guard or over, under or through any fence or gate designed or installed for the purpose of prohibiting or restricting entry;
- b. enter any place that has been fenced off or otherwise closed to the public;
- c. bathe, swim or wade in or add any dye or chemical to the water of any sump, drain, fountain, pond or lake;
- d. enter, pry, look or loiter in any lavatory, dressing room or building or portion of a building expressly reserved for the use of the opposite sex;
- e. create, commit or take part in any nuisance or disturbance, behave in a disorderly or offensive manner or use indecent language or commit any act of indecency;
- f. climb a tree;
- g. throw or discharge any stone, arrow or other missile, otherwise than at an organised sporting or recreational function conducted with the permission of the Council;
- h. use or operate any device, whether electronic or otherwise, which emits noise of such volume as to cause a nuisance or annoyance to other persons on or near the property;
- i. play or practice the game of golf except on an area set aside for that purpose;
- j. light a fire other than in a fire place provided for that purpose;
- k. destroy, damage, injure, cause harm to, catch, snare or take any animal;
- l. be in a state of intoxication.

10. On Council property, without the permission of the Council to do so, a person shall not—

- a. unlock or unfasten any gate or door;
- b. enter any dressing or training room or use any locker therein;
- c. advertise any thing by any means;
- d. organise, conduct or address a gathering or meeting of persons or organise or take part in a procession or demonstration or carry a placard or notice;
- e. camp, lodge or tarry overnight, or frequent for the purpose of camping, lodging or tarrying;
- f. erect a tent or any other temporary cover for the purpose of entertainment.

11. (1) In this by-law reference to an "animal" does not include a dog.

(2) The Council may set aside property or portion of property as an area upon which a person may ride or drive an animal or into which a person may bring an animal.

(3) A person shall not ride or drive or bring an animal onto any property that has not been set aside for that purpose.

(4) A person shall not ride or drive any animal on property set aside for that purpose in a manner so as to create or become a nuisance.

12. (1) The Council may set aside property as an area on which persons may fly motorised model aeroplanes and the Council may define or limit the days and hours on or during which such model aeroplanes may be flown.

(2) A person shall not fly a motorised model aeroplane on property that has not been set aside for the purpose or other than on day or at a time defined or limited by the Council.

13. (1) The Council may set aside property as a children's playground.

(2) The Council may limit the ages of persons who are permitted to use a playground and may erect a notice to that effect on the playground.

(3) A person over the age specified in a notice erected on a playground, other than a person having the charge of a child or children in that playground, shall not enter or use that playground or interfere with the use of it by a child or children.

#### **Hiring of Council Property**

14. The Council may in its discretion grant permission to hire property or refuse to grant permission to hire or grant permission subject to such conditions as it thinks fit.

15. Unless the Clerk is prepared to accept a later application, every application for permission to hire under this By-law shall be made in writing to the Clerk at least 14 days before the date the property is required and shall specify—

- a. the name and address of the application who seeks to hire the property;
- b. the organisation, if any, the applicant represents;
- c. the property required for hire;
- d. the purpose for which the property is sought for hire;
- e. the date and time the property is sought for hire;
- f. any additional information the Council may require.

16. In the event of two or more applications being made for the hire of the same property for the same date and time the Council may in its discretion determine which, if any, applicant shall be granted permission to hire.

17. The Council may at any time cancel any permission to hire and where it does so the Council shall not be liable to the hirer for any loss or damage sustained.

18. The fees or charges relating to an application for permission to hire any property shall be those set by the Council from time to time under the Act and no permission is valid until the respective amount has been paid in accordance with these By-laws.

19. Subject to by-law 22, on the granting of a permission the hirer shall forthwith pay to the Council 25 per cent of the hire fee payable so as to reserve the hiring of the property for the date and time sought by the hirer.

20. Subject to by-law 22, the hirer shall, at least 7 days prior to the commencement of the term of the hiring, pay to the Council the balance of the hire fee together with such further amounts as may be required by the Council a bond against any damage which may occur during such term of hiring and as a deposit to cover possible excessive cleaning expenses.

21. Where a permission to hire is granted within 7 days of the commencement of the hire term of the hiring the hirer shall forthwith pay to the Council the hire fee together with any bond or cleaning deposit applicable to the hiring.

22. In the event of the permission to hire being cancelled, whether by the Council or the applicant, the whole or any part of the hire fee as may have been paid at the time of such cancellation, other than any amount on bond against damage or deposit to cover cleaning, as may be determined by the Council in its discretion shall be forfeited and any such fee that is not so forfeited shall be refunded by the Council to the applicant.

23. Amounts paid on bond against damage or as a deposit to cover excessive cleaning may be refunded in total or in part after assessment by the Council or its officers of the effect of the hiring on the condition and cleanliness of the property.
24. Subject to these By-laws, the hirer may determine which persons may during the term of the hiring enter the hired property whether land or a building or portion thereof.
25. The hirer of any property shall—
- a. maintain and keep the property in good order;
  - b. ensure that no spirituous liquors, wines, ales or spirits are brought onto or into the property during the term of the hiring except when permitted in writing by the Council;
  - c. be solely responsible for leaving the property in a clean and tidy condition;
  - d. be solely responsible for any damage done to the property and for payment for such damage as may exceed the amount paid on bond for the hiring;
  - e. be solely responsible for the carrying out and compliance with the requirements of these By-laws and other written law applicable to the hiring;
  - f. allow an officer of the Council seeking to enforce these By-laws or any other written law applicable to the hiring or otherwise acting in accordance with any written law or any member of the Police Force free ingress to the property.
26. If, in the opinion of an officer of the Council, all necessary actions have not been taken to comply with the provisions of the Health Act or other written law applicable to the hiring of the property, the Council or its officers may at any time prior to or during the term of the hiring forbid and prevent use of the property.
27. In the event of the use of a property being forbidden or prevented under by-law 26 the hirer shall forfeit the hire fee and any other amounts which may have been paid under these By-laws and the Council or its officers shall not be liable to the hirer for any loss or damage sustained.
28. No person on or in any hired property shall—
- a. damage, mark or deface any part of the property;
  - b. drive any nails, tacks, screws or other such items into any woodwork or walls of a building;
  - c. erect internal or external decorations on a building without written permission of the Council;
  - d. move any furniture, plant or effects from place to place within a building without the permission of the Council and under the supervision of the caretaker or other officer of the Council;
  - e. enter or be allowed to enter while intoxicated;
  - f. use profane or improper language;
  - g. perform offensive impersonations of living persons, or anything calculated to produce a disturbance, riot or breach of peace;
  - h. stand, loiter or cause any obstruction whatsoever in an entrance, exit or passageway of a building.
29. Following the completion of a term of hiring and within such time as may be set by the Council, all equipment or other things belonging to the hirer or the organisation the hirer represents shall be removed from the property or, with the permission of the Council, stored on the property in such storage space as is determined by the caretaker or other officer of the Council.
30. The Council shall not be responsible for damage or breakage to or loss of any equipment or other things not stored in accordance with by-law 29.
31. Where lighting other than the normal lighting on or in a property is required it shall be a condition of hiring that an electrician approved by the Council be in attendance during the term of the hiring and where such electrician is provided by the Council the hirer shall be responsible for payment of all costs incurred by the Council in engaging the electrician.

#### Penalties

32. Any person who contravenes or fails to comply with any provision of these By-laws commits an offence and is liable on conviction to a penalty not exceeding \$500 for each offence.

## LOCAL GOVERNMENT ACT 1960

*Shire of Busselton*

## By-law Relating to Street Lawns and Gardens

In pursuance of the powers conferred upon it by the abovementioned Act, the Council of the abovementioned Municipality hereby records having resolved on the 27th day of October 1993, to make and submit for confirmation by the Governor the following By-law Relating to Street Lawns and Gardens:

1. The By-laws relating to Street Lawns and Gardens published in the *Government Gazette* on the 23rd day of April 1963, together with the amendments thereto published in the *Government Gazette* on the 24th day of April 1975, the 12th day of September 1986 and the 27th day of November 1987 are hereby repealed.
2. In this By-law unless the context otherwise requires:
  - “garden” means an area of a street which is planted, developed or treated otherwise than as a lawn;
  - “carriageway” means a portion of a road that is improved, designed or ordinarily used for vehicular traffic, and includes the shoulders, and areas, including embayments, at the side or centre of the road, used for the standing or parking of vehicles, but does not include a lane, right-of-way or driveway;
  - “Council” means the Council of the Shire of Busselton;
  - “footpath” means that part of a road set apart or constructed for the use of pedestrians and every established footway, pavement, land thoroughfare or any other part off a road set apart for the use of pedestrians;
  - “intersection” means the area comprised within imaginary straight lines joining in succession the points of transection of the property lines to two or more roads that meet each other. Where the property lines are curved at any corner, the point of transection of the property lines shall be regarded as the point on the curve nearest to the point at which those property lines, if extended in straight lines from each end of the curve, would meet;
  - “junction” means that part of a road lying between imaginary straight lines at right angles to the road commencing from the points of transection formed by its own property lines with the property lines of a road which abuts thereon. Where the property lines are curved at any corner, the points of transection formed by the property lines shall be determined in the same manner as is provided in the definition of “intersection”;
  - “lawn” means an area of a street which is planted solely with grass and which comprises no other landscaping feature other than a tree or shrub planted by the Council;
  - “property line” means the boundary between the land comprising a street and the land that abuts thereon.
3. Where before the coming into operation of this By-law a garden has been planted in a street the owner or occupier of the land that abuts on that portion of the street in which that garden is planted shall ensure that the garden complies with the provisions of this By-law but is not required to obtain a permit pursuant to this By-law.
4. (1) A person shall not plant a garden in a street, except pursuant to a permit issued by the Council and then only in conformity with this By-law.
  - (2) The Council shall not issue a permit for the planting of a garden in any portion of a street, except on the application of the owner or occupier of the land that abuts on that portion of the street.
  - (3) A person requiring a permit to plant a garden in a street shall submit to the Council a sketch plan setting out details of the proposed garden and the positions of the proposed garden beds and any trees or shrubs proposed to be planted in relation to the frontage of the carriageway.
  - (4) The owner or occupier of land that abuts on portion of a street may plant a lawn in that portion of the street without obtaining a permit to do so unless the lawn is part of a garden in the portion of the street.
5. A person shall not plant a garden in a street—
  - (a) so that it extends beyond the frontage in respect of which the permit is issued;
  - (b) so that it encroaches on the pavement of a carriageway or a made footpath;
  - (c) that is not graded from the frontage of the land abutting on the portion of the street to the kerb of the carriageway and in accordance with the general ground levels obtained in that street. Earth mounding, rocks or retaining walls or other solid items are not permitted;
  - (d) so that access to any mail box is obstructed.

6. (1) The owner or occupier of land abutting on portion of a street in which a lawn or garden is planted shall ensure that any water pipe laid to that lawn or garden—
  - (a) is laid and kept beneath the surface of the street at a depth of not more than 30cm nor less than 15cm and so that any fitting connected to a pipe does not project above the surface of the lawn or garden;
  - (b) if connected to a public water supply, is laid to comply with the requirements of the body constituted for, and having control of that supply of water in the district;
  - (c) if connected to a private water supply, where passing under road, pavement, made footpaths or crossings, is of galvanised iron, PVC or of copper complying with the Australian Standards for pressure water pipes; and
  - (d) has approved valves, located within the property where they are connected to the water supply and is fitted so as to give complete control of the flow of water from that supply.
- (2) Where a person, in the course of laying pipes pursuant to this By-law, causes damage to any road, pavement, footpath or crossing, or to any water, gas or sewerage pipes, to any power or telephone cables or to a fire hydrant, that damage may be made good, by the authority having control of the thing damaged, at the expense of that person on whose behalf the pipes were laid, and the amount of that expense may be recovered in any court of competent jurisdiction.
7. A person shall not water a street lawn or garden in such a manner as will, or may, occasion inconvenience to persons using the adjoining carriageway or footpath.
8. (1) A person shall not plant or keep any tree or shrub in a garden in a street if that tree or shrub is of a height exceeding 0.75 metres, if that tree or shrub is within 6 metres of a junction or intersection.
- (2) Nothing in this By-law authorises a person to place or erect any fence, enclosure, rockery or other obstruction on, or about, a lawn or garden in a street.
- (3) Shrubs, ground cover, wood chips are permitted but aggregates and loose gravel are not permitted as a matrix in the street garden.
- (4) Paving in conjunction with landscaping of street verges is permitted in accordance with the following:
  - (a) Paving materials to be used are limited to a maximum of 25% of the verge area excluding driveways if the material is concrete slabs or stabilised gravel and 33% if it is carried out in block or brick work.
  - (b) In all instances if there is no footpath, a 2 metre wide strip parallel and adjacent to the kerb should be provided and this paving should be sufficiently stable for foot traffic and conform to a specification approved by the Council.
9. (1) The Council may at any time by notice in writing to the owner or occupier of land that abuts on portion of a street in which a lawn or garden is planted require that owner or occupier to remove any tree, shrub, water piping or fitting from that lawn or garden and the owner or occupier shall comply with that notice within the time stipulated for compliance therein in the notice.
- (2) If an owner or occupier upon whom a notice has been served pursuant to sub-clause (1) of this clause fails to comply with that notice within the stipulated time, the Council may remove the tree, shrub, water piping or fitting from that lawn or garden referred to in the notice at the expense of the owner or occupier and any expense incurred by the Council in so doing may be recovered from that owner or occupier in a court of competent jurisdiction.
10. (1) The Council or any service authority having access to the road reserve may, without being liable to compensate any person therefore, dig up all or any part of a lawn or garden in a street, for the purpose of carrying out any authorised works.
- (2) A person employed by the Council acting pursuant to this clause shall not disturb a lawn or garden or damage any pipes laid under that lawn or garden to any greater extent that is reasonably necessary for the purpose of carrying out any authorised works.
11. (1) Where the Council for the purpose of carrying out authorised works is of the opinion that the carrying out of those works may be impeded by the existence of piping, under a lawn or garden in a street, it may give notice to the owner or occupier of the land abutting on the lawn or garden to remove the piping, until the completion of the works. Where the owner or

occupier does not comply with the notice within the time stipulated in the notice from compliance therewith the Council may remove the piping at the expense of the owner or occupier, and any expense incurred by the Council pursuant to this clause may be recovered in any court of competent jurisdiction.

- (2) The Council shall not be liable for damage to piping under a lawn or garden in a street, occasioned either in the course of the removal of the piping under the provisions of sub-clause (1) of this clause or in the course of carrying out authorised works.
12. (1) Except as provided in this By-law, a person shall not wilfully damage a lawn or garden in a street.
- (2) Except as provided in this By-law, a person other than the owner or occupier of land that abuts upon portion of a street in which a garden is planted or a person authorised by that owner or occupier shall not remove any flower, plant, or shrub from that garden.
13. The Council shall not be liable for any damage sustaining by a person by reason of, or arising out of, the planting, or existence, of a lawn or garden in a street.
14. A person who commits an offence against this By-law is liable to a maximum penalty of five hundred dollars (\$500) and where the offence is a continuing one to a maximum daily penalty during the breach of fifty dollars (\$50) per day.

**DOG ACT 1976**

*Municipality of the Shire of Koorda*

By-laws Relating to Dogs

In pursuance of the powers conferred upon it by the abovementioned Act and of all other powers enabling it, the Council of the abovementioned municipality hereby records having resolved on 18th September 1991, to make and submit for confirmation by the Governor of the following By-laws.

1. The Shire of Koorda By-laws Relating to Dogs published in the *Government Gazette* dated 12th December 1929, are hereby repealed.
2. In these By-laws the term "Council" shall mean the Koorda Shire Council.
3. The Council may establish and maintain a pound for the impounding of dogs seized pursuant to the provisions of the Dog Act 1976, or these By-laws.
4. A dog seized by the Police or by a person authorised by the Council may be placed in a pound.
5. Where a dog has been seized or placed in a pound, the keeper of the pound or other person authorised by the Council shall, if the owner or person usually in charge of the dog is known to him, forthwith notify such person that the dog has been impounded.
6. If the owner or person apparently acting on behalf of a owner of a dog seized or impounded shall claim such dog, then, upon payment of the fees specified in the First Schedule hereto, together with the prescribed licence fee relating to the dog, if that dog is not licensed, the dog shall be released to such person.
7. The poundkeeper shall be in attendance at the pound for the release of dogs at such times and on such days of the week as shall from time to time be determined by the Council.

8. Any person applying for the release of a dog seized or impounded shall prove to the satisfaction of the poundkeeper or other person authorised by the Council, the ownership of the dog and his authority to take delivery of it. The poundkeeper or authorised person may accept such proof as he considers satisfactory and no person shall have any right of action against him or the Council in respect of the delivery of a dog in good faith.

9. If a dog should not be claimed and the said fees paid within 72 hours of its being seized, or if the dog having a collar around its neck with a registration tag for the current registration period affixed thereto shall not be claimed and the said fees paid within 72 hours of the service of notice upon the registered owner, the poundkeeper or other person authorised by the Council may sell the dog.

10. Upon the sale of a dog, the proceeds of a sale shall be the property of the Council and may be disposed of in such a manner as the Council thinks fit. The owner of a dog sold pursuant to these By-laws shall have no claim against the Council in respect of the proceeds thereof.

11. If within the times mentioned in By-law 9 hereof, or at any time before the destruction of a dog, the dog has not been claimed as aforesaid and the said fees paid, and if no offer has been received for its purchase, the dog may be destroyed.

12. Notwithstanding anything herein contained, but subject to the provisions of subsection (12) of section 29 of the Dog Act 1976, any dog seized or impounded may at any time be destroyed upon the written authority of a registered veterinary surgeon, medical practitioner or health surveyor.

13. If the Council shall destroy a dog at the request of its owner, whether such a dog shall have been seized or impounded or not, the owner shall pay to the Council the fee specified in the First Schedule hereto.

14. Except for a dog used for guiding a blind person or where the Minister has under section 8 (3) of the Dog Act 1976, authorised a person to be accompanied by a specific dog, the owner or person in charge shall prevent that dog from entering or being in any of the following places—

- (1) A public building.
- (2) A theatre or picture gardens.
- (3) A house of worship.
- (4) A public cemetery.
- (5) A shop or other public business premises—excluding a pet shop or premises used for the practice of a registered veterinary surgeon.

15. For the purpose of section 31 and 32 of the Dog Act 1976, the Council dog exercise area shall be as specified in the Fourth Schedule hereto. The exercising of dogs in the dog exercise area shall be subject to the provisions of the Dog Act.

16. Any person liable for the control of a dog who allows that dog to excrete on any street or public place or on any land within the municipality without the consent of the occupier of that land, commits an offence unless the excreta is removed forthwith and disposed of either on private land with consent or the occupier of in such manner as the Council may approve.

17. No person shall—

- (a) unless a poundkeeper or other employee of the Council duly authorised in that regard release or attempt to release a dog from a pound;
- (b) destroy, break into, damage, or in any way interfere with or render not dog-proof any pound;
- (c) destroy, break into, damage, or in any way interfere with or render not dog-proof any dog cart vehicle or container used for the purpose of catching holding or conveying dogs which have been seized.

18. The payment of fees in respect of the seizure, care, detention or destruction of a dog shall not relieve the owner of their liability to penalty under the Dog Act 1976, or the Dog Regulations or these By-laws.

#### Regulation of Licensed Kennel Establishments

19. The occupier of premises shall not unless the premises are licensed as an approved kennel establishment or have been granted exemption pursuant to section 26 (3) of the Act keep or permit to be kept on those premises more than two dogs over the age of three months and the young of those dogs under that age.

20. An application for a licence to keep an approved kennel establishment shall be in the form of the Second Schedule and shall be accompanied by two copies of a plan showing the details and specifications of all kennels and yards appurtenant thereto and showing the distances from the said kennels to the boundaries of the land the subject of the application and all buildings on the said land together with such other information as the Council may require.

21. The occupier of any premises whereon more than two dogs are kept or permitted or suffered to remain and such premises have been approved as a licensed kennel establishment pursuant to these By-laws, shall provide a kennel or kennels which shall comply with the following conditions—

- (1) Each kennel have a yard appurtenant thereto.
- (2) Each kennel and each yard and every part thereof shall not be at any less distance than 10 metres from the boundaries of the land in the occupation of the occupier.
- (3) Each kennel and each yard and every part thereof shall not be at any less distance than 25 metres from any road or street to which the premises has its main frontage. In the case of a corner allotment no part of any kennel or yard shall be at any less distance than eight metres from the side boundary to which the premises has its secondary frontage.
- (4) Each kennel and each yard and every part thereof shall not be any less distance than 10 metres from any dwelling, church, schoolroom, hall, factory, dairy or premises whatsoever wherein food is manufactured, packed, stored or prepared for human consumption.
- (5) The walls shall be constructed of concrete, brick, stone, or timber frame lined on both sides with either contoured fibre cement sheeting or galvanised iron.
- (6) The roof shall be constructed of an approved impervious material.
- (7) All external surfaces of a kennel shall be painted with good quality paint and be repainted when directed by an officer of the Council.
- (8) The lowest internal height shall be at least two metres from the floor.
- (9) Each yard shall be securely fenced and kept securely fenced in such a manner so as to prevent a dog passing over, under or through the fence.
- (10) Gates shall be provided and be fitted with proper catches or means of fastening.
- (11) The upper surface of the floor of each kennel shall be set at least 10 centimetres above the surface of the surrounding ground and shall be constructed of granolithic cement finished to a smooth surface having a fall of not less than one in 100 to a drain which shall be properly laid, ventilated and trapped. All floor washings shall pass through this drain and shall be disposed of in accordance with the health requirements of the Council.
- (12) At least 2.5 square metres of the floor of any yard adjacent to the kennel floor shall be constructed in the same manner as the floor of the kennel.
- (13) For each dog kept therein every kennel shall have not less than two square metres of floor space and every yard not less than 2.5 square metres.
- (14) All kennels and yards and all feeding and drinking vessels shall be maintained in a clean condition and cleansed and disinfected when so ordered by an officer of the Council.
- (15) Each kennel shall be constructed so far as is practicable with materials which prevent or minimise emission of noise therefrom.

22. The occupier of any premises shall maintain any area of those premises frequented or occupied by a dog or dogs in clean condition. Refuse, dog faeces and food wastes must be disposed of daily in an approved manner. Odours, fleas, flies and other vermin must be effectively controlled.

23. The occupier of any premises which have been licensed by the Council as an approved kennel establishment shall not allow, permit or suffer any dog to be at large or roam outside the kennel or exercise yard, except for the purpose of reasonable exercise where a competent person is in proximity to the dog.

24. An application for approval of the Council, for premises to be licensed as an approved kennel establishment shall be made, as set out in the Second Schedule hereto and shall be submitted with two copies of plans, showing the kennels and yards to the boundaries of the lot or lots and all buildings on the subject of the application and other land contiguous thereto and other information as Council may require.

25. No kennel or a kennel establishment or proposed kennel establishment shall be erected for the keeping of dogs unless and until plans, specifications and location plan showing the proposed site for such kennel and of the yard appurtenant thereto have been approved by the Council.

26. Council may not approve or register a kennel establishment until the occupier of the premises has given notice of the intention to establish a kennel upon the premises by—

- (a) not less than one advertisement in a newspaper circulating in the district; and
- (b) given written notice to the owners and occupiers of all adjoining properties at least thirty days before the application is made to the Council.

27. Approved kennel establishments shall be licenced by the Council on receipt of the fee prescribed in the First Schedule. Such licence shall remain in force for one year from the date of issue and shall be subject to annual review before renewal.

28. The fee payable for a licence to keep an approved kennel establishment is that specified in the First Schedule.

29. A kennel licence may be cancelled at any time by the Council if the Council is dissatisfied with the conduct of the establishment.

30. In the event of a person not renewing the kennel registration as provided for in By-law 27 of these By-laws, or the Council refusing to renew the registration if the kennel establishment is not kept in accordance with these By-laws, the said kennel establishment shall not be used for the keeping of dogs.

31. Subject to the Dog Act the Council may in its absolute discretion grant or refuse a licence for the erection and establishment of a dog kennel.

32. Any person who shall commit a breach of any part of these By-laws, shall, upon conviction be liable to a penalty not exceeding \$200.

### LOCAL GOVERNMENT ACT 1960

*The Municipality of the Shire of Waroona*  
By-law Relating to Reserves and Foreshores.

In pursuance of the powers conferred upon it by the abovementioned Act and of all other powers enabling it, the Council of the abovementioned Municipality hereby records having resolved on 24th August 1993 to make and submit for confirmation by the Governor the following by-law—

1. In this by-law unless the context otherwise requires—

“Act” means the Local Government Act 1960;

“Authorised Officer” means an Officer of the Council who is authorised by the Council to serve notices under sections 669C and 669D of the Local Government Act 1960;

“Council” means the Council of the Municipality of the Shire of Waroona;

"Foreshore" means all that land in the Shire of Waroona which lies between the low water mark and the high water mark of the Indian Ocean;

"License" has the same meaning as is given to that word in the Road Traffic Act 1974 and Control of Vehicles (Off Road Areas) Act 1978

"Off Road Vehicle" has the same meaning as is given to these words in the Control of Vehicles (Off Road Areas) Act 1978 (as amended) and which complies with noise and safety standards to qualify for registration in accordance with the Act and Regulations.

"Owner" in relation to a vehicle means the person who is the holder of the requisite vehicle license under the Road Traffic Act 1974 in respect of that vehicle or, if the vehicle is not licensed under that Act, the person who owns the vehicle or is entitled to its possession;

"Reserve" means parklands, squares, reserves, beaches and other lands, included in the Shire of Waroona and set apart for the use and enjoyment of the inhabitants of the Shire and includes parks and other lands acquired for public purposes, and vested in or under the control, or management of the Shire of Waroona;

"Vehicle" has the same meaning as is given to that word in the Road Traffic Act 1974, as amended from time to time, but includes trail bikes, beach buggies and other recreational vehicles licensed or unlicensed, but does not include a wheelchair being used by a physically impaired person.

2. On a Reserve or a Foreshore a person shall not—
  - (a) commit or cause a nuisance;
  - (b) be in a state of intoxication;
  - (c) behave in disorderly manner, create or take part in a disturbance, use foul or indecent language or commit any act of indecency;
  - (d) Undertake any activity deemed illegal by any other Statute.
3. On a Reserve or a Foreshore a person other than a Shire employee executing their normal duties, shall not—
  - (a) throw or discharge any stone, arrow, bullet or other missile;
  - (b) climb over or upon a fence or gate;
  - (c) unlock or fasten a gate, unless authorised by the Council to do so;
  - (d) enter any dressing or training room, or use any locker therein unless authorised by the Council to do so;
  - (e) destroy, damage, injure, or cause harm to any bird or animal;
  - (f) damage or injure any plant, lawn, flower, shrub or tree;
  - (g) cut or damage any soil or turf;
  - (h) climb any tree;
  - (i) deposit or leave any rubbish, refuse, offal, paper, bottles, broken glass, china or litter of any kind whatsoever except in a receptacle provided for the purpose.
4. A person other than an employee of the Council executing their normal duties shall not without the consent of the Council—

ON A RESERVE:

  - (a) drive or ride or bring any vehicle onto a reserve or permit any person to drive or ride or bring any vehicle onto a reserve except on or over such parts of the reserve as are set aside as roads or driveways or vehicle parking areas;
  - (b) park or stand any vehicle on a reserve except in an area set aside for that purpose;

ON A FORESHORE:

  - (c) unless that person is the holder of a current drivers license, drive or ride or bring any vehicle licensed under the Road Traffic Act 1974, onto a foreshore.
  - (d) unless that person is the holder of a current drivers license, drive or ride or bring any off-road vehicle onto a foreshore.
  - (e) drive or ride any vehicle on a foreshore in such a manner as to cause inconvenience or annoyance to any other person.
5. On a foreshore a person shall not—
  - (a) Sell, expose for sale or invite any offer to buy any goods, wares, food, refreshments, fruit or other merchandise or things (whether of the like kind as the foregoing or not) except in an area set apart for the purpose by the Council and then only with the prior consent of the Council.

- (b) Hire, expose for hire or invite any offer to take on hire any vehicle, boat or other vessel or thing (whether of the like kind as the foregoing or not) except in an area set apart for the purpose by the Council and then only with the prior consent of the Council.
6. On a reserve a person shall not without the consent of the Council—
- (a) sell, expose for sale or invite any offer to buy any goods, wares, food, refreshments, fruit or other merchandise or things;
  - (b) play or practice at golf, or strike a golf ball except on an area set aside for that purpose;
  - (c) take part in a procession or demonstration;
  - (d) organise, address or participate in a political meeting or rally;
  - (e) use or install a loud speaker or amplifier;
  - (f) distribute or exhibit any printed or written pamphlet, handbill, placard or notice in any manner whatsoever;
  - (g) stamp, pencil, affix, construct or erect or cause to be stamped, stencilled, affixed, constructed or erected any signboard, hoarding, placard, handbill, notice, advertisement or document whatsoever.
  - (h) light a fire other than in a fire place provided for the purpose;
  - (i) camp, lodge or tarry overnight, or frequent for the purpose of camping, lodging or tarrying overnight;
  - (j) erect a tent or any other temporary cover for the purpose of entertainment or for the display of any merchandise.
7. On a reserve or foreshore a person shall not practice or play in or at any game or sport in such a way as to cause inconvenience or annoyance to any other person.
8. (a) In this clause reference to an "animal" does not include a dog.
- (b) The Council may set aside a reserve or foreshore or portion of a reserve or foreshore as an area upon which a person may ride or drive an animal or onto which a person may bring an animal.
- (c) A person shall not ride or drive or bring an animal onto any reserve or foreshore or any part thereof that has not been set aside for that purpose pursuant to subclause (b) of this clause.
- (d) A person shall not ride, drive, exercise, train or race any animal on any part of a reserve or foreshore set aside under subclause (b) of this clause in a manner so as to create or become a nuisance.
9. (a) The Council may set aside a reserve or foreshore or portion of a reserve or foreshore as an area on which persons may fly mechanically operated model aeroplanes and the Council may define or limit the hours and days during which such model aeroplane may be flown.
- (b) A person shall not fly a mechanically operated model aeroplane on a reserve or portion of a reserve or foreshore that has not been set aside pursuant to subclause (a) of this clause or at a time or on a day defined or limited by the Council under subclause (a) of this clause.
10. (a) The Council may set aside a reserve or portion of a reserve as a children's playground.
- (b) The Council may limit the ages of persons who are permitted to use a playground set aside under subclause (a) of this Clause and may erect a notice to that effect on the playground.
- (c) A person over the age specified in a notice erected on a playground set aside under subclause (a) of this clause, other than a person having the charge of a child or children in that playground, shall not enter or use that playground, or interfere with the use of it by a child or children.
11. A person found on a reserve or foreshore in a state of intoxication or behaving in a disorderly manner, or creating or taking part in a disturbance, or using foul or indecent language, or committing an act of indecency thereon may be forthwith removed from the reserve or foreshore by a member of the Police Force.
12. A person found undertaking in any activity deemed illegal by any other Statute within a reserve or foreshore may be forthwith removed from the reserve by any member of the Police Force.
13. A person who does not do a thing which by or under these by-laws he is required or directed to do and a person who does a thing which by or under this by-law is prohibited from doing, commits an offence.
14. A person who commits an offence against this by-law is liable on conviction, to a maximum penalty of \$500.

15. The modified penalty for an offence against Clauses 4 (a), 4 (b), 4 (c) 4 (d) or 4 (e) if dealt with under section 669D of the Act, is \$50.
16. (a) A notice served under subsection (2) of the section 669C of the Act in respect of an offence against this by-law shall be in or to the effect of Form 2 of the Schedule to this by-law.
- (b) A notice sent under subsection (5) 669D of the Act withdrawing an infringement notice served under that section in respect of an offence against this by-law shall be in or to the effect of Form 3 of the Schedule of the by-law.

**DOG ACT 1976**

*Municipality of the Town of Albany*

**BY-LAWS RELATING TO DOGS (No. 25)**

In pursuance of the powers conferred by the above Act and all other powers enabling it, Council hereby records having resolved on 25 January 1994 to make and submit for confirmation by the Governor the following amendments to its by-laws Relating to Dogs (No.25) as published in the *Government Gazette* dated 28 July 1989 and amended by notices published in the *Government Gazette* dated 6 September 1991.

By-law 25 is amended by—

(1) inserting the following Part after Part 111.

Part IV—Offences Relating to Dogs.

14. A person liable for the control of a dog other than a *bona fide* guide dog accompanied by a visually impaired person or a person engaged in the training of guide dogs, shall prevent that dog from entering or being in any of the places specified in the Fourth Schedule hereto, unless with the written approval of Council or an officer delegated by Council for the purpose.

15. For the purposes of Sections 31 and 32 of the Act, the Council dog exercise areas shall be those places specified in the Second Schedule hereto.

16. A person liable for the control of a dog who permits that dog to excrete on any street or public place or on any land within the district without consent of the occupier of that land commits an offence unless the excreta is removed forthwith and disposed of either on private land with the consent of the occupier or in such other manner as the Council may approve.

17. The owner or occupier of business premises within the District on which a dog is kept shall cause a portion of those premises on which the dog is kept to be separated from areas accessible to the public and have the means capable of confining the dog to that portion.

18. A person who contravenes or fails to comply with any provision of this By-law commits an offence and is liable upon conviction to a penalty not exceeding \$200.00.

19. (a) The offences specified in the Third Schedule hereto are prescribed pursuant to Section 45A(2) of the Act as offences in relation to which a modified penalty applies and the amount appearing directly opposite each such offence is the prescribed modified penalty payable to the offence.

(b) Where a person authorised under the Act has reason to believe that a person has committed an offence against any of the clauses specified in the Third Schedule hereto, he may serve on that person an Infringement Notice in the form prescribed in Form 7 of the Schedule to the Dog Regulations 1976.

(c) An Infringement Notice may be served on an alleged offender personally or by posting it to his address as ascertained from him, at the time or immediately following the occurrence giving rise to the allegation of the offence, or as recorded by Council pursuant to the Act.

(d) Where a person who received an Infringement Notice fails to pay the prescribed penalty within the time specified in the Notice or within such further time as may be allowed, he shall be deemed to have declined to have the allegation therein dealt with by way of a modified penalty.

(e) A person on whom an Infringement Notice has been served may within the time specified in the Notice or such further time as may be allowed, send or deliver to the Council the amount of the prescribed penalty, with or without a statement as to the circumstances giving rise to the allegation in the Infringement Notice, and the Council may thereupon—

(i) appropriate that amount in satisfaction of the penalty and issue an acknowledgment; or

(ii) withdraw the Infringement Notice and refund the amount so paid.

(f) An infringement Notice may, whether or not the prescribed penalty has been paid, be withdrawn by the Council by sending a Notice in the form prescribed in Form 8 of the Schedule to the Dog Regulations 1976 to the alleged offender at the address specified in the Notice or his last known place of residence or business and in that event, any amount received by way of modified penalty shall be refunded and any acknowledgment of the receipt of that amount shall for the purposes of any proceedings in respect of the alleged offence, be deemed not to have been issued.

**BY-LAW 107 RESCISSION OF RESOLUTION**

- (a) all members of the Council who were present at the time the resolution was passed are also present at the time the rescission or alteration is moved;
- (b) the member who proposes the rescission or alteration motion:
  - (i) clearly identifies the resolution to be rescinded or altered; and
  - (ii) clearly states the reason or reasons for seeking the rescission or alteration; and
- (c) a motion to that effect is carried by a simple majority of the members voting on the proposal at the meeting.

107 (2) The Council may rescind or alter a resolution at a meeting after that resolution was passed:

- (a) (i) where notice of the motion to rescind or alter is not given until such meeting, if a motion to that effect is carried by an absolute majority of the members of the Council; or
- (ii) where the member intending to propose the rescission or alteration motion through the Clerk, has given written notice of intention to each of the other members of the Council at least seven days before the meeting, if a motion to that effect is carried by the majority of the members voting on the proposal at the meeting; and
- (b) the member who proposes the rescission or alteration motion:
  - (i) clearly identifies the resolution to be rescinded or altered; and
  - (ii) clearly states the reason or reasons for seeking the rescission or alteration.

**107A IMPLEMENTATION OF SUBSTANTIVE RESOLUTION**

107A (1) A substantive resolution shall not be implemented by the Clerk or any officer of the Council until 12 noon on the first working day, following the Council meeting at which that resolution was passed.

107A (2) Where a notice of motion for rescission or alteration of a resolution is received after the meeting at which the resolution was passed, but before 12 noon on the first working day following that meeting, the substantive resolution shall not be acted upon until the rescission or alteration motion is:

- (a) moved and voted upon by the Council; or
- (b) withdrawn by the member who proposed the rescission or alteration motion.

107A (3) Where a notice of motion for rescission or alteration of a resolution is received after 12 noon on the first working day following the meeting at which that resolution was passed, the Clerk or any authorised officer of the Council may implement the resolution, provided that at the meeting at which the motion to rescind or alter that resolution is to be moved, the Clerk shall inform those present at the meeting:

- (a) that the substantive resolution has not been implemented to any extent and the reasons for such delay; or
- (b) that the substantive resolution has been partially implemented and to what extent; or
- (c) that the substantive resolution has been fully implemented.

## 107B REPEAT RESOLUTIONS

107B (1) A motion to rescind a resolution shall not be moved more than once, at the same meeting.

107B (2) Without affecting the generality of sub by-law (1) of this by-law, no motion to rescind a resolution to rescind shall be accepted.
