### COLLEGES ACT 1978

#### COLLEGE OF CUSTOMISED TRAINING STATUTE

Pursuant to section 26 of the Colleges Act 1978 the Interim Council of the College of Customised Training hereby makes the Statute set out hereunder and authorises the affixing of the Common Seal of the College thereto.

#### Statute 1

##### 1.0 Interpretation

1.1 In this statute unless the contrary intention appears—

- "Chairman" means the Chairman of the Council appointed pursuant to section 20 of the Act, or elected under section 16 of the Act.
- "College" means the College of Customised Training established under the Act.
- "Council" means the Council of the College and includes the Interim Council of the College appointed under section 20 of the Act.
- "Managing Director" means the person appointed or seconded to be the Chief Executive Officer of the College pursuant to section 30 of the Act and includes a person appointed as Acting Managing Director.
- "Member" means a member of the Council.
- "Minister" means the responsible Minister.
- "Rule" means any rule or by-law made under a statute pursuant to section 26 (7) of the Act.
- "Sealed" means sealed with the Seal.
- "Section" means a section of the Statute in which the word is used.
- "Statute" means a Statute of the College made pursuant to section 26 of the Act.
- "The Act" means the Colleges Act 1978.
- "The Seal" means the Common Seal of the College.

## 2.0 Common Seal

### 2.1 The form of the Seal of the College is—



### 2.2 The Managing Director shall keep the seal in strict custody.

### 2.3 Authorisation—

2.3.1 The Seal shall not be affixed to any document except by authority of a resolution of the Council or as authorised by subsection 2.3.2 of this section.

2.3.2 Where a document required to be sealed relates to matters which in the opinion of the Chairman or in his absence, the Deputy Chairman,

(i) do not require prior consideration by the Council

or

(ii) are of an urgent nature,

the Chairman, or Deputy Chairman (as the case may be) may direct that the Seal be affixed to that document.

2.3.3 In the event of the Seal being affixed to any document, pursuant to subsection 2.3.2 of this section, the Chairman, or Deputy Chairman shall report to the Council at the first opportunity stating—

(i) the nature of the document to which the Seal was so affixed; and

(ii) the reason or reasons for his directing that the Seal be so affixed.

### 2.4 Where the Seal is affixed to any document;

2.4.1 The affixing of the Seal shall be carried out in the presence of, and attested by—

(i) the Chairman or Acting Chairman; and

(ii) the Managing Director.

2.4.2 A clause shall be inserted at the end of the document to which the Seal is affixed in the following form—

The Common Seal of the College of Customised Training was hereto affixed by authority of the Council of the College in the presence of—

.....  
Chairman

Managing Director

2.5 The Managing Director shall cause an appropriate officer of the College to establish and maintain a register of the use of the Seal in which that officer shall record in respect of each document to which the Seal is affixed

2.5.1 the nature of the document;

2.5.2 the date on which the Seal was affixed;

2.5.3 the authority for the affixing of the Seal; and

2.5.4 the name and description of each person attesting the affixing of the Seal.

## 3.0 Rules of the College

3.1 The Council may make Rules not inconsistent with the Act or with any statute with respect to—

(a) the management of the College;

(b) the types of contracts, agreements and other legal documents which may be executed by an officer of the College on behalf of the College without use of the seal;

(c) Officers seconded to the College;

- (d) the manner and time of convening, holding and adjourning the meetings of the Council, the manner of voting at those meetings, the powers and duties of the Chairman, the conduct and record of the business, the appointment of committees of the Council and the quorum, powers and duties of those committees;
- (e) the fees to be charged for courses of study or instruction, consultancies and other services or products.
- (f) the control and investment of the property of the College; and
- (g) any matter authorised or directed by the Act to be prescribed by Rules in relation to the College.

3.2 A Rule shall be made by resolution of the Council and shall be sealed with the Seal.

3.3 The Council may by resolution revoke or amend the whole or any part of a Rule. A Rule shall not be revoked or amended unless notice of the intention to move such a motion is placed on the agenda of a meeting of the Council.

3.4 A Rule, the amendment of a Rule or the rescission of a Rule shall be published at the College by posting a copy of it on a notice board in or outside that part of the College building or buildings containing the administration offices of the College for a period of not less than 7 days and shall thereafter be placed in a schedule of Rules to be kept by the Managing Director.

3.5 A Rule shall take effect from the date upon which it is so published unless a later date is specified in the Rules in which event the Rule shall take effect upon that later date.

#### 4.0 Chief Executive Officer

The Chief Executive Officer of the College shall be known by the title "Managing Director", shall be the Chief Executive Officer and the Chief Academic Officer of the College and shall have such powers as are vested in the Managing Director by virtue of the Act, the Statutes, the Rules and the By-laws and any other powers lawfully delegated to the Managing Director by Council from time to time.

#### 5.0 Conduct of Council Meetings

##### 5.1 Council to Meet.

5.1.1 The Council shall hold such meetings as shall be necessary for the exercise of its functions.

5.1.2 The Chairman may at any time convene a meeting of the Council.

5.1.3 Upon the written request of any four (4) members of the Council, the Chairman shall convene a special meeting of the Council to be held within fourteen (14) days of the request. The written request shall set forth the object or objects for which the meeting is required.

##### 5.2 Quorum.

5.2.1 At a meeting of the Council not less than one-half of the total number of members for the time being shall constitute a quorum.

5.2.2 In the event of a quorum not being present within half-an-hour after the time appointed for a meeting, the meeting shall be adjourned to a date not later than fourteen (14) days after the date of such meeting.

##### 5.3 Passage of Resolutions—At a meeting of the Council;

5.3.1 all motions shall be passed on the basis of a simple majority of the valid votes of members present;

5.3.2 when any question voted upon by the Council results in an equal number for and against, the Chairman shall declare the question lost.

##### 5.4 Rescinding of a Resolution.

A resolution of the Council shall not be rescinded unless notice of the intention to propose such rescission is placed on the agenda of a meeting.

##### 5.5 Committees of the Council.

5.5.1 The Council from time to time may;

(i) appoint committees either for general or specific purposes;

(ii) require a committee to advise the Council in respect of any matter or class of matters.

5.5.2 The membership of committees appointed by the Council shall be determined by the Council and may include persons who are not members of the Council.

5.5.3 The Managing Director shall be an *ex officio* member of all committees established by the Council except when specifically excluded by resolution of the Council.

##### 5.6 Delegation of Power.

The Managing Director shall cause an appropriate officer of the College to establish and maintain a register of all resolutions of the Council passed pursuant of section 25 of the Act delegating all or any of the Council's powers, authorities, duties and functions under the Act and of all resolutions revoking any such delegation.

**5.7 Rules of Debate.**

Subject to the provisions of the Statute, the Chairman shall regulate the proceedings of all meetings of the Council.

**HEALTH (ASBESTOS) AMENDMENT REGULATIONS 1994**

Made by the Lieutenant-Governor and deputy of the Governor in Executive Council.

**Citation**

1. These regulations may be cited as the *Health (Asbestos) Amendment Regulations 1994*.

**Principal regulations**

2. In these regulations the *Health (Asbestos) Regulations 1992\** are referred to as the principal regulations.

**Regulation 2 amended**

3. Regulation 2 of the principal regulations is amended by inserting in the appropriate alphabetical position the following definition —

“

**“dwelling-house”** does not include any associated structure or outbuilding that is not an integral part of a dwelling-house's structure;

”.

**Regulation 3 repealed and a regulation substituted**

4. Regulation 3 of the principal regulations is repealed and the following regulation is substituted —

“

**Application**

3. These regulations have effect in all districts.

”.

**Regulation 6 amended**

5. Regulation 6 is amended —

(a) in paragraph (b) by deleting “was” and substituting the following —

“ is ”; and

- (b) by deleting paragraphs (c) and (d) and substituting the following paragraphs —

“

(c) the asbestos cement sheet forms part of a fixture on land when the ownership of that land is transferred to another; or

(d) the asbestos cement sheet forms part of a dwelling-house (whether or not a fixture on land) which is sold or supplied and which, at that time, is not substantially dismantled.

”.

### Regulation 7 amended

6. Regulation 7 of the principal regulations is amended —

- (a) by deleting “or” after subregulation (1) (a);
- (b) by inserting after subregulation (1) (a) the following paragraph —

“

(aa) where, for the purpose of carrying out work under or near an asbestos cement sheet fence, the person dismantles and reinstates the whole or part of the fence within a reasonable time; or

”;

- (c) by deleting subregulation (2) (b) and substituting the following —

“

(b) the use of that asbestos cement sheet as that part of that structure has continued, without the position of the asbestos cement sheet being changed, since these regulations came into operation.

”;

- (d) in subregulation (3) by inserting after “damages,” the following —

“ cuts, ”;

- (e) by deleting subregulation (4) (d) and substituting the following paragraph —

“

(d) not using a high pressure water jet, or compressed air, unless in a manner which adequately prevents asbestos fibres entering the atmosphere and which is approved in writing by the Executive Director, Public Health;

”; and

- (f) by deleting subregulation (4) (e) and substituting the following paragraph —

“

(e) ensuring, so far as is reasonably practicable, that asbestos cement sheet is not broken or abraded;

”.

**Regulation 7A inserted**

7. After regulation 7 of the principal regulations the following regulation is inserted —

“

**Asbestos dwelling-houses**

7A. (1) A person who moves a dwelling-house built wholly or partly with asbestos cement sheet commits an offence unless, in the course of moving it, that part of it built wholly or partly with asbestos cement sheet is not substantially dismantled.

(2) A person shall not cut or deliberately break asbestos cement sheet for the purpose, or in the course of moving, a dwelling-house built wholly or partly with asbestos cement sheet.

”

**Regulation 10 amended**

8. (1) Regulation 10 (2) of the principal regulations is repealed and the following subregulation is substituted —

“

(2) Material containing asbestos in a district other than a district referred to in Schedule 1 shall be disposed of at a place approved in writing as a place for the disposal of material containing asbestos by the local authority of the district.

”

(2) Regulation 10 (3) is amended by deleting “11” and substituting the following —

“ 12A ”.

**Regulations 11 and 12 repealed and regulations 11, 12 and 12A substituted**

9. Regulations 11 and 12 of the principal regulations are repealed and the following regulations are substituted —

“

**Asbestos for disposal to be separated etc.**

11. A person shall not —

- (a) supply material containing asbestos to another for the purpose of having that other person dispose of it; or
- (b) take material containing asbestos to a place referred to in Schedule 2 or 3, or to a place approved under regulation 10 (2),

unless —

- (c) it is separated from other material for disposal where that is reasonably practicable; and
- (d) it is wrapped in plastic so as to prevent asbestos fibres entering the atmosphere, or is contained in such other manner as is approved in writing by the Executive Director, Public Health.

**Duty to notify others of presence of asbestos**

12. (1) A person who supplies material containing asbestos to another for the purpose of having that other person dispose of it shall inform (whether by use of an appropriate label or otherwise) the other person that it is or contains asbestos.

(2) A person who takes material containing asbestos to a place referred to in Schedule 2 or 3, or to a place approved under regulation 10 (2), shall inform (whether by use of an appropriate label or otherwise) the person who operates or controls the place that it is or contains asbestos.

**Executive Director may approve place and manner of disposal in special cases**

**12A.** (1) If satisfied that the circumstances of a particular case warrant the disposal of material containing asbestos at a place other than a place referred to in Schedule 2 or 3, or a place approved under regulation 10 (2), the Executive Director, Public Health may, in writing —

- (a) approve a place for the disposal of the material containing asbestos; and
- (b) give directions as to the manner in which the material containing asbestos is to be transported to and disposed of at that place.

(2) A person who is given an approval under subregulation (1) and who disposes of material containing asbestos —

- (a) at the place approved, does not commit an offence under regulation 10 (3);
- (b) in a manner that is in accordance with it, does not commit an offence under regulation 11.

**Regulation 13 amended**

**10.** Regulation 13 of the principal regulations is amended by deleting “by the Executive Director, Public Health” in the first place where it occurs and substituting the following —

“ under regulation 10 (2) ”.

**Regulation 14 inserted**

**11.** The principal regulations are amended by inserting in Part 5 before regulation 15 the following regulation —

“

**Power to take sample**

**14.** (1) An authorized person may take a sample of any thing which he or she believes on reasonable grounds —

- (a) is asbestos cement sheet or material containing asbestos; and
- (b) is or may be evidence in relation to an offence under these regulations.

(2) When taking a sample, an authorized person shall —

- (a) cause no more damage to property than is reasonably necessary;
- (b) divide the sample into 3 separate parts and package and label them appropriately;
- (c) give one part to the person in possession of the thing from which the sample is taken;
- (d) have the second part analysed; and
- (e) safely keep the third part for future comparison.

”

of the *Prisons Regulations 1982\** before 1 July 1994, any subsequent steps in the procedures set out in regulation 8 of those regulations (including the making and disposal of a claim) may be taken in respect of that treatment or supply on or after 1 July 1994 as if regulation 8 of those regulations had not been repealed.

  - (ii) Internal firebreaks 10 metres wide surrounding compartments of 100 hectares maximum.
- (d) Rural Residential Zones—Woodridge, Ocean Farm, Gingin Heights and Redfield Park; and Rural Industry Zone—Frogmore.

Landowners or occupiers shall each year clear firebreaks not less than 2.5 metres wide immediately inside all external boundaries of the land, or, subject to Council's approval in writing, on an alternative alignment.

## 2. Fuel Depots

You shall clear firebreaks not less than 3.5 metres wide so as to completely surround the perimeter of land occupied by drums used for the storage of inflammable liquids, whether the drums contain inflammable liquid or not, including any land on which ramps for holding the drums are constructed. You shall also clear of all inflammable material all the land within the firebreak required by this paragraph.

3. Urban Land—(All land within the townsites of Gingin, Guilderton, Seabird, Ledge Point and Lancelin). You shall—




