**FISHERIES ACT 1905****LAKE ARGYLE FISHERY NOTICE 1994**

Notice No. 665

FD 128/88.

Made by the Minister under sections 9, 10 and 11.

**Citation**

1. This may be cited as the *Lake Argyle Fishery Notice 1994*.

**Interpretation**

2. In this notice unless the contrary intention appears—

"authorised boat" means a boat which is licensed under regulation 2 of the Fisheries Regulations 1938 and is authorised by an endorsement on that licence to be used to take fish from the waters described in Schedule 1;

"barramundi" means the species of fish *Lates calcarifer*.

**Prohibition on taking fish**

3. (1) All persons other than—

(a) the holder of a professional fisherman's licence when operating from an authorised boat; or

(b) a person who is using a line or rod, reel and line and not operating from a boat licensed under Regulation 2 of the Fisheries Regulations 1938,

are prohibited from taking any fish whatsoever by any means in the waters described in Schedule 1.

(2) The holder of a professional fisherman's licence when operating from an authorised boat shall not take or attempt to take any fish in the waters described in Schedule 2 at any time.

**Restrictions on authorised boats**

4. (1) The holder of a professional fisherman's licence when operating from an authorised boat, and using a net to take fish from the specified waters, shall not use more than 1500 metres of net at any one time.

(2) The person in charge of a boat operating in the specified waters shall not permit more than 1500 metres of net to be used from the boat at any one time.

(3) An authorised boat—

(a) shall not be used to take fish in any other Western Australian waters unless otherwise authorised by licence or licence endorsement; and

(b) shall not be used to take barramundi by any means in the waters described in Schedule 1.

5. Notwithstanding the provisions of clause 3 all persons are prohibited from taking any fish whatsoever by means of nets in the waters described in Schedule 1 during the period 1 November in any year to 31 December in the same year.



**Determination of position by reference to the Australian Geodetic Datum**

6. (1) Where for the purpose of this notice it is necessary to determine a position on the surface of the Earth by geographical co-ordinates, that position shall be determined on the Australian Geodetic Datum which is defined by an ellipsoid having a semi-major axis (equatorial radius) of 6 378 160 metres and a flattening of 1/298.25 and fixed by the position of the origin being the Johnston Geodetic Station in the Northern Territory of Australia.

(2) The Johnston Geodetic Station referred to in subclause (1) shall be taken to be situated at 25°56'54.5515" south latitude and at 133°12'30.0771" east longitude and to have a ground elevation of 571.2 metres above the ellipsoid referred to in that subclause.

**FISHERIES ACT 1905****SHARK BAY SNAPPER LIMITED ENTRY FISHERY NOTICE 1994**

Notice No. 656

FD 374/78

Made by the Minister under section 32.

**Citation**

1. This notice may be cited as the *Shark Bay Snapper Limited Entry Fishery Notice 1994*.

**Interpretation****2. In this notice unless the contrary intention appears—**

“authorised boat” means a licensed fishing boat that under clause 7, 9 or 15 of this notice is authorised to be used in the Fishery;

“commencement date” means the date that this notice commences operation;

“drop line” means a fishing line with no more than 25 hooks attached and when used for fishing is anchored by a weight, buoyed at the surface and deployed vertically through the water;

“Fishery” means the Shark Bay Snapper Limited Entry Fishery declared under clause 3;

“hand line” means a fishing line with no more than 5 hooks attached (for the purpose of this definition if not more than 5 hooks are joined by threading the point of one hook through the eye of another, or if not more than 5 hooks are joined by fastening their shanks together they shall be deemed to be one hook);

“licence” means a limited entry fishery licence or supplementary access licence that authorises a boat to be operated in any part of the Fishery;

“licensed fishing boat” means a boat licensed pursuant to regulation 2 of the Regulations;

“minimum unit holding” means—

(a) in the case of a class A licence, twenty (20) transferable units; and

(b) in the case of a class B licence, ten (10) transferable units;

“off season” means the periods—

(a) 1 January to 30 April; and

(b) 1 September to 31 December,

in any year;

“operate” means—

(a) to search for snapper;

(b) to attempt to take snapper;

(c) to take snapper;

(d) to engage in any other activity that can reasonably be expected to result in the taking of snapper;

“peak season” means the period 1 May to 31 August in the same year;

“quota” means the maximum weight of snapper that may be taken by a person operating in the Fishery from an authorised boat and being calculated by the number of units endorsed on the licence;

“quota period” means the period of the peak season;

“Regulations” means the *Fisheries Regulations 1938*;

“snapper” means any fish of the species *Pagrus auratus*;

“standard container” means a container made of plastic or similar material having a capacity of 32 litres and the following internal measurements—

(a) length at top—597 millimetres;

(b) breadth at top—362 millimetres; and

(c) depth—203 millimetres;

“transfer” means the passing of ownership or effective control of the rights, entitlements and obligations attached to a licence, from one person to another person;

“trap” means a device for taking fish which—

(a) has a surface float attached which shall measure not less than 150 millimetres in diameter and that float shall be branded or stamped with the registered number of the authorised boat that is used to set or lift the trap and each letter or figure of the brand or stamp shall be legible and measure not less than 60 millimetres high and 10 millimetres wide;

(b) has an internal volume, including that of any object enclosed within its external frame, not exceeding 2 cubic metres calculated in accordance with the following formula—

(i)  $0.785 \times \text{height} \times [\text{greatest diameter}]^2$  if the trap is a circular trap; or

(ii)  $\text{height} \times \text{greatest length} \times \text{greatest width}$  for any trap that is not circular;

(c) has only one entrance; and

(d) shall not have any form of chamber, partition or obstruction within the trap which may impede the egress of fish;

“unit” for the year commencing 1 January 1994 means 1 tonne of whole snapper;

"unit entitlement" means the number of units allocated to an authorised boat, are endorsed on the licence for that boat and may consist of transferable and non-transferable units.

**Declaration of limited entry fishery**

3. It is hereby declared that snapper in the waters described in the Schedule constitute a limited entry fishery, named the Shark Bay Snapper Limited Entry Fishery.

**Criteria for a person to operate in the Fishery**

4. A person shall not operate in the Fishery unless—
- (a) the person holds a professional fisherman's licence issued pursuant to the Regulations; and
  - (b) the person is operating from an authorised boat.

**Criteria to operate a boat in the Fishery**

5. The criteria to determine the boats which may be used in the Fishery—
- (a) under a class A licence, is that immediately prior to the commencement date the boat was a licensed fishing boat and in accordance with the *Shark Bay Snapper Limited Entry Fishery Notice 1990* was authorised to be used in the Shark Bay Snapper Limited Entry Fishery under a class A licence;
  - (b) under a class B licence, is that immediately prior to the commencement date the boat was a licensed fishing boat and in accordance with the *Shark Bay Snapper Limited Entry Fishery Notice 1990* was authorised to be used in the Shark Bay Snapper Limited Entry Fishery under a class B licence;
  - (c) under a Supplementary Access Licence, is that immediately prior to the commencement date the boat was a licensed fishing boat and in accordance with the *Shark Bay Snapper Limited Entry Fishery Notice 1990* had access to the Shark Bay Snapper Limited Entry Fishery under a Supplementary Access Endorsement; or
  - (d) the boat replaces a boat to which either paragraph (a), (b) or (c) applies.

**Prohibition on taking or selling snapper**

6. (1) A person other than a person to whom section 32 (5) of the Act applies, shall not operate in the Fishery other than in accordance with this notice.
- (2) A person shall not, for gain or reward, sell or otherwise dispose of snapper taken contrary to this notice.

**Licences**

7. (1) The licensee of a boat as described in Clause 5 may apply to the Director for a licence to operate the boat in the Fishery.
- (2) A licence expires on 31 December of the year in which the licence is current.
- (3) A person may apply to the Director for the renewal of a licence at any time within 30 days before the licence expires.
- (4) If the Director considers that it is appropriate to do so, the Director may in the case of an application made under—
- (a) subclause (1)—approve the issue of a licence; or
  - (b) subclause (3)—approve the renewal of a licence.
- (5) A licence may be issued or renewed subject to conditions that shall be endorsed on it.
- (6) When a licence is issued or renewed, the licensee shall be endorsed to show—
- (a) the name and licensed fishing boat number of the boat in respect of which it is issued;
  - (b) the name and address of the licensee of that boat;
  - (c) the licence number;
  - (d) the date of issue or renewal;
  - (e) the period for which the licence is valid;
  - (f) the number and type of units allocated to the licence; and
  - (g) any conditions imposed on the licence.
- (7) Subject to clause 20 and with the prior written approval of the Director the holder of a licence may transfer a licence to another person.

**Supplementary access**

8. (1) A Supplementary Access Licence may specify—
- (a) the means by which snapper may be taken;
  - (b) the maximum number of units which may be taken in any specified period;
  - (c) the area of the Fishery in which the snapper may be taken; and
  - (d) the period during which snapper may be taken.

**(2) A Supplementary Access Licence—**

- (a) is subject to any of the requirements under this notice or any other conditions as specified by the Minister; and
- (b) may be withdrawn by the Minister at any time.

**Permitted means of taking snapper**

9. (1) Where a licence has been nominated to be used in the off season in accordance with clause 10, snapper may be taken by means of not more than—

- (a) 5 hand lines at any one time; or
- (b) 5 drop lines at any one time,

and by no other means.

(2) An authorised boat being used in the peak season in accordance with a nomination made under clause 10 may take snapper by any means provided that where traps are used the following conditions shall apply—

- (a) traps shall not be used in the following areas of the Fishery—

**Area 1**

All waters within Shark Bay bounded by the high water mark of the mainland and a line drawn in a south westerly direction from Quobba Point on the mainland to a point 3 miles due north of Koks Island; thence south to Koks Island; thence along the eastern and southern shores of Koks Island to its southern most point; thence in a southerly direction to Cape Ronsard on Bernier Island; thence along the eastern shore of Bernier Island to Cape Couture; thence in a southerly direction to Cape Boullanger on Dorre Island; thence along the eastern shore of Dorre Island to Cape St Cricq; thence in a south westerly direction to Cape Inscription on Dirk Hartog Island; thence along the northern, eastern and southern shores of Dirk Hartog Island to Surf Point; thence in a south westerly direction to Steep Point on the mainland; and

**Area 2**

All the waters within three (3) nautical miles of Koks Island, Cape St Cricq and Cape Inscription together with all the waters within one (1) nautical mile of Bernier, Dorre and Dirk Hartog Islands and within one (1) nautical mile of the mainland of Western Australia from Steep Point south to the parallel of 26° 30' south latitude;

- (b) traps shall not be left in the water for any period exceeding 30 minutes other than in accordance with clause 18;
- (c) a boat shall not be used to set or pull traps in any waters of the Fishery other than those traps which are marked for use by that boat as specified in clause 2;
- (d) not more than 5 traps are used to take, or attempt to take, snapper at any one time; and
- (e) a person shall not use a trap that does not comply with the specifications of a trap as specified in clause 2.

**Notification of fishing season**

10. (1) The licensee of a boat with a class A licence or class B licence or any combination of those licences shall, prior to 1 January in each year, notify the Director in writing of the intention to take snapper under each individual licence in either—

- (a) the off season; or
- (b) the peak season; or
- (c) both the off season and the peak season and subject to a 10 unit reduction of peak season quota; or
- (d) both the off season and peak season provided that the authorised boat may not be used to take snapper in—
  - (i) any part of the Fishery north of 25°17' south latitude; and
  - (ii) the Fishery during the months of July, October, November and December.

(2) A person may not use a boat to take snapper in both the off season and the peak season under the authority of any one licence unless otherwise approved in writing by the Director.

(3) Any notice given under subclause (1) shall be irrevocable for the year in respect of which it was given unless otherwise approved in writing by the Minister.

(4) A person shall not use a boat to take snapper other than during the season nominated in accordance with subclause (1) in respect of that boat.

**Closure of the Fishery to specified boats**

11. (1) Where, under clause 10 (1), notice has been given that a boat will be used in the off season under a class B licence, that boat shall not be used to take, or attempt to take, transport at sea, or land ashore snapper under the authority of that licence, during the period commencing on 1 May and ending on 15 May in the same year.

(2) Where, under clause 10 (2) (d), the Minister has approved the use of an authorised boat to take snapper in the off season and the peak season under the authority of any one licence that boat shall not be used to take, or attempt to take snapper under that licence—

(a) in any part of the Fishery north of 25° 17' south latitude; and

(b) in the Fishery during the months of July, October, November and December.

(3) A boat which is authorised to be used to take snapper in accordance with clause 15 shall only take snapper during the peak season.

(4) A person who operates a boat—

(a) endorsed on a class A or class B licence; or

(b) authorised to take snapper under the authority of a Supplementary Access Licence; or

(c) authorised to take snapper in accordance with clause 15,

shall not take, or attempt to take, snapper in the area of the Shark Bay Beach Seine and Mesh Net Limited Entry Fishery\* at any time.

(5) A boat endorsed on a licence permitting that boat to be used—

(a) to take snapper in the Shark Bay Beach Seine and Mesh Net Limited Entry Fishery\*; or

(b) within the Shark Bay Beach Seine and Mesh Net Limited Entry Fishery\*,

may take or attempt to take snapper within the Shark Bay Beach Seine and Mesh Net Limited Entry Fishery\*.

(6) Notwithstanding the provisions of clauses 10 (2) and 11 (2), where a person has nominated to operate a boat with a class B boat in the on season, that boat may be used to take snapper in all waters of the Fishery excluding the waters of the Shark Bay Beach Seine and Mesh Net Limited Entry Fishery\* in the peak season during the period 16 August in any year to 31 August in the same year.

#### **Units**

12. The number and type of units that shall initially be endorsed on a licence is the number and type of those units that were endorsed on the licence immediately prior to the commencement date.

#### **Quota**

13. (1) In any quota period, unless otherwise authorised in writing by the Minister, a person shall not permit a boat to be used to take, or attempt to take more snapper from the Fishery than the quota specified in units on the licence for that boat.

(2) When a licence is transferred in accordance with clause 20 the transferee shall only take the remaining quota in respect of that quota period that the transferor would have been able to take had the transfer not taken place.

#### **Unit entitlement during peak season**

14. (1) Each licence shall have endorsed on it the—

(a) total unit entitlement;

(b) total transferable unit entitlement;

(c) total non-transferable unit entitlement; and

(d) unit entitlement which may be taken during the peak season,

applicable to that licence.

(2) If the licensee of an authorised boat gives notice under clause 10 that the boat will be used in the peak season the unit entitlement specified in subclause (1) (d) applicable to that licence for that boat shall not be exceeded unless otherwise approved in writing by the Minister.

(3) Notwithstanding any other action which may be taken against a licensee who exceeds the unit entitlement during the peak season in any year, the Minister may adjust the unit entitlement of that licensee for the following year by deducting an amount equal to the amount by which the entitlement was exceeded provided that any such reduction to the unit entitlement is no more than 0.05 units.

(4) If a person who has had the unit entitlement reduced in accordance with subclause (3) gives notice under clause 10 that a licence will be used in the off peak season then the reduction to the unit entitlement shall apply when the licence is next used in the peak season.

(5)(a) A licensee who does not take his full entitlement during the peak season in any one year may, prior to January of the following year, apply in writing to the Minister for approval to carry over to the following peak season the unused portion of the unit entitlement, provided that the unit entitlement carried over shall not exceed 0.5 unit.

- (b) If the Minister approves a carry over of unit entitlement in accordance with subclause (a) then that carried over unit entitlement shall only apply to the following peak season and shall not be carried over to any subsequent year.
- (c) To calculate the unit entitlement carry over for any year the following formula shall be used—
- A - B = C where
- “A” = the endorsed unit entitlement allocated in accordance with paragraph (d) of subclause 14 (1);
- “B” = the units taken during the current peak season; and
- “C” = subject to subclause 14 (5) (a) and (b), the carry over for the following peak season.

(6) A licensee who is authorised to use a boat in both the off season and the peak season pursuant to clause 10 (1) (c) shall have the unit entitlement specified on the licence for that boat reduced by 10 units.

- (7) Notwithstanding the provisions of clause 20 (7) a boat which has—
- (a) been nominated for use during the peak season;
- (b) had units transferred from the licence relating to that boat such that the unit entitlement of that licence falls below the minimum unit entitlement,
- may be used to take the reduced entitlement, which is below the minimum unit entitlement, during the peak season.

#### **Incidental catch**

15. (1) A boat licensed to fish within—
- (a) the Shark Bay Prawn Limited Entry Fishery\*\*;
- (b) the Shark Bay Scallop Limited Entry Fishery\*\*\*;

shall not take more than 1 unit in any peak season.

(2) The fishing boat licence for a boat specified in subclause (1) shall be endorsed accordingly.

#### **Restrictions on carrying, unloading, landing and transfer of snapper**

16. (1) A person shall not within the Fishery—
- (a) use a boat to carry or to land ashore snapper or any filleted fish taken by that boat for sale or disposal for gain or reward other than—
- (i) during the season nominated under clause 10 in respect of the licence for that boat; or
- (ii) in accordance with clause 8, 11 (5) or 15; or
- (b) transfer snapper or any filleted fish taken by a boat for sale or disposal for gain or reward to any other boat at sea,

unless approved in writing by the Minister.

- (2) A person who operates a boat—
- (a) licensed or endorsed under clause 8 or 15 shall not transport at sea or land ashore within the boundaries of the Fishery any snapper or filleted fish taken outside the Fishery unless otherwise approved in writing by the Minister;
- (b) endorsed on a class A or class B licence shall—
- (i) if snapper are on board the boat at any time when that boat is within the boundaries of the Fishery, land those snapper ashore only within the boundaries of the Fishery; and
- (ii) not use that boat to transport at sea or land ashore within the boundaries of the Fishery filleted fish taken outside the Fishery unless otherwise approved in writing by the Minister; and
- (c) on which snapper is transported or landed in accordance with subparagraph (2) (b) (i) shall have that snapper counted against the unit entitlement allocated under clause 14.

(3) The holder of a licence, having consigned snapper and completed the consignment note in accordance with clause 17 shall not remove, or cause or permit the removal of any part of that consignment until an accurate weight of snapper has been determined and entered on the quota disposal record in accordance with clause 17.

(4) A person who operates on an authorised boat or a boat endorsed on a licence which is endorsed in accordance with either clauses 8, 11 (5) or 15 shall only land snapper from that boat at a place specified by an Inspector within the Port of Carnarvon or Denham, or at such other place as directed by an Inspector.

(5) A person who operates on an authorised boat or a boat endorsed on a licence which is endorsed in accordance with either clauses 8, 11 (5) or 15 shall—

- (a) give not less than three hours notice of the intention to land snapper to an Inspector, or a person nominated by the Inspector, at Carnarvon or Denham by means of—
  - (i) the Telstra Communications (formerly OTC);
  - (ii) the telephone; or
  - (iii) a method approved by the Inspector at Carnarvon or Denham;
- (b) not land snapper in containers holding other fish; and
- (c) having commenced landing snapper ashore—
  - (i) complete the unloading in one uninterrupted operation;
  - (ii) not put to sea until all the snapper on the boat have been landed ashore.

(6) A person referred to in subclause (5) shall not land, or allow or permit a person to land, snapper in standard containers unless a Shark Bay snapper consignment note as specified in clause 17 has been completed and delivered to the Inspector, his office or a place nominated by the Inspector at Carnarvon or Denham.

(7) A person referred to in subclause (5) shall not land, or allow or permit a person to land, snapper in containers other than standard containers unless—

- (a) the snapper are landed between 0600 hours and 1800 hours on any day; and
- (b) an Inspector is in attendance.

#### **Records to be kept**

17. (1) Subject to subclause (2) a person referred to clause 16 (1) shall, when landing snapper—

- (a) complete in duplicate, in the quota disposal record book details of any snapper landed ashore;
- (b) submit the original copy of the completed quota disposal record to the Inspector at the time and place of landing the snapper; and
- (c) retain the duplicate copies of used quota disposal records and the original and duplicate copies of any unused or spoiled quota disposal records in the quota disposal record book and produce that book to an officer of the Fisheries Department on demand.

(2) A person referred to in subclause (1) when landing snapper in standard containers shall—

- (a) complete details, on the Shark Bay snapper consignment note in the quota disposal record book, showing the number of standard containers or other receptacles landed ashore; and
- (b) immediately on receiving precise details of the weight of snapper consigned, complete the quota disposal record in accordance with subclause (1) in respect of the consignment referred to in paragraph (a).

(3) A person referred to in subclause (1) shall not land any snapper in accordance with subclause (2) unless the Shark Bay snapper consignment note has been delivered to the Inspector, his office or a place nominated by the Inspector at Carnarvon or Denham in accordance with clause 16 (6).

(4) For the purpose of this clause "quota disposal record book" shall mean the quota disposal record book provided by the Fisheries Department.

#### **Trap holding area**

18. (1) Traps may be placed in those areas of the Fishery being the waters within Shark Bay adjacent to—

- (a) Bernier Island within a radius of 1 nautical mile of Cleft Rock; and
- (b) Dorre Island within 500 metres of the foreshore on the eastern side of the island between Cape Boullanger and Smith Point.

(2) Traps when placed in the areas described in subclause (1) shall—

- (a) not be baited; and
- (b) have their doors tied open.

#### **Boat replacement**

19. A boat specified on a licence may, on application by the licensee and with the written approval of the Director, be replaced by another boat.

**Transfers**

20. (1) Where a licence has a unit entitlement which is less than the minimum unit holding the licence shall not be transferred.

(2) When a licence is transferred, any non-transferable units allocated to that licence shall be removed from the unit entitlement and shall cease to have effect.

(3) Where the licence is transferred, the transferee shall, in the calendar year in which the transfer takes place, operate the boat in the season which has been nominated for that licence in accordance with clause 10.

(4) Subject to the prior written approval of the Director, a licensee may transfer part of the unit entitlement allocated to that licence to one or more other licensees, provided that any single transfer involves a minimum of five units.

(5) Where the total transferable unit entitlement of a licence has been transferred to other licences any non-transferable units shall be removed from the licence and cease to have effect.

(6) Where a class B licence is endorsed with a unit entitlement of twenty or more units the status of that licence will be amended to a class A licence.

(7) Subject to clause 14 (7), where the transferable unit entitlement of a licence falls below the minimum unit holding the licence shall not be used within the Fishery.

**Applications and prescribed fees**

21. An application to the Director under this notice shall be—

- (a) made on the form approved by the Director;
- (b) lodged, subject to any directions in this notice, in accordance with the directions on the form; and
- (c) accompanied with the prescribed fee, if any.

**How the Director may give notice**

22. The Director may, by letter, or by notice published in *The West Australian* newspaper or in the *Western Fisheries* magazine published by the Fisheries Department, give notice from time to time of the names and addresses of the persons who hold licences to engage in the Fishery and the zones to which those licences apply.

**Determination of position by reference to the Australian Geodetic Datum**

23. (1) Where for the purpose of this notice it is necessary to determine a position on the surface of the Earth by geographical coordinates, that position shall be determined on the Australian Geodetic Datum which is defined by an ellipsoid having a semi-major axis (equatorial radius) of 6 378 160 metres and a flattening of 1/298.25 and fixed by the position of the origin being the Johnston Geodetic Station in the Northern Territory of Australia.

(2) The Johnston Geodetic Station referred to in subclause (1) shall be taken to be situated at 25°56'54.5515" south latitude and at 133°12'30.0771" east longitude and to have a ground elevation of 571.2 metres above the ellipsoid referred to in that subclause.

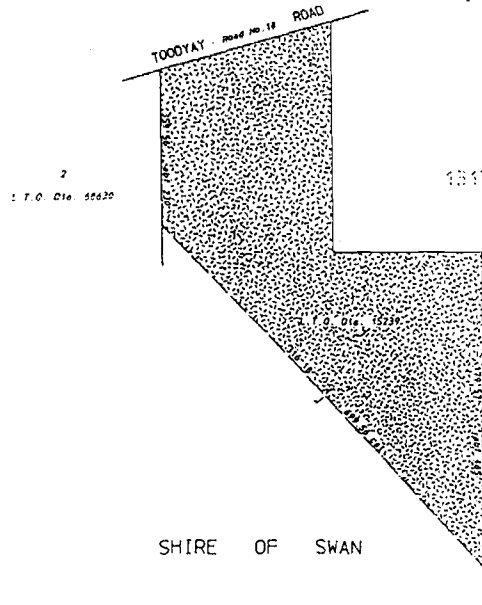
