Pursuant to the powers contained in section 33 of the above Act, you are hereby required on or before the 30th October, 1994 within the Shire of Beverley to plough, cultivate, scarify, chemically spray or otherwise clear and thereafter maintain free of all inflammable material until the 15th April, 1995 firebreaks as stipulated in the following positions on the land owned or occupied by you.

- 1.4 **FUEL DRUMS**—All grass and other inflammable materials must be cleared from areas where fuel drums, bowsers, and/or overhead fuel tanks, either empty or containing fuel are stored. The cleared area is to extend for a distance of at least 6 metres completely surrounding the fuel drums, bowsers and/or overhead fuel tanks.

BEVERLEY TOWNSITE: On or before the 30th November, 1994.

That all buildings or group of buildings have an area not less than four (4) metres wide from such building clear of all inflammable material.

- (a) All lots with an area of .1012 ha ( $\frac{1}{4}$  acre) or less shall be either—
- (i) Clear of all inflammable material; or
  - (ii) Have grass mown to a height no greater than 5 cm.
- (b) All lots with an area greater than .1012 ha ( $\frac{1}{4}$  acre) but no larger than .8084 ha (2 acres) shall be either—
- (i) Clear of all inflammable material; or
  - (ii) Have all fallen timber removed and a firebreak of at least 2.2 metres wide, completely free of all inflammable material provided inside and along all external boundaries.
- (c) All lots or combination of lots that comprise of one holding and having an area greater than .8084 ha (2 acres) shall have a firebreak of 2.2 metres wide free of all inflammable material provided inside and along all external boundaries.

If it is impracticable for any reason to comply with the above requirements of this notice, owners or occupiers should seek Council approval to make necessary adjustments.

The firebreaks will be inspected shortly after the respective completion dates applicable to the various areas, and the penalty for failing to comply with this notice is a fine of not more than \$1 000, or a penalty of \$40 may be incurred by issue of an infringement notice, and a person in default is also liable, whether prosecuted or not, to pay the cost of performing the work directed in this notice if it is not carried out by the owner or occupier by the date required by this notice.

If the requirements of this notice are carried out by burning, such burning must be in accordance with the relevant provisions of the Bush Fires Act, which includes the necessity for permits to burn during the restricted burning season.

Notice to All Owners and/or Occupiers of Land in the Shire of Gnowangerup

Pursuant to powers contained in section 33 of the above Act, you are hereby required on or before 1 November 1994 to clear of all inflammable material, firebreaks as stated hereunder. Thereafter to maintain these firebreaks clear of inflammable material up to and including 22 March 1995.

1. Prepare firebreaks not less than three (3) metres wide within two hundred (200) metres of all external property boundaries whether such land is cleared, part cleared or uncleared except where an exemption has been granted in accordance with the requirements below.

Internal firebreaks within a property boundaries shall be optional.

Note: Application for a permit of exemption from the installation of firebreaks where soil degradation or erosion may occur shall be made to the relevant district Fire Control Officer and subject to an inspection by the Fire Control Officer, the adjoining neighbour and the owner of the land.

Subject to agreement by all parties the Fire Control Officer shall issue a permit exempting the installation of firebreaks in the agreed location.

2. Exemption may be sought on conservation grounds in areas of high risk from wind or weather erosion. An annual permit for exemptions will be issued by Bush Fire Control Officers following an on site inspection by a Committee of: Bush Fire Control Officer, neighbour and owner. This permit to be renewed annually.

3. Internal firebreaks and firebreaks around crops are optional. However, it is strongly recommended that some form of strategic firebreaks are maintained within the property. Suggested ratio is one (1) km per 250 hectares.

4. Prepare firebreaks not less than three (3) metres wide within one hundred (100) metres of, and surrounding, all building, hay stacks and fuel pumps.

5. Prepare firebreaks not less than ten (10) metres wide immediately around the perimeter of any scrub or timber which has been logged, chain or otherwise prepared for burning within seven (7) days of such work being completed.

No area to exceed two hundred and fifty hectares.

In respect of land within any townsite within the Shire you shall—

(a) Where the area is two thousand (2 000) square metres or less, remove all inflammable material on the land from the whole area of the land.

(b) Where the land exceeds two thousand (2 000) square metres, firebreaks not less than two (2) metres wide shall be prepared immediately inside and along all external boundaries of the land.

6. An adequate firebreak must be constructed three (3) metres wide around stubble and pasture prior to burning.
