POISONS ACT 1964

POISONS (SCHEDULED SUBSTANCES) AMENDMENT ORDER  
(NO. 2) 1994

Made by His Excellency the Governor in Executive Council.

**Citation**

1. This order may be cited as the *Poisons (Scheduled Substances) Amendment Order (No. 2) 1994*.

**Commencement**

2. This order comes into operation on the day it is published in the *Government Gazette*.

**Principal Act**

3. In this order the *Poisons Act 1964*\* is referred to as the principal Act.

**Appendix "A" amended**

4. (1) Appendix "A" to the principal Act is amended by inserting after clause 2 the following clause —

3. In a Schedule, unless the contrary intention appears —

"**divided preparations**" means preparations manufactured and packed as discrete dosage units prior to sale or supply and includes tablets, capsules, cachets, single dose powders or single dose sachets of powders or granules;

"**dosage unit**" means an individual dose of a poison and includes a tablet, capsule, cachet, single dose powder or a single dose sachet of powders or granules;

"**external**" in relation to the use of a poison, means application in the ears, eyes, or nose, or to a body surface other than in the mouth, rectum, vagina, urethra or other body orifice;

**“internal”** in relation to the use of a poison, means administration —

- (a) orally except for topical effect in the mouth; or
- (b) for absorption and the production of a systemic effect —
  - (i) by way of a body orifice other than the mouth; or
  - (ii) parenterally, other than by application to unbroken skin;

**“topical”** in relation to the use of a poison, means application for the purpose of producing a localized effect on the surface of the organ or within the tissue to which it is applied.

(2) The Second Schedule in Appendix “A” to the principal Act is amended —

- (a) by inserting in the appropriate alphabetical position the following item —

 INDOMETHACIN as the only therapeutically active substance in spray preparations for external use containing 1 per cent or less of indomethacin.  
 ”;

- (b) by deleting the item commencing “PHENIRAMINE” and substituting the following item —

- (a) in eye drops;
- (b) in primary packs of 10 doses or less, for the prevention or treatment of motion sickness, except in preparations for the treatment of children under 2 years of age; or
- (c) in oral preparations when included with one or more of the following medicaments —
  - (i) an antitussive except codeine or dihydrocodeine;
  - (ii) an expectorant; or
  - (iii) a sympathomimetic amine;

except in preparations for the treatment of children under 2 years of age.

”; and

- (c) by deleting the item commencing “PHENOL” and substituting the following item —

“  
 PHENOL, or any homologue of phenol boiling below 220°C, for human therapeutic use, except —

- (a) when included in the Fourth Schedule; or
- (b) in preparations for external use containing 1 per cent or less of such substances.

Where the bush on the land owned or occupied by you has been bulldozed, chained or prepared in any similar manner for clearing by burning (whether you intend to burn the bush or not), clear of all inflammable materials, firebreaks not less than twenty (20) metres wide immediately inside the external boundaries of the land on which bulldozed, chained or otherwise prepared bush is situated.
3. Where there is standing timber on land owned or occupied by you and it is intended to burn such timber, to clear of all inflammable material, firebreaks not less than six (6) metres wide immediately inside the external boundaries of the land on which the timber is standing.
4. Landowners and/or occupiers adjoining Vacant Crown Land are, in addition to the above, encouraged to maintain external firebreaks where their property adjoins the Vacant Crown Land.

**Townsites**

Urban land (all land within the townsites of Dandaragan, Regans Ford, Badgingarra, Cervantes and Jurien) you shall clear lots of all debris, dry grass, dry bush, etc., of an inflammable nature. That within townsites, on all undeveloped lots, that a 2 metre wide firebreak be slashed around boundaries of each lot and that all dry material be removed from the break.

**General**

In situations where construction of firebreaks in accordance with the Order may aggravate soil erosion problems or where the owner or occupier of land considers a more effective system of fire protection can be obtained or for any other reason, Council may approve an application for alternative siting of firebreaks. With reference to section 33 of the Bush Fire Act 1954, you are required to carry out fire prevention work on land owned or occupied by you in accordance with the provisions of this order.

This work must be carried out by 1 December 1994 and kept maintained throughout the summer months until 31 March 1995.

An inspection of firebreaks and hazard removal will be carried out in all areas of the Shire by an authorised officer.

Persons who fail to comply with the requirements of this order may be issued with an infringement notice (Penalty \$80) or prosecuted with an increased penalty, and additionally, Council may carry out the required work at the cost to owner or occupier.

If it is considered for any reason to be impractical to clear firebreaks or remove flammable materials as required by this notice or if natural features render firebreaks unnecessary you may apply to the Council or its duly authorised officer not later than the 15 November 1994 for permission to provide firebreaks in alternative positions or to take alternative action to abate fire hazards on the land. If permission is not granted by the Council or its duly authorised officer, you shall comply with the requirements of this notice. If the requirements of this notice are carried out by burning, such burning must be in accordance with the relevant provisions of the Bush Fires Act.

#### 1. Rural Land

- (a) On land which is divided by or abuts a formed or partly formed road or railway reserve, a firebreak not less than two metres wide shall be provided within 60 metres of the boundary of the road or railway reserve. Breaks are not permitted on road reserves without Council approval.
- (b) A firebreak two metres wide shall be provided immediately surrounding and within twenty metres of the perimeter of all buildings, haystacks and fuel storage areas situated on the land. Haystack means any collection of hay including fodder rolls placed or stacked together.
- (c) A cleared area of at least a six metre radius shall be provided around all combustion pumping engines.

#### 2. Eucalyptus and Pine Plantations

- (a) Firebreaks not less than ten metres in width around the perimeter of land on which trees are planted.
- (b) Not less than ten metres in width along those portions of plantations which enjoy a common boundary with a road reserve.
- (c) Not less than six metres in width in such positions that no part or compartment of a plantation shall exceed 28ha in area.
- (d) Where ten metre breaks are required in accordance with this Section of Council's Firebreak Order, pruning of overhang shall be carried out up to a height of five (5) metres above the firebreak (Ground level).
- (e) In addition to the breaks specified, plantations traversed by SEC power transmission lines have additional obligations under the Electricity Act.

#### 3. Townsites Land: (Includes Residential, Commercial and Industrial Land)

Townsites: Donnybrook, Balingup, Kirup, Mullalyup, Newlands, Preston and Noggerup.

- (a) Where the area of land is 2 024 m<sup>2</sup> (approx. 1/2 acre) or less, remove all flammable material on the land except living trees, shrubs and plants from the whole land, and;
- (b) Where the land exceeds 2 024 m<sup>2</sup> (approx. 1/2 acre) clear firebreaks at least 2 metres wide, immediately inside all external boundaries of the land, and also immediately surrounding all buildings situated on the land. Grass on the remaining area of the land must be either grazed, cut for fodder, or totally removed from the land.
- (c) Council, on the recommendation of a Bush Fire Control Officer, may vary these conditions in certain circumstances.

#### 4. Special Rural and Special Residential Land

The owners of all existing small rural holdings zoned as "Special Rural" or "Special Residential" under Town Planning Schemes, must maintain free of all flammable material a firebreak not less than two metres in width immediately inside all external boundaries of the land, and a twenty metre wide fuel free zone around all buildings on the land.

#### 5. Fuel and/or Gas Depot

In respect of land owned by you on which is situated any container normally used to contain liquids or gas fuel, including the land on which any ramp or support is constructed, you shall have the land clear of all flammable materials.

#### 6. Welding, Cutting, and Grinding Equipment

Persons shall not operate welding, cutting or grinding apparatus of any kind during the Prohibited Burning Times on land which is under crop, pasture or stubble unless at least one fire extinguisher is provided and there is compliance with any other fire controls required by the Fire Control Officer.

#### 7. Roadside Verges

Council policy is that no vegetation is to be removed from road verges and no verge is to be burnt without a permit for that specific purpose.

**BUSH FIRES ACT 1954***Shire of Waroona*

## Notice to Owners and Occupiers of Land

Important information relating to your responsibility as a landholder in the Shire of Waroona.

With reference to section 33 of the Bush Fires Act 1954, you are required to carry out fire prevention work on land owned or occupied by you in accordance with the provisions of this order.

This work must be carried out on or before November 30th and kept maintained throughout the summer months until the close of Restricted Burning Period.

An inspection of firebreaks and hazard removal will be carried out in all areas of the Shire by authorised Officers on or after November 30th. Persons who fail to comply with the requirements of this order may be issued with an infringement notice (penalty \$40) or prosecuted with an increased penalty, and additionally, Council may carry out required work at cost to the owner or occupier.

If it is considered for any reason to be impractical to clear firebreaks as required by this notice or natural features render firebreaks unnecessary you may apply to the Council or its duly authorised Officer not later than the 1st day of November for permission to provide firebreaks in alternative positions (strategic breaks) or to take alternative action to abate fire hazards on the land. If permission is not granted by the Council or its duly authorised Officer, you shall comply with the requirements of this notice, if the requirements of this notice are carried out by burning, such burning must be in accordance with the relevant provisions of the Bush Fires Act, burning is permitted on Sundays and Public Holidays, at discretion of relevant Fire Control Officers.

**A. Rural Land**

Firebreaks not less than two (2) metres wide must be provided in the following positions:

- (a) within 60 metres inside and along the boundaries of all land including that which is uncleared, so as to form a continuous break around the holding.

(Note: Firebreaks constructed on road verges do not constitute a legal firebreak).

- (b) not more than 100 metres and not less than 20 metres from the perimeter of all groups of buildings, haystacks and fuel installations provided on that land. Note 1: 10 round bales constitute a haystack; 5 large oblong bales constitute a haystack; 200 small oblong bales constitute a haystack. Note 2: Irrigation Area—owners or occupiers may be exempt from all or part of the requirements of the above if, in the opinion of the Fire Control Officer responsible for the area in which the land is located, there is no need to construct breaks on the irrigated land or non-irrigated land, not exceeding 20 hectares in area if surrounded by irrigated land.

**B. Rural/Residential Zone**

The owners of all existing small rural holdings zoned "Rural/Residential" under Town Planning Schemes, must maintain clear of all flammable materials, a firebreak not less than two (2) metres wide immediately inside all external boundaries of the land.

**C. Urban Land (Residential, Special Residential, Commercial, Industrial and Rural Land within Waroona/Hamel townsites)**

In respect of land owned or occupied by you within the above townsites or any area subdivided for other purposes, you shall:

- (a) where the area of land is 2024 sq.m. (approx. .5 acre) or less, remove all flammable material on the land except living standing trees, from the whole of the land; and
- (b) where the area of land exceeds 2024 sq.m. (approx. .5 acre) provide firebreaks of at least two (2) metres wide immediately inside all external boundaries of the land and also immediately surrounding all buildings situated on the land. Where several adjoining lots are held or used by the owner/occupier, the firebreaks may be provided inside, along the external boundaries of the group of lots.

**D. Preston Beach Townsite**

Owners and occupiers of lots within Preston Beach Townsite are required to reduce fire hazards by means of slashing vegetation. Contract slashing is available by contacting the following contractor:

Burning off of lots is not recommended.

**F. Fuel and/or Gas Depots**

In respect of land owned or occupied by you on which is situated any container normally used to contain liquid or gas fuel, including the land on which any ramp or support are constructed, you shall maintain the land clear of all flammable materials.

**G. Fire Protection of Private Hard/Softwood Plantations****Definitions and Specifications**

**Plantation**—Any area of planted Pines or Eucalyptus species exceeding 3 hectares.

**Windbreaks**—Will be defined as planted areas not exceeding 15 metres in depth with an unrestricted length.

**Firebreaks**—15 metres Boundary Break. The first row of trees must be at least 15 metres from the outside edge of the break.

The outer 10 metres of the firebreak must be cleared of all flammable material on the ground and will have a 10 metre vertical clearance, i.e. with no overhanging branches. The remaining 5 metres must be maintained in a low fuel condition, i.e. short grass may considered a low fuel.

**Minimum Firebreak Standards**

The following firebreak standards will apply for plantations:

- Firebreaks constructed 15 metres wide (as per definition) on the boundaries of plantations or on such other location as may be agreed between the Waroona Shire Council and the plantation owner.
- Firebreaks clear of all flammable material 6 metres wide should surround compartments of approximately 30 hectares.
- All firebreaks must be maintained in trafficable condition and trees on both sides of breaks progressively pruned to a minimum height of 4 metres to allow unrestricted access of maintenance and fire fighting equipment and so as to maintain an effective width of firebreak.
- Where power lines pass through plantation areas firebreaks as per S.E.C. specifications must be provided.

**H. Camping and Cooking Fires (section 25 Bush Fires Act)**

In accordance with the provisions of section 25 (1a) of the Bush Fires Act 1954, the lighting of fires in the open air in the district, outside the townsites and away from designated barbecue/picnic areas, within the Shire of Waroona for the purpose of camping or cooking is prohibited during the prohibited burning times December 15th to March 14th, inclusive.

**BUSH FIRES ACT 1954**

*City of Gosnells*

**FIREBREAK NOTICE**

Notice to all Owners and/or Occupiers of Land in the Municipality of the City of Gosnells

Pursuant to the powers contained in section 33 of the above Act, you are hereby required on or before the 30th day of November 1994 or within fourteen days of the date of your becoming owner or occupier should this be after the 30th day of November, 1994 and thereafter up to and including the 26th day of April 1995 to have, and maintain a firebreak, clear of inflammable material, at least 3 metres wide immediately inside all external boundaries of each single lot owned or occupied by you and also immediately surrounding all buildings situated on the land.

All land situated within the Western Australian Fire Brigades Board District of 1012 square metres or less is exempt from the above requirements but Council does retain the right to remove any fire hazard at the owner and/or occupiers expense following failure of an owner and/or occupier to comply with the requisitions of an order in writing to clear a fire hazard or fire break in accordance with Section 33 of the Act.

Where land is greater than 1012 square metres, a three metre fire break is required as per this fire break notice.

If it is considered to be impracticable for any reason to clear firebreaks as required by this notice, you may apply to the Council or its duly authorised officer in writing not later than the 11th November 1994 for permission to provide firebreaks in alternative positions on that land. If permission is not granted by the Council or its duly authorised officer, you shall comply with the requirements of this notice.

The penalty for failing to comply with this notice is a fine of not more than \$1 000 and a person in default may also receive an infringement notice of \$80 and be liable, whether prosecuted or not, to pay the cost of performing the work directed in this notice if it is not carried out by the owner or occupier by the date required by this notice.


If the requirements of this notice are carried out by burning, such burning must be in accordance with the relevant provisions of the Bush Fires Act.

The following sketches have been prepared to show how the fire rules should be applied. Burning permits to be obtained from the Council Rangers Department 9 am to 4.30 pm weekdays only. Fines of up to \$1 000 are applicable where burning is carried out without the required burning permit.


