1. This notice may be cited as the *Prohibition on Fishing ("Sanko Harvest" Wreck Site) Notice 1995*.

Determination of position by reference to the Australian Geodetic Datum

2. (1) Where, for the purpose of this notice it is necessary to determine a position on the surface of the earth by geographical coordinates, that position shall be determined on the Australian Geodetic Datum which is defined by an ellipsoid having a semi-major axis (equatorial radius) of 6 378 160 metres and a flattening of 1/298.25 and fixed by the position of the origin being the Johnston Geodetic Station in the Northern Territory of Australia.

(2) The Johnston Geodetic Station referred to in subclause (1) shall be taken to be situated at 25° 56' 54.5515" south latitude and 133° 12' 30.0771" east longitude and to have a ground level elevation of 571.2 metres above the ellipsoid referred to in that subclause.

Prohibition on taking fish

3. A person shall not take, or attempt to take, any fish by any means from the waters of the Southern Ocean within 500 metres of the intersection of 34° 07' 22.98" south latitude and 122° 04' 56.34" east longitude.

RETAIL TRADING HOURS (TOURISM PRECINCTS) EXEMPTION
ORDER 1995

Made by the Minister for Fair Trading under section 5 of the Act.

Citation

1. This order may be cited as the *Retail Trading Hours (Tourism Precincts) Exemption Order 1995*.

Commencement

2. This order comes into operation on 5 February 1995.

Interpretation

3. In this order, unless the contrary intention appears —

“**Fremantle area**” means the portion of the State delineated in black and bordered red on Department of Land Administration Miscellaneous Diagram No. 504 (a representation of which is reproduced in Schedule 1 and shaded grey);

“**motor shop**” means a general retail shop or portion of a general retail shop, as the case requires —

(a) in, on or from which motor vehicles are sold by way of retail sale; or

(b) in, on or from which spare parts for motor vehicles are sold by way of retail sale in conjunction with the sale of motor vehicles;

“**Perth area**” means the portion of the State delineated in black and bordered red on Department of Land Administration Miscellaneous Diagram No. 503 (a representation of which is reproduced in Schedule 2 and shaded grey).

Retail trading hours — Fremantle area

4. General retail shops, other than motor shops, in the Fremantle area are exempted from section 12 (1) of the Act on the days specified in column 1 of the Table to this clause in each week on the condition that those general retail shops shall be closed —


(a) on those days during the hours specified opposite and corresponding to those days in column 2 of the Table; and

(b) on Anzac Day, Good Friday and Christmas Day.



POISONS ACT 1964

POISONS AMENDMENT REGULATIONS (NO. 9) 1994

Made by His Excellency the Governor in Executive Council.

Citation

1. These regulations may be cited as the *Poisons Amendment Regulations (No. 9) 1994*.

Principal regulations

2. In these regulations the *Poisons Regulations 1965** are referred to as the principal regulations.

For amendments to 13 December 1994 see 1993 Index to Legislation of Western Australia, Table 4, pp. 206-8, and Gazettes of 26 May, 24 June, and 2 and 16 September 1994.]

Regulation 51F repealed and a regulation substituted

3. Regulation 51F of the principal regulations is repealed and the following regulation substituted —

“ **Treatment not to exceed 60 days unless authorized by Commissioner of Health**

51F. (1) A medical practitioner shall not write, issue or authorize a prescription or document or supply a drug of addiction for the treatment of a person, other than a drug addict, for a period in excess of 60 days, or for periods that in the aggregate over the preceding 12 months exceed 60 days, or for a course of treatment exceeding 60 days, unless he has first obtained written authorization to do so from the Commissioner of Health.

(2) Where a medical practitioner has written, issued or authorized a prescription or document prescribing the use, sale or supply of a drug of addiction, for the treatment of a person other than a drug addict, or supplied a drug of addiction for the treatment of a person, other than a drug addict, for a period of 60 days, or for periods that in the aggregate over the preceding 12 months exceed 60 days, or for a course of treatment exceeding 60 days, the medical practitioner shall not thereafter write, issue or authorize a prescription or document prescribing the use, sale or supply of a drug of addiction in relation to that person or supply a drug of addiction in relation to that person unless —

- (a) the medical practitioner has first obtained written authorization under this regulation to do so from the Commissioner of Health; or
- (b) the Commissioner of Health has issued an authorization under this regulation to do so in relation to that person and the authorization is current.

(3) Notwithstanding any authorization referred to in subregulation (1) or (2) a medical practitioner shall not write, issue or authorize a prescription or document prescribing the use, sale or supply of methadone for the treatment of a person or supply methadone for the treatment of a person except for a person suffering from intractable pain arising from a condition of health other than addiction to drugs.

(4) In any authorization issued for the purposes of subregulation (1) or (2) given with respect to a particular person the Commissioner of Health may specify that any one or more of the conditions and restrictions set out below apply, namely —

- (a) that the prescription be issued by or the treatment be administered by a specified medical practitioner;
- (b) that only a specified drug of addiction be prescribed or used for treatment;
- (c) that the type of the drug of addiction specified be of the type specified;
- (d) that the amount to be prescribed or used for treatment shall not exceed the amount specified;
- (e) that the amount to be prescribed or used on any one day shall not exceed the amount specified;
- (f) that the concentration to be prescribed shall not exceed the concentration specified;
- (g) that the intervals between the issue of prescriptions or the administration of the drug of addiction shall be such as are specified;
- (h) that the prescription be supplied at the pharmacy specified;

- (i) that the amount dispensed on a single prescription not exceed such amount as is specified;
- (j) that the amount that may be supplied on any one day shall not exceed such amount as is specified.

(5) An authorization issued for the purposes of subregulation (1) or (2) is valid for such period as is specified unless revoked by the Commissioner of Health before the expiration of that period.

(6) A medical practitioner shall not write, issue or authorize a prescription or document prescribing the use, sale or supply of a drug of addiction or supply a drug of addiction otherwise than in accordance with such conditions and restrictions as are specified.

(7) A pharmaceutical chemist shall not sell or supply a drug of addiction otherwise than in accordance with such conditions and restrictions as are specified pursuant to this regulation.

(8) An authorization issued prior to 1 October 1980 is valid until revoked by the Commissioner of Health or until it expires whichever first occurs.

(9) In this regulation "specified" means by the Commissioner of Health in an authorization issued by him under this regulation in relation to a person other than a drug addict.

- (a) in paragraph (c) by deleting "16" and substituting the following —
" 18 "; and
- (b) in paragraph (g) by deleting "16" and substituting the following —
" 18 ".

Whereas under the provision of the Health Act 1911, a Local Authority may make or adopt by-laws and may alter, amend or repeal any by-laws so made or adopted. Now, therefore, the Town of Albany being a Local Authority within the meaning of the Act and having adopted the Model By-laws described as Series "A" as published in the *Government Gazette* of 17 July 1963, and as amended from time to time thereafter, hereby resolves and determines that the said Model By-law so amended and adopted shall be further amended as follows—

By-law 19 of Part 1 of the Model By-laws Series "A" is amended by deleting sub-bylaws (3) and (4) and substituting the following—

"(3) A person wishing to deposit refuse on land set aside for such purpose by the Council shall, upon entry on the land and prior to depositing the refuse on the land, pay to the Council one or more of the fees specified in sub-bylaws (4); (5); (6) or (7).

(4) (a) The fee payable for the deposit refuse from a vehicle, trailer or bulk bin with a maximum volume capacity of 4 cubic metres or less shall be the fees as determined by multiplying—

(i) the rate specified in Column 2 of Schedule 1 to this by-law that corresponds to the maximum volume capacity of the bulk bin containing the refuse as specified in Column 1 of that Schedule,

by

(ii) the charge specified in Column 2 of Schedule 2 to this by-law that corresponds to the type of refuse to be deposited as specified in Column 1 of that Schedule.

(b) For the purpose of paragraph (a) the maximum volume capacity of a bulk bin shall be the maximum volume capacity as displayed on the outside of the bin in accordance with the provisions of sub-bylaw (8).

(5) (a) The fee payable for the deposit of refuse from a vehicle with a payload of more than 4 tonnes shall be the fee as determined by multiplying—

(i) the actual payload of the vehicle

by

(ii) the charge specified in Column 2 of Schedule 2 to this by-law that corresponds to the type of refuse to be deposited as specified in Column 1 of that Schedule.

(b) For the purposes of paragraph (a) the actual payload of a vehicle will be determined in whole tonnes and where the payload of a vehicle incorporates part of a tonne that part shall be rounded to the next whole tonne.

(6) Notwithstanding anything in sub-bylaws (4) and (5)—

(a) the fee payable for the deposit and burial of asbestos shall be \$20.00 for each cubic metre, or part thereof, deposited; and

(b) the fee payable for the deposit of tyres at the Hanrahan Road Refuse Site shall be—

(i) \$1.00 for each car tyre deposited;

(ii) \$3.00 for each truck tyre deposited; and

(iii) \$5.00 for each tractor tyre deposited.

(7) The minimum fee that shall be paid for any deposit of refuse shall be \$2.00.

(8) For the purpose of sub-bylaw (4), a bulk bin shall have displayed on the outside of the bin, in lettering of a minimum height of 250mm, the maximum volume capacity of the bin.

(9) The Council may, at its discretion, refuse the deposit of recyclable material on the Hanrahan Road Refuse Site.
