PART IIIB—PROCESSING LICENCES**

FD 476/86.

The public is hereby notified that in accordance with section 35CA of the Fisheries Act 1905, I have approved the amendment of the Processors Licence number 1111 issued to Bremer Fish Processors to allow the processing of salmon and herring at Lot 648 Cnr Yate Place and Wellstead Road, Bremer Bay, subject to the following conditions—

1. Shall comply with the requirements of the Fisheries Act 1905-1975 and all Regulations, Orders in Councils, and Notices and Ministerial Directions issued thereunder.
2. Shall not be used for the processing of Prawns or Western Rock Lobster.
3. Shall comply with the requirements of the Health Act 1911 (amended).
4. Shall comply with the requirements of any town planning scheme or interim development order gazetted under the provisions of the Town Planning and Development Act 1928 (amended), or the Metropolitan Region Town Planning Scheme Act 1959 (amended).
5. Shall be registered as an export establishment pursuant to the provisions of the Parliament of the Commonwealth Export Control Act 1982, and Orders made thereunder, more specifically the Prescribed Goods (General) Orders and the Fish Orders, should it be used to process fish for export.
6. Shall not be used for the processing of marron (*cherax tenimanus*) unless a licence held under section 39C of the Fisheries Act 1905.
7. Shall not receive or buy any unprocessed Australian Salmon or Australian Herring from any licensed Australian Salmon fisherman or Herring trap fisherman authorised to fish west of Dillon Bay.
8. Shall not receive or buy any unprocessed Australian Herring taken by fisherman in any waters west of Dillon Bay.

In accordance with the provisions of section 35K, any person aggrieved by this decision, may within fourteen days after publication of this notice, appeal against the decision or order by serving on the Minister for Fisheries a statement in writing on the grounds of their appeal.

**FAIR TRADING****FT301****RETAIL TRADING HOURS ACT 1987  
RETAIL TRADING HOURS (FILLING STATIONS)  
EXEMPTION ORDER 1995**

Made by the Minister for Fair Trading under section 5 (1) of the Act.

**Citation**

1. This order may be cited as the *Retail Trading Hours (Filling Stations) Exemption Order 1995*.

### Commencement

2. This order comes into operation on the day after the day on which it is published in the *Gazette*.

### Certain filling station operators — exemption from s. 14 (5)

3. (1) A person who operates a prescribed filling station is exempt from section 14 (5) of the Act.

(2) For the purpose of subclause (1) a filling station is a prescribed filling station if —

- (a) only goods specified in Schedule 1 are sold at the filling station;
- (b) the filling station is owned by one eligible person or not more than 6 eligible persons trading in partnership or by a body corporate with not more than 6 shareholders all of whom are eligible persons;
- (c) the eligible persons referred to in paragraph (b) are personally and actively engaged in the filling station;
- (d) not more than 10 persons (inclusive of the eligible persons who own and operate the filling station) work in the filling station at any one and the same time; and
- (e) the chief executive officer has issued a certificate in relation to the filling station certifying that it is a prescribed filling station in terms of this subclause.

(3) A person is not an eligible person for the purposes of subclause (2) unless —

- (a) in relation to a case where the person is the only person in question the person —
  - (i) is a natural person; and
  - (ii) does not own or operate, either alone or together with any other person, more than 3 retail shops except as a shareholder in a listed corporation as defined under the *Companies (Western Australia) Code*;

and

- (b) in relation to a case where the person in question is one of a group of persons, the person —
  - (i) is a person to whom the provisions of paragraph (a) (i) and (ii) apply;
  - (ii) does not own or operate another retail shop together with a person who is outside that group of persons; and
  - (iii) does not himself or herself own or operate a retail shop alone if one of the other persons in the group owns or operates a retail shop that is not owned or operated together with the other persons in the group.

(4) It is a condition of this exemption that the operator of a filling station to whom the exemption applies —

- (a) is to notify the chief executive officer of any change in the ownership or directorship of the filling station within 14 days of such change; and
- (b) is to display the certificate referred to in subclause (2) (e) in a prominent position, clearly visible to staff and members of the public, within the filling station.

(5) The chief executive officer may cancel a certificate issued under subclause (2) (e) if the chief executive officer is satisfied that the filling station is not owned or operated in terms of subclauses (2) and (3).

12. Light globes, torches, dry batteries, candles.
13. Panty-hose, boot and shoe laces, cotton, needles, pins.

15. Swimming pool chemicals and accessories.
16. Maps, barbecue requisites, tarpaulins, firewood, coolers.

## RETAIL TRADING HOURS ACT 1987

RETAIL TRADING HOURS (FILLING STATIONS)  
EXEMPTION ORDER (NO. 2) 1995

Made by the Minister for Fair Trading under section 5 (1) of the Act.

**Citation**

1. This order may be cited as the *Retail Trading Hours (Filling Stations) Exemption Order (No. 2) 1995*.

**Commencement**

2. This order comes into operation on 22 May 1995.

**Interpretation**

3. (1) In this order —

“prescribed filling station” has the meaning given in the *Retail Trading Hours (Filling Stations) Exemption Order 1995*.

(2) In this order, a reference to a numbered zone refers to the district corresponding to that numbered zone, as prescribed by the *Retail Trading Hours (Filling Station Zones) Regulations 1988* for the purposes of section 14 of the Act.

**Exemption (filling station trading hours) — (Zones Nos. 1 to 8 inclusive)**

4. A person who operates a filling station in any of Zones Nos. 1 to 8 inclusive may sell or allow to be sold —

- (a) fuel;
- (b) requisites; or
- (c) goods prescribed under section 14 (5) (b) of the Act,

at that filling station, or keep that filling station open, during such hours as the operator thinks fit and to that extent the *Retail Trading Hours Act 1987* does not apply to filling stations in those zones.

**Further exemption (prescribed filling station trading hours) — (Zones Nos. 1 to 8 inclusive)**

5. In addition to the exemption in clause 4, a person who operates a prescribed filling station in any of Zones Nos. 1 to 8 inclusive may sell or allow to be sold goods specified in Schedule 1 to the *Retail Trading Hours (Filling Stations) Exemption Order 1995* at that prescribed filling station, or keep that prescribed filling station open, during such hours as the operator thinks fit and to that extent the *Retail Trading Hours Act 1987* does not apply to prescribed filling stations in those zones.

**Amendment of previous Order**

6. The *Retail Trading Hours Exemption Order (No. 24) 1992\** is amended in clause 4 (1) by deleting "the metropolitan area (Zones Nos. 1 to 8 inclusive)".

(2) In this order, a reference to a numbered zone refers to the district corresponding to that numbered zone, as prescribed by the *Retail Trading Hours (Filling Station Zones) Regulations 1988* for the purposes of section 14 of the Act.

**Exemption (filling station trading hours) — Zones Nos. 10, 11, 13 and 15**

4. A person who operates a filling station in —

- (a) the Bunbury District (Zone No. 10);
- (b) the Kalgoorlie-Boulder District (Zone No. 11);
- (c) the Geraldton District (Zone No. 13); or
- (d) the Esperance District (Zone No. 15),

may sell or allow to be sold —

- (e) fuel;

- (f) requisites; or
- (g) goods prescribed under section 14 (5) (b) of the Act,

at that filling station, or keep that filling station open, during such hours as the operator thinks fit and to that extent the *Retail Trading Hours Act 1987* does not apply to filling stations in those zones.

**Further exemption (prescribed filling station trading hours) — Zones Nos. 10, 11, 13 and 15**

5. In addition to the exemption in clause 4, a person who operates a prescribed filling station in —

- (a) the Bunbury District (Zone No. 10);
- (b) the Kalgoorlie-Boulder District (Zone No. 11);
- (c) the Geraldton District (Zone No. 13); or
- (d) the Esperance District (Zone No. 15),

may sell or allow to be sold goods specified in Schedule 1 to the *Retail Trading Hours (Filling Stations) Exemption Order 1995* at that prescribed filling station, or keep that prescribed filling station open, during such hours as the operator thinks fit and to that extent the *Retail Trading Hours Act 1987* does not apply to prescribed filling stations in those zones.

**Amendment of previous Order**

6. The *Retail Trading Hours Exemption Order (No. 3) 1994\** is amended in clause 3 (1) —

- (a) by deleting “the Kalgoorlie-Boulder District (Zone No. 11)”;
- (b) by deleting “, the Geraldton District (Zone No. 13)”.

      - (i) to ensure appropriate standards of development and maintenance are achieved within the zone; and
      - (ii) to control and enhance the health, safety, convenience and the general welfare and amenity of the locality.
    - 6.11.2 The following provisions shall apply to all land included in the zone in addition to any provisions which are more generally applicable to such land under this Scheme:
      - (a) All development in the Fascine Waterway Development zone shall be determined by the Council on its merits as if the development proposed were listed as an AA use in Table No.1—Zoning Table.

- (b) Subdivision and development of land within the Fascine Waterway Development zone shall be generally in accordance with the Carnarvon Fascine Structure Plan signed by the Shire Clerk and which forms part of the Scheme.
- (c) Notwithstanding what may be shown on the Carnarvon Fascine Structure Plan, the Department of Planning & Urban Development and the Shire of Carnarvon may approve minor variations to the subdivision design and recommended landuses, providing any alteration remains consistent with the overall intent of the Structure Plan and is consistent with the provisions and objectives of this Scheme.
- (d) Those areas identified for residential development on the Carnarvon Fascine Structure Plan shall be subject to the requirements of the R Codes as described elsewhere in the Scheme. The provisions of the R20 Code shall apply to all residential development, except those sites which may be nominated now on the Structure Plan (or in the future as a result of an approved departure from the Structure Plan), as being suitable for higher density development in which case the R40 Code shall apply. Where the provisions of this Section of the Scheme vary from any of the R Code requirements expressed elsewhere in the Scheme the provisions of this Section shall prevail.
- (e) Given that the boundary of a lot is defined as being 0.5m beyond the toe of the canal walls, the maintenance of all water frontage walling, retaining and revetment shall be the responsibility of each lot owner.
- (f) The existing canal walls along a canal frontage shall be kept in a structurally sound condition to the satisfaction of the Local Authority, and shall not be altered, extended or removed without the written approval of the Council first being applied for and obtained.
- (g) No retaining wall or fencing shall be erected within 1.0 metres from the top of the original canal wall.
- (h) No retaining wall (other than a canal wall) situated more than 1.0m, but less than 7.0m from the top of the original canal wall, shall exceed 1.0m above the stabilised surface level.
- (i) No side or rear fence situated within 7.0m from the top of the original canal wall shall exceed 0.9m above the stabilised surface level.
- (j) No side fence situated more than 7.0m from the top of the original canal wall shall exceed 1.8m above the stabilised surface level.
- (k) No rear fence situated more than 7.0m from the top of the original canal wall shall exceed 1.5m above the stabilised surface.
- (l) Council shall require that any side or rear fencing situated within 7.0m from the top of the original canal wall shall be of open grill construction and solid fencing shall not be permitted.
- (m) All fencing other than that which is required to be of open grill standard shall be manufactured of materials and be of a construction standard which Council considers to be compatible with the overall objective of creating a high standard of visual amenity in this zone. In reaching any decision in this regard, Council will be mindful of the recommendations and guidelines contained within the Landscape Master Plan, Fibro and colourbond fencing shall not be permitted.
- (n) Council may permit any dwelling or structure, including retaining wall, canal wall or fencing, building or outbuilding to be erected at any height above or below the stabilised surface level and any setback from the canal frontage, provided that;
- (i) Council is satisfied that there will be an improved architectural amenity resulting from a minimum setback distance between buildings and the canal frontage in the particular case;
  - (ii) Council is satisfied that the overall amenity and appearance of the canal frontage will be maintained or improved;
  - (iii) A professional structural engineer provides certification as to the structure soundness of the proposed works (i.e. Council is satisfied that no erosion or soil instability will result).
- (o) All clothes drying areas and utility areas which, in the opinion of the Council, detract from the amenity of either the canal frontage or the road frontage, shall be screened from view to the satisfaction of Council.
- (p) For the purpose of applying and enforcing the relevant setback and development standards, the front of any lot is that boundary which abuts the road reserve. The boundary abutting a waterway is the rear of the lot.


