**CONSERVATION AND LAND MANAGEMENT ACT 1984
ORDER TO EXCISE A PORTION OF STATE FOREST No. 13**

CALM File 030983F4304; DOLA File 1780/994, 2701/990

Made by His Excellency the Governor under Section 9 (2).

Whereas both Houses of Parliament passed a resolution that a proposal from His Excellency the Governor dated the Twentieth day of July 1993, for the partial revocation of State forest Nos. 7, 13, 17, 22, 24, 25, 31, 37, 38 and 65, should be carried out. Now, His Excellency the Governor, with the advice and consent of the Executive Council, declares that the dedication of Crown land as State forest No. 13 is partially revoked by excision of the area described in the schedule.

Schedule

All that portion of State forest No. 13 being the whole of the land shown bordered in red on Department of Conservation and Land Management registered plan No. 1749.

Area: about 23 347 hectares.

Public Plan: Mt Observation SW, Beraking NE & SE, Chidlow SE, Coolaring NW, SW & SE and Yaganing NE 1:25 000.

BROOME PRAWN FISHERY—DIRECTIONS TO LICENSING OFFICERS NOTICE 1995

Notice No. 713

FD 690/87.

Pursuant to section 17 I hereby give licensing officers the following directions regarding the issue and endorsement of fishing boat licences to authorise boats to be used to take prawns by means of trawling in the waters described in the Schedule to this notice.

Citation

1. This notice may be cited as the *Broome Prawn Fishery—Directions to Licensing Officers Notice 1995*.

Interpretation

2. In this notice unless the contrary intention appears—

“approved” means approved by the Director;

“fishing boat licence” means a licence issued pursuant to regulation 2 of the *Fisheries Regulations 1938*;

“Fishery” means the taking of prawns by trawling from the waters specified in the Schedule;

“fishing permit” means a fishing permit issued pursuant to the *Fisheries Management Act 1991* (Commonwealth);

“operate” means to—

(a) attempt to take prawns by trawling;

(b) take prawns by trawling;

(c) engage in any activity that could reasonably be expected to result in taking prawns by trawling;

“prawns” means all species of decapod crustacea of the family *Penaeidae*.

Directions to licensing officers

3. (1) Licensing Officers shall use the following criteria to determine if a fishing boat licence for a boat may be endorsed to authorise the boat to be used to take prawns by means of trawling in the waters specified in the Schedule—

(a) The name of the boat—

(i) is endorsed on a current fishing boat licence; and

(ii) was, as at 1 July 1994, endorsed on a fishing permit and that permit authorised the boat to be used to take prawns by trawling in the waters specified in the Schedule during the period 10 June 1994 to 25 July 1994;

or

(b) The name of the boat—

(i) is not endorsed on a current fishing boat licence; and

(ii) was, as at 1 July 1994, endorsed on a fishing permit and that permit authorised the boat to be used to take prawns by trawling in the waters specified in the Schedule during the period 10 June 1994 to 25 July 1994;

or

(c) The name of the boat is endorsed on a current fishing boat licence and that boat has replaced a boat to which subparagraph (a) (ii) applies;

or

(d) The name of the boat is not endorsed on a current fishing boat licence and that boat has replaced a boat to which subparagraph (b) (ii) applies.

- (2) The following endorsement and conditions shall be placed on the fishing boat licence for a boat which satisfies the criteria specified in paragraph (a) or paragraph (c) of subclause (1)—

“ **BROOME PRAWN TRAWL FISHERY**

(a) The boat to which this licence applies is authorised to be used to take prawns by means of trawling in the waters specified in the Schedule to these conditions.

(b) The access granted under paragraph (a) is interim access only and may be withdrawn at any time.

(c) Prawns may only be taken during the period commencing 10 June 1995 and ending 25 July 1995 (“the season”).

(d) The licensee or person in charge of the boat to which this licence applies shall—

(i) attend a pre-fishing meeting at the Broome Office of the Fisheries Department immediately before the start of the season;

(ii) ensure that the boat is fitted with a fully operational Global Positioning System (“GPS”) and that if a malfunction with the GPS develops during the season then the boat shall immediately cease fishing until the fault is rectified and the Officer In Charge of the Fisheries Department in Broome is notified;

(iii) facilitate the carrying of Fisheries Officers and Observers including their embarkation and disembarkation in Broome;

(iv) ensure that any Fisheries Officer or Observer has unrestricted access to all navigational and communications equipment;

(v) ensure that all persons on the boat give full co-operation and assistance to any Fisheries Officer or Observer in the performance of their duties;

(vi) ensure that any pearl oyster brought aboard the boat is returned to the sea immediately; and

(vii) ensure that the Western Australian Fisheries Department research logbook is accurately completed in a legible form and forwarded to the appropriate address.

Schedule

All Western Australian waters bounded by a line commencing at the intersection of 17° 20' south latitude and 121° 50' east longitude; thence south to the intersection of 17° 50' south latitude and 121° 50' east longitude; thence east to the intersection of 17° 50' south latitude and 121° 55' east longitude; thence north to the intersection of 17° 40' south latitude and 121° 55' east longitude; thence east to the intersection of 17° 40' south latitude and 122° east longitude; thence north to the intersection of 17° 20' south latitude and 122° east longitude; thence west to the commencement point.

(3) To authorise a boat, which meets the criteria specified in paragraph (b) or paragraph (d) of subclause (1) to be used to operate in the Fishery the following action shall be taken—

- (a) The holder of a fishing permit referred to in paragraph (b) of subclause (1) shall apply in the approved manner for a fishing boat licence; and
- (b) if that application is approved by the Director a fishing boat licence with the licensed fishing boat number LFBQ101 shall be issued to the applicant and the boat name shall be endorsed on the licence.

(4) In addition to the conditions specified in subclause (2) of this clause the following conditions shall be placed on a fishing boat licence issued pursuant to subclause (3)—

- “ (a) This licence shall not be transferred.
- (b) The endorsement permitting the boat named on this licence to be used to take prawns in the waters specified in the Schedule to these conditions shall not be transferred.
- (c) The boat to which this licence applies shall not be used to take any fish by any means in any Western Australian waters other than prawns by trawling in the waters specified in the Schedule during the period commencing on 10 June 1995 and ending on 25 July 1995.
- (d) Unless otherwise authorised in writing by the Minister this licence shall not be renewed. ”

Schedule

All Western Australian waters bounded by a line commencing at the intersection of 17° 20' south latitude and 121° 50' east longitude; thence south to the intersection of 17° 50' south latitude and 121° 50' east longitude; thence east to the intersection of 17° 50' south latitude and 121° 55' east longitude; thence north to the intersection of 17° 40' south latitude and 121° 55' east longitude; thence east to the intersection of 17° 40' south latitude and 122° east longitude; thence north to the intersection of 17° 20' south latitude and 122° east longitude; thence west to the commencement point.
