

By-law Relating to the Payment of Rates and Charges

In pursuance of the powers conferred upon it by the abovementioned Act and of all other powers enabling it, the Council of the abovementioned Municipality hereby records having resolved on the 14th day of December 1994 to make and submit for confirmation by the Governor the following By-law—

1. Rates and Charges imposed by the Council of the City of Geraldton under the provisions of the Local Government Act 1960 shall become due and payable on the day on which the memorandum referred to in Section 550 (1) of the said Act is published in the *Government Gazette*.

2. Notwithstanding the requirements of clause 1 hereof, the rates and charges may, at the option of the ratepayer, who is the owner or occupier of the rateable property, upon approval being granted to a written application, substantially in the form of the FIRST SCHEDULE, by such officers as shall be nominated from time to time by Council, be paid by instalment in accordance with the following options—
 - (a) Option 1

Upon receipt of a written application by the Council, substantially in the form of the FIRST SCHEDULE, rates and charges may be paid by four (4) instalments which so far as practicable shall be equal, with—

 - (i) The first instalment being paid within thirty-five (35) days of issue of the Rate Notice;
 - (ii) The remaining three (3) instalments to be paid on or before the 15th day of November, January and March in that financial year.
 - (b) Option 2

Make application to the Council to pay rates by instalments other than as detailed in Option 1. Upon approval by the Council the rates are then due and payable on the dates specified by the Council in the approval.
3. In each case where a ratepayer elects to pay under clause 2, each application will be subject to an administration fee of \$20.00. The administration fee shall be payable with the first instalment.
4. If the first instalment and the written application as defined in clause 2 above are not received within thirty-five (35) days from the date as defined in clause 1 above, rates and charges become due and payable in full within thirty-five (35) days of such date.
5. If any instalment other than that referred to in clause 4 shall be in arrears for a period of two (2) months or more then the total outstanding balance shall become due and payable forthwith.
6. A person who has elected to pay the rates and charges by instalments is liable for the payment of any penalty imposed by the Council in accordance with Section 550A of the Local Government Act 1960 on the rate if the rate is not paid in full by the relevant date referred to in that Section.
7. A discount of the current rates not exceeding 5% as determined by the Council and specified in the Notice of Valuation and Rate shall be allowed to a person liable to pay the rate if the rate and charges and any arrears are paid in full within thirty five (35) days after the issue of the Notice of Valuation and Rate.




