Elizabeth the Second, by the Grace of God, Queen of Australia and Her other Realms and Territories, Head of the Commonwealth. To all of whom these presents shall come, GREETING: Know Ye that

whereas by section 9 of the *LAND ACT 1933*, power is given to the Governor to grant leases of any portion of Crown land to any person referred to in that section for the purposes referred to in that section: And whereas , in the said State, has made application for a lease of the land hereinafter described for the purposes of ; And whereas the said Governor has approved the granting of the said lease; We of our especial Grace, and in consideration of the premises, and also in consideration of the rents hereinafter reserved and on the part of the said executors, administrators, and assigns (hereinafter called "the Lessee"), to be paid, and in exercise of the powers given by the Act, do by these Presents demise and lease to the said Lessee the natural surface and so much of the land as is below the natural surface to a depth of metres of ALL THAT piece or parcel of land being and containing as delineated by a border of green colour on the plan hereon, with the appurtenances: To have and to hold the premises hereby demised subject to the powers, reservations, and conditions herein and in the Schedule below, and in the Act contained, and with all the rights, powers, and privileges conferred by the Act as are applicable hereto, unto the said Lessee, *for the term of years\* or in perpetuity\**, to be computed from the day of , for the purposes aforesaid: Yielding and Paying therefore *during the said term\* or in perpetuity\** unto Us, Our heirs and successors, the yearly rent of without deduction, by equal payments half-yearly, in advance on or before First day of March and First day of September in every year, such rent to be paid to our Minister for Lands: Provided, nevertheless, that it shall at all times be lawful for Us, Our heirs and successors, or for any person or persons acting in that behalf by Our or their authority, to resume and enter upon possession of any part of the said lands which it may at any time by Us, Our heirs and successors, be deemed necessary to resume for roads, tramways, railways, railway stations, bridges, canals, towing paths, harbour or river improvement works, drainage utility, or convenience, and for the purpose of exercising the power to search for minerals and gems hereinafter reserved, and such land so resumed to hold to Us, Our heirs and successors, as of Our or their former estate, without making to the said Lessee, or any person claiming under the Lessee, any compensation in respect thereof; so, nevertheless, that the lands so to be resumed shall not exceed one-twentieth part in the whole of the lands aforesaid, and that no such resumption be made of any part of the said lands upon which any buildings may have been erected, or which may be enclosed and in use as gardens, or otherwise for the more convenient occupation of any such buildings or on which any other improvements as defined by the Act have been made without compensation: Provided also, that it shall be lawful at all times for Us, Our heirs and successors, or for any person or persons acting in that behalf by Our or their authority, to cut and take away any such indigenous timber, and to search and dig for and carry away any such stones or other materials which may be required for making or keeping in repair any roads, tramways, railways, railway stations, bridges, canals, towing paths, harbour works, breakwaters, river improvements, drainage or irrigation works, and generally for any other works or purposes of public use, utility, or convenience, without making to the lessee, or any person claiming under the Lessee, any compensation

in respect thereof, and we do hereby save and reserve to Us, Our heirs and successors, all mines of gold, silver, copper, tin or other metals, ore, and mineral, or other substances containing metals, and all gems and precious stones, and coal or mineral oil, and all phosphatic substances in and under the said land, with full liberty at all times to search and dig for and carry away the same, and for that purpose enter upon the said land or any part thereof: and we do hereby save and reserve to Us, Our heirs and successors, all petroleum (as defined in the *Petroleum Act 1967*) on or below the surface of the said land with the right reserved to Us, Our Heirs and successors and persons authorized by Us, Our heirs and successors to have access to the said land for the purpose of searching for and for the operations of obtaining petroleum in any part of the said land subject to and in accordance with the *Petroleum Act 1967* or any Act repealing and enacted in substitution of that Act: Provided also, that if the said Lessee shall, during the term hereby created, at any time make default in payment of the rent hereby reserved, or shall fail or cease to use, hold, and enjoy the said land for the special purpose, or shall fail or neglect to comply with, perform or fulfil all or any of the conditions scheduled below, or the conditions or provisions of the Act, and it shall thereupon be lawful for Us, Our heirs and successors into and upon the said demised premises, or any part thereof in the name of the whole to re-enter, and the same to have again, repossess, and enjoy as if this deed-poll had never been executed, without making any compensation to the said Lessee.

#### LOCAL GOVERNMENT ACT 1960

##### *Municipality of the Shire of Meekatharra*

##### By-law Relating to Trading in Public Places

In pursuance of the powers conferred upon it by the abovementioned Act and of all other powers enabling it, the Council of the abovementioned Municipality hereby records having resolved on 19th November 1994 to make and submit for confirmation by the Governor the following By-law relating to trading in public places within the Townsite of Meekatharra.

1. Repeal: The Shire of Meekatharra Stall holder By-laws published in the *Government Gazette* of the 3rd January 1936 and Hawkers By-laws published in the *Government Gazette* of the 30th July 1937, are repealed.

2. Interpretation: In this By-law, unless the context otherwise requires—

“Council” means the Municipality of the Shire of Meekatharra.

“Public Place” includes a street, way and other place which the public are allowed to use, whether the street, way or place is or is not on private property.

“Trading” means selling/or hiring of goods, wares, merchandise or services or offering goods, wares, merchandise or services for sale or hire, in a street or other public place and includes displaying goods, wares or merchandise for the purpose of offering them for sale or hire, inviting offers for sale or hire, soliciting orders or carrying out any other transactions therein, but does not include the setting up of a stall, or the conducting of business at a stall, under the authority of a licence issued under by-laws made under section 242.

“Community Association” means an institution, association, club, society, or body, whether incorporated or not, the objects of which are of a charitable, benevolent, religious, cultural, educational, recreational, sporting or other like nature and the members of which are not entitled or permitted to receive any pecuniary profit from the transaction thereof.

3. This By-law shall not apply to the selling or offering for sale of newspapers or magazines, nor shall it apply to community associations.

4. No person shall carry on trading in any public place unless that person is acting within the specifications of a current licence issued under this By-law and for which all fees and charges have been paid.

5. An application for a licence shall be in writing and shall contain such information as the Council may require.

6. In considering an application for a licence the Council shall have regard for any relevant policy statements, and for the desirability of the proposed activity and its location and for the circumstances of the case, and may refuse to issue a licence, in which case it shall provide the applicant with reasons in writing.

7. The Council may issue a licence specifying such requirements, terms and conditions as the Council sees fit including—

- (a) the place to which the licence applies;
- (b) the days and hours when trading may be carried on;
- (c) the number, type, form and construction, as the case may be, of any stand, table, structure or vehicle which may be used for trading;
- (d) the particulars of the goods or services or transaction in respect of which trading may be carried on;
- (e) the number of persons and the names of persons permitted to carry on trading, and any requirements concerning personal attendance at the place of trading and the nomination of assistants, nominees or substitutes;
- (f) whether and under what terms the licence is transferable;
- (g) any prohibitions or restrictions concerning the causing of any nuisance, the use of signs, the making of noise and the use of amplifiers, sound equipment, sound instruments and lighting apparatus;
- (h) any requirements concerning the display of the licence holder's name and other details of licence, the care, maintenance and cleansing of the place of trading or the vacating of the place when trading is not taking place;
- (i) any requirements regarding the acquisition by the licence holder of public risk insurance; and
- (j) the period not exceeding 12 months during which the licence is valid.

8. The amount of the charges and fees shall be calculated and payable in accordance with the Schedule hereto.

9. The Council may revoke a licence in the event that the licence holder breaches any provision of this By-law or fails to comply with any requirement, term or condition of the licence.

10. Where a licence is revoked the Council shall if requested, provide the licence holder with reasons in writing and shall refund the charge having first deducted the charge applicable to the period from the issuing of the licence to its revocation.

11. Any person who contravenes or fails to comply with any provisions of the by-laws commits an offence and is liable on conviction to a penalty for up to \$1 000 or imprisonment for six (6) months.



Pursuant to the powers contained in section 33 of the above Act, you are hereby required on or before the 1st November, 1995, to plough, scarify, cultivate, chemically spray, mow, slash or otherwise clear and thereafter maintain free of flammable material until the 14th February, 1996, firebreaks of the following dimensions and in the following positions on the land owned or occupied by you:

**1. RURAL LAND AND SPECIAL RURAL LAND**

Boundary firebreaks are not compulsory, however—

- (a) Landowners can provide firebreaks if they desire, no less than 2.5 metre wide; and
- (b) Firebreaks shall be installed at least 6 metres wide around the perimeter of any homestead building (excluding isolated non inflammable buildings), haystacks (within 100 metres of any building) or group of structures or installations. These firebreaks shall be in place during the period 1st November 1995 to 14th February 1996 by cultivating or spraying in such positions as are necessary.

**2. TOWNSITE LAND**

Within the town boundary as defined by the Town Planning Scheme including Residential, Commercial, Industrial, Deferred Urban and Special Rural whether such land is occupied or not.

- (a) Where the area of land is 2100m<sup>2</sup> (approximately half acre) or less, remove all flammable material from the whole of the land. For the purpose of this notice, flammable material does not include live standing trees, cultivated plants or shrubs in gardens.
- (b) Where the area of land exceeds 2100m<sup>2</sup> (approximate half acre), clear firebreaks not less than 2.5 metres wide, immediately inside and along all external boundaries of the property.

**FLAMMABLE MATERIAL:** Includes bush, timber, boxes, cartons, paper and like flammable materials, rubbish and also any combustible matter, but does not include green standing trees or growing bushes and plants in gardens or lawns.

No person shall operate a grain harvesting machine on any land unless he has provided a mobile and operational fire-fighting unit, having a water capacity of at least 600 litres, situated in or immediately adjacent to the paddock where harvesting operations are being conducted.

## Notice to Owners and Occupiers of land in the Shire of Mullewa

Pursuant to the powers contained in section 33 of the above Act, you are hereby required on or before the 1st October 1995, to plough, scarify, cultivate or otherwise clear, and thereafter maintain free from all flammable material until 31st March 1996, firebreaks in accordance with the following—

**1. RURAL LAND**

Owners and Occupiers of Lands, other than within a townsite, shall clear of all flammable material firebreaks of at least three (3) metres width as close as practically possible inside and along the whole of the external boundary of their property or properties.

**2. TOWNSITE LAND**

Owners and Occupiers within a townsite shall—

- (a) Clear of all flammable material the whole of the area where—
  - (i) The area of the land is 2 023 square metres or less or,
  - (ii) The land is used for storage of flammable liquids, or
  - (iii) There is a hotel situated thereon.
- (b) If the area of land exceeds 2 023 square metres (half an acre)—
  - (i) Clear of all flammable material firebreaks at least two (2) metres wide immediately inside all external boundaries of the land, or
  - (ii) have the grass mown to a height of not more than 50mm over the whole of the land, except where the land is used for the storage of flammable liquids.

**3. HOMESTEADS, BUILDINGS, HAYSTACKS, STACKS OF FODDER, BULK FUEL, DRUMS AND LIQUID PETROLEUM**

Owners and Occupies of land shall—

During the period from 1st day of October 1995, to the 31st day of March 1996 inclusive, have firebreaks at least three (3) metres wide in such positions as are necessary to completely surround the perimeter of any homestead, building, fuel installation (including drums), haystack (where such a haystack is situated within 200 metres of any homestead, building, fuel installation) or group of such structures or installations.

**4. HARVESTING**

A fully operational mobile fire fighting unit complete with a container with at least 400 litres minimum capacity of water is to be readily available to any paddock being harvested. A fully operational plough, tillage or cultivator equipment is to be readily available, and in close proximity, to any paddock being harvested. the responsibility to supply these units being that of the landholder.

**5. GENERAL INFORMATION**

If for any reason it is considered impractical to comply with any provision of this notice a written application for a variation may be made to the Shire Council and must reach the Shire Clerk by the 30th day of September 1995. Any such application must bear the signature of the Fire Control Officer of the brigade area signifying his agreement to the variation.

If permission for variation is not granted the terms of this notice must be complied with, or as the Council directs.

**6. REGISTRATION**

It is in the interest of all residents to be registered members of the Bush Fire Brigade covering the area in which they own land. 
