**RETAIL TRADING HOURS ACT 1987****RETAIL TRADING HOURS (ROCKINGHAM) EXEMPTION ORDER 1995**

Made by the Minister for Fair Trading under section 5.

**Citation**

1. This Order may be cited as the *Retail Trading Hours (Rockingham) Exemption Order 1995*.

**Interpretation**

2. In this order—

"Public Holiday" means a public holiday under section 5, section 7 or section 8 of the *Public and Bank Holidays Act 1972* but does not include Anzac Day, Christmas Day or Good Friday.

"School term" means a school term determined by the Minister charged with the administration of the *Education Act 1928* under that Act.

**Exemption periods**

3. (1) During the period commencing on the first-mentioned day in each of the following paragraphs and ending at the close of business on the second-mentioned day in each of those paragraphs, namely—

- (a) 1 January to the second Sunday in February;
- (b) the Saturday preceding Labour Day to the following Monday;
- (c) the Saturday following the end of the first school term to the Sunday preceding the second school term;
- (d) the Saturday following Good Friday to Easter Monday;
- (e) the Saturday preceding Foundation Day to Foundation Day;
- (f) the Saturday following the end of the second school term to the Sunday preceding the third school term;

- (g) the Saturday following the end of the third school term to the Sunday preceding the fourth school term;
- (h) the Saturday preceding the Queen's Birthday public holiday to the Queen's Birthday public holiday;
- (i) the first Sunday in December to Christmas Eve; and
- (j) Boxing Day to the last day of December;

general retail shops other than specified general retail shops in the areas or localities specified in Column 1 of the Schedule are exempted from the *Retail Trading Hours Act 1987* on the days specified in the Schedule subject to the conditions as to hours of closing specified opposite and corresponding to those areas or localities in Column 2 of the Schedule.

(2) In sub-clause (1)—

“specified general retail shops” means general retail shops—

- (a) in, on or from which motor vehicles are sold; or
- (b) in, on or from which spare parts for motor vehicles are sold by way of retail sale in conjunction with the sale of motor vehicles.

**Rubbish Charges**

The following charges are prescribed for the removal of house and trade refuse and other rubbish from premises situated within the aforesaid parts of the said districts of the Shire of Roebourne, namely—

- (a) Premises within Townsites which are not permitted to be rated—
  - (1) \$3.00 for each daily emptying by the Shire of Roebourne of a receptacle by an occupier in accordance with By-law 12 hereof.
  - (2) \$17.00 per cubic metre for the removal by the Shire of Roebourne of other trade refuse.
- (b) Special areas not rateable under the Gross Rental Value system as prescribed by the Local Government Act.
  - (1) A charge set by the Shire taking into account the time taken for travelling, collecting and tip maintenance.

## Notice to all Owners and/or Occupiers of Land

Pursuant to the powers contained in Section 33 of the above Act, you are hereby required on or before 30 November 1995 or within 14 days after the date of you becoming an owner or occupier should this be after 30 November 1995 and thereafter up to and including 31 March 1996, to have a firebreak clear of all flammable material at least three metres wide immediately inside all external boundaries of the land and also immediately surrounding all buildings situated on the land which is maintained free of all flammable material.

If it is considered to be impracticable for any reason to clear firebreaks as required by this notice, you may apply to Council or its duly authorised Officer not later than 14 November 1995, for permission to provide firebreaks in alternative positions on the land. If permission is not granted by the Council or its duly authorised Officer, you shall comply with the requirements of this notice.

Flammable material is defined for the purpose of this order to include bush (as defined in the Bush Fires Act), boxes, cartons, paper and like flammable materials, rubbish and also any combustible matter, but does not include green standing trees and plants in gardens or lawns.

The penalty for failing to comply with this notice is a fine of not less than \$80.00 or more than \$800.00. A person in default is also liable, whether prosecuted or not, to pay the cost of performing the work directed in this notice if it is not carried out by the owner or occupier by the date required by this notice. Council discourages the requirements of this notice to be carried out by burning, and urges owners or occupiers to attend to this task by rotary hoeing, cultivation or scarifying. However, should burning take place, it must be in accordance with the relevant provisions of the Bush Fires Act 1954.

## FIRE CONTROL ORDER 1995/96

Pursuant to the powers contained in Section 33 of the Bush Fires Act 1954, all owners and occupiers of land within the Shire of Pingelly are hereby required to take, provide and/or maintain fire control measures during the firebreak period, as follows—

“Excluded Area” means an area of rural land not exceeding 30 hectares, where it is physically impossible to install firebreaks, or where in the owner's or occupier's opinion, the installation of firebreaks would be detrimental to the conservation of remnant or natural vegetation or the establishment of re-afforested areas.

“Farming Land” means all land within the Shire of Pingelly zoned ‘Farming’ under the Town Planning Scheme No. 2.

"Firebreak" means ground from which all inflammable material has been removed and on which no inflammable material is permitted during the firebreak period.

"Firebreak Period" means the time between 1st November and 15th April in the following year.

"Inflammable Material" means bush (as defined by the Bush Fires Act 1954), timber, boxes, cartons, paper, and the like inflammable materials, rubbish and any combustible matter, but does not include buildings, standing trees or growing bushes or plants in gardens or lawns.

"Rural Residential Land" means all land within the Shire of Pingelly zoned 'Rural Residential' under the Town Planning Scheme No. 2.

"Townsite Land" means all land within the townsite of Pingelly not zoned as 'Rural Residential' under the Town Planning Scheme No. 2.

#### Farming Land

On farming land other than excluded areas, the owner or occupier shall—

- (a) clear firebreaks not less than two metres wide—
  - (i) inside all external boundaries of the land,
  - (ii) within fifteen metres of the perimeter of all buildings and remove all inflammable material from within the two metres of all such buildings, and
  - (iii) so as to divide the land into areas not exceeding 400 hectares,
- (b) remove all inflammable material for a continuous distance of 5 metres immediately surrounding every haystack, hayshed, stationary pump or engine, and
- (c) remove all inflammable material for a continuous distance of 15 metres, or to the external boundary of the land whichever is nearer, from around fuel depots,

All excluded areas remain the owner's or occupier's responsibility and any variation as permitted by this Order does not render null and void any duty otherwise required by law.

#### Townsite Land

On townsite land, where a property or adjoining properties having the same ownership or control and are used as a single holding, the owner or occupier, shall—

- (a) provide and maintain firebreaks not less than 2 metres in width inside all external boundaries of the land, or
- (b) clear by burning, all inflammable material likely to be conducive to the outbreak, spread or extension of a fire from the whole of the land, or
- (c) have all inflammable material likely to be conducive to the outbreak, spread or extension of fire removed, and the grass maintained to a height not greater than 10 cms.

#### Rural Residential Land

### WATER BOARDS ACT No. 4 OF 1904

#### BUSSELTON WATER BOARD

In pursuance of the powers conferred upon it by the abovementioned Act, the Busselton Water Board hereby records having resolved on the 18th day of September 1995 to make and submit for confirmation the following By-laws relating to Long Service Leave for Employees.

#### INTERPRETATION:

1. In this By-law, unless the context otherwise requires—
  - (a) "Board" means the Busselton Water Board.
2. (a) All employees of the Board shall, after each period of ten years continuous service as permanent full time employees thereof, commencing from 27 January 1976, be entitled to thirteen weeks long service leave. Long service leave to be taken at the convenience of the Board, who will as far as possible, meet the wishes of the employee but the Board may require the employee to take leave by giving not less than three months notice.
  - (b) Long service leave shall be commenced within two years of becoming due.
3. Absence on account of sickness shall not be deemed to be a break in continuity of service providing the period of absence shall not exceed three months in any year, unless otherwise decided by the Board.
4. Employees due to take long service leave shall be paid at the same rate of ordinary pay as was paid in the week prior to taking such leave.
5. Employees shall not be entitled to long service leave until the completion of ten years service. After the completion of the first ten years service, employees will then be entitled to a pro rata payment if they leave the service of the board before the next period of service is completed.
6. Where an employee commences a period of long service leave, the employee may, if the employee and the Board agree in writing, be paid for each week of that period at half the rate at which he/she would otherwise be entitled to be paid, but only half of any period of leave in respect of which the worker is paid shall be taken into account for the purpose of ascertaining the amount of leave, if any, to which he/she is thereafter entitled.

7. Where an employee commences a period of long service leave the employee may, if the employee and the Board agree in writing, be paid for each week of that period at double the rate at which he/she would otherwise be entitled to be paid, but double any period of leave in respect of which the employee is so paid shall be taken into account for the purpose of ascertaining the amount of leave, if any, to which the employee is thereafter entitled.
8. Long service leave shall be considered as a special period of recuperation after a lengthy term of service with a view to fitting the employees for a further term of service, and during such leave no employees shall undertake any form of employment for hire or reward, unless by special permission of the Board. Any contravention of this subclause shall entitle the Board to dismiss the employee from its service and to cease paying or to recover any amounts paid in advance, of long service leave.

The By-law set out herein was made and passed by a resolution of the Busselton Water Board at a duly convened meeting of the Board held on 18 September 1995 and supercedes Long Service By-laws adopted on 11 March 1974 (amended 9 February 1976).
