The Western Australian Planning Commission has considered all the submissions received in respect of the proposals for the "South East Corridor—South of Armadale Amendment" (No. 966/33). This proposal was first published in the *Government Gazette* on April 7, 1995. The Commission has recommended that the amendment be modified.

The modified amendment has been presented to and approved by the Governor. It will now be tabled in both Houses of Parliament, where it must remain for 12 sitting days before coming into effect. These actions are requirements under the Metropolitan Region Town Planning Scheme Act (1959).
