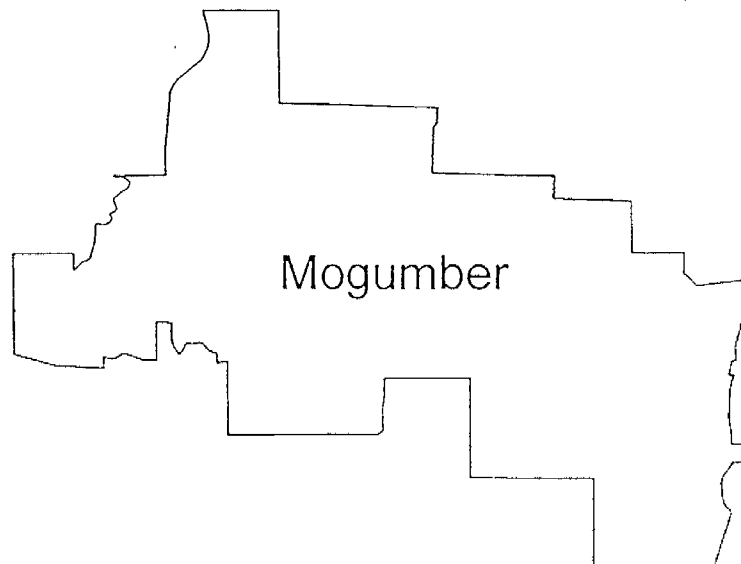

AG408**SOIL AND LAND CONSERVATION ACT 1945****SOIL AND LAND CONSERVATION
(LATHAM LAND CONSERVATION DISTRICT) ORDER 1995**

Made by His Excellency the Governor in Executive Council under Section 22 and 23 of the Soil and Land Conservation Act 1945 on the recommendation of the Minister for Primary Industry.

Citation

1. This order may be cited as the *Soil and Land Conservation Act (Latham Land Conservation District) Order 1995*.

Interpretation

2. In this order—

- “appointed member” means a person appointed under clause 5 (1)(b) or (c) to be a member of the committee;
- “commissioner” means the person for the time being holding or acting in the office of the Commissioner for Soil Conservation;
- “committee” means the Land Conservation District Committee for the Latham Land Conservation District;
- “member” means a member of the Committee;
- “the district” means the Latham Land Conservation District constituted by clause 3;
- “the producer organisations” means the bodies known respectively as the Western Australian Farmers Federation (Inc) and the Pastoralists and Graziers Association of Western Australia.

Latham Land Conservation District

3. The land described in the Schedule to this order is hereby constituted the Latham Land Conservation District.

Establishment of the committee

4. Pursuant to Section 23 (2) of the Soil and Land Conservation Act 1945 there is hereby established for the district a land conservation district committee to be known as the Land Conservation District Committee for the Latham Land Conservation District.

Constitution of the committee

5. (1) It is hereby determined on the recommendation of the Minister, after consultation with the Shire of Perenjori that the committee shall comprise 8 members of whom—

- (a) one shall be the Commissioner of Soil and Land Conservation or his nominee;
- (b) one shall be appointed by the Commissioner on the nomination of the Shire of Perenjori;
- (c) two shall be appointed in accordance with subclause (2)
- (d) 4 shall be persons actively engaged in, or affected by or associated with landuse in the district;

(2) The Western Australian Farmers Federation (Inc.) shall submit to the Commissioner a panel containing the names of persons willing to be appointed as members of the committee and where such a panel is submitted in accordance with this order two persons whose names appear on the panel submitted by the Western Australian Farmers Federation (Inc.) shall be appointed by the Commissioner.

(3) Subject to this clause, each appointed member shall hold office for such period not exceeding 3 years as is specified in the instrument of this appointment and is eligible for reappointment.

(4) The Minister may grant leave of absence to an appointed member on such terms and conditions as the Minister determines.

(5) The Minister may terminate the appointment of an appointed member for inability, inefficiency or misbehaviour.

(6) If an appointed member—

- (a) is or becomes an undischarged bankrupt or person whose property is subject to an order or arrangement under the laws relating to bankruptcy;
- (b) has his appointment terminated by the Minister, pursuant to subclause (4);
- (c) is absent, except on leave duly granted by the Minister, from 3 consecutive meetings of the committee of which he has had notice;
- (d) resigns his office by written notice addressed to the Minister, the office of that appointed member becomes vacant.

Proceedings of the committee

6. (1) The committee shall hold its meetings at such place on such days and at such intervals as the committee shall from time to time determine.

(2) At any meeting of the committee—

- (a) a majority of the members constitute a quorum;
- (b) the Chairperson will preside and where he or she is absent from the meeting the members may appoint one of their number to preside at that meeting;

- (c) each member present is entitled to a deliberative vote; and
 - (d) where the votes cast on any question are equally divided the Chairperson, or the presiding member in terms of paragraph (b), shall have a casting vote.
- (3) The committee shall cause accurate minutes to be kept of the proceedings at its meetings.
- (4) To the extent that it is not prescribed, the committee may determine its own procedure.

3. Clause 2 of the principal order is amended by inserting in the appropriate alphabetical position the following definition—

“Commissioner” means the person for the time being holding or acting in the office of the Commissioner of Soil and Land Conservation.

Clause 5 amended

4. Clause 5 of the principal order is amended—

(a) in subclause (1)

(i) by deleting “18” and substituting the following “21”; and

(ii) in paragraph (b) by deleting “Minister” and substituting the following “Commissioner”; and

(iii) by deleting paragraphs (c) & (d) and substituting the following;

(c) 2 shall be appointed in accordance with subclause (2)

(d) 1 shall be appointed in accordance with subclause (2a)

(e) 15 shall be persons actively engaged in, or affected by or associated with landuse in the district including an officer from the Department of Conservation and Land Management, and by deleting “Minister” and substituting the following “Commissioner”

(b) by deleting subclause (2) and substituting the following;

(2) The Western Australian Farmers Federation (Inc.) shall submit to the Commissioner a panel containing the names of persons willing to be appointed as members of the committee and where such a panel is submitted in accordance with this order two persons whose names appear on the panel submitted by the Western Australian Farmers Federation (Inc.) shall be appointed by the Commissioner.

(2a) The Pastoralists and Graziers Association of Western Australia shall submit to the Commissioner a panel containing the names of persons willing to be appointed as members of the committee and where such a panel is submitted in accordance with this order one person whose name appears on the panel submitted by the Pastoralists and Graziers Association of Western Australia shall be appointed by the Commissioner.

SETTLEMENT AGENTS' PROFESSIONAL INDEMNITY & FIDELITY INSURANCE CERTIFICATE WORDING

WHEREAS the Settlement Agents Supervisory Board (hereinafter called "the Board") has agreed to the Insurer (hereinafter called "the Company") on behalf of all Licensees from time to time required by the Act to be insured and on behalf of and for the benefit of Former Licensees providing insurance in accordance with the Terms, Conditions and Exclusions contained herein,

And Whereas the Licensees (hereinafter called "the Insured") named in the Certificate of Insurance having paid to the Company the premium stated in the Certificate of Insurance to effect insurance with the Company,

The Company agrees:

SECTION 1: Professional Indemnity

To indemnify the Insured (which expression shall in this Section 1 only include any person or persons in the direct employ of the Insured) against all sums which the Insured shall become legally liable to pay for any claim or claims first made against the Insured during the period of insurance for breach of professional duty by reason of any negligence whether by way of any act, error or omission whenever or wherever committed or alleged to have been committed in the conduct of the Insured's profession or business.

SECTION 2: Fidelity

This Policy shall indemnify the Insured in respect of any pecuniary loss including loss of bearer bonds, coupons, bank notes, currency notes negotiable instruments or stamps sustained by him and first discovered by the Insured during the Period of Insurance by reason of any dishonest, fraudulent, malicious or illegal act or omission of the Insured or person in his direct employ in the conduct of the Insured's profession.

Provided Always That

No indemnity shall be afforded to any person committing or condoning such act or omission, and the Insured shall take all reasonable steps requested by the Company to recover the loss and shall permit the Company, if he so requests, to himself take such recovery action in the name of the Insured and in that event the Insured shall assist and co-operate with the Company and shall provide the Company with such information (including signed statements) as the Company may reasonably require.

Provided that the liability of the Company shall not exceed in the aggregate in respect of each claim (including claimant's costs) the Limit of Liability stated in Memorandum 7 and in addition all costs and expenses incurred with the consent of the Company in the defence or settlement of any such claim, provided that, if a payment in excess of the said Limit of Liability is made to dispose of any such claim, the Company's liability for any such costs and expenses so incurred shall be limited to such proportion thereof as the said Limit of Liability bears to the amount of the payment so made.

Provided further that in respect of each claim there shall be deducted from the amount of such claim, as finally determined, the amount of the Deductible stated in Memorandum 8 and the liability of the Company shall be limited to the amount, if any, in excess of such Deductible but not exceeding the Limit of Liability stated in Memorandum 7.

EXCLUSIONS APPLICABLE TO SECTION 2

The Company shall not be liable under this Policy in respect of or in relation to any person acting alone or in collusion with others:

1. for more than the Limit of Liability stated in Memorandum 7 notwithstanding that such dishonest, fraudulent malicious or illegal act or acts were committed by such person during more than one Period of Insurance;

2. for any loss, or to that part of any loss, as the case may be, the proof of which either as to its factual existence or as to its amount, is deducted from an inventory computation or a profit and loss computation; provided, however, that this Exclusion shall not apply to loss of money or other property which the Insured can prove, through evidence wholly apart from such computations, was sustained by the Insured through any dishonest, fraudulent, malicious or illegal act or acts committed by any one or more of such persons;
3. for any loss arising from any fraudulent, dishonest, malicious or illegal act or acts committed by such person after the Insured shall have knowledge or information of such act of dishonesty, fraud, malice or illegal act on the part of such person;
4. for any loss arising from the complete or partial non-payment of, or default upon any loan, extension of credit or transaction in the nature of, or amounting to, a loan, obtained from or made by the Insured or by any of the employees whether authorised or unauthorised unless such loss results from dishonesty, fraud, malice or illegal act on the part of any of the employees.

GENERAL EXCLUSIONS

1. This Policy does not cover
 - (a) any loss arising directly or indirectly caused by or contributed to by or arising from
 - (i) ionising radiations or contamination by radioactivity from any nuclear fuel or from any nuclear waste from the combustion of nuclear fuel.
 - (ii) war, invasion, acts of foreign enemies, hostilities (whether war be declared or not), civil war, rebellion, revolution, insurrection, military or usurped power or martial law.
2. EXTENSIONS AUTOMATICALLY INCLUDED

Subject to the limitation of indemnity stated in the Schedule in respect of all claims under this policy the following extensions are automatically included.

Each extension is subject to the terms, excess and Limit of Indemnity of this policy.

The cover provided by each extension is limited to claims or circumstances reported to the Insurers during the Period of Insurance.

1. Libel and Slander

This policy shall cover any claim first made against the Insured during the Period of Insurance for libel and slander by reason of words written or spoken by the Insured in the conduct of the Insured's profession.

2. Trade Practices Act

3. Loss of Documents

If during the Period of Insurance the Insured shall first discover that any documents as defined by this clause the property of or entrusted to the Insured, which may be now or hereafter be, or be supposed or believed to be, in the custody of the Insured, or in the custody of any other person to or with whom such documents have been entrusted, lodged or deposited by the Insured in the ordinary course of business, have while within Australia been destroyed, damaged, lost or mislaid and after diligent search cannot be found, the Company shall indemnify the Insured against:

- a. legal liability which may attach to the Insured in consequence of such documents having been so destroyed, damaged, lost or mislaid, and
- b. costs and expenses of whatsoever nature incurred by the Insured in replacing or restoring such documents provided that such costs and expenses shall be supported by accounts approved by a competent person nominated by the Company.

- b. the expression "documents" shall in this clause mean deeds, wills, agreements, maps, plans, books, letters, forms and documents of any nature whatsoever including computer printouts BUT SHALL NOT MEAN or extend to any other form of computer records nor computer memory whether programs or database or otherwise and however recorded NOR SHALL IT MEAN or extend to bearer bonds, coupons, bank notes, currency notes or negotiable instruments.

4. Fraud & Dishonesty of Employees

This policy shall indemnify the Insured in respect of the legal liability of the Insured arising from any claim first made against the Insured during the Period of Insurance by reason of any dishonest, fraudulent, malicious, or illegal act or omission of the Insured's employees in the conduct of the Insured's profession.

Provided always that

no indemnity shall be afforded to any person committing or condoning such act or omission, and the Insured shall take all reasonable steps requested by the Company to recover the loss and shall permit the Company, if it so requests, to itself take such recovery action in the name of the Insured and in that event the Insured shall assist and co-operate with the Company and shall provide the Company with such information (including signed statements) as the Company may reasonably require.

DEFINITIONS

In this Policy:

1. "Act" means The Settlement Agents Act 1981 as from time to time in force.
2. "Business" means the business of a Settlement Agent as defined in the Act, under the name stated in the Certificate of Insurance or such other name notified to the Company from time to time.
3. "Licensee" has the same meaning as in the Act.
4. "Each Claim" shall mean all claims arising from the same act, error or omission.
5. "Insured" means the Licensee, Firm or the Related Business, Directors and any person who is or becomes or who has ever been an employee of the Insured.
6. "Commencement Date" means that date as of which the Certificate of Insurance becomes effective.
7. "Firm" means the person or persons carrying on the Business from time to time.
8. "Former Licensee" means any Licensee who has ceased to carry on Business as a principal.
9. "Period of Insurance" means the period so specified in the Certificate of Insurance.
10. "Related Business" means any service, administrative or nominee company or other person entity or trust associated with or providing services to the Business and specified in the Certificate of Insurance or notified in writing to the Company and not being a Firm carrying on a Business.
11. "Insurer" means the Insurance Company(ies) whose name(s) appear(s) in the Certificate of Insurance.
12. Words importing any gender include every other gender.

INTERPRETATION

1. The terms "Insured", "Licensee", "Firm" and "Business" shall be read as if they were separately defined in each Insurance effected by the issue of a Certificate of Insurance and were defined by reference to the Firm referred to in the respective Certificate of Insurance.
2. This Master Policy and every Certificate of Insurance shall be governed by and construed according to the laws of the State of Western Australia.

MEMORANDA

1. Currency of Master Policy

This Master Policy commences on the 1st day of November 1995 and shall continue until midnight 31st October 1996 and may thereafter be renewed for such further periods and with such variations as may be agreed between the Company and the Board.

2. Premium

The premium payable for the issue of a Certificate of Insurance to a Licensee for the Limit of Liability shall be as agreed between the Company and the Board, but the Company reserves the right to vary the standard Premium based upon prior claims and circumstances as declared on the questionnaire.

3. Premium Payable by New Licensee

A Licensee which commences Business other than at the commencement of a year of insurance under the Master Policy shall pay, in order to obtain insurance in respect of the Business of that Licensee, a premium equal to the premium payable by a Licensee reduced pro rata for every whole month by which the Period of Insurance is less than twelve months, subject to a minimum premium of \$105.00 inclusive.

4. Issue of Certificates of Insurance

The Company through its intermediary, Minet Professional Services Ltd, will issue Certificates of Insurance annually in the form of the Schedule hereto on receipt of the premiums payable in accordance with Memorandum 2 above to Licensees who are required by the Act to be insured.

5. Effect of Certificate

Each Certificate when issued shall have effect as if it were a separate Policy of insurance made between the Company and the Insured in the Terms of the Certificate and of this Policy.

6. Insurance of Former Licensees

A Former Licensee who has at any time been insured under any Master Policy or whose successors in business have at any time been insured thereunder shall be entitled to be indemnified by the Company in respect of any claim or claims first made against him during the currency of this Policy as if a Certificate of Insurance had been issued to him hereunder and as if there were specified in such Certificate:

- (a) As the Period of Insurance, the period during which this Policy shall be in force; and
- (b) As the Limit of Liability, the sum of
 - Section 1—\$1,000,000
 - Section 2—\$1,000,000

7. Limit of Liability

Section 1 The Limit of Liability for each claim shall be as stated in the Schedule and shall be not less than \$1,000,000.

Section 2 The Limit of Liability for each claim shall be \$1,000,000

8. Deductible

The Company shall not be liable to indemnify the Insured in respect of the first \$1,000 of each claim.

9. Variation by Agreement

The Board and the Company may by agreement vary any of the terms of this Policy other than the terms of Memoranda 2, 7 and 8 as above with respect to any Certificate of Insurance which is issued after the effective date of such variation. The effective date of variation shall be the date nominated in the agreement being a date not earlier than the date the agreement is made.

10. No Refusal of Cover

The Company may not refuse any cover pursuant to this Master Policy to any Licensee.

11. Cross Liability (Applicable to Section 2 only)

The word "Insured" shall be deemed to apply to each person comprising the Insured in the same manner as if a separate Policy had been issued to each of them and the act, error or omission of one shall not prejudice the right of any other to indemnity under this Insurance but the total liability of the Company in respect of all the individuals and entities comprising the Insured shall not exceed the Limit of Liability as stated in Memorandum 7 above.

GENERAL CONDITIONS**1. No Admission or Settlement**

The Insured shall not admit liability for or settle any claim or incur any costs or expenses in connection therewith without the written consent of the Company. The Company shall be entitled at its own expense at any time to take over and conduct in the name of the Insured the defence or settlement of any claim.

2. Notice of Claims

The Insured shall give notice to the Company in writing as soon as practicable of any circumstances giving rise or likely to give rise to a claim under this Policy and the Insured shall

- (a) within fourteen days from the date of such notice (unless the Company has in writing agreed to extend such period) deliver to the Company a detailed statement in writing of the loss sustained;
- (b) at all reasonable times permit the Company to inquire into, investigate and examine the circumstances of the alleged loss by the Insured, and the claim in respect thereof, and the Insured shall, at his own expense upon being required so to do by the Company produce all books, vouchers, correspondence, documents, receipts, and all other information in his possession or control relating to the alleged loss, and shall furnish copies of such of them and otherwise give all possible assistance as may be required by the Company so far as they relate to such claim or may in any way enable the Company to ascertain the correctness thereof or the liability of the Company under this Policy.

3. Effect of Giving Notice of Circumstances

If a notice of circumstances is given to the Company under the preceding clause either by or on behalf of the Insured or by or on behalf of his successors in business any claim subsequently made (whether before or after the expiration of the Period of Insurance) pursuant to such an intention to claim or arising from circumstances so notified shall be deemed to have been made on the date when such notice was given.

4. Other Insurance

Upon giving any notification pursuant to General Condition 2, the Insured shall inform the Company as to any other Insurance or indemnity pursuant to which the Insured is entitled to any benefit in respect of that claim.

5. Fraud

If any Licensee shall prefer any claim knowing the same to be false or fraudulent, as regards amount or otherwise, the insurance provided to such Licensee shall become void and all claim thereunder shall be forfeited.

6. Recoveries

If the Insured shall sustain any loss covered by this Policy which exceeds the Limit of Liability stated in the said Schedule, the Insured shall be entitled to all recoveries (except from suretyship, insurance, reinsurance, security or indemnity taken by or for the benefit of the Company) by whomsoever made on account of such loss under this Policy until fully reimbursed less the actual cost of effecting the same and any remainder shall be applied to the reimbursement of the Company.

7. Subrogation Agreements

This Policy does not cover any liability for or arising directly or indirectly from any claim for loss or damage in respect of which the Insured has at any time by deed or agreement foregone, excluded or limited a right of recovery.

8. Right of Company Upon Breach or Non-Compliance

Where the Insured's breach of or non-compliance with any term or condition of this insurance has resulted in substantial prejudice to the handling or settlement of any claim against the Insured in respect of which insurance is provided hereunder the Insured shall reimburse to the Company the difference between the sum payable by the Company in respect of that claim and the sum which would have been payable in the absence of such prejudice PROVIDED ALWAYS THAT it shall be a condition precedent to the right of the Company to seek such reimbursement that it shall have fully indemnified the Insured in accordance with the terms hereof.

9. Queen's Counsel Clause

The Company agrees to pay claims which may arise under this Insurance without requiring the Insured to dispute any claim unless a Queen's Counsel (to be mutually agreed upon by the Insured, the Firm and the Company) advises that the claim could be contested with a reasonable prospect of success by the Insured and the Insured or the Firm consents to such claim being contested, but such consent is not to be unreasonably withheld. In the event of any dispute arising between the Insured, the Firm and the Company as to what constitutes an unreasonable refusal to contest a claim the Chairman for the time being of the Board shall nominate a Referee to decide this point only and the decision of such a Referee shall be binding on all parties.

10. Prejudice to Insurers

Where the Insured's breach of or non-compliance with any condition of this insurance has resulted in substantial prejudice to the handling or settlement of any claim against the Insured in respect of which the Insured is insured hereunder the Insured shall reimburse to the Insurers the difference between the sum payable by the Insurers in respect of that claim and the sum which would have been payable in the absence of such prejudice. Provided always that it shall be a condition precedent of the right of the Insurers to seek such reimbursement that they shall have fully indemnified the Insureds in accordance with the terms hereof.

Firebreak Order

With reference to Section 33 of the Bush Fires Act 1954, you are required to carry out fire prevention work on land owned or occupied by you, in accordance with the provisions of this order.

Details of work required to be completed are detailed in this advertisement. Work must be completed by the 30th November, 1995, with the exception of the Australind area, as bordered red on the map marked "Appendix A" (available from the Council Office), work in this area must be completed by midnight on 14th December, 1995, and all work must be kept maintained until the close of the Restricted Burning Period, 1996.

Persons who fail to comply with the requirements of this Order may be issued with an Infringement Notice (penalty \$80) or prosecuted with an increased penalty, and additionally, Council may carry out the required work at cost to the owner or occupier.

If it is considered to be impractical to clear firebreaks or remove flammable materials as required by this notice, or where:

- (a) compliance with this order may aggravate soil erosion; or
- (b) you consider a more effective system of fire protection can be obtained; or
- (c) natural features render firebreaks unnecessary,

you may apply to the Council or the Area Fire Control Officer, not later than the 1st day of November, 1992, for permission to provide firebreaks in alternative positions or to take alternative action to abate fire hazards on the land.

If permission is not granted by the Council or the Area Fire Control Officer, you shall comply with the requirements of this notice. If the requirements of this notice are carried out by burning, such burning must be in accordance with the relevant provisions of the Bush Fires Act.

A. RURAL LAND/SPECIAL RURAL LAND

Firebreaks not less than two (2) metres wide must be provided in the following positions:

- (a) within 60 metres inside and along the boundaries of all land.
- (b) so as to divide the land into areas of not more than 120 ha (300 acres).
- (c) around all groups of buildings, haystacks (includes two or more round bales placed in a pad-dock for storage purposes) and fuel installations.
- (d) Irrigation Areas—Owners or occupiers may be exempted from all or part of the requirements of the above. Consult your Area Fire Control Officer.

B. URBAN LAND (Residential, Commercial and Industrial land within a townsite or any other area subdivided for residential purposes).

- (a) Where the area of land is 2,024 sq.m (approximately half acre) or less, remove all flammable material on the land except living standing trees, from the whole of the land;
- (b) Where the area of land exceeds 2,024 sq.m (approximately half acre) provide firebreaks of at least two (2) metres wide.

Note: Myalup and Binningup—The following are accepted in lieu of item (a) of the above requirements:

Firebreaks two (2) metres wide inside and around all boundaries of land are accepted in lieu of item (a) of the above requirements.

- 1. Firebreaks two (2) metres wide inside and around all boundaries of land.
- 2. Slashing of the entire block.
- 3. Removal of isolated fire hazardous materials on the block.

C. FUEL AND/OR GAS DEPOTS

In respect of any land used for the above purpose, you shall maintain the land clear of all flammable materials.

D. PLANTATIONS

(a) Definitions

- (i) A plantation is any area of planted pines or eucalyptus species exceeding 3 hectares in area.
- (ii) A windbreak is a planted area a maximum of 15 metres wide but with no defined length.

(b) Boundary Firebreaks

On the horizontal plane, a firebreak shall be provided 15 metres wide and immediately adjoining all external boundaries of the planted area. The outer 10 metres will be cleared of all flammable material while the inner 5 metres, i.e. that portion closest to the trees, may be kept in a reduced fuel state, i.e. by slashing or grazing grass provided that the height of the grass does not exceed 8 centimetres.

On the vertical plane, a clear space 10 metres high will be maintained above outer 10 metres of the firebreak.

(c) Internal Firebreaks

Plantations shall be subdivided into areas not exceeding 30 hectares by firebreaks 6 metres wide which shall be cleared of all flammable material.

In the vertical plane, a clearance of a minimum height of 4 metres from ground level will be maintained above the firebreak.

(d) Special Risks

(i) Public Roads and Railway Reserves

Firebreaks 15 metres wide shall be maintained where the planted area adjoins public roads and railway reserves. The specification will be as for "boundary firebreaks" on planted areas.

(ii) Power Lines

Firebreaks shall be provided along power lines where they pass through or lie adjacent to planted areas.

The specification of the width and the height of clearing shall be in accordance with State Energy Commission specifications.

E. ROTARY SLASHERS

The possibility of fires started by rotary slashers being operated in bush or grassland during the summer months, is brought to the attention of landowners. They are asked to take care to avoid fires when slashing in dry or hot conditions.

Immediately inside land on which bush has been bulldozed, chained or prepared in any similar manner for clearing by burning (whether you intend to burn the bush or not); provided that the firebreak required to comply with this paragraph only shall be not less than 7 metres wide. Where the land is prepared for clearing by burning after 19th September, 1995 you shall provide the firebreak immediately.

If it is considered to be impracticable for any reasons to clear firebreaks as required by this notice, you may apply to Council or its duly authorised officer for permission to provide firebreaks in alternative positions on the land. If permission is not granted by the Council, or its duly authorised officer, you shall comply with the requirements of this notice.

The penalty for failing to comply with this notice is a fine not exceeding \$400.00 and a person in default is also liable, whether prosecuted or not, to pay the cost of performing the work directed in this notice if it is not carried out by the owner or occupier by the date required by this notice.

The penalty for non-compliance with this notice is a maximum fine of \$1,000, and notwithstanding prosecution, Council may enter upon the land and carry out required works at the owner's/occupier's expense.

An inspection of firebreaks and hazard removal will be carried out in Special Rural areas on or after 1st December each year and Rural and Urban areas on or after 22nd December each year.

**IMPORTANT INFORMATION RELATING TO YOUR RESPONSIBILITIES AS A LANDHOLDER
IN THE SHIRE OF BUSSELTON****SPECIAL RURAL LAND**

Firebreaks will be inspected in Special Rural areas on or after 1st December each year.

RURAL AND URBAN LAND

Inspections of these areas will commence on or after 22nd December each year.

A. RURAL LAND

(All land other than a pine plantation and that listed as URBAN)

You shall clear of all inflammable material (living or dead) firebreaks at least 2 metres wide;

1. A firebreak not less than 2 metres wide must be constructed within a perimeter of 20 metres of all homesteads, buildings, haystacks and fuel storage areas on the land.
2. In the case of haystacks the firebreak must not be closer than 6 metres of the haystacks.
3. Where the area of the land exceeds 120 hectares (approximately 300 acres) additional firebreaks so as to divide the land into areas of not more than 120 hectares (approximately 300 acres) which are completely surrounded with a firebreak.

B. SPECIAL RURAL LAND

The owner of all existing small rural holdings zoned as Special Rural Land under Town Planning Schemes must maintain a 3 metre wide firebreak totally cleared of all inflammable material (living or dead) and such firebreak to be constructed within 6 metres of the external boundaries of the land.

STRATEGIC FIREBREAKS

1. Where a special rural subdivision is protected by a 3 metre wide firebreak cleared of all inflammable material (living or dead) around the perimeter of the subdivision, it shall be the responsibility of all land owners abutting the firebreak to maintain that portion of the firebreak which adjoins the boundary of their property. Plans of strategic firebreaks approved by Council are available for inspection at the offices of Council during normal working hours. Currently the following subdivisions are approved to use strategic firebreaks:

1.1 Commonage Special Rural Area, including:

- Brushwood Brook Estate
- Windmill Ridge Estate
- Quindalup Heights
- Bayview Ridge
- Gunyulgup Valley Estate
- Gunyulgup Heights
- Wildwood Park
- Wildwood Estate
- Highlands Estate

1.2 Meelup Hills.

1.3 Siesta Park (between Siesta Park Road and Caves Road).

2. Other land owners within these subdivisions, not abutting the strategic firebreaks are not required to construct firebreaks on their individual properties. However, land owners are expected to maintain their properties in a low fuel situation.

C. URBAN LAND

(Residential, commercial and industrial land within a townsite or within any area subdivided for residential purposes)

1. Where the area of land is 2 024m² (approximately 1/2 acre or less) you must remove all inflammable material from the whole of the land except living trees, shrub and plants.
2. Where the area of land exceeds 2 024m² (approximately 1/2 acre), you shall clear of all inflammable materials (living or dead), firebreaks of at least 3 metres wide, within 6 metres of the inside of all external boundaries of the land. However, land owners are still expected to maintain the remainder of their properties in a low fuel situation.

D. FUEL AND/OR GAS DEPOTS

In respect of land owned or occupied by you on which is situated any container normally used to contain liquid or gas fuel, including the land on which any ramp or supports are constructed, you shall maintain the land clear of all inflammable materials (living or dead) and clear a firebreak not less than 2 metres wide within a perimeter of 20 metres of all homesteads, buildings, haystacks and fuel storage areas on the land.

E. PINE, EUCALYPT, PROTEA PLANTATIONS AND VINEYARDS

(A plantation is defined as a group of trees greater in area than 40 metres x 40 metres)

Firebreaks not less than 5 metres in width completely free of all inflammable material (living or dead) are to be constructed around the perimeter of the land and a further 10 metre low fuel density area in plantations immediately adjoining the 5 metre firebreak is to be maintained on which pines, eucalypts, protea and vines are planted.

A 5 metre wide firebreak clear of all inflammable material (living or dead) is required along those portions of a pine, eucalypt, protea or vineyard which enjoys a common boundary with a road reserve and not less than 6 metres in width in such positions that no part or compartment of a pine, eucalypt, protea plantation or vineyard shall exceed 28 hectare in an area.

Land owners are encouraged to have sufficient fire fighting equipment to protect themselves. Details of equipment useful for the protection of property can be obtained from either Council or the Local Fire Control Officer.

BUSH FIRES ACT (SUMMARY)

- A. Permits to burn are required for the whole of the restricted periods and can only be obtained from the area Fire Control Officers.
- B. Any special conditions imposed by the Fire Control Officer when issuing permits must be strictly adhered to.
- C. The permit holder shall give notice of his intention to burn to:
 - 1. The Shire Officer no later than on the day when the burning is to take place. Saturday burning must be notified by 5pm Friday (telephone 097 81 0444).
 - 2. The owner or occupier of adjoining land.
 - 3. The nearest office of the Department of Conservation and Land Management (CALM) if the land is situated within 3kms of State Forest Land (telephone CALM Busselton on 097 52 1677).
 - 4. A National Parks Rangers if the land adjoins National Park (telephone National Parks Yallingup 097 55 2144).
- D. Period of notice to neighbours prior to burning can not be more than 28 days or less than 4 days, although lesser notice may be determined by mutual agreement of all neighbours.
- E. Your attention is drawn to Items 5, 6, 7, 8 and 9 printed on the back of the permit.
- F. All landowners and occupiers who incur a bush fire have an obligation to assist each Fire Control Officer to compile a Fire Report Form.
- G. Garden refuse or rubbish burnt on the ground may be lit only between 6pm and 11pm and must be completely extinguished with water or earth by midnight. All inflammable matter is to be cleared within 5 metres at all points of the site of the fire and a person must be in attendance during the whole time the fire is burning.
- H. Any incinerator used to burn rubbish must be properly constructed. An open drum with or without a lid is not an appropriate incinerator.
- I. It is in the interest of all residents to be registered members of the Bush Fire Brigade which covers the area, wherein they own land. Membership of a Fire Brigade is the safest way to ensure cover under the Shire's Bush Fire Insurance Policy, which covers personal injury and damage to equipment resulting from fighting bush fires.

WHAT PROCEDURES GOVERN USE OF ALTERNATIVE MEASURES?

If it is considered to be impracticable for any reason to clear firebreaks as required by the firebreak notice, you may apply to Council no later than 8th November for permission to provide firebreaks in alternative positions of the land or of a different nature. A copy of a document titled "Fire Management Guidelines for private land retained for Conservation Purposes" will assist in this regard and is available along with the relevant application forms from Council. If permission is not granted by the Council or its duly authorised officer you shall comply with the requirements of this notice. If the requirements of this notice are carried out by burning, such burning must be in accordance with the relevant provisions of the Bush Fires Act.
