City of Gosnells

Model By-laws—Series "A"

Pursuant to the provisions of the Health Act 1911 the City of Gosnells, being a Local Authority within the meaning of the Health Act 1911, having adopted the Model By-laws described as Series "A" under the Health Act 1911 and reprinted pursuant to the Reprinting of Regulations Act 1954 in the *Government Gazette* on 17 July 1963, and as amended from time to time, has resolved and determined that the adopted by-laws, shall be amended as follows—

MODEL BY-LAWS—SERIES "A"

PART I—GENERAL SANITARY PROVISIONS

(1) Insert a new by-law 28A after the by-law 28 to read as follows—

Slaughter of Animals

28A. (1) Subject to subclause (2) a person shall not slaughter any animal for any purpose what-so-ever within the district.

(2) Subclause (1) does not apply to—

- (a) premises located in Yale Road, Thornlie on Part Lot 63, Canning Location 18 contained on Diagram 33715.
- (b) ethanasia of animals by veterinarians or other duly authorised persons approved by the Principal Environmental Health Officer.

HEALTH ACT 1911*Shire of Merredin*

Pursuant to the provisions of the Health Act 1911, the Shire of Merredin being a Local Authority within the meaning of the Health Act, having adopted the Model By-Laws described as Series "A" made under the Health Act 1911 and as reprinted pursuant to the Reprinting of Regulations Act in the *Government Gazette* on 17 July 1963, and amended from time to time, has resolved and determined that the adopted By-Laws, shall be amended as follows—

In Part 1 after By-Law 28 insert a new By-Law 28A as follows—

Keeping of Pigs

28A The keeping of pigs is prohibited within—

- (a) the townsites of Burracoppin, Hines Hill, Muntadgin, Nangeenan and Nukarni and within all that land contained within a strip 1.5 kilometres wide, surrounding and contiguous to the boundary of each of those townsites.
- (b) the townsite of Merredin and within all that land contained within a strip 5 kilometres wide, surrounding and contiguous to the townsite boundary of Merredin.
- (c) 1.5 kilometres of any dwelling house on an adjoining lot not in the same ownership.

In Part IX Section C the following By-Law is revoked.
