REAL ESTATE AND BUSINESS AGENTS (REMUNERATION) NOTICE 2 of 1995

Made by the Real Estate and Business Agents Supervisory Board under Section 61.

**Citation**

1. This notice may be cited as the *Real Estate and Business Agents (Remuneration) Notice 2 of 1995*.

2. (1) The fees set out in the Schedule are the maximum amounts of remuneration which licensees under the Act may charge for services rendered in the course of and incidental to their business as agents.

(2) The amendments to the Schedule shall apply to all transactions carried out pursuant to an appointment entered into after the date of this notice.
