BADGINGARRA RUBBISH SITE BOUNDED BY LOCATION NO. 1160 AND 1960.

SPECIFIED CONDITION: Domestic Refuse Disposal Sites

1. Burning shall take place within the designated area cleared of all inflammable material (Grass, papers, etc.) save live standing trees, immediately inside the fenced area up to the Excavation Site, and where possible outside the fenced area up to a distance of 50 metres from the edge of the tip face. The Domestic Refuse site will be located a minimum of fifty (50) metres from the site boundary.
 (See extraordinary conditions.)
2. A wire mesh fence a minimum of two (2) metres in height is to totally surround the tip site and be maintained in a sound condition throughout the period of this Suspension. The fence shall be constructed with an angled wing across the entrance so as to prevent wind blown materials exiting the site and such entrance shall be upwind of the annual prevailing winds. 4. A buffer zone (distance) of five hundred (500) metres minimum will be maintained between the disposal site and any residential development or other sensitive area eg. schools, hospitals, industrial areas.
5. A firebreak three (3) metres wide cleared of all inflammable material to be maintained inside the fenced area surrounding the excavation site, and immediately outside of the fenced area and placed around the total perimeter of the disposal site location throughout the Prohibited and Restricted Burning Period.
 (See extraordinary conditions.)
6. The volume of waste to be burnt shall not exceed that which can be safely burnt and declared safe within the hours of 8 am and 12 midnight on any one day.
7. The fire shall be attended by at least four (4) able bodied Council/Brigade personnel who have had the minimum level of Bush Fire Fighting Training as defined by the Bush Fires Board of W.A. until the fire is declared safe.
 (See extraordinary conditions.)
8. (a) Throughout the duration of the burning two (2) fire fighting vehicles (appliances) operated by Council/Brigade personnel shall be on site. Each vehicle to have a minimum water carrying capacity of five hundred (500) litres, fitted with a minimum of thirty (30) metres of nineteen (19) millimetre diameter rubber hose and pump capable of delivering a minimum of two hundred and fifty (250) litres of water per minute at a minimum of seven hundred (700) KPA through an adjustable nozzle capable of projecting water in the spray and jet configurations.
 (b) A Shire loader or grader and its operator (operator to be in addition to personnel as described in Condition No. 7) will also be on site throughout the duration of the burning.
 (See extraordinary conditions.)

9. Fires are only to be lit by Council staff member or a Fire Control Officer specifically authorised to do so by the Local Authority and only after a local forecast for the day has been obtained from the Bureau of Meteorology and the Group Officer (Chief Bush Fire Control Officer) or his designated deputies have been consulted and agree to the burn taking place.
10. Before any fires are lit for refuse disposal notification must be firstly given to—
 - (a) Department of Conservation and Land Management if they have land vestings within the Local Authority.
 - (b) Adjoining Private Property Owners (to be notified the day prior to the burning taking place).

(See extraordinary conditions.)

11. No fires to be lit on a Sunday or Public Holiday.
12. All burns are to be declared "**SAFE**" by a designated Council staff member or a Fire Control Officer as authorised by the Local Authority in Condition No. 9, prior to fire fighting equipment and personnel being permitted to depart the area.
13. At the completion of domestic refuse burning and prior to further dumping taking place the Local Authority is to secure that section of the excavation from public access and further dumping, through fencing or other appropriate means. Further dumping is not to take place in that part of the excavation until ignition of such waste can not occur.
14. No fires are to be lit on the site subject to this Suspension on a day for which the fire danger forecast issued by the Bureau of Meteorology in respect of that locality is Very High or Extreme (Total Fire Ban)

SPECIFIED CONDITION: Domestic Refuse Disposal Sites

Burning shall take place within the designated area cleared of all inflammable material (Grass, papers, etc.) save live standing trees, immediately inside the fenced area up to the Excavation Site, and where possible outside the fenced area up to a distance of 50 metres from the edge of the tip face. CERVANTES RUBBISH SITE SITUATED ON RESERVE NO. 36638, LOT 616.

SPECIFIED CONDITION: Domestic Refuse Disposal Sites

1. Burning shall take place within the designated area cleared of all inflammable material (Grass, papers, etc.), save live standing trees, immediately inside the fenced area up to the Excavation Site. The Domestic Refuse site will be located a minimum of fifty (50) metres from the site boundary.
(See extraordinary conditions)
2. A wire mesh fence a minimum of two (2) metres in height is to totally surround the tip site and be maintained in a sound condition throughout the period of this suspension. The fence shall be constructed with an angled wing across the entrance so as to prevent wind blown materials exiting the site and such entrance shall be upwind of the annual prevailing winds. Wire mesh shall be a maximum of one hundred (100) millimetre in aperture size ie: Poultry Mesh type.
3. Waste material for burning shall be arranged in trenches or excavations for burning. This area shall not be sited over a previously land filled site.

powers contained in Section 25B of the said Act, approve the suspension of the operations of Section 25 that relate to a fire to be lit, or which is lit, for the purpose of destroying garden refuse or rubbish or any like purpose during the declared Prohibited and Restricted Burning Times on land set aside for the purpose in the Municipal District of the Shire of Ravensthorpe. This notice shall have effect until revoked and is issued subject to the following specified conditions—

SPECIFIED CONDITIONS—Domestic Refuse Disposal Site

Ravensthorpe and Hopetoun Refuse Disposal Sites—Reserves ↑7380 and ↑35865 respectively.

1. A wire mesh fence a minimum of 1.8 metres in height is to totally surround the tip site and be maintained in a sound condition throughout the period of this suspension. HEALTH (FOOD HYGIENE) AMENDMENT REGULATIONS 1996

Made by the Lieutenant-Governor and deputy of the Governor in Executive Council under section 247 of the Act with the advice of the Food Advisory Committee and under section 343 (5) of the Act.

Citation

1. These regulations may be cited as the *Health (Food Hygiene) Amendment Regulations 1996*.

Commencement

2. These regulations come into operation on 1 February 1996.

Principal regulations

3. In these regulations the *Health (Food Hygiene) Regulations 1993** are referred to as the principal regulations.

Legislation of Western Australia, Table 4, p. 129.]

Regulation 3 amended

4. Regulation 3 of the principal regulations is amended by inserting in their respective alphabetical positions the new definitions following —

“

“certificate of registration” means a certificate of registration, or a certificate of renewal of registration, issued under regulation 9B and in force at the material time;

“manufactured smallgoods” means uncooked meat or meat products which are —

- (a) minced, chopped or comminuted;
- (b) subjected to fermentation; and
- (c) when processed, intended for consumption without cooking;

“registration” means a registration, or a renewal of a registration, granted under regulation 9B and in force at the material time;

“smallgoods manufacturer’s licence” or **“licence”** means a licence, or a renewal of a licence, issued under regulation 9A and in force at the material time.

”

Part 2 amended

5. Part 2 of the principal regulations is amended by adding, after regulation 9, the new Divisions following —

“

***Division 4 — Licensing of persons producing
manufactured smallgoods***

Persons producing manufactured smallgoods to be licensed

9A. (1) A person who, after 2 months have elapsed since the coming into operation of the *Health (Food Hygiene) Amendment Regulations 1996*, conducts a business which produces manufactured smallgoods and who does not hold a smallgoods manufacturer’s licence issued in accordance with this regulation commits an offence.

(2) An application for a licence under this regulation shall be made to the Local Authority in the form of Form 3 of Schedule 2, accompanied by the fee set out in item 1 of Schedule 5.

(3) The Local Authority shall consider each application made under subregulation (2) and may grant or refuse the application, having regard to the suitability of the applicant to hold the licence, to whether the applicant has had relevant experience or training, and to the interests of public health, and may take into

account criteria considered appropriate by the Executive Director, Public Health, including the applicant's record of compliance with public health requirements and an approved food safety plan.

- (4) The Local Authority shall —
 - (a) where an application for a licence is granted, issue to the applicant a licence in the form of Form 4 of Schedule 2;
 - (b) where an application for a licence is refused, notify the applicant in writing of the reasons for the refusal and refund the fee.
- (5) A licence under this regulation shall —
 - (a) take effect on and from the day it is granted and, unless sooner surrendered, cancelled, revoked or suspended, continue in force until the following 30 June;
 - (b) be subject to these regulations and to any terms or conditions endorsed on the licence by the Local Authority; and
 - (c) authorize the holder to carry out any act necessary or in connection with the conduct (in any premises registered under regulation 9B) of the business in respect of which the licence is granted.
- (6) The renewal of a licence —
 - (a) may be granted by the local authority, without application;
 - (b) if not renewed by the local authority without application, may be applied for in the same manner, and be accompanied by the same fee, as an initial application; and
 - (c) shall remain in force, unless sooner surrendered, cancelled, revoked or suspended, for the period 1 July to 30 June.

Division 5 — Registration of premises used for producing manufactured smallgoods

Registration of premises

9B. (1) A person who, after 2 months have elapsed since the coming into operation of the *Health (Food Hygiene) Amendment Regulations 1996*, conducts a business producing manufactured smallgoods in premises which are not registered in accordance with this regulation commits an offence.

(2) Where a person is the holder of a current smallgoods manufacturer's licence, the Local Authority may grant registration of the premises in which that person conducts, or proposes to conduct, a business producing manufactured smallgoods.

(3) An application for registration shall be made to the Local Authority in the form of Form 5 of Schedule 2, accompanied by the fee set out in item 2 of Schedule 5.

(4) Where the Local Authority is satisfied that the premises comply with these regulations the Local Authority shall register the premises and grant the proprietor a certificate of registration in the form of Form 6 of Schedule 2.

- (5) A certificate of registration shall —
 - (a) take effect on and from the day it is granted and, unless sooner surrendered, cancelled, revoked or

suspended, continue in force until the following 30 June;

- (b) be subject to these regulations and to any terms or conditions endorsed on the certificate of registration by the Local Authority; and
 - (c) authorize the holder to conduct in the registered premises the business for which the smallgoods manufacturer's licence held by that person was granted.
- (6) The renewal of a registration —
- (a) may be granted by the local authority, without application;
 - (b) if not renewed by the local authority without application, may be applied for in the same manner, and be accompanied by the same fee, as an initial application; and
 - (c) shall remain in force, unless sooner surrendered, cancelled, revoked or suspended, for the period 1 July to 30 June.

2. After Part IX add a new Part X to read as follows—

PART X—OFFENCES

Offences and Penalties

1. (1) A person who is required by a provision of Part IV and Part VII to do anything or refrain from doing anything and who fails to comply with that provision commits an offence and is liable to—
 - (a) a fine that is not more than \$2 500 and not less than—
 - (i) in the case of a first offence, \$250;
 - (ii) in the case of a second offence, \$500;
 - and
 - (iii) in the case of a third or subsequent offence, \$1 250;
 - and
 - (b) if that offence is a continuing offence, a daily penalty which is not more than \$250 and not less than \$125.
- (2) A person who is required by any provision of these by-laws, other than a provision of Part IV or Part VII, to do anything or refrain from doing anything and who fails to comply with that provision, commits an offence and is liable to—
 - (a) a fine that is not more than \$1 000 and not less than—
 - (i) in the case of a first offence, \$100;
 - (ii) in the case of a second offence, \$200; and
 - (iii) in the case of third or subsequent offence, \$500;
 - and
 - (b) if the offence is a continuing offence, a daily penalty which is not more than \$100 and not less than \$50.
2. Any expense incurred by the Local Authority in consequence of a breach or non observance of these by-laws, or in the execution of work directed to be executed by a person and not executed by that person, shall be paid by the person committing the breach or non observance or failing to execute the work.

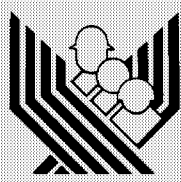
