Municipality of the Town of Mosman Park

By-laws Relating to Beekeeping

In pursuance of the powers conferred upon it by the abovementioned Act and all other powers enabling it, the Council of the abovementioned Municipality hereby records having resolved on the 26th October 1993, to repeal the whole of the By-law relating to the keeping of bees published in the *Government Gazette* of 3rd July 1963, and to make and submit for confirmation by the Governor the following By-laws.

Citation

1. These By-laws may be cited as the Town of Mosman Park Beekeeping By-laws.

Application

2. These By-laws shall apply and have force and effect throughout the whole of the district.

Interpretation

3. (1) In these By-laws unless the context otherwise requires—

“Act” means the Local Government Act 1960, as amended, and any Regulations or By-laws made thereunder.

“Authorised Officer” means the Clerk of the Council, or any Environmental Health Officer, or any other Officer authorised by the Council.

“beehive” means a movable or fixed structure, container or object in which a colony of bees is kept.

“Council” means the Council of the Town of Mosman Park.

“district” means the municipal district of the Town of Mosman Park.

“Environmental Health Officer” means an Environmental Health Officer appointed by the Council under the Health Act 1911 and includes an Acting or Assistant Environmental Health Officer.

“lot” has the meaning given it in the Town Planning and Development Act 1928, as amended.

“private street” has the meaning given to it by section 285 of the Act.

(2) Unless otherwise defined herein, the terms and expressions used in these By-laws shall have the meanings given to them in the Act.

(3) In these By-laws a reference to the Council having the power to do something in its discretion or a reference to the Council forming an opinion prior to the doing of anything shall be deemed to include a reference to any person, committee or body to whom the Council has delegated the power of doing the thing or exercising such discretion or forming such opinion.

Keeping of Bees

4. No person shall keep or permit to be kept bees on any lot within the district without written approval from the Council.

5. Written approval from the Council to keep bees shall—

(1) Limit the number of beehives kept on any lot in the district to not more than two (2); and

(2) Be for a period of not more than five (5) years.

6. Written approval may be given with or without conditions as considered appropriate by the Council and the person to whom the approval is given shall comply with such conditions.

7. Notwithstanding by-laws 4, 5 and 6 a person shall not keep or permit to be kept bees in beehives on any lot within the district unless at all times—

(1) An adequate and permanent supply of water in a receptacle is provided on such lot within three (3) metres of the beehive;

(2) The beehive is kept not less than five (5) metres from the boundary of the lot; and

(3) The beehive is kept not less than ten (10) metres from any house, footpath, street, private street or public place.

8. No person shall keep or permit to be kept bees on a footpath, street, private street or public place.

9. No person shall keep bees in such a manner as to cause a nuisance to any person.

10. Whenever in the opinion of the Council a nuisance arises because of the keeping of bees, Council may by written notice direct the occupier of the land to remove the beehives from the land within a time specified in that notice.

11. Any person who contravenes any provision of these By-laws commits an offence and is liable upon conviction to a maximum penalty of \$500.00 and also, if such offence is in its nature a continuing offence, to a daily penalty not exceeding \$50.00 during the continuance of the offence after the date of the conviction.
