WILDLIFE CONSERVATION ACT 1950

WILDLIFE CONSERVATION (RARE FLORA) NOTICE 1996

Made by the Minister under section 23F.

Citation

1. This notice may be cited as the *Wildlife Conservation (Rare Flora) Notice 1996*.

Interpretation

2. In this notice —

“**extant**”, in relation to taxa, means known to be living in a wild state;

“**protected flora**” means any flora belonging to the classes of flora declared by the Minister under section 6 (6) of the Act to be protected flora by notice published in *Gazette* 9 October 1987, p. 3855;

“**rare flora**” has the meaning given by section 23F (1) of the Act;

“**taxon**” includes any taxon that is described by a genus name and any other name or description.

Note: the plural form of “taxon” is “taxa”.

Rare flora

3. Subject to clause 4, protected flora —

- (a) specified in Schedule 1, being taxa that are extant and considered likely to become extinct or rare and therefore in need of special protection; and
- (b) specified in Schedule 2, being taxa that are presumed to be extinct in the wild and therefore in need of special protection,

are declared to be rare flora for the purposes of section 23F of the Act throughout the whole of the State.

Certain protected flora excluded

4. Clause 3 does not apply to those plants of a taxon of protected flora specified in Schedule 1 or 2 that are growing in a domesticated or cultivated state.

Revocation

5. The *Wildlife Conservation (Rare Flora) Notice 1995** is revoked.

POISONS ACT 1964**POISONS AMENDMENT REGULATIONS (No. 5) 1996**

Made by His Excellency the Governor in Executive Council.

Citation

1. These regulations may be cited as the *Poisons Amendment Regulations (No. 5) 1996*.

Regulation 43B inserted

2. After regulation 43A of the *Poisons Regulations 1965** the following regulation is inserted —

“

Prescribed purposes (section 41 (1))

43B. For the purposes of subsection (1) of section 41 of the Act —

- (a) analytical chemical analysis;
- (b) anaesthesia of exotic animals; and
- (c) training animals for the detection of substances included in Schedule 9 to the Act,

are purposes for which a specified person may be authorized under that subsection to manufacture, prepare, possess or use a specified substance included in Schedule 9 to the Act.

”.

Bush Fire Notice and Requirements

Notice to all owners and/or occupiers of land in the Shire of Augusta-Margaret River

In accordance with section 33 of the Bush Fires Act 1954, you are required to carry out fire prevention work on land owned or occupied by you in accordance with the provisions of this order.

The penalty for non-compliance with this notice is a maximum fine of \$2 000, and notwithstanding prosecution, council may enter upon the land and carry out required works at the owner/occupier's expense.

An inspection of firebreaks and hazard removal will be carried out in all areas of the Shire by an authorised officer (Townsites after December 1, 1996; Rural after December 22, 1996).

Rural and Special Rural Areas

This work must be carried out by December 22, 1996, and kept maintained throughout the summer months until April 12, 1997.

A. Rural Land:

1. A firebreak not less than 2 metres wide must be constructed inside and within 100 metres of the boundary of each property where the boundary is adjacent to or adjoins a constructed or used surveyed road. (Firebreaks constructed on road verges do not constitute a legal firebreak under the Bush Fires Act, and Council approval is required prior to construction of additional firebreaks on roadside verges.)
2. A firebreak not less than 2 metres wide must be constructed within a perimeter of 20 metres of all homesteads, buildings, haystacks and fuel storage areas on the land.
3. Where uncleared land abuts a boundary, a firebreak not less than 2 metres wide must be constructed inside and within 100 metres of such boundaries.

B. Special Rural Land:

1. The owners of all existing small rural holdings zoned "Special Rural" in Town Planning Schemes must construct a firebreak not less than 2 metres wide, immediately inside all boundaries.
2. An area of 30 metres around the house must be cleared of hazardous material to create a fuel-free zone. This zone is defined as an area devoid of understorey, leaves, rubbish and dead timber. Trees within the fuel-free zone are acceptable, provided they are not heavily barked and do not overhang the house.
3. Pasture land shall be grazed, slashed, or the fire hazard reduced by some other means, to the satisfaction of a duly appointed officer.

Townsites

This work must be carried out by December 1, 1996, and kept maintained throughout the summer months until April 12, 1997.

C. Townsites—Gracetown and Prevelly Park

In respect of land owned or occupied within these townsites or any area subdivided for other purposes, you shall:

1. Remove all flammable material (including ground fuel build-up) on the whole of the land except living standing trees, or
2. Construct a firebreak not less than 1.5 metres wide, immediately inside both side and rear boundaries, together with a firebreak not less than 3 metres in width around all buildings on the land. All fuel residue material from firebreak construction to be removed from the block.

D. All other townsites (including Molloy Island)

In respect of land owned or occupied by you within any townsite or any area subdivided for other purposes, you shall:

1. Where the area of land is up to and including 4 000 sqm, remove all flammable material on the land except living standing trees, from the whole of the land, and
2. Where the area of land exceeds 4 000 sqm, clear of flammable materials, firebreaks at least 2 metres wide, immediately inside all external boundaries of land, and also immediately surrounding all buildings situated on the land.

E. Private Hardwood/Softwood Plantations

Any area planted with pines or eucalyptus species exceeding five (5) hectares but not exceeding fifteen (15) hectares:

1. Firebreaks not less than two (2) metres wide around the perimeter on land on which plantation is established.
2. Firebreaks not less than ten (10) metres wide, two (2) metres of which must be cleared of all flammable materials, on the boundary. The remaining eight (8) metres must be maintained in a low fuel condition, e.g. short grass may be considered 'low fuel', where the plantation is adjacent to or adjoins a constructed, used surveyed road or enjoys a common boundary. Plantations exceeding fifteen (15) hectares to comply with the Bush Fires Board recommendation.

F. Fuel and/or Gas Depots

In respect of land owned or occupied by you on which is situated any container normally used to contain liquid or gas fuel, including the land on which any ramp or support is constructed, you shall have the land clear of all flammable materials.

Special Notice to Land Owners & Occupiers

The Council forwards a copy of this Firebreak Order each year. The Notice is also published in the *Augusta-Margaret River Mail* and copies are available at the office counter.

If it is considered impractical for any reason to clear firebreaks or remove flammable materials from the land as required by the Notice, you may make written application to the Council not later than the 15th day of November, 1996, for permission to provide firebreaks in alternative positions or to take alternative action to abate fire hazards on the land. This application must be countersigned by the Bush Fire Control Officer for the area in which the land is situated to signify his agreement to the variation. If permission is not granted by the Council or its duly authorised officer, you shall comply with the requirements of this notice.

Bush Fire Precautions, Prohibited Burning Times

The prohibited burning times which apply within the Shire are: December 22, 1996 to February 28, 1997.

Restricted Burning Times

The restricted burning times are: November 9, 1996 to December 21, 1996 and March 1, 1997 to April 12, 1997.

These dates are subject to slight variation according to seasonal conditions, but any alterations will be advertised locally.

Bush Fire Order 1996/97

Notice to all owners and/or occupiers of land in the Shire of Capel

With reference to section 33 of the Bush Fires Act, you are required to carry out fire prevention work on land owned or occupied by you in accordance with the provisions of this order.

This work must be carried out by 30th November 1996, and kept maintained throughout the summer months until the close of the Restricted Burning Period on 26th April 1997.

An inspection of firebreaks and hazard removal will be carried out in all areas of the Shire by an Authorised Officer after 30th November 1996.

Persons who fail to comply with the requirements of this order may be issued with an infringement notice or prosecuted with an increased penalty, and additionally, Council may carry out the required work at a cost to the owner or occupier.

Definitions: For the purpose of this order the following definitions apply—

“Firebreak” means ground from which all flammable material has been removed and on which no flammable material is permitted to accumulate during the Prohibited and Restricted Burning Periods.

“Fuel Free Zone” means the removal of dead grass, leaf litter, trash and understorey bush.

“Greenbelt Area” means all rural and urban land located west of—

- (i) Minninup Road—from the northern boundary of the Shire of Capel to the junction of Minninup Road and Fishermans Road.
- (ii) The unmade portion of Minninup Road—from the junction of Minninup Road and Fishermans Road to its junction with Mangles Road.
- (iii) Mangles Road—from its junction with the unmade portion of Minninup Road in (ii) south to its junction with Roberts Road.
- (iv) Roberts Road—from its junction with Mangles Road West to its junction with Mallokup Road.
- (v) Mallokup Road—from its junction with Roberts Road South to its junction with Ludlow North Road.
- (vi) Ludlow North Road—from its junction with Mallokup Road South to the Southern Boundary of the Shire of Capel.

“Haystack” means any collection of hay including fodder rolls placed or stacked together.

“Low Fuel Zone” means the removal of dead grass, dead trees, leaf litter and trash.

“Plantation”—

- (i) A Plantation is any area of planted pines or eucalyptus species exceeding 3 hectares in area.
- (ii) A windbreak is planted area a maximum of 15 metres wide but with no defined length.

Minimum Fire Hazard Removal Requirements**A. Rural Land (All land other than land described below)—**

1. Firebreaks at least 2 metres in width and not more than 20 metres from the perimeter of all buildings and haystacks situated on the land so as to completely surround the buildings and haystacks.
2. Firebreaks at least 2 metres in width immediately inside and along all external boundaries so as to form a continuous break all around the holding except where an exemption has been granted (Roadside firebreaks do not constitute a legal firebreak under the Bush Fires Act.)
3. Lessees of Railway Reserves shall have a firebreak at least 3 metres in width along the common boundary between the land leased from Westrail and other land owned or occupied.

B. Special Rural Land

The owners of all existing small Rural holdings zoned as Special Rural land under Town Planning Schemes must maintain clear of all flammable material, a firebreak not less than 2 metres inside all external boundaries of land and a 20 metre wide low fuel zone around all buildings on the land.

On the vertical plane on the side of the firebreak the trees are to be pruned to a minimum height of 5 metres.

C. Special Rural Lots—Part Boyanup AA Lot 157, Gelorup (Ramblewood Stage 4)

Lots 66, 68, 70, 71, 72, 73, 74 and 77 of Part Boyanup AA Lot 157 are required to maintain the 5 metre wide strategic firebreak that is on the land. On lots 66 to 68 and lots 70 to 77 of Part Boyanup AA Lot 157 which have buildings situated on them, a 20 metre wide fuel free zone is required around all buildings.

D. Urban Land (Residential, Commercial and Industrial land within a townsite or within any area subdivided for residential purposes, including Gelorup)—

1. Where the area of land is 2 000 m² or less, remove all flammable material on the land except living standing trees from the whole of the land.

2. Where the area of land exceeds 2 000 m², but not more than 5 000 m²—

(a) A 2 metre wide firebreak is required immediately inside all external boundaries of the land. On the vertical plane on the side of the firebreak the trees are to be pruned to a minimum height of 3.5 metres.

or

(b) Remove all flammable material (including ground fuel build up) on the land by either slashing, grazing or burning.

3. Where the area of land exceeds 5 000 m² a firebreak not less than 2 metres wide inside all external boundaries of the land and a 20 metre wide low fuel zone around all buildings on the land is required.

On the vertical plane on the side of the firebreak the trees are to be pruned to a minimum height of 5 metres.

E. Greenbelt Area: A 2 metre wide firebreak is required on the west side of the roads defining the "Green Belt" area, unless an exemption has previously been granted.**F. Peppermint Grove Townsite: All land situated within Peppermint Grove Townsite are exempt from the order to install a firebreak, but Council does retain the right to remove any fire hazard at the owner and/or occupier's expense following the failure of an owner and/or occupier to comply with the requisition of an order in writing to clear a fire hazard or firebreak in accordance with section 33 of the Bush Fires Act.****G. Plantations—****Boundary Firebreaks—**

On the horizontal plane a firebreak shall be provided 15 metres wide and immediately adjoining all external boundaries of the planted area. The outer 10 metres will be cleared of all flammable material while the inner 5 metres, i.e. that portion closest to trees may be kept in a reduced fuel state, i.e. by slashing or grazing grass provided that the height of the grass does not exceed 8cm.

On the vertical plane a clear space 4 metres high will be maintained above outer 10 metres of the firebreak.

Internal Firebreaks—

Plantations shall be subdivided into areas not exceeding 30 hectares by firebreaks 6 metres wide which shall be cleared of all flammable material.

In the vertical plane a clearance of a minimum height of 4 metres from the ground level will be maintained above the firebreak.

Special Risks—**(i) Public Roads and Railway Reserves—**

Firebreaks 15 metres wide shall be maintained where a planted area adjoins public roads and railway reserves. The specification will be as for "Boundary Firebreaks" on planted areas.

(ii) Powerlines—

Firebreaks shall be provided along powerlines where they pass through or lie adjacent to planted areas. The specification of the width and the height of clearing shall be in accordance with State Energy Commission of Western Australia specifications.

Fuel and/or Gas Depots—

In respect of land owned or occupied by you on which is situated any container normally used to contain liquids or gas fuel, including the land on which any ramp or supports are constructed, you shall have land clear of all flammable materials.

Firebreak Variations—

If it is considered impractical for any reason to clear firebreaks or remove flammable materials from the land as required by this notice, you may make written application and include a plan of your land detailing your fire prevention measures to the Council or its duly authorised Officer, no later than the 31st day of October, 1996 for—

(i) Permission to provide firebreaks in alternative positions or take alternative action to abate fire hazards on the land,

- (ii) an exemption from the requirement to provide firebreaks for either a twelve month or a five year period.

This application must be counter-signed by the Bush Fire Control Officer for the area in which the land is situated to signify his agreement to the variation. If permission is not granted by the Council or its duly authorised Officer, you shall comply with the requirements of this order.

Campfires—

Camp fires are totally banned within the whole of the Shire during the prohibited burning period, except in recognised camping and picnic areas where properly constructed facilities exist.

Notice to all owners and/or occupiers of land within in the Shire of Dandaragan

Firebreaks

Pursuant to the powers contained in Section 33 of the above Act, you are hereby required on or before the 1st day of November, 1996 to clear of all inflammable materials, firebreaks in accordance with the following, and thereafter to maintain the firebreaks clear of all inflammable material up to and including the 29th day of March, 1997.

Rural Land

1. Clear of all inflammable material, firebreaks at least three (3) metres wide inside and within fifty (50) metres of all external boundaries of all improved and unimproved land owned or occupied by you. For the purpose of this section, all road reserves are to be taken as boundaries.
2. Where the bush on the land owned or occupied by you has been bulldozed, chained or prepared in any similar manner for clearing by burning (whether you intend to burn the bush or not), clear of all inflammable materials, firebreaks not less than twenty (20) metres wide immediately inside the external boundaries of the land on which bulldozed, chained or otherwise prepared bush is situated.
3. Where there is standing timber on land owned or occupied by you and it is intended to burn such timber, to clear of all inflammable material, firebreaks not less than six (6) metres wide immediately inside the external boundaries of the land on which the timber is standing.
4. Landowners and/or occupiers adjoining Vacant Crown Land are, in addition to the above, encouraged to maintain external firebreaks where their property adjoins the Vacant Crown Land.

Townsites

Urban land (all land within the townsites of Dandaragan, Regans Ford, Badgingarra, Cervantes and Jurien) you shall clear lots of all debris, dry grass, dry bush, etc., of an inflammable nature.

That within townsites, on all undeveloped lots, that a 2 metre wide firebreak be slashed around boundaries of each lot and that all dry material be removed from the break.

General

In situations where construction of firebreaks in accordance with the Order may aggravate soil erosion problems or where the owner or occupier of land considers a more effective system of fire protection can be obtained or for any other reason, Council may approve an application for alternative siting of firebreaks. If for any reason it is considered impractical to clear firebreaks as required by this notice, you may apply to the Council or its authorised officer not later than the 15th day of October for permission to provide firebreaks in alternative positions. If permission is not granted by the Council or its authorised officer, you shall comply with the requirements of this notice.

Persons who fail to comply with the requirements of this order be issued with an infringement notice on the spot, penalty of \$80.00 or if prosecuted in court a fine of up to \$1,000.00. In addition, Council can carry out the required work at the cost of the owner or occupier.

If the requirements of this notice are carried out by burning, such burning must be in accordance with the relevant provisions of the Bush Fires Act.

If individuals intend to install firebreaks in any approved alternative location, it is the individual's responsibility to consult and verify approval for this to occur with their insurers.

SPECIAL ORDERS—Section 33

The requirements of this order are considered to be the minimum standard of fire prevention work required to protect not only the individual properties, but the district generally. In addition to this order, the Shire Council may issue separate special orders on owners or occupiers if a particular hazard removal is deemed necessary.

“Fire Break” means ground from which all flammable material has been removed and on which no flammable material is permitted during the fire break period.

“Flammable Material” defined for the purpose of this notice to include bush (as defined in the Bush Fires Act) boxes, cartons paper and the like flammable materials, rubbish and also any combustible matter but does not include green standing trees, or growing bushes or plants in gardens or lawn.

Owners or occupiers of land in the Shire of Carnarvon are required to have firebreaks constructed prior to the firebreak period which is from the 1st November 1996 to the 30th April 1997 inclusive.

Persons who fail to comply with requirements of this order may be issued with an Infringement notice Penalty \$80 or prosecuted and face a fine of not more than \$1,000. Additionally Council may carry out the required work at cost to the owner or occupier.

If for any reason it is considered impracticable to comply with the provisions of this order, you may make a written application for a variation to the order which must reach the Shire Council not less than fourteen days prior to the date by which the firebreak is to be established. Approval to any such variation will only be granted where the Bush Fire Control Officer for the area has first signified his approval to the variation by his signature on the written application. If the application is not approved by the Shire Council you shall comply with the requirements of this notice.

1. Townsite Land: In respect of land owned occupied by you in the Townsite of Carnarvon.
 - (a) Where the area of land is 2024 square metres or less, remove all flammable material on the land from the whole of the land.
 - (b) Where the area of land exceeds 2024 square metres construct firebreaks at least two metres wide immediately inside all external boundaries of the land and also immediately surrounding all buildings situated on the land.
 - (c) In respect of any land owned or occupied by you, which there is situated any containers/installation used for the storage of flammable liquid or gas fuel, you shall clear the land of all flammable material.
2. Water pumping installations, Gascoyne River area

All owners of water pumping installations with diesel or petrol driven engines for the pumping of water from the Gascoyne River or its bed are required to construct firebreaks six metres wide on all sides of such pumping installations.
3. Rural Land (other than townsite land)
 - (a) A firebreak shall be constructed not less than 3 metres in width immediately inside and along the whole of the external boundaries of the property or properties owned or occupied by you.
 - (b) Where buildings are situated on the property, additional firebreaks not less than three metres in width must be provided within 100 metres of the perimeter of such buildings in such a manner as to completely encircle the building.
 - (c) Pastoral Buildings—two firebreaks of not less than three metres in width and not more than 20 metres apart must be provided within 100 metres of the perimeter of such buildings in such a manner as to completely encircle the building.

Special Orders—Section 33

The requirements of this order are considered to be the minimum standard of fire prevention work required to protect not only individual properties but the district generally. In addition to the requirements of this order, the Shire Council may issue separate special orders on owners or occupiers if hazard removal is considered necessary.

2. A firebreak 20 metres wide shall be maintained immediately inside the external boundaries of all land which has been bulldozed, chained or prepared in any similar manner for clearing by burning (whether it is intended to burn the bush or not).
3. All absentee land owners/occupiers not residing within the Shire of Beverley shall construct and maintain free of inflammable material a firebreak not less than 2.2 metres wide along all external boundaries of their property.

NOTE: All absentee rural land owners/occupiers are asked to notify their Fire Control Officer of their contact telephone number and address. If you are unaware of your Fire Control Officer, please contact the Shire of Beverley on (096) 46 1200 to obtain this information.

4. A firebreak 4 metres wide shall be cleared and maintained around all stationary pumps and motors.
5. Paddock burns—at any time, where a landholder intends to burn paddocks the following must be provided to prevent the escape of fire—
 - (i) A firebreak 2.2 metres wide clear of all inflammable material completely surrounding the area to be burnt.
 - (ii) An operational fire, fighting unit having a capacity of not less than 650 litres.

(b) TOWNSITE LAND

1. All lots with an area of 2024m² (1/2 acre) or less shall be either clear of all inflammable material or have grass mown to a height no greater than 5 cms.
2. All lots or combination of lots that comprise of one holding and having an area 2024m² (1/2 acre) shall be either—
 - clear of all inflammable material or have a firebreak 2.2 metres wide free of all inflammable material provided inside and along all external boundaries.

(c) FUEL DUMPS

In respect of land owned or occupied by you, on which is situated any fuel dump, in addition to the requirements of paragraphs (a) and (b) you shall remove all flammable materials or material likely to become flammable during summer from land occupied by bulk storage tanks and/or drums used for storage of liquid fuel whether the bulk storage tanks and/or drums contain liquid fuel or not. This includes the land on which ramps for holding the drums are constructed. The flammable material free ground must be maintained to a distance of at least 4 metres outside the perimeter of any drum, stack of drums or drum ramp or bulk storage tank.

Flammable material is defined for the purpose of this notice to include vegetation, timber, boxes, cartons, paper and like materials, rubbish and any other combustible matter, but does not include green standing trees, garden plants, growing bushes or maintained lawns, stacked wood heaps or buildings.

(d) If it is considered to be impracticable for any reason to clear firebreaks on the land in the situations required by this Notice or by the date required by this Notice, you may apply to the Council or its duly Authorised Officer for variations by the Order. An application must be made no later than 14 days prior to the date by which firebreaks are required to be constructed, for permission to provide firebreaks in alternative positions or by an alternative date or to take alternative action to abate fire hazards on the land. If permission is not granted by the Council or its duly Authorised Officer you shall comply with the requirements of this Notice.

(e) The penalty for failing to comply with this Notice is a fine and the person in default is liable, whether prosecuted or not, to pay the cost of performing the work.

(f) If the requirements of this notice are carried out by burning, such burning must be in accordance with the relevant provisions of the Bush Fires Act 1954.

HARVESTING OPERATIONS

During any period when harvesting operations are being conducted there shall be provided in the same paddock or within 100 metres of that paddock an operational independent mobile fire fighting unit having a water capacity of not less than 650 litres. The tank of the unit shall be kept full of water at all times during the harvest operations. The responsibility to supply the unit being that of the landholder.

Notice to all Owners and Occupiers of Land within the district of the Shire of Toodyay

Pursuant to the powers contained in Section 33 of the abovementioned Act, you are hereby required on or before the date specified hereunder, or within 14 days of the date of you becoming an owner or

occupier of land within the Shire of Toodyay should that be after the specified date, to clear a firebreak clear of inflammable material on the land in the manner specified hereunder and thereafter to maintain that firebreak clear of inflammable material up to and including 30 April in the following year.

1. Rural Land

1.1 Rural land is all land other than land within the Toodyay townsite.

Specified date: 28 October.

1.2 Where the land does not exceed 20 hectares, a firebreak 2 metres wide shall be cleared and maintained inside and within 10 metres of the external boundaries of the land.

1.3 Where land exceeds 20 hectares but does not exceed 200 hectares, a firebreak 2 metres wide shall be cleared and maintained inside and within 100 metres of the external boundaries of the land.

1.4 Where land exceeds 200 hectares, a firebreak 2 metres wide shall be cleared and maintained in such a manner as to divide the land into areas not exceeding 200 hectares, each area being completely surrounded by a firebreak.

1.5 A firebreak 3 metres wide shall be cleared and maintained immediately around all buildings, haystacks and fuel ramps situated on the land.

1.6 A firebreak 2 metres wide shall be cleared and maintained immediately around any unattended stationary motor (including electric motors) when that motor is operating.

1.7 A firebreak 20 metres wide shall be cleared and maintained immediately inside the external boundaries of all land which has been bulldozed, chained or prepared in any similar manner for clearing by burning (whether it is intended to burn the bush or not) provided that where the bulldozing, chaining or other method of preparation for clearing is completed after 28 October in any year, the firebreak is required to be completed within 28 days of such completion.

1.8 On all land situated within the sub-divisions known as "Majestic Heights" and "Majestic Waters" as designated in the Shire of Toodyay Town Planning Scheme No. 3, a firebreak 15 metres wide shall be cleared and maintained immediately around all buildings on the land.

Please Note:

It shall not be necessary to remove live standing trees when providing the firebreaks required by this section.

Note—Firebreak Variations

If for any reason it is considered to be impracticable to clear firebreaks or remove inflammable material from land as required by Part 1 of this Order, you may apply in writing to the Council or its duly authorised officer on or before 14 October in any year, for permission to provide firebreaks in an alternative position. 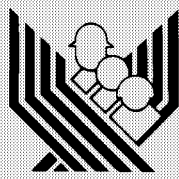


