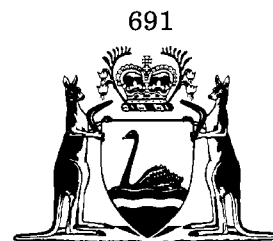

**MURDOCH UNIVERSITY ACT 1973**

It is hereby notified that the Governor in Executive Council acting under the provisions of section 25 of the Murdoch University Act 1973 has approved amendments to Statute No. 19 as set out in the attached schedule.

## SCHEDULE

The existing Statute No. 19 be repealed and replaced with a new Statute 19 titled "Convocation and Alumni Association".

## MURDOCH UNIVERSITY

## STATUTE NO. 19—CONVOCATION AND ALUMNI ASSOCIATION

## 1. MEMBERSHIP

## 1. Convocation shall consist of—

- (a) all persons who are or have been members of the Senate;
- (b) all persons admitted to a degree or diploma awarded by the University;
- (c) all full-time or fractional full-time members of the academic staff of the University;
- (d) all full-time or part-time members of the general staff of the University who hold a degree awarded by any recognised university, as determined by the Registrar;
- (e) all persons admitted as honorary members by resolution of Convocation;
- (f) any other persons as prescribed by Regulation.

## 2. All persons eligible for membership of Convocation shall be eligible for membership of the Alumni Association.

## 2. FUNCTIONS OF CONVOCATION

The functions of Convocation shall include—

- (a) the submission of proposals regarding the welfare of the University for the consideration of Senate;
- (b) the submission of reports to the Senate on matters referred to it by the Senate;
- (c) under the provisions of section 12(1)(f) of the Murdoch University Act, the election of three members of Senate; and
- (d) such other acts or matters conferred or imposed by Regulation.

## 3. ALUMNI ASSOCIATION

- (a) The Alumni Association shall be a federated body comprising members of Convocation generally, who may form special interest "Chapters" which shall be formally recognised by the Senate.
- (b) The aims, functions and constitution of the Alumni Association and such other acts or matters as are necessary for the effective functioning of the Association shall be prescribed by Regulation.

## 4. STANDING COMMITTEE

- (a) The affairs of Convocation shall be managed by a Standing Committee, which shall comprise members elected by each of the constituent Chapters of the Alumni Association and the membership of Convocation at large in the manner prescribed by Regulation.
- (b) The President of the Alumni Association shall be the Chair of the Standing Committee.
- (c) The quorum and procedures for meetings of the Standing Committee shall be prescribed by Regulation.

## 5. GENERAL MEETINGS

- (a) General Meetings of Convocation may be convened by—
  - (i) resolution of the Senate; or
  - (ii) the submission to the Registrar by not fewer than 50 members of a request for a General Meeting, to be held not less than 23 nor more than 42 days from the date of receipt of the request.
- (b) By public notice, at least 21 days notice will be given to members of the place and time of a General Meeting and the general nature of its business.
- (c) The quorum for a General Meeting shall be twenty members.
- (d) The President of the Alumni Association shall act as Chair of General Meetings. In the absence of the President, the General Meeting shall elect a Chair from among the members present and the Registrar shall act as Returning Officer for that election;
- (e) Procedures for a General Meeting shall be determined by the meeting or, in the absence of such determination, the Rules of Debate (Rules 16 to 27 inclusive) contained in the Standing Orders of the Senate shall, with necessary modifications, apply.
- (f) Any decision or resolution made on a question by the majority of members present shall be the decision of Convocation.

## 6. REPEAL

Statute No. 19—Convocation is hereby repealed.

**“Sanitary Plumbing”** means the installation, renewal, replacement, alteration, repair or maintenance of above ground pipework, fittings and fixtures which convey waste to the sanitary drainage system.

**“Water Supply Plumbing”** means the installation, renewal, replacement, alteration, repair or maintenance of water supply systems.

**“Water Supply System”** means the pipes and fittings used or intended to be used for the supply of water from a meter assembly to the points of usage within any property, and includes any water storage tank or pipes from a water storage tank.

**“Licensed Plumber”** means a person who holds a plumber’s licence.

**METROPOLITAN WATER SUPPLY, SEWERAGE AND DRAINAGE  
AMENDMENT BY-LAWS 1996**

Made by the Minister under section 146 of the Act.

**Citation**

1. These by-laws may be cited as the *Metropolitan Water Supply, Sewerage and Drainage Amendment By-laws 1996*.

**Principal by-laws**

2. In these by-laws the *Metropolitan Water Supply, Sewerage and Drainage By-laws 1981\** are referred to as the principal by-laws.

**By-law 1.1 amended**

3. By-law 1.1 of the principal by-laws is amended —

- (a) by inserting in their appropriate alphabetical positions the following definitions —

“

**“Drainage Plumbing”** means the installation, renewal, replacement, alteration, repair or maintenance of —

- (a) below ground property sewers which operate under gravity flow conditions;
- (b) sanitary drainage pumping pits and any associated pressure mains; or

30.4.4 The holder of a drainage plumber's licence may carry out drainage plumbing within the Metropolitan Water, Sewerage and Drainage Area and may carry out or cause to be carried out drainage plumbing within areas open for sewerage house connections.

”
