### CONSERVATION AND LAND MANAGEMENT ACT 1984

#### MANAGEMENT PLAN FOR SHARK BAY MARINE RESERVES

The National Parks and Nature Conservation Authority advises that the management plan for the Shark Bay Marine Reserves is available.

Shark Bay is of international significance having been inscribed on the World Heritage List in 1991 in recognition of the area's outstanding universal natural values. Values of the marine reserves include a diverse range of marine habitats including stromatolites and extensive seagrass meadows, one of the largest dugong populations in the world, high economic value for commercial fisheries and extensive use for recreational fishing and other recreational activities.

The management plan was prepared in accordance with sections 53 to 61 of the Conservation and Land Management Act 1984, and was released by the Hon. Minister for the Environment on 22 February 1997. No modifications were made to the management plan under section 60(2) of the Act, and it comes into operation with this *Government Gazette* notice.

### EAST PERTH REDEVELOPMENT SCHEME

Correction to Duration of Advertising Amendment No. 4 available for Inspection

The Hon Minister for Planning has granted approval to advertise for public comment Amendment No. 4 to the East Perth Redevelopment Scheme. The Amendment was recently advertised not in accordance with the relevant sections of the East Perth Redevelopment Act 1991 and is hereby readvertised for an amended duration.

The purpose of the Amendment is to extend the Scheme over the remaining portion of the East Perth Redevelopment Area located north-east of the railway line to the Swan River, thereby creating Precincts 16, 17, and 18. The Precincts are to be named Summers Street South, Old Power Station and Transport Corridor respectively consistent with their localities. The Amendment also includes supporting Planning Policies for these Precincts.

Copies of the proposed Amendment and accompanying Policy are available for inspection at the offices of the Authority at 184 Bennett Street, East Perth between the hours of 8.30 am and 5.00 pm. Telephone 222 8000.

Written submissions on the proposed Amendment must be received by the Authority not later than close of business on 6 May 1997. The Authority may modify the proposed Amendment to give effect to any submissions received.

**COMMUNITY SERVICES (CHILD CARE SERVICES BOARD)

1. This order may be cited as the *Community Services (Child Care Services Board) Amendment Order 1997*.

2. In this order the *Community Services (Child Care Services Board) Order 1988\** is referred to as the principal order.

**Chairperson or other member unable to act**

7. (1) If the chairperson is unable to act by reason of sickness, absence or other cause, or during any vacancy in that office, the deputy chairperson is to perform the functions of the chairperson.

(2) If a member other than the chairperson is unable to act by reason of sickness, absence or other cause, or during any vacancy in that office, the Minister may appoint another person to act in the member's place and, while so acting according to the tenor of his or her appointment, that person is to be taken to be a member of the Board.

(3) If the member who is deputy chairperson is performing the functions of the chairperson, the Minister may, under subclause (2), appoint another person to act in his or her place as a member.

(4) The appointment of a person under subclause (2) may be terminated at any time by the Minister.

(5) No act or omission of a person acting in place of another under this clause is to be questioned on the ground that the occasion for his or her appointment or acting had not arisen or had ceased.

”.

**Clause 8 amended**

6. Clause 8 (5) of the principal order is amended by deleting “the chairman is” and substituting the following —

“ both the chairperson and deputy chairperson are ”.

**Clause 8A inserted**

7. After clause 8 of the principal order the following clause is inserted —

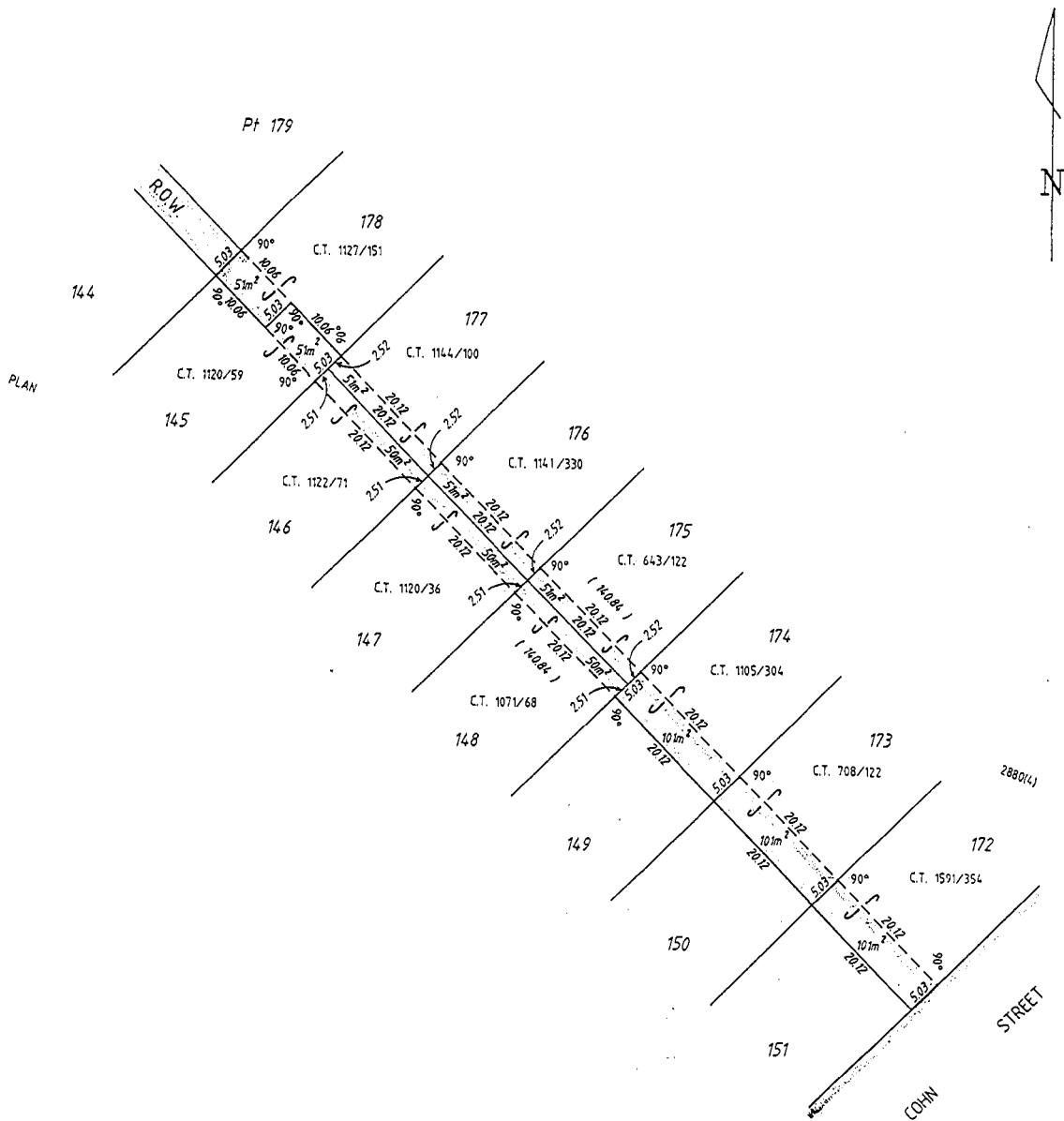

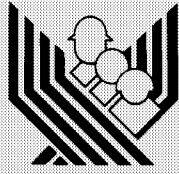
